Clerk is First to Testify in Grand Theft Trial

Boise County - Boise County's Clerk, Mary Prisco, was the first witness called to the stand to testify in the Rana Klingner Trial. She lay much of the background as to the office, how Auditor Certificates

(ACs) were generated and by whom. The time in question was between 2013 & 2014, when Klingner worked as a Deputy Auditor in the Clerk's Office. There had been 14 jurors chosen to sit for this trial. The venue had recently been changed to Ada County, along with a new District Judge and jury from Boise.

Clerk Prisco, the custodian of financial records, spoke about

the financial documents provided to Bailey & Company for the audit. *"Whatever they need, we prepare* and they are simply reviewing what we've provided to them," says Prisco. She recounted the county departments that receive funds, which include: The Court, Recorder's Office, Solid Waste, Planning & Zoning, the Sheriff's Office, Assessor's Office, and Treasurer's Office. They receive cash, checks and credit card payments. The departments normally hand deliver a transmittal sheet, which is brought over to the clerk's office.

Jay Rosenthal, Boise County's Chief Deputy Prosecutor, asked the Clerk, "Who was the individual assigned to receive those transmittals in 2013 and 2014?" Prisco, a 20-year resident of Boise County and elected to the office in 2011, answered, "Our Deputy Auditor, *Rana Klingner.*"

When a determination was made that there was a loss, from theft, Prisco submitted a claim of \$47,922 to the county's insurance carrier. This money was reimbursed, minus

the deductible of \$1,000.

Prisco said that she had hired Klingner in April of 2012, originally to fill a position as Jury Commissioner. However, when a position came open in May, Klingner was promoted to work as the Deputy Auditor. "She did have quite a bit of financial and accounting experience, which is difficult to come by in Boise County," said Prisco. She recalled that at this time, the county was having a very "difficult time" financially, because of the Alamar Lawsuit.

Rosenthal asked if she and Ms. Klingner "became good friends both in and out of the office." Prisco replied warmly, *"We became good friends."* When allegations began to surface in 2014, the deputy prosecutor asked, "Were you supportive of Mrs.

Klingner?" She responded definitively, *"I was very supportive."* However, in October of 2014, Clerk Prisco was directed to put Ms. Klingner on Administrative leave by legal counsel. In December, legal council directed, "a notice of intent to terminate, with the option of resignation," said Prisco. Klingner resigned, but is now facing two counts of Grand Theft.

The Ada County Courthouse unexpectedly lost power and there was not time enough for Clerk Prisco to be cross examined by the defense, before an alarm sounded. Everyone was asked to evacuate. Two Boise fire engines arrived, then firefighters went into the building armed with heavy gear and axes.

Power was restored about 45 minutes later, but by then, court had been canceled for February 14th. Court proceedings would resume the following day and were scheduled to continue throughout the week -- *perhaps even longer--* with a long list of witnesses.

Ice Jams Scrape Through Creeks

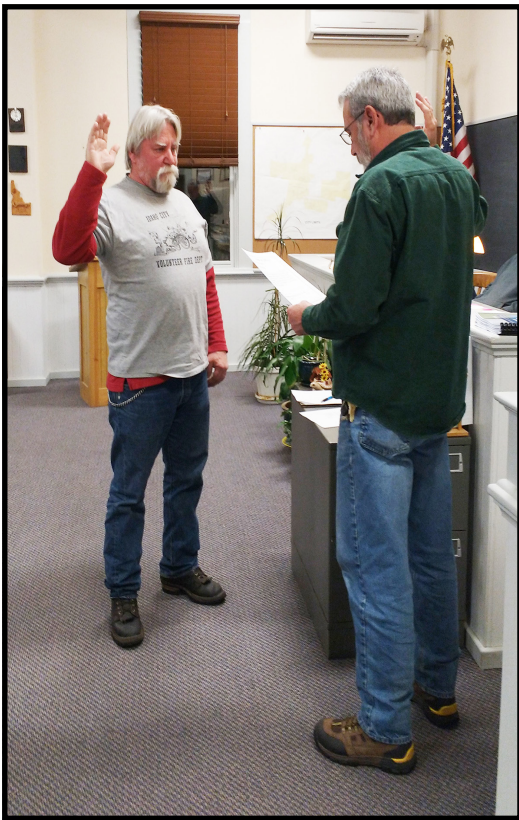
East Boise County - On Saturday, February 11th, the significant rain and warming trend sent debris and ice down in 2-mile stretches. The build up had the Boise County Road Department, Idaho Transportation Department (ITD) and volunteer fire departments a little worried. Boise County's Sheriff's Deputies were on scene at the conduit, where Mores Creek meets with Grimes Creek. The snow and ice sludge had been building and threatened to cause damage to the bridge. A large backhoe (lower) was called in by ITD to help remove some of the larger ice chunks, in danger of colliding and building up behind the bridge on Hwy 21. Photographed (up) Jim Bryant (left), Wilderness Ranch Fire Chief, said as a kid, he remembered ice jams like these were a common occurrence during the winter. Curtis Dill, of the Boise County Road Department, identified the problem blockage along Grimes Creek that was nearly flooding a nearby home. Crouch City Council Discuss Snow & Building Fees

Crouch - Crouch City Council held their regularly scheduled meeting February 8, 2017. All members were in attendance including Mayor Bob Powell, Council President Richard Messick and Council Members Wendy Bates, Jackie Kraupp and Dana Hinson. Also present was City Attorney Tony Pantera with substitute Clerk, Janet Juroch.

A Public Hearing for Building Inspection Fees was attended by two residents of Crouch, Jim Trudeau and Eileen Brail. Attorney Pantera noted a 2016 ordinance that did layout the permitting inspection process with four procedural inspections and had been approved in a past Public Hearing. According to Attorney Pantera, "Fees met the mandatory two time publication in the Idaho World and that this is resolution for fees not building codes. The

fees are to go with the building codes enacted last month. Fees are conservative and should not be for producing revenue".

The Building Fees of Resolution Number 2017-R001 with a fee of \$200 to meet each inspection of footing, foundation, framing and final inspection and not to exceed \$800. A Roll Call vote was made and the motion carried unanimously. Attorney Pantera reminded everyone that all other regular permit fees remain the same with some exclusions that are also in place already.

The new city well still needs a survey done so that the lot split can be finished. Snow has made it hard to place survey markers by Sean Sullivan of ALS Survey. Sullivan will be working on this issue.

Water Master Report from Terry Tucker was read by Clerk. There are some issues with the tank. The snow has

made it difficult to work on the tank so it is requested to look at a maintenance plan for snow plowing. Tucker noted that the telemetry that tells the pump when to send water to the tank was not working, saying, "It could be as simple as a wire disconnected because of the snow, tank leakage, signal, etc." He will update the Clerk as soon as he has more information. Council members want to look into a remote system for repairs, too.

Further discussion by Member Messick said that water from the tank was used for fire suppression of a nearby home that caught fire. This left the only Crouch resident on the water system to run out of water due to the Garden Valley Fire Department taking water from the tank. It was explained to the council that the tank is not always full at this time of year so that water can remain

fresh and potable. Water was simply used up after the incident. Council wants to be better informed when larger amounts of water are used from that tank so adjustments can be made.

Fire hydrant clearing was another topic since they are currently buried in snow. The GVFD indicated that fire hydrant clearing is the responsibility of the city. City Clerk Chandler is looking into plans for the New Life youth group helping as a service project. Richard Messick noted "The State Fire Marshall Reports say there should be a 3 foot radius around a hydrant cleared."

Discussion continued regarding snow removal for next year. "The snow accumulation is not making people happy," according to Mayor Powell with people in town expressing concerns of safety. Others have approached the council members about plowing, or lack

thereof, concerning the main road in town. Council agreed that individual businesses doing their own snow plowing is not working out with so many complaints coming into the office. Attorney Pantera will look into those possible provisions to keep the roads clear for the city at next meeting in March.

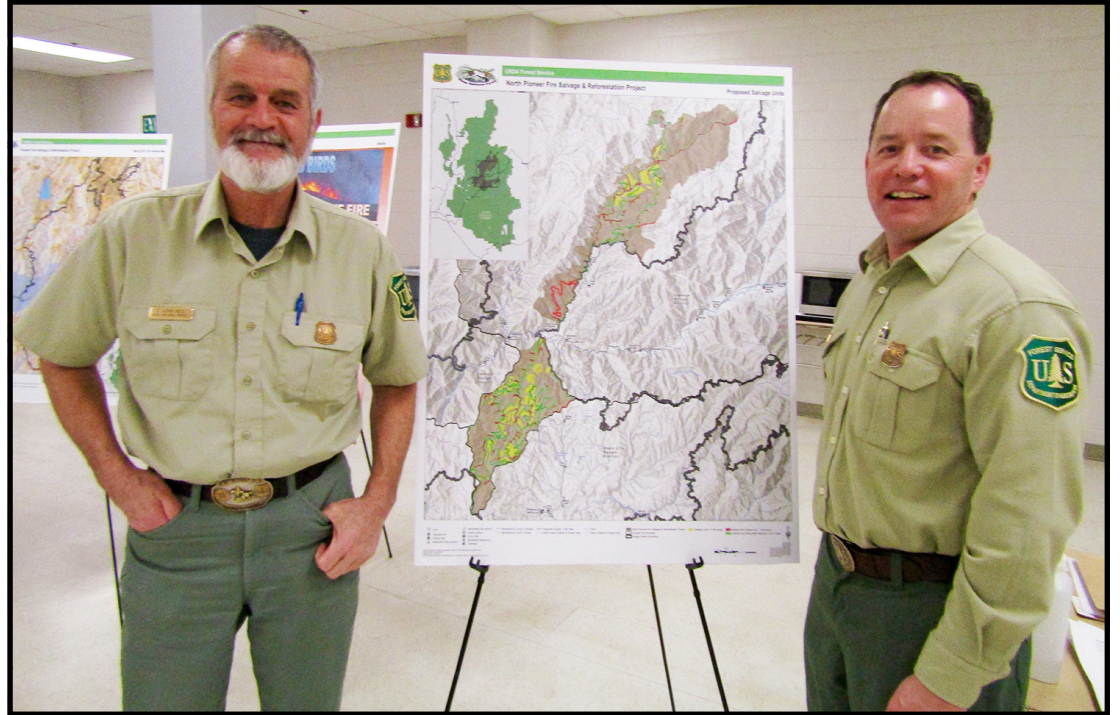

Forest Service Addresses Pioneer Fire Salvage

Garden Valley - In an effort to be transparent, the USFS had three informational meetings for the public to come and see what work has been done regarding the 2016 Pioneer Fire. Meetings were held in Idaho City, Boise and Garden Valley. Proposed activities will include hazard tree removal and burned tree salvage harvests to be completed in 2018. Other activities will continue for at least 10 years, such as reforestation and infrastructure work. The goal is to make sure the burned forests areas are able to be open to the recreational

activities in these areas remain while maintaining safety. There will be some trails closed as they are deemed hazardous due to debris and soil erosion. Another important area is making sure that ecologically plants and wildlife in those areas will thrive while keeping out the huge potential for weeds and non-native plants to take root. Idaho City - During this scoping period, they are looking for public comment, until February 27th. Representatives say that in harvesting the already lost timber base, this will reduce the hazards and also pay for restoration efforts. The Pioneer Fire burned nearly 190,000 acres of forest. Only a small percentage of this area can be accessed for proposed logging.

John Kidd, Lowman District Ranger, recognizes that the fire has, "Changed the landscape

forever." Efforts have already gone forth with salvage efforts along 3 roadsides and in 1 campground. Now they will be able to open in the spring for public recreation.

The Forest Service is proposing to extend logging efforts 200 feet from off the roads, disregarding any portion that may contaminate a riparian area, such as a creek.

Kidd added, "We're hoping to have a decision signed in June." Brant Petersen, Idaho City District Ranger, agreed and stated, "This could happen

really quick!"

The U.S. Forest Service is *not* proposing to decommission any road, nor will there be a change to management of those roads. The roads that are closed will remain closed.

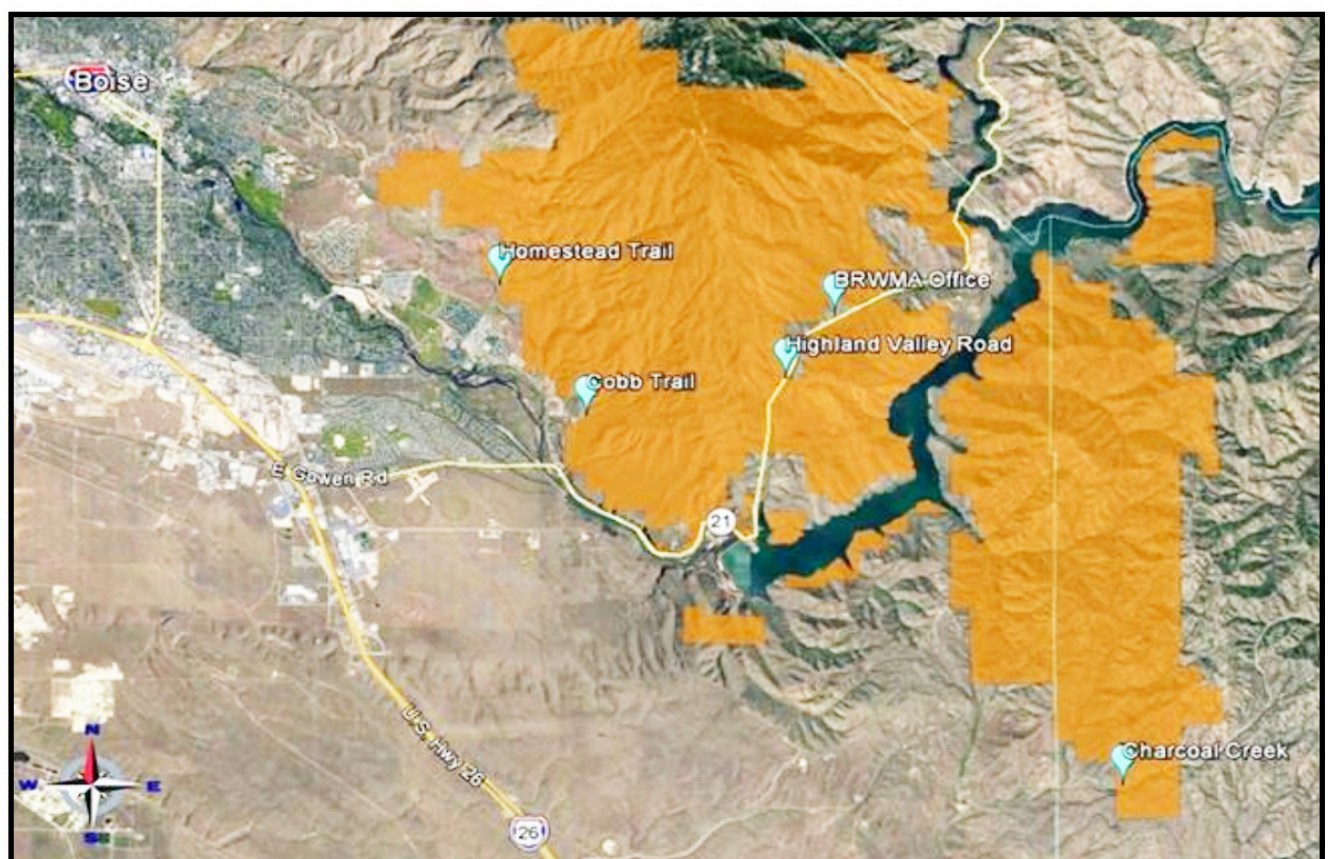
The Forest Service hopes to be ready for "reforestation" efforts in 2018. It would take a few years for the nursery to grow seed collected from the cones in the Boise National Forest, that came from the same elevation and coniferous trees.

Another Closure to Public by Idaho Fish & Game

Idaho Fish & Game
Boise - Closure to limit disturbance to wintering big game. The Charcoal Creek segment of the Boise River Wildlife Management Area is now closed to all public entry. This portion of land is located south and east of Lucky Peak Reservoir and north of the Blacks Creek Road. This closure is in addition to the one that occurred in late January for the Boise Front Segment. Both closures have been instituted to help protect wintering big game animals and will remain in effect until further notice. The closures eliminate a source of stress for big game animals already dealing with abundant snow and low temperatures in the area. "Providing secure areas for these animals to weather the storms, without additional stress from human disturbance, can improve their chances to survive the winter," said Zach Swearingen, Fish and Game habitat manager. The area was established to permanently protect portions of big game critical winter range

in the Boise Foot-hills. Large numbers of mule deer and elk migrate from the Sawtooth Mountains to winter there. During severe winters, approximately 7,000 mule deer can utilize the area. Minimizing disturbance to wintering animals can have large impacts in helping them conserve energy and survive until spring arrives. 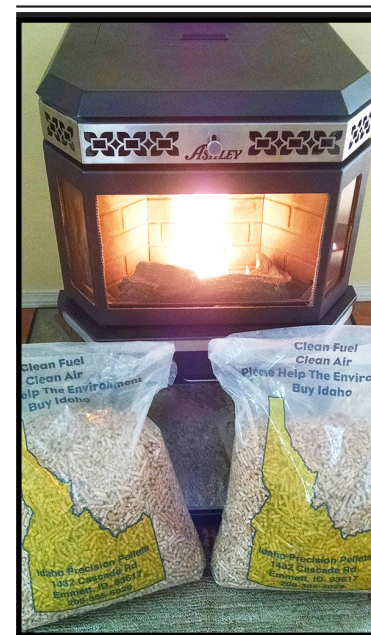
