Conflict of Roles ~ Requiring Planning & Zoning Appointment to Step Down

Boise County -- There is once again a vacancy in the Horseshoe Bend District #5 of Planning and Zoning. Doug Bergey had been appointed to the P&Z Commission on March 21, 2017, by the Boise County Board of Commissioners. Now Bergey turned in his resignation on Monday, March 27, 2017, with apologies to Planning and Zoning Administrator Rora Canody, explaining the resulting conflict of interest he discovered.

District #5 had a vacancy that needed to be filled. After applications were received, the Boise County Board of Commissioners made the decision to appoint Bergey. A statement by the Board of County Commissioners stated, that with land use related and surveying experience, Bergey was the appropriate candidate. It was also noted that Bergey worked for Forsgren Engineering, which is a company that Boise County regularly contracts with for surveying and engineering pur-

A potential conflict was addressed by the Board and they consulted with their Prosecuting Attorney and independent legal counsel. The conclusion was that if there was a potential for conflict, Bergey could recuse himself from decisions when appropriate.

After the appointment was made, Bergey met with Keith Simila, Executive Director of the Idaho Board of Professional Engineers and Professional Land Surveyors. Bergey stated that when applying for the P&Z Commission vacancy he overlooked the Board's decision in April of 2014, regarding a very similar situation in Northern Idaho. He said, "Essentially the Board's attorney stated that simply recusing oneself was not enough to remove the conflict of interest appearance." He concluded from that decision he could be on the P&Z Commission or work for the County Engineer, but not both.

Bergey had to make the decision that he could either volun-


teer on the Planning and Zoning Commission or continue his work with Forsgren. He said, "At this point I am not ready to retire from my job." He sent in his letter of resignation to Mrs. Canody.

Bergey apologized for his feeling of letting P&Z and the County Commissioners down and said, "I should have done more due diligence on my part." Bergey thought that recusing himself from projects he was involved in would be enough, as did legal counsel. However, the revised ruling of the Licensing Board looks at a Conflict of Interest under IDA-PA 10.01.02.008 that would "jeopardize the client's interest or quality of service" and should be avoided. This also follows Idaho Code 59-701 as a potential violation of the Ethics of Government.

In essence, the Licensing Board states that the key point is "licensees or certificate holders in elected or appointed of-

who fices are able to contract or recommend a contract for engineering and/or surveying services may find they or their company can no longer solicit or accept contract with the same government entity. It is no longer sufficient to hold office or recuse yourself from those decisions."

Bergey did add, "I love our county and want to serve it. My role will probably continue, as it has, helping and answering questions, or more accurately providing my opinion when asked."

Thank you, Jay, for serving so faithfully and ensuring that the Prosecutor's Office still continued to function throughout the years. We hope that you enjoy retirement and



All Paws Training Goal is a Well Socialized Pet

Pets around us are often like family and bring a fun experience to daily living. Dogs particularly bond a family together, take trips, ride in cars, fetch and go for walks. That is in a perfect world. However, sometimes our pets fail at socializing properly and that makes for some stressful times for the

owner and their pets. Learning techniques to train your dog will improve their life and ensure their safety.

All Paws Boarding and Training is operated by Daryl Klepsa-Andries, owner and a certified trainer with ABCDT qualifications. She has started puppy and adult dog training classes in Garden Valley. Daryl comes from a military background with 6 years in the U.S. Air Force. Upon completion of the military career, she was admitted to the Dog Obedience Program that is meant for Veteran's for six months.

Daryl got to thinking about training animals when people commented about how well behaved her own dogs was. Her dog, Jade, went with her to every class and became very well trained too. Jade is at every puppy or adult dog training session because she is like a role model for socialization. She shares, does not mind a dog who barks at her and is very calm natured. Jade is a medium sized adult dog and is Shephard, Akita and

Husky mix.

Daryl also has a rescue dog, Ramon, who needs to learn socialization with other dogs and not pull on his lead. Daryl uses kibble rewards and has other tricks to entice dogs to feel comfortable. At the adult class there are five dogs this session and each one has different social issues, ranging from barking at everything going on to an extremely shy dog. Daryl says that the goal after the 7 lessons is that each dog will be better at social settings with other animals around. This includes other things affecting the dog's ability to be social such as nonfamily people, bikes, or cars, for example. Linda Ruppel has her Newfoundland puppy named Haiku in one class and giggles, "I think the class is more about training the dog owner than the dog."

By January she will begin her schooling for a MDT (Master Dog Trainer) certification. Completion will be in July of 2018. With an MDT she will be able to train service/rescue dogs and guide dogs. She will be certified for behavioral training needed for specialty use dogs. Her certification at this point is obedi-

ence training.

Daryl is very interested in training cats saying they are "very trainable." This requires taking another course specifically in cat behavioral training. Cats have unique behaviors and need to be trained differently.

Eventually Daryl wants to have a place where she can arrange boarding. Since she is a new resident to Garden Valley, she pet sits, while looking for a facility that she can train and board animals. "It is hard to find any open place around here for training and boarding. There is not a lot available without buying property and just building a new facility from scratch. But we are looking," admits Daryl.

Classes are going on currently but will be looking for future sign ups towards the end of May. Class is held at the Cascade Vet Clinic in Garden Valley at 6pm. Mondays and Fridays are Puppy Classes and Wednesdays are Adult Dog Classes. Cost is \$175 for seven lessons. Call or text Daryl at 218-791-2715 with questions or email at allpawsbt@gmail.

This person will be chosen to fill the term, extending into 2019. Boise County's Elections Clerk, Sarita Loya, researched as far back as 10 years to try to find the last election for this school board, but there was no record of one held.

My child had a very difficult time with this new style of teaching because she was an 8th grader in 9th grade math and receiving 8th grade math instruction not 9th grade, because that is what the ISAT test would be on. When I went to the school to discuss this I was told over and over again "Change is hard" with no issues being resolved. I pulled her form this math environment at the end of the semester and placed her in online math due to the mass amounts of stress Mastery was causing my child. I would love to hear from parents whose child is having difficulty in this new style of math. For all of you folks who are wondering what Mastery Math is that do not have children attending Basin school District, it is a self-paced program that the student has to have a "B" level of understanding in order to move on to the next concept. There are no due dates and the student never knows what grade they have until, it might be too late. needed new representation in Idaho City. My pledge is to represent the families of Idaho City area, to listen to the needs of the students and concerns of the parents and support them as a voted representative should."




Brandee Kline Basin School District 72 School Board, District 1 Seat

Lower Your Property Taxes Apply by April 18th

BOISE, IDAHO — April 3, **2017** — April 18 is the last day this year to submit applications to your county assessor for a reduction in your 2017 property taxes.

Homeowners who qualify for Idaho's Property Tax Reduction (Circuit Breaker) Program can get property taxes on their primary Idaho residence and up to one acre of land reduced by as much as \$1,320. The state pays a portion of the homeowner's property taxes. Last year, the state approved more than 27,000 claims for a

To qualify for property tax reduction, applicants can have no more than \$29,640 in total 2016 income (after allowable deductions), and they must be U.S. citizens or legal permanent residents. They must also be in at least one of the following categories as of Jan. 1, 2017:

Age 65 or older Blind Widow(er) of any age Former prisoner of war or hostage

Recognized as disabled by the Social Security Administration, Railroad Retirement Board, Federal Civil Service, a public employee retirement

> Fatherless or motherless child under 18 years old

<u>ESCAPED FROM THE TERRITORIAL PRISON</u>

Editor's note: Idaho City comes alive in this exciting story of a prison escape. Unfortunately, some of it was damaged or had words hidden in a fold. The World may never know the whole story, but it is surely one for the history books...

Escaped from Prison.

The four prisoners confined to the Territorial prison made their escape last Wednesday night. The facts, as we learn them, are as follows: There were confined in the prison the following convicts, viz: Hiram Kurtz, of Iowa, aged 40 years, sentenced for life for killing a Chinaman in this city more than a year ago; Michael Dunn, an Irishman, aged 32 years, sentenced to 20 years for killing McKay on Buena Vista Bar early last Spring; Victor Boley; an American, aged 35 years, sentenced to 20 years for killing Jakey Jordan in Boise City last year; and Michael Deal, of Iowa, aged 28 years, sentenced for 2 years for stealing horses in Owyhee, in 1865. Deal's term of imprisonment would expire in a month or two more, and it is known that his part in the escape was forced upon him by his desperate comrades at the peril of his life. For some days, the prison has been under the immediate care of Jos. Rowe and Rob't Griffith, the jailers. On Wednesday morning Rowe was in this city on business and Griffith was alone on guard. About 10 o'clock, Dunn asked permission to be let into the prison yard for a necessary purpose. Agreeably to the custom, Griffith led him out and back. Dunn was ironed, as were Boley and Kurtz, with shackles on the ankles. As Griffith was unlocking the heavy iron grated door separating the prison cells and hall from the outer room, Dunn stood a few feet from him, and as the door was unlocked, leaped and grasped him about the arms and body. By concerted plan, at that instant those inside pulled the door open to-

wards them, and immediately grappled Griffith. One took his pistol, another his knife, and then rushed him, powerless to help himself or to engage successfully with them, to the rear part of the prison passage, and then shoved and locked him in one of the cells. He struggled and fought manfully, but the prisoners had his weapons, he had no one to aid him, and his struggles were ineffectual. With Griffith disposed of, the prisoners first proceeded to take off their shackles and then ordered the Chinaman employed as cook in the prison to prepare them a first rate dinner. Expecting Rowe to come every minute, the prisoners watched for him. About noon, he was seen crossing the long footbridge leading to the Bar. Soon he came to the outer gate. He had a chicken under one arm, and a book under the other. Deal, who had been a "trusty" about the prison, opened the gate for him. Suspecting nothing, he entered. In an instant two of the convicts <damaged> revolver at his breast and threatened to shoot him. In a struggle soon afterwards Kurtz struck at Rowe with a knife, declaring he would have an eye from him, but Dunn and Deal caught his arm, and the point of the knife just cut through the clothing close to the skin of Rowe's right arm. After disarming and overpowering Rowe, they locked him up, first in a separate cell, but finally in the same cell with Griffith, and also locked up the Chinese cook. During the afternoon they roamed about the prison, took a Henry rifle, two revolvers, several knives, an abundant supply of food, and stood watch until night. Kurtz was disposed to kill Rowe and Griffith both, but not until Dunn threatened to lock him up again and have him kept a close prisoner did the villain desist from his threats to murder Rowe, against whom he had a special grudge. About dusk, Gilmore, who was permitted to get water from the prison, went as usual for a bucket full. It was passed out to him by Deal, and Gilmore went away suspecting no wrong. Between the hours of 9 and 12 Wednesday night, Messrs. Rowe and Griffith think, the convicts made their exit from the prison. They had passed some food and water to the imprisoned jailers, and left. Unable to get out of the cell, without any means of making a noise loud enough to be heard by some men occupying the cabin at the foot of the hill below the prison, they could do nothing either to extricate themselves or to give the alarm. Early the next morning, they got the Chinaman to break up some wood work in the cell where he was confined, and to rattle and bang away and howl until the men in the cabin finally heard the noise, and went up to see what was the matter. The convicts had locked the outer gate after them, and the high fence had to be climbed from the outside. The keys to the prison doors were found inside the enclosure, and soon the two jailers and the Chinaman, all held fast prisoners by the escaped convicts, were restored to liberty. They hurled over the city to acquaint Sheriff Crutcher with the facts. That efficient officer has so far done all that could be done towards effecting the re-arrest of

the fugitives. No blame can be attributed to Mr. Giffith, who was simply the victim of a plot which might have prevailed over a more experienced jailer. Of course no one can, with the facts before them, attribute blame or censure to Mr. Rowe, for it was impossible for him to know anything of what had transpired inside while he was absent, and no one man could have successfully contended with the prepared and armed prisoners, taken as he was, seized so suddenly, at the outer prison fence gate. He and Griffith made desperate, but hopeless, struggles. <within a fold> Each periled life to prevent the escape of the prison-

It is doubtful if Dunn will permit himself to be taken alive. He has the Henry rifle, and many of the cartridges.

When the jailers were locked in the cell they heard Kurtz and Boley threaten to kill <in a fold>, to burn down the jail, and to murder Sheriff Crutcher; but Dunn would listen to none of those murderous proposals, and finally in his calm, firm manner, compelled the <in fold> to do as he wished them. Deal will <in fold> to surrender himself at once, as his term of confinement has nearly expired. But <in fold> be kept along with the others by force.

"Bricks & Boardwalks" Idaho's Territorial Prison - 1864

"This hand-hewn prison was originally erected above Elk Creek, north of Idaho City. It had fourteen cells, and handwrought nails, chains, door lifts, and window irons were used to discourage escape. Before this jail was built, an early Idaho City observer noted that there was no jail but plenty of trees and rope. The cost of law and order was high. So, it was that Boise County's first sheriff, Sumner Pinkham, received \$30,000 for thirteen months' service in 1863-64. Although

many were indicted for firstdegree murder, juries usually found the accused not guilty, and most prisoners spent only a short time in this jail."

"This rough structure was used as a territorial prison until the 1870's. The jail's original building site was undermined by placer mines and the structure fell into Elk Creek. It has been moved at least four times before coming to rest in its present location. The Idaho City Historical Foundation currently owns and maintains it."

It's TAX TIME! Time to take a closer look at all the taxes other people are levying or planning to levy on WE THE PEOPLE. We know the tax implications of the \$20 trillion nation debt. It's rapidly approaching \$70,000 per person and doubling every few years. We know the tax implications of ObamaCare. Health care taxes are off the charts. At least ours are. Global Warming Carbon Taxes? Who knows? Worse, we don't have a clue what the 2-Forks Recreational Water and Sewer (TAXING) District has planned for our pocket books. However, we can get a good idea with what we already know.

We know the 2-Forks centralized water treatment plant (~cost \$5M est.) needs about one-half mile (2640' est.) of collection piping to serve the 300 SFL lots. That means each SFL home, on average, requires less than 10 feet (2640/300 est.) of sewer pipe to get service. This low number comes from the fact that lots are densely packed and very close to the sewer facility. The cost for laying sewer pipe runs about \$100 (est.) per foot, which includes mobilization, excavation, installation and lateral prep (\$264,000 est.), or \$880 per lot. So we can see the SFL home owners' cost of collection infrastructure (piping) is minimal (\$264K) compared to the treatment facility cost (\$5M). Collection piping only makes up about 5% percent (5% est.) of the entire fixed costs for SFL sewer service (\$264,000/\$5,264,000M est.) So, when amortized, the fixed cost of sewer ownership for each lot owner is about \$17,546 (\$5,264,000/300 est.) Okay let's see how these costs change when we scatter these 300 sewer customers all over Garden Valley.

2-Forks say they need 10 miles of main sewer line manifold to reach 300 customers. That's about 176 feet per customer (10x5280/300 est.), or in dollars about \$17,600 (\$100x176 est.) But, to get service, GV customers need additional piping to get from the main pipe to their home. On average, we can assume this is another 176 feet and \$17,600 for total of \$35,200 of fixed piping costs per GV customer or 40 times (\$35,200/\$880 est.) the cost for SFL customers. This is why centralized waste treatment facilities don't work for rural communities. Do you think for a minute SFL home owners will want to subsidize the fixed cost of sewer serve for the rest of GV? Would you? \$20Tdebt + "free-money" can't fix this!

A few months ago I embarked on a campaign to get better access to Emergency Services within Boise County. This effort resulted in forming a group of concerned citizens known as Boise County Citizens Against Loss of Life, or BC-CALL. In this effort, letters were sent to six Corporations involved in the Communications industry. There were ZERO responses. At first I was disheartened by the lack of interest, but I decided to press on. Since the formation of BC-CALL several things have happened. First, the Idaho City Chamber went on record as fully backing this project, and they even made me an honorary member, for which I am grateful. Second, we learned that T-Mobile is, in fact, putting a cell tower in the Idaho City area, scheduled for completion some time in 2017. While this is good news for some, the larger problem still exists, that of little or no reliable access to our 9-1-1 system in significant portions of our County.

I have recently drafted a letter to T-Mobile thanking them for their commitment, and offering any assistance we might provide. I also asked several important questions about coverage area and usability by non T-Mobile subscribers for Emergency access. At the same time I wrote a second letter to the local or regional offices of the other providers, reinforcing our desire for improved communications. Of course I mentioned T-Mobile's planned tower. could not send this second letter to AT&T, because I was not able to find an address other than Corporate Headquarters, which had already ignored the first letter. 

BOISE COUNTY COMMISSIONERS' MEETING

Transcribed by Eileen Capson

March 21, 2017

Present: Commissioners Alan Ward, Roger Jackson and Laura Baker

Pledge of Allegiance – Sheriff Jim Kaczmarek

EXECUTIVE SESSION: [Time 9:02am to 9:33am] Coming out of closed session, Commissioner Ward said there

was no action per pending liti-

gation, personnel, or exempt

records.

CONSTITUENT INPUT:

None.

MINUTES: The official meeting minutes were approved for March 14th.

DEPARTMENTAL ISSUES:

ELECTIONS: The Election's Clerk spoke about the March 14th Horseshoe Bend election for the levy. The commissioners approved the canvas of the votes – "155 Yes and 74 No". The number of ballots cast were 229, "It was a great election." Chairman Ward commented positively, "Good

job, Horseshoe Bend."

TRAVEL POLICY FOR MEALS: The county allows up to \$45 a day for instate conferences. Requiring a receipt was discussed. Clerk Mary Prisco stated regarding the policy, "My interpretation of it is, it's up to each of us as department heads to manage within our budget and within the policy that states that max of \$45. The alternative is for the Board to change the Travel Policy and actually set forth a max for each meal." Commissioner

Baker suggested that there are "GSA" amounts for each meal and that it would "cut down on having to keep track of receipts." Chairman Ward added, "That was the whole idea was the time spent working with the receipts and gathering all of them, we wouldn't have that lost time anymore."

PLANNING & ZONING **COMMISSION:** A new member from Horseshoe Bend was chosen to make it an odd number of 5 members of this voluntary commission. Commissioner Ward said to the P&Z administrator, "Mr. Burgie would be beneficial because of his intense background and for so many matters that are in front of you." She agreed. He added, "Not that the other applicant doesn't have background too." Doug Burgie was appointed to this position.

SHERIFF: Jim Kaczmarek said they had an "all hazards, multi-agency exercise" in Garden Valley. He spoke about reimbursing people for temporary emergency personnel. "Really what we ran into was, people who were on volunteer fire departments running out of time with their regular job. If their boss says, 'Yeah, you need to work that to help your community, but you're out of time here,' so they're not getting paid if they're doing that for the county on a volunteer basis." The sheriff will be exploring this option.

He also stated there were some "self-evacuations" on the Middle Fork. Chairman Ward stated that they had had an email from Ms. Capson regarding a "Declaration of Emergency" that morning. He then asked the sheriff, "Are we close to that or do you have a feel for that?" Sheriff Kaczmarek responded, "I've had

one prepared to present to you guys, if any of us thought it was necessary. I don't think at this point."

COUNTY AUDIT: Clerk Prisco stated, "We did finalize our audit, our 2016 Financial Statement," with Bailey & Company. She said there was "a need for policy, particularly with regards to our capital assets... on identifying transactions that can impact at the financial statement level that can impact our budget, verses actual." She said that the bridges that have been built in Boise County since 2007 should have been identified. There was no policy. "Heads up on that!"

MAY ELECTIONS: The election's clerk commented that they would only be having an election for the Boise Basin School District Trustees' Seats for Zone 1 and 2. Mapping is being done in conjunction with the Assessor's office, for the School Board. "It's the first one we've had in many, many years," said the election's clerk.

AGREEMENT: An agreement was signed between Boise County Sheriff's office and North Fork Championship, to provide event traffic control, police service. The mass gathering was approved for June $15^{th} - 17^{th}$.

FEDERAL LANDS PROJ-

ECTS: An engineer spoke about "a call for projects" for access. He said that Arrowrock Road and the Banks/Lowman Road, "which is a very good candidate." It is being considered for a "chip seal" for the entire length, fixed, and painted. This is expected to be about a \$2 million project, which the county would match 7.3%, or about \$150,000. The application will come before the Board for signature next week.

Prescribed Fires for the Idaho City Ranger District

Boise, Idaho, April 4, 2017 -- Southwest Idaho interagency fire managers anticipate favorable spring weather conditions for planned low-intensity prescribed fires. Prescribed fires are designed to reduce hazardous vegetation (fuels), catastrophic wildfire potential, improve wildlife habitat, and reduce wildfire threats to communities.

The www.rxfire.com website is updated with information regarding southwest burns planned within Idaho Department of Lands (IDL), Bureau of Land Management (BLM), Payette National Forest (NF) and Boise National Forest (NF). Weather and conditions permitting, burns are scheduled to start in April and continue through June. Approximately 1,760 acres are planned for ignition in eight project areas within the Boise NF.

Public and firefighter safety is always the first priority in all public land fire operations. Fire managers develop burn plans that account for safety, logistical and staffing considerations, specific fuel and weather prescriptions and smoke management. All controlled burns undergo specific and deliberate criterion and are only approved when favorable

conditions are present.

Information and regulation signs will be posted on roads that access burn areas in advance of ignitions and remain in place through burn completion.

Fire officials strongly advise recreationists and homeowners to plan activities in accordance with the proposed dates and locations of burns and to use extreme caution near prescribed fire areas. The burns may impact access to designated burn areas, travel routes and individuals sensitive to smoke. Please be aware of firefighters and equipment in the area and on roadways, comply with posted notices and slow driving speeds in areas of decreased visibility.
