### Poaching Mushrooms Gets Federal Charges Illegal Commercial Operation is Halted by Law Enforcement

**Boise County** -- Morel Mushrooms were discovered in mass, being harvested illegally by a commercial operation. Buying and/or selling forest products without a special-use permit could prove to have felony implications. On Saturday evening, May 28<sup>th</sup>, Boise County's Sheriff, Jim Kaczmarek, and an officer for the U.S. Forest Service confiscated the more than 500lbs of carefully harvested and sorted morel mushrooms. The contraband was gathered and transported in a refrigerated trailer unit, belonging to

the operation, whose name(s) have not yet being released. A very helpful citizen near Idaho City helped the Sheriff to translate Spanish, upon the return of workers from the Boise National Forest, with another 50 or 60lbs of morels. It is expected that Federal charges will be extended at this point in the investigation. "It is truly an unfortunate situation that a few have taken advantage of the system and chosen to commercially harvest mushrooms outside the legal designated season," says Idaho City's District Ranger, Brant Petersen. "This will di-

rectly affect the availability of Mushrooms for those individuals that chose to wait for the legal season." He continued, "With the high snowpack we didn't feel we could finish the Pioneer restoration planning document, complete the much-needed BAER stabilization work and administer the commercial harvest, so we started the season as soon as we could, which is June 1<sup>st</sup>. We knew it would leave some of the Pioneer fire roads and trails open to travel and mushrooms growing prior to the season starting." He added with some humor, "The good news is, there is thou-

sands of acres of burned ground and with this warm weather, much more should open up to the upcoming harvest season." Breck Young, Patrol Captain with the U.S. Forest Service Law Enforcement, said, "We want to assure that the resource is protected from damage from commercial Harvest activities. Possible damage could include sanitation issues, off-road vehicles, or using tools not allowed during the harvest season." The primary objective of law enforcement during the commercial mushroom season is to protect the public and their employees.

### Black Bear Attacks Hunter From Clear Creek

**Clear Creek** -- Marvin Jennings, 43, of Clear Creek had been hunting bear with his uncle from Washington on Sunday evening. The men spotted a large black bear eating at their bait site. The uncle shot and wounded the animal, which laid down. Upon approach, the bear charged Jennings, knocking him

down. The two tumbled down a hill, with the bear biting Jennings multiple times on the left arm and leg. The animal was considered to be about 10 years old, and its incisors had nearly been worn down to the gum line, but the canine teeth were still very intact. Bill London, Idaho Fish and Game District Conservation Officer, measured the Black Bear to be 5' 3" from nose to tail and weighed between 200 and 230lbs. This was still a healthy bear, despite its age.

Jennings was able to kill the bear with a handgun. He was later flown by helicopter to a Boise hospital with non-life threatening injuries. Clear Creek's Fire Chief, Sam Bonovich said that Jennings hoping to get out of the hospital by the weekend. On Monday, he underwent surgery for his left arm. Several different agencies came together to help in this animal attack, along with Federal, State and volunteers. Officer London was very impressed by the community's preparedness

and show of support, including help from the local EMS and the Clear Creek Volunteer Fire Department. Officer London also expects that with more people moving out into the hills, hunting and recreating, there will be "more interface with wildlife and people." The Idaho Fish & Game returned the skull and cape back to the family, after evaluating and collecting data on the animal. The uncle had a bear tag and the meat was salvaged by the family.

### Boise County Seeks Justice for Embezzlement Case

**Boise County** -- Mr. William Young, representing Rana Klingner in this embezzlement case against Boise County, explained his client's demeanor, "She respects the decisions made by the court and the jury in this case, but in the end, she disagrees with the result. Let me make this clear, you won't hear her talk today about acceptance, as would typically be expected." Boise County's Deputy Prosecutor, Spencer Lay, spoke on behalf of the State, "This isn't a mistake. This isn't something

that she did, planned and then had a lapse of judgment and then decided to go through with. This is eighteen months of theft. Know that there is almost, if not but very minimal, no criminal action in the past. But there is 18-months of repeated, systematic theft." He continued, "We now are seeing NO remorse in this crime. And thus, we don't see the fact of rehabilitation is an option in this case." He spoke about public safety and the victims in this case, "Boise County and every citizen in it." He asked for a

**Garden Valley** -- An interest in the mountain biking sport has grown, especially with the Mountain Biking Club that formed last year at the Garden Valley School. Parents are also interested in what is viewed as a lifelong sport and joining their kids on the trails. The mountain biking club has monthly trail rides for the whole family. The opportunity to be in a cycling league has been exciting for the kids as well.

The Wolverine on Wheels club participates in the Idaho Interscholastic Cycling League as the WOW team. Last year they went to different venues around the Southwestern part of the state to compete in racing events. Despite not winning any races, kids are returning for the sheer excitement to try it again this summer. Families go to make a camping trip out of the weekend, which include places such as Galena Summit, Jug Mountain, Grand Targhee, Magic Mountain and Bogus Basin. The kids have their own races away from adult competitions. Safety and fun is the whole plan for beginner riders to the advanced.

It seems that our club/team is growing!" says Scott Kahre, Garden Valley Mountain Biking Club Director.

The Idaho Cycling League has a fleet of quality mountain bikes and helmets for students who wish to participate in the

July through October season of riding with the Wolverine on Wheels Team of Garden Valley. All that is required is to take care of the equipment, attend the regular team practices and try out 2 of the 5 races. Kahre says, "If time permits, we may be able to loop back on a different trail that ends with a challenging downhill section. Obviously, we will finish before dark!" As always, every rider is required to wear a helmet. Let Scott know if you don't have a helmet and Scott can get one from some donations that were received last year. The rides are open to families across the county who want to join in on the fun.

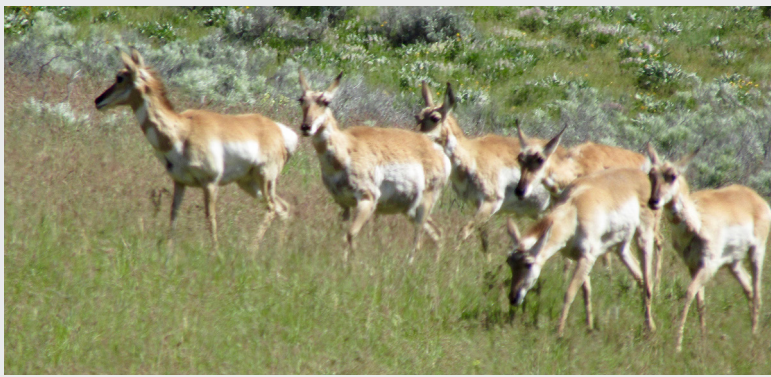

SUMMARY OF AMENDED ORDINANCE NO. 2016-01

BOISE COUNTY AMENDED UNIFIED LAND USE ORDINANCE

AN ORDINANCE AMENDING THE LAND AND DEVELOPMENT REGULATIONS FOR BOISE COUNTY, IDAHO WHICH CONSIDERS PROVIDING LAND AND DEVELOPMENT REGULATIONS FOR BOISE COUNTY, IDAHO, CONSIDERING ALL LANDS WITHIN THE JURISDICTION OF THE GOVERNING BOARD AS ONE MULTIPLE USE DISTRICT; SETTING THE AUTHORITY, PURPOSE, SCOPE, AND DEFINITION OF TERMS; SETTING STANDARDS AND REVIEW PROCEDURES FOR VARIOUS LAND USES, PROVIDING FOR VARIANCES; SETTING STANDARDS AND PROCEDURES FOR THE SUBDIVISION OF PROPERTY; SETTING STANDARDS AND PROCEDURES TO MITIGATE THE RISK TO LIFE AND STRUCTURES FROM SPREADING WILDLAND FIRE INTO DEVELOPED LAND AND STRUCTURE FIRES FROM SPREADING TO WILDLAND FUELS; SETTING STANDARDS AND PROCEDURES TO MINIMIZE PUBLIC AND PRIVATE LOSSES DUE TO FLOOD CONDITIONS; PROVIDING STANDARDS FOR THE CONSTRUCTION OF PRIVATE AND PUBLIC ROADS; SETTING STANDARDS AND PROCEDURES FOR STREET NAMING AND ADDRESSING; PROVIDING FOR DESIGNATION OF HAZARDOUS DEVELOPMENT SITES; SETTING GENERAL SIGN REGULATIONS; SETTING PROCEDURES FOR THE MITIGATION OF SUBDIVISION IMPACTS ON THE SCHOOL DISTRICT TO PROVIDE SERVICES; SETTING PROCEDURES FOR THE REQUIREMENT FOR THE ISSUANCE OF BUILDING PERMITS AND CERTIFICATES OF OCCUPANCY OR CERTIFICATES OF COMPLETION; PROVIDING FOR ADMINISTRATION, APPEALS, AMENDMENTS, SEVERABILITY, ENFORCEMENT, AND PENALTIES.

AMENDMENTS:

1. Add "Shooting (Game Bird) Preserve to Table 4.1.D.5
2. Add "Shooting (Game Bird) Preserve in the list of definitions.
3. Section 2.10 Appeal Procedures: Language changes in sections 2.10.A.1, 2.10.A.2, 2.1.B.1, 2.10.B.2.
4. Amend the Flood Section 4.5 as presented to the Board.
5. Remove the proposed Section 5.16 Minor Subdivision Plat Requirements and Procedure.
6. Amend language in Sections: 2.4.D.3, 2.5.G.7, 3.1.A.2.a, 2.4.C.1, 2.5.B.3, 2.5.B.4, 2.9.B, 2.9.C.4, 2.12.C, 3.7.A.4, 5.4.A.1, 5.4.B.9, 5.17 and 1.12.

Resolution #2017-30, a Boise County Resolution amending the Unified Land Ordinance, Ordinance #2016-01, was approved and signed by the Boise County Board of Commissioners on May 30<sup>th</sup>, 2017 with an effective date of June 1<sup>st</sup>, 2017. Idaho City saw smoke rising on Thursday morning, May 25th, from the forest. Luckily, this was all planned as a part of firefighter training week. This was an opportunity for several different agencies to come together, including the Department of Lands, U.S. Forest Service and Bureau of Land Management (BLM).

The object was to help train up a "rookie crop of firefighters to help us out during the summer," explained Jared Jablonski, BLM Fire Mitigation and Education Specialist. "It's extremely important because it's where the boots meet the ground. The firefighters get the experience on an actual fire line with an actual little bit of heat and a little bit of smoke to kind of get their bearings on, if it's something they really do want to continue further down the road."

Joseph Schindel, Fire Prevention Officer, said there were engine crews staged to help replicate an actual fire. Parameters were also in place, to keep the fires to a certain size, which were approximately a half acre to an acre, in size. Five separate crews hiked up to their preplanned area, with tools in hand, wearing all of their firefighter gear and packs. The Practice Burn Day was successful and the weather proved favorable with moist conditions to extinguish all threat of fire.

# Starting a Goose Family Along the Middle Fork

**Garden Valley** -- The first photo was taken on February 17th this year, and shows a pair of Geese inspecting "their" nesting box for possible use this year. It most likely is the nesting location that this same pair used last year but as you can see, this year the nest presented some new



challenges.

The second photo was taken on March 8th, and shows progress in terms of reduced snow but conditions clearly required continued patience



from this persistent pair of geese.

Finally on April 7th, eggs were laid in the nesting box as evidenced, not by someone disturbing the goose and pecking

in, but by observing an adult goose nestled down in the box and remaining there for extended periods of time. This step in starting a family this year was more than a half-month later than normal.

Then, on the morning of May 6th, we could see hatchlings milling around in the nesting box, and by mid-day 7 baby geese made the leap six feet down to the ground where they all bounced a time or two – normal for them – before joining their parents for their first day of

life's adventures.

**Note:** On May 6th when the goslings jumped out of the nest, the Middle Fork River was a bit above flood stage at our location, so the water was moving very fast. Having watched for most of an hour after the goslings left the nest, they still had not gone out onto the River. In previous years, all goslings have been out on the water in less than a half-hour after leaving the nest, but this year the sight and sound

of raging water seemed to instill caution on the adult geese and their offspring. With other things competing for our time, Pat and I never did see this brood of goslings enter the water, but after about 2 hours we noticed that they were gone ... somewhere.

In light of the dangerous river conditions, a nagging question loomed concerning the success or failure of this brood of goslings in their first major confrontation with Mother Nature. Sooo, it was a "yippee!" occasion on May 16th, 10 days after the hatch, when a glance from the kitchen window looking down near the river revealed both adult geese along with 7 healthy-looking goslings just off the edge of our lawn, (3rd photo) and not just healthy but three or four times larger than they were on hatch-day. Two days later on May 18th we were again visited by this same family of geese with all 7 goslings picking food from our lawn and then huddling together on the grass to soak up some sun and share the warmth. (4th photo) By the way, previous broods that we have observed during the past several years ranged in the number of goslings from as few as 4 to as many as 6, but this is the first time we've seen a "Lucky 7".

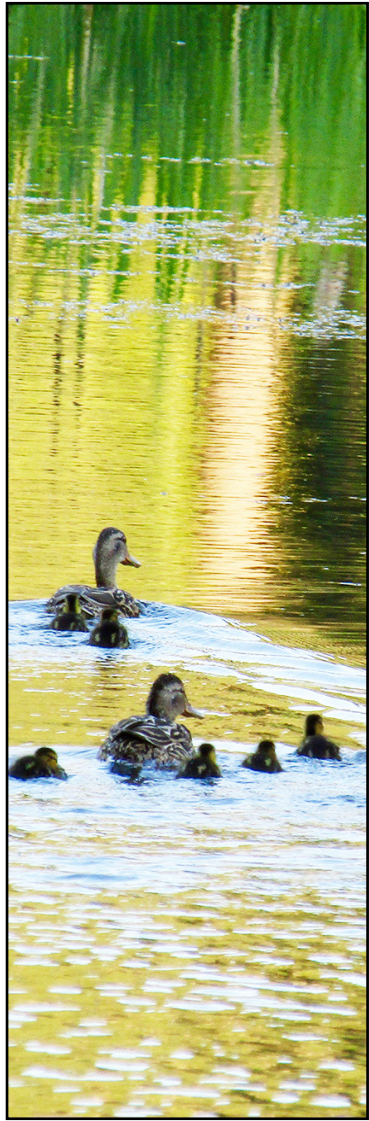

The amazing thing is there are a lot of people who actually believe building out 20 miles of collection piping

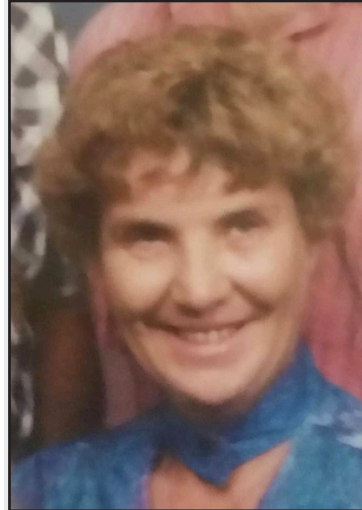
for 300 homes will somehow result in a fabulous success. We ALL have watched SFL failing to attract buyers over the last decade with far less sewer piping infrastructure and total cost of ownership. Why would the result be any different for Garden Valley business owners and residents? Garden Valley will develop the same cancer once 2 Forks is allowed to fly across the river. How can it be otherwise? It worked for Detroit. It worked for SFL. It will work for Garden Valley. That the Boise County Commissioners encouraged this economic and environmental insanity with a grant of tax payer money to 2 Forks is unconscionable. But then, none of them live within the 2 Forks targeted taxing zone. The Bottom-line: If a centralized sewer system with minimal collection piping for 300 homes hasn't worked to attract buyers for SFL lots and homes over the last decade, what are the chances the result would be any different over the next decade if 40 times more piping is distributed the length and breadth of Garden Valley for 300 existing homes?

NO. 2017-03**

AN ORDINANCE PROVIDING FOR THE USE OF FIREWORKS WITHIN THE CITY OF CROUCH, LIMITING THE AREAS WHERE FIREWORKS MAY BE DEPLOYED, TO PROMOTE THE HEALTH AND SAFETY OF THE PUBLIC AT LARGE.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF CROUCH, BOISE COUNTY, IDAHO:

**FIREWORKS:** It shall be unlawful for any person, except in compliance with this chapter to:

1. Alter any fireworks;
2. Throw any fireworks from, into or at a moving vehicle, or at any person, or into or at any structure;
3. Sell, store, possess, discharge, or use any fireworks at any time not permitted under Idaho Statute;
4. Use fireworks in any area that constitutes a threat to public health and safety, which is defined as follows:  
**Within 300 feet of:**
  - a. Middle Fork Road beginning at the East end of the Dirty Shame Parking Lot/Calvary Chapel property, Eastward on Middle Fork Road to the end of the Wander Inn property (486 S Middlefork Rd);
  - b. Old Crouch Road beginning at Crouch Bridge Northwest to the intersection of Old Crouch Road and Middle Fork Road;
  - c. The length of Market Street;
  - d. The entire GV Market/MACU property including front and back parking lots and James Castle Square, Tucker Museum, Community Hall, City Hall
  - e. Any other areas that pose a severe fire threat based on the vegetative or other conditions during the current fire season as determined by the Fire Chief, provided that

notice of such areas is given in advance.

A highlighted map of the above area is provided for reference.

5. It shall be unlawful for any person, firm or corporation to violate any of the provisions of this Chapter of the Crouch City Code, and any violation thereof shall constitute an infraction and shall be punishable by a fine of One hundred Dollars (\$100.00) excluding court costs and fees. An infraction is a civil public offense, not constituting a crime, which is punishable only by a penalty not exceeding one hundred dollars (\$100) and for which no period of incarceration may be imposed. There is no right to a trial by jury of a citation or complaint for an infraction and such trials shall be held before the court without a jury. A separate offense shall be deemed committed on each day during or which a violation occurs or continues.  
a. A second and any subsequent conviction of any violation of any of the provisions of this Chapter of the Crouch City Code within five years shall constitute a misdemeanor, punishable by a fine of not more than three hundred dollars (\$300.00) or by imprisonment for not more than thirty (30) days, or by both such fine and imprisonment.  
b. Fireworks being used in violation of this chapter shall be confiscated by law enforcement or by the Garden Valley Fire Protection District..

This ordinance shall be in full force and effect from and after its passage. The Map is available at Crouch City Hall on Tuesdays, Wednesdays, or Thursdays.

PASSED by the Council and APPROVED by the Mayor of the City of Crouch, Idaho this 10<sup>th</sup> day of May, 2017.

mandatory prison sentence, 2 years fixed plus 5 years indeterminate, for this breach of trust as a public servant with public funds.

Clerk Mary Prisco spoke to the court from a victim impact statement, "I simply could not believe that my trusted friend would have stolen repeatedly from our county, nor that she was capable of such a personal betrayal. For many months following her forced resignation, I continued to believe in her innocence."

Rana Klingner stated tearfully, "This case has been a painful, but enlightening introduction to the criminal justice system. Our system of justice is not perfect, which no system is." She continued speaking about her future, "I am strong and committed to doing whatever I can to make this right

and put this behind me."

Senior Judge Michael McLaughlin said on May 24<sup>th</sup>, "I spent quite a bit of time going through all of the documents that were admitted during the trial and I can say, after going through all of that evidence, the court is very well satisfied that the jury had a clear basis to find you guilty beyond a reasonable doubt. And I will say another thing that there were criticisms of the accounting system that were put into place by the elected clerk. But, I find that the accounting system, that I had an opportunity to look at the transmittals, the other documents, I don't know if the State could have moved forward without that accounting system put into place. And like with any accounting system, there has to be a level of trust by the employees. I think those are important things to

point out in a general nature."

Having worked 18 embezzlement cases over the course of his career, Judge McLaughlin continued, "We've had a lot of cynicism about our institutions today and whether we have more in Boise County or some other county, the fact of the matter is this was public funds. These were public funds and the citizens of the county expect those who have the privilege of working for the county to be honest and trustworthy with those funds, and that trust was breached."

"I grew up in a small town, so I know what can happen. I'm not shocked that folks pick sides in smaller communities. Yes, you had to move. Yes, you've had loss of jobs, and those are consequences of your actions, your decision." He stated that as a whole she's been "a good citizen, other than

this extreme deviation."

Judge McLaughlin expressed, "I understand where the State's coming from, for 18 months, something was going on. And when I looked at your financial records... The motivation to do this, because your spending was essentially out of control in many areas. Again, it doesn't justify it, but I don't see that continuing at this point in time."

"You're not a multiple offender or professional criminal, I recognize that there was an 18-month period of time that -- I'm not sure if I'm totally satisfied with the explanation as to why this went on-- But I don't believe that this is going to happen again. You're going to be placed on a 5-year probationary period. The court is going to enter a conviction for this offense. When you take public money of this amount and of this manner, I think granting of a withheld judgment would be in the court's judgment, a use of discursion. And, if in the end of 5-years, when you've successfully completed your probation, paid back restitution, you can come into court and ask that this be reduced to a misdemeanor. It's not like you've got to live with a felony on your record the rest of your life."

Upon employment, Klingner will have to submit to an employer in writing that she is "a convicted felon for theft and that it was embezzlement. That's a requirement." The judge added, "I don't think by locking you up in the peniten-

tiary at \$20,000 a year and not getting this restitution paid, that is the primary focus here, that is in the interest of justice."

"Part of this 5-year sentence, conviction entered 2 years fixed and 3 years indeterminate -- suspended, you'll do 30 days forthwith in the Ada County Jail. Another 90 days can be with work release." The judge explained the sentencing, "Some might say that's too light, but I want you to have that reinforcement that you put your family at risk when you did this."

As a term of condition of her probation, the judge ordered that she take a "personal financial management class. When I saw all of those overdrafts, all of those line of credit payments, I think some training in that area is just beneficial. My wife made me take one of those, now that we're retired. It's a good thing and you need to do it." Klingner will be made to pay court costs and a \$1,000 fine. The court has order \$36,376.37 in restitution at a rate of 5.375% interest. She will also be made to pay the cost of probation supervision, provide a DNA sample and right thumb print. Klingner has the right to appeal this verdict to a higher court within 42 days.

Senior Judge Michael McLaughlin concluded, "You're going to go to jail today and I hope over the next 30-days, and through your thoughts and prayers, that you gain the understanding of what you've done here."

**Boise County Board of Commissioners' "Victim Impact Statement"**

"Thank you for this opportunity to present a victim impact statement on behalf of the Boise County Board of Commissioners. The Board represents the 7,000 citizens and taxpayers of Boise County."

"The criminal activity of Ms. Klingner has had a dramatic impact on the County and those whom the County serves in a number of ways, which I will summarize in this statement. First, we believe Ms. Klingner's criminal activity resulted in the theft of nearly \$50,000 in County funds -- nearly all of which came to the citizens through the taxes, fees, fines, and court costs. Ms. Klingner stole money that the county's citizens placed in our hands-- money that was taken in for the benefit of all our citizens."

"Second, the way Ms. Klingner chose to conduct her criminal activity targeted funds that were designated by the weakest and poorest for the Indigent Services Fund, a service that offers interest free loans to our citizens that have medical emergencies and lack the insurance or personal funds to cover their expenses. This program is sustained by grants and those citizens paying back their loans, dollar by dollar. Through manipulation of the County's accounting and trust Ms. Klingner took concerted

efforts to hide or mask her embezzlement, Ms. Klingner literally was taking funds that were specifically designated to pay the medical costs of sick people who do not have insurance. Once law enforcement figured out how Ms. Klingner accomplished her theft, members of the Idaho State Police and our staff were able to identify nearly \$10,000.00 of the misappropriated funds that were taken from a number of payments designated by citizens for Indigent Services between 2013 and 2014."

"Third, Ms. Klingner's criminal activity resulted in residual financial loss to the County beyond the period of her employment. The work hours put in by our staff on discovering the theft, investigating the theft, preparing for the trial, and recovering the accounting flaws is a very real drain on the County's coffers. These hours do not consider the Prosecutor Office's time nor the Sheriff's, this is only asking you to consider Clerk, Indigent Services, Treasury, Solid Waste, and the Court to name a few. The restitution cannot begin to cover the time and money the County has lost as a result of Ms. Klingner's theft. I want to reaffirm that our request for restitution is a conservative request, only asking for the direct loss of

funds."

The Commissioners listed the impacts of Ms. Klingner's embezzlement on Boise County, stating: "With respect to the sentencing, the County is angry that the seriousness of her crime and the repercussions of her actions have never been shown by Ms. Klingner. Remorse for these crimes is not too much to ask. We understand the right to be proven guilty and the assumptions, however once the verdict came in we had hoped Ms. Klingner would show some remorse. We hope the Judge's prison sentence for Ms. Klingner will reflect her callousness."

Commissioners continued, "For these and many other reasons we respectfully would ask for a punishment that fits these crimes. Again, we thank you for the opportunity to present this Victim Impact Statement on behalf of the employees of Boise County, the Board of Commissioners, and Boise County's citizens."
