Tragic Motorcycle Accident Remembering the Life of Butch Anderson

EAST BOISE COUNTY --

The first time you met Butch it usually wasn't a good day. Meeting Butch probably meant you were out of water or your house was burning down.

I didn't know Butch well, but in listening to stories about Butch from fellow firefighters, I gained a new perspective. Bottom line, Butch was a complex man; water manager, road supervisor, firefighter, friend. In listening to the stories, several of Butch's traits were repeated in almost every story. He was a determined man, *determined to get the job done*. If he didn't have the right part, he would manufacture it until he could get the proper replacement. If someone was without water, he and his crew would work on the problem until it was fixed. When it took time, *he would deliver water to folks going without*. He was more than the sometimes scruffy fellow driving that gray pick-up. *Did you know Butch was the President of the Idaho Water Managers Association?* He knew the water regs forward and back and sometimes consulted with Idaho DEQ on problems. He could be stubborn when he thought he was right. He didn't back down from critics, but he rarely got angry about criticism. *But most of all, he was kind, always ready to lend a helping hand to folks in need, great or small. This kindness drove his love of the fire department and his commitment to giving to our community.* Let me relate a few of the stories I heard.

Butch was a gruff guy with a big heart! A few years ago, he

got wind of an elderly couple living in a home without insulation or interior drywall. Winter was approaching and Butch took it upon himself to raise money for materials to insulate and drywall the whole house. He then recruited several firefighters to complete the job. It took several weekends but Butch stuck to it and the job was completed before the first snow. If you worked for him it was the same, stick to it until the job was done!

This "*stick to it*" attitude and his kindness was evident in his impact on our community. Last winter we experienced a significant amount of snow with several heavy dumps. One story told about a firefighter having to get his daughter to the airport during one of these unusually heavy snow storms. He had a very long uphill drive and couldn't get out. Butch heard about it and saw to it that his drive was plowed out so he could get to the airport on time. Another firefighter told about the time last year when her driveway was getting out of hand with snow and she couldn't keep-up with her snow blower. One evening she heard a noise outside and it was Butch using a back hoe to lift the snow banks and give her room to blow the future snow. In both of these stories Butch did it on his own, without being asked and without expecting any thanks.

One thing could get Butch to pause a project, when the fire pager went off, Butch answered the call whenever possible. On one call, a vehicle had gone over the edge on Evergreen Drive and had started a brush fire. Butch was on scene ASAP, went down the side of

the mountain, stomped out the fire near the vehicle and started to hold c-spine on the driver. During the call, Butch protected his patient from falling debris as other firefighters scrambled up and down the mountain to fight the fire and prepared to rescue the driver. The fire got out of hand to the point a helicopter had to make water drops on the area. Once again Butch made sure his patient was protected from the falling water. He was awarded by the Governor for his actions on July 19th, 2006. *However, this was one honor he kept to himself.*

On another winter call, Butch had to drive the ambulance in a severe snow storm when no one else would. He got the patient to the hospital, but when returning to the Ranch, the snow was so deep that the ambulance got stuck by the mail center on Rush Creek Road. Butch and another firefighter walked to the fire station to get a backhoe and Butch towed the ambulance to the station. After doing that, he plowed-out around the

station just in case there was another call, then the ambulance and fire trucks could get out.

Butch could take a joke. On one training day with the fire department, his fellow firefighters decided to prank ole' Butch and told him they were going to flush out a tank of firefighting foam into Mores Creek to see if they could get a raise out of Butch. Well it seem their prank worked because Butch "*vigorously*" refused to let them do it. In the end he realized it was a prank and he was OK with them, but you can be sure they didn't try any more pranks like that again.

I think the most telling story about Butch was his last radio transmission to WR Fire Chief Jim Bryant on June 30th. The fire department had been put on stand-by and Butch relayed, "*250 from 277 -- If you need me, I'm standing-by!*"

VETERANS' MEMORIAL SITE FOR GV

GARDEN VALLEY -- A Veterans' Memorial at Weilmunster Park has been approved and plans will continue for fundraising efforts by the Garden Valley Parks and Recreation District. Chris Gill presented the idea on behalf of the Garden Valley Syringa Club, which is a longtime established philanthropic group.

The idea came about when discussing the possibility of having a flag pole installed at Weilmunster Park, during a Parks & Rec meeting. Chris recounted that the discussion went on with her family and the Syringa Club, saying, "*How cool if we could do a memorial, too!*" This would be a community project of the Syringa Club, as they approved the idea.

The Park & Rec board listened to Chris' presentation and were all in favor of seeing a display honoring veterans at the park. The board wanted to make sure they had a plan and design of where and what will be involved to make the memorial happen. The plan was approved with some minor tweaking on ideas, such as the base materials.

Basically, the design will be the

flag pole with a dedication plaque at its base with the five military insignias. Each one will be a 10 inch flat relief bronze emblems representing the Army, Navy, Coast Guard, Air Force and Marines. The bronze insignias will be mounted on concrete pedestals in a semi-circle around the flag pole. A minimum of a 4 x 6 all-weather USA flag will be flown on a 30 foot pole with a 3 x 5 POW flag underneath the American flag which signifies that area as a Veterans' Memorial. An idea of a solar spot light would enable the flag to have the flag light on at night.

There has also been discussion of the surface needed for the pedestals. Black rock was considered but maintenance is more difficult and rocks could end up in the grass making mowing more difficult. Instead, it was suggested to have pavers and include them in as a fundraiser with possible engraving of names on the paver. This is still under discussion.

Project costs will require fundraising. Now in place at Mountain America Credit Union in Garden Valley is a special account via the Syringa Club that is labeled the Veterans' Memorial Fund. The

public can make donations at any time to help with the project. Any funds remaining after the project is complete will remain in that account for future maintenance.

The Syringa Club is looking for donation of time/labor during construction, as well as any materials such as concrete or pavers and edging. Chris said at the meeting, "We already have a possible donation of the flag pole as well as one or two of the emblems. The military emblem cost is \$270 each. Anyone wishing to donate the cost of an emblem in memory of an individual's service is welcome, or donate with military branch friends. The dedication plaque will give sponsorship of the project by Syringa Club and the Parks and Recreation District."

The Syringa Club is trying to raise awareness for the project as well as recognize how many veterans live in this area. Please direct calls to Chris Gill at 462-4629 for information regarding the memorial. The goal is to have the memorial in place and dedicate it to the community and veterans on Veterans' Day this fall.

GARDEN VALLEY -- Garden Valley folks can meet at 9:30am at the Community Church parking area to join the FREE Garden Tour on Saturday, July 15th. Right now, there are four gardens to tour. Usually the tours are finished by noon. **Helpful advice:** As always bring a hat, sunscreen, sunglasses and water. Have a pencil and paper on hand to jot down notes, since the gardeners will give helpful hints for successful gardens at each of the garden sites.

"It is wonderful way to get to know others interested in gardening and share gardening ideas," according to Anita Sherwood, local gardener aficionado in the Garden Valley area. She explains that each garden is very unique. So, as people visit, they can learn how to plan gardens with similar ideas. The gardens are not publicized, so that only invited people can come to view this tremendous work. These gardens will include vegetable and also flower gardening.

Anita explains that raising any type of garden in the mountains has its own unique challenges, besides a short growing season. The soil often needs work to condition it by adding a variety of products that will enrich the soil or balance the alkalinity. Often, another disadvantage is that the wildlife enjoys munch-

ing on particular flowers and vegetables. These so-called "problems" will be addressed. Anita reassures anyone that "a garden can be grown in the mountains." She says, "You just can't plan to stick a plant or seed in the ground and expect it to grow. There is work that needs to be done to fit the various soils in the area."

Children are welcome to come also, as long as they are with their parents. This is an enjoyable time for learning and sometimes there are treats offered from the gardeners as well. Just

remember to bring items for a potentially warm and sunny morning. Meet at the Community Church, which is located on the Middlefork Road about three miles north of Crouch.

BOISE COUNTY**Electrofishing on Mill Pond at Night
In Horseshoe Bend**

HORSESHOE BEND --

In the information age, word travels fast. A couple of weeks ago, IDFG staff operated a large aluminum electrofishing boat equipped with floodlights, booms, spider droppers, and a 5000-watt generator on Mill Pond at night. An odd sight to say the least!! This effort generated a lot of question about our activities and management direction, so we thought take the opportunity to answer some of them.

The IDFG purchased Mill Pond from Boise Cascade in 1964 using federal Dingell Johnson (DJ) excise tax funds generated from the sale of fishing tackle. Since then, fishing license and DJ funds have been used to develop the pond into a quality fishing area. Water for the pond is supplied through

a surface diversion from the Payette River (during higher river levels), from percolation of ground water, and from a ground water pump. Depending on the season, this allows for the most efficient (and cheap) water delivery. IDFG has also developed a boat ramp, restroom, fishing dock, and outlet control structure. Other amenities and trash services are provided by Boise County via a mutual agreement.

The fishing opportunities in Mill Pond are provided by naturally self-sustaining populations of largemouth bass and bluegill, by trapped and hauled adult-sized channel catfish, and by hatchery produced, catchable-sized rainbow trout (~10"). During the last three years, about 50-60 catfish and 5,000 to 6,000 rainbow trout have been released annually to enhance fishing.

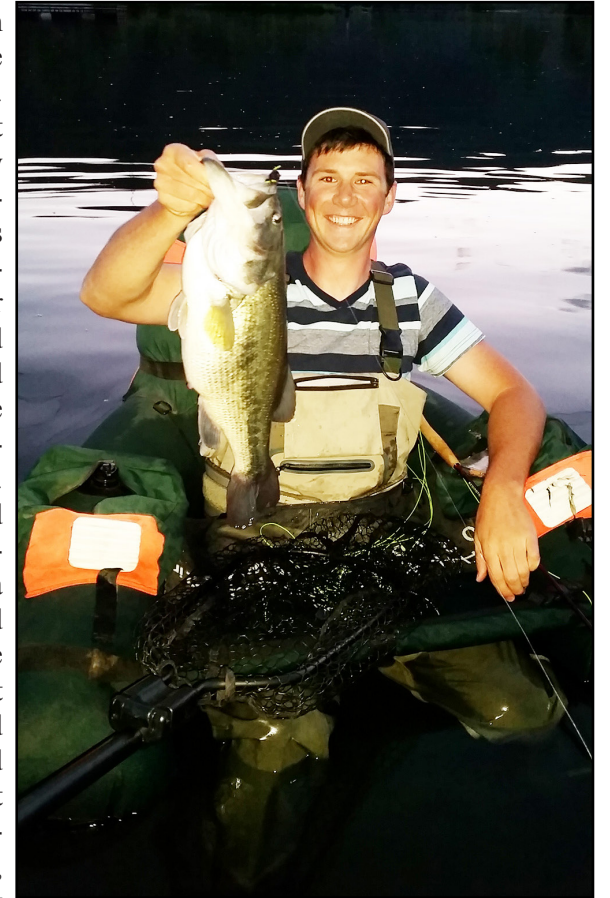
The largemouth bass and bluegill populations are monitored periodically with nighttime electrofishing. This method allows us to capture, measure, mark, and collect fin rays to assess mortality, growth, and harvest rates, as well as to estimate numbers and determine the overall "health" of the fishery. Electrofishing surveys are usually conducted at night because fish tend to move into shallow water where they can be sampled more effectively. The most recent monitoring of the Mill Pond's populations occurred during 2014. At that time, Mill Pond contained about 750 largemouth bass and almost 19,000 bluegill, high numbers for a water of this size. Annual harvest rate of bass was 17% which is considered low to moderate and likely contributed to the presence of quality- to trophy-sized bass. In short, no regulations changes were deemed necessary at the time. Trend monitoring will occur in future years to ensure populations remain healthy.

Recently, IDFG staff attempted to use Mill Pond as a source for bass and bluegill to jump start other formerly drought-stricken waters that had recently refilled due to last winter's abundant precipitation. Unfortunately, cold water temperatures prevented us collecting fish here during 2017; however, a total of about 70 bass and 450 bluegill have been

moved from here within the last five years. Operating at night usually allows several benefits including efficiency (higher catch rates and less time), and less chance of disturbing anglers. Trapping and hauling warm-water fish is a common and sustainable practice that has been used widely around the Southwest Region for decades. In fact, this is how bass and bluegill populations were established in Mill Pond. Warmwater fish are highly productive with individual female bass and bluegill containing several thousands to tens of thousands of eggs depending on size. Staff take precautions to avoid translocating too many individuals from any one water body in any one year, and trophy-sized fish are not moved. Details of all translocation efforts are recorded and documented in IDFG annual reports which are publically accessible (see Technical Reports on the IDFG website).

IDFG staff have also been managing aquatic weeds at Mill Pond for many years. Eurasian milfoil and curly-leaf pond weed can reach nuisance levels that annoy anglers and reduce fisheries quality. When this occurs, IDFG takes action, including use of approved herbicides and stocking of grass carp. Grass carp aren't your run of the mill common carp that muddy local waters; instead, they are a sterile variety incapable of reproducing that only eat plant material. Grass carp are our friends, a useful tool

I think he had a good head on his shoulders and I was impressed that he had connections with the EPA and Water Resources, all those federal people, I think that was a big part of the process of getting some grant money we got for the water system. Like I said, I enjoyed working with him. He knew how to work around the legal things to make things happen."

Butch helped bring up the water system up to meet the National Fire Protection standards.

Jim Bryant, Wilderness Ranch Fire Chief: In disbelief, the news of his passing seemed like a cruel joke. "He was always there if you needed him." He continued, "Butch had so many irons in the fire; it's going to be hard to fill those shoes." He was in charge of a lot of water systems, and had 3 sets of keys he'd carry around with him. Jim had looked forward to rebuilding hotrods with Butch, since he was getting close to retirement too. "He always found time, even though he'd worked a 30-hour day, sometimes." In regards to the water systems, "Without Butch, a lot of people are going to be wondering what's going on. He had it all up in his head."

Jim believed that the motorcycle provided "some stress release" and Butch enjoyed riding it when he could.

HORSESHOE BEND WWII OFFICER SMIDT

Written by Historian, Don Fry

Dozens of men and at least one woman from Horseshoe Bend and Jerusalem served in the Second World War. At least four men were killed and several others were wounded. Still others were in serious combat and lived through difficult or dangerous experiences, including men who were on Wake Island working for Morrison-Knudsen when the Japanese invaded. These men spent the entire war in POW and labor camps in Japan and China. This is the story of one of those men, from Horseshoe Bend, who was killed.

Robert Henry Smidt was the son of Silas and Ida Smidt, who had a homestead on Jackass Creek. He was the 5th of 6 children, 4 girls and 2 boys. His mother was a schoolteacher. After he graduated from grade school in Horseshoe Bend, he went to Boise for high school.

Smidt always wanted to be a pilot. On June 6th 1940, more than a year and a half before the United States entered the war, he enlisted as a private in the air corps at Vancouver Barracks, Washington for a three-year enlistment. His enlistment record said he was 5' 8" tall and weighed 132 lbs. He had one year of college and was unmarried.

By 1942 he had risen to the rank of Flight Officer (Warrant Officer) and was in flight training. During 1942-43 he was in the 326th fighter Squadron Unit training in single-engine fighters at Hamilton Field, in California. During this training, he was involved in an accident reported in the *Capital Journal*, Salem Oregon Thursday, March 18, 1943:

Spokane Flier Killed in Crash.

Hamilton Field, CA, March

18__Second Lieut. Jack S Scriven, 24, Spokane Wash. Was killed last night in a collision of two fighter planes over Oakland, the Hamilton Field public relations office announced today. Flight Officer Robert H. Smidt, 21, son of Mrs. Ida P. Smidt of Horseshoe Bend, Idaho, brought his plane down safely following the collision.

Later in 1943, he was transferred to the 96th fighter Squadron, 82nd Fighter Group, US Army Air Force, part of the North African Desert Air Force. (The squadron jacket patch shows a desert hare (rabbit) wearing boxing gloves.)

His squadron flew the P-38 Lightning. The P-38 was a dual engine fighter. It had a very distinctive look, with dual fuselages and booms and with the pilot located between the two fuselages. It was a versatile airplane, very successful in the Pacific Theater where it was mostly used for bomber escort and strafing. But it could not match German fighters in a dogfight. Despite glowing reports by the Army Air Force, losses of P-38s in the European Theater were very great. On 25 August 1943, 13 P-38s were shot down in a single sortie by *Jagdgeschwader 53 Bf 109s* without achieving a single kill. On 2 September 10 P-38s were shot down, in return for a single kill. Kurt Bühligen, third highest scoring German pilot on the Western front with 112 victories, recalled later: "The P-38 fighter (was) easy to burn. Once in Africa we were six and met eight P-38s and shot down seven. One sees a great distance in Africa and our observers and flak people called in sightings and we could get altitude first and they were low and slow." General der Jagdflieger Adolf Galland was unimpressed with the P-38, declaring, "it had similar shortcomings in combat to our Bf 110, our fighters were clearly superior to it." The tactical shortcomings of the P-38 were not acknowledged by the Army Air Force at the time and to a large measure, not since.

The 82nd Fighter Group (USAAF) had arrived in Northern Ireland in October 1942, about the same time the Allies launched their invasion of North Africa and long before Robert Henry Smidt reported. By December 1942, Axis forces had repelled the Allied advance, and the long winter campaign had begun. Late in December 1942 the 82nd Fighter Group moved to North Africa. Between Christmas and New Year's Day, the 82nd operated from Tafaraoui Airfield, Algeria, to protect convoys from submarines. On January 1, 1943, they were moved to Telergma Airport, Algeria, where they were mostly used for dive bombing and strafing attacks on ground targets and on Axis aircraft being used to fly supplies to North Africa. The official Army Air Force histories, which, as noted above reported only the successes, bragged about the 82nd: "The 82d distinguished itself in dogfights with enemy fighters while escorting bombers over Gabes, Sfax, Tunis, Bizerte, Kairouan, Sardinia, and other points. On 20 March 1943, while escorting B-25s in a sea search off Cape Bon, a group of P-38s engaged the enemy in an air battle. Even though they were outnumbered by 50 enemy fighters, the 82d emerged with 11 confirmed kills, 2 probables, and 2 damaged, while not losing a single bomber."

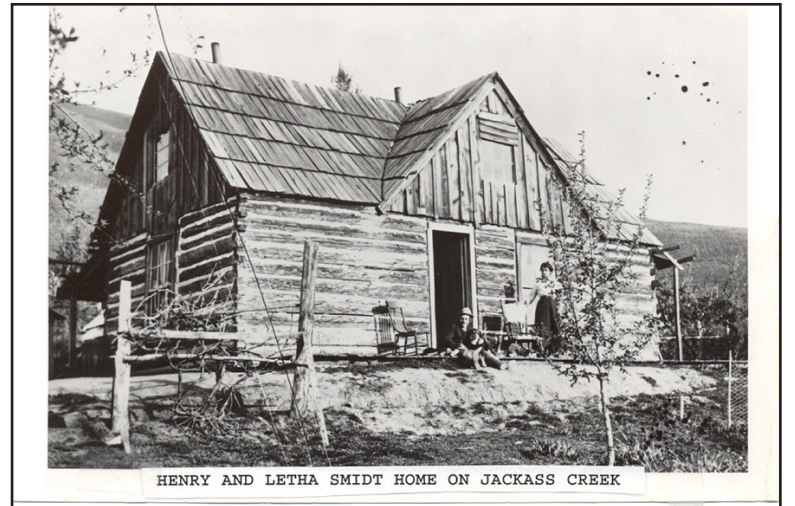
In April 1943, the 82nd moved to Tunis. The Army Air Force history tells, "On 11 April (the 82nd) destroyed 32 Junkers Ju 52s during a fighter sweep against enemy transport planes that were coming from Italy to supply the crumbling Afrika Corps. The group scored hits on 14 April during a bombing mission on a large transport off Cape Zebid and on 8 May executed a bombing attack on the airdrome at Pantelleria."

The Tunisian campaign ended in May 1943. Between December 1942 and May 1943, the 82d Fighter Group had flown 152 combat missions and 2,439 combat sorties. While escorting B-25, B-26, and B-17 bombers on 1,880 sorties, the group encountered 751 enemy aircraft, destroyed 199 of them, and lost 64 P-38s.

In May-June 1943, the 82nd took part in the air bombardment of Pantelleria. From July to August 1943, they engaged in the liberation of Sicily while supporting bomber raids against Naples on 17 July and participating in the first raid on Rome on 19 July. They flew 191 combat missions, including 3,335 combat sorties; escorted 2,987 B-25s and 382 B-26s; and engaged in 57 skip and dive bombing attacks. The 82d destroyed 78 enemy planes and damaged 56, while losing

11 P-38s. We do not know exactly when Robert Henry Smidt joined the 96th Fighter Squadron or which of these battles he was in. What we do know is that on August 19, 1943 Robert Henry Smidt's plane went down over the Mediterranean and his body was never recovered. He was awarded the Air medal with Oak Leaf Cluster and the Purple Heart. His name is memorialized in North African American Cemetery in Carthage, Tunisia among the names of the men buried or missing at sea.

As explained by Lt Kennedy, leader of his P-38 flight on that day, here is what happened: "On August 19, 1943, I led a flight of P-38s in a 96th Squadron Formation on a Bomber Escort Mission to lower Italy. As I did not have a regular flight with the same pilots each time, I don't remember who was in my flight, but I don't recall having to back off on any maneuvers because one or more couldn't keep up. After the target and crossing the coast of Italy, I saw a B-25 land in the water and the crew get into a rubber life raft. I drank enough water out of my canteen so it would float and dropped it to them. I started circling to keep them in sight while expecting the air rescue plane to show up. Clayton Tillingham saw us and flew high cover. After some time, Clay and I decided the rescue plane was not coming and each sent our second element to Palermo to gas up and try to get him to come. Clay and I stayed until we had to leave to get gas and we went to Palermo. We were able to convince the rescue pilot we could cover him and went back to where we had left the life raft, but we were not able to find it. We learned

11 P-38s.

much later the crew had been picked up by an Italian Hospital ship very soon after we left them. We went back to Palermo and spent the night before returning to Grombalia. I am assuming Smidt was in my second element and after leaving to get help, I never saw him again nor ever heard why he ended up missing. In retrospect, it never entered my young mind to ask if everyone knew their way home."

The Missing Air Crew Report filled out by LT Kennedy said Smidt's plane was last seen 30 miles south of Capri Island, Italy. The B-25 Crew of six they were trying to save all became POWs. Their airplane, decorated with a pinup girl in a bathing suit was nicknamed, "Worth Fighting For" had sunk. They had spent the night in the dinghy and turned on their emergency radio that transmitted an SOS in the morning. The Germans were on them within 30 minutes of turning on the radio. The six crew members spent 21 months in German POW camps and were released at the end of the war. For many years his family held out hope that Robert had also survived and been taken prisoner, but no further word was ever heard. The American Legion Post in Horseshoe Bend is named for him, since he was the first from the area to lose his life in the war.

New Informational Signage ~ Helpful as Tourists Visit

GARDEN VALLEY -- There are now the blue informational signs that give tourists a heads up to know where certain places are and which local radio station to tune into. After months of Planning and Zoning decisions for consideration and detailed approval from the Boise County Road and Bridge Department, the signs are in place. Letting tourists know this information along the roadways is helpful.

Signs were made for KXGV-LP, 98.6FM Radio in Garden Valley to let people know where to tune in on the radio dial. The sign locations for the

radio are placed on the Middlefork Road north of Crouch and another one as drivers enter Crouch on the south end of the Middlefork Rd.

The other sign is giving direction to turn towards Crouch to find the Garden Valley Center for the Arts, The GV/Crouch Historical Museum and the Garden Valley Visitor Information Center. One sign is on Banks Lowman Road before the turn-off to Crouch. The other is also on Banks Lowman Rd. close to the Davey's Bridge for those traveling from Lowman, heading west.

Informational signs help road users know what might

be in towns along the traveled areas. The idea is to bring tourists in by turning into Crouch. Once they drive through tourists can then see other shops and restaurants available. This makes for good economic development for the area.

Rich Smith, Board Member of the Community Radio station, said, "While I agree that we don't want to see a forest of signs that without county approval," he admitted that is quite the process to get a sign on the road. Approval must be made by the County Commissioners and the County Road department after application approval through Planning and Zoning sign ordinance rules. The blue highway signs must meet specific standards for size

and lettering. This keeps uniformity in signage along the highways and county roads.

The costs of the blue signs is not cheap either, but they are important in providing good information. Many travelers pass through the Garden Valley area, unaware that there is a lot to offer just by taking the Crouch turnoff. With cell service not readily available along Banks Lowman Rd to look at maps on phones, the signs should help people find their destination or services easily.

BOISE COUNTY COMMISSIONERS' MEETING

Transcribed by Eileen Capson

June 27, 2017

Present: Commissioners Alan Ward, Roger Jackson and Laura Baker

CONSTITUENT INPUT: None

MINUTES: The minutes from June 20th were accepted by motion.

EMERGENCY MANAGER:

A better deal on porta-potties was discussed for the eclipse event. Purchasing them was also discussed. Emergency Manager Bob Showalter said, "Even if the county wanted to put that money into buying their own, or not have to rent them. Then whatever events that go down in whatever town or whatever emergency wherever, the county would have its own porta-potties." Chairman Jackson was not in favor of owning porta-potties. Commissioner Baker suggested speaking to the Road Department, because they were \$3,000 over budget for porta-potties. Showalter said that Garden Valley is pretty well prepared, but "I haven't heard plans coming out of Horseshoe Bend or at the intersection of the Banks/Lowman, [Hwy.] 55, and then Banks/Lowman and [Hwy] 21 is going to be crazy as well." Flagger will be available by Idaho Transportation Department. He suggested the commissioners sign the Declaration of Emergency now, in case they should need it later. He added that several other counties had already done this. Showalter presented a contract with a company. Chairman Ward stated, "So, we're talking \$2,800 to \$2,900?" Show-

alter confirmed and continued, "Those are not insured. So, if somebody decides to throw them into the river, like they did up in Lowman -- *I don't know how that porta potty got into the water and all* -- but we would be liable for damages."

Commissioner Jackson asked a road department person about the charge for porta potties. He said that they owned one and have put it on a trailer, "so when we're doing some ditch cleaning up, on [Highways] 21, 55 and 17 there, we pull it with us." Jackson inquired about the charge for \$3,791, over budget.

SHERIFF: "Radon be gone," Chairman Ward said melodiously. Sheriff Jim Kaczmarek and Prosecutor Dan Blocksom said the project was a total of about \$9,000. Chairman Ward motioned to approve the contract from Radon Be Gone in the amount of \$8,545, which was within the Sheriff's budget and for the office.

SCHOOL RESOURCE OFFICER: This is the last year for the Millennial Grant for the School Resource Officer(s). Each school has contributed to the officer's salary. Chairman Ward motioned to accept the grant award through Juvenile Justice in the amount of \$19,550 for the Idaho City project, \$20,087 to the Horseshoe Bend project, and the amount of \$20,144 for the Garden Valley project.

2 FORKS RECREATION & SEWER DISTRICT: Commissioner Jackson made motion to pay the 2 Forks Recreation & Sewer District "bill, \$2,267.50 out of the Idaho Gem Grant fund."

BOISE COUNTY OUTDOOR BURNING ORDINANCE: This will revise the Unified Land Ordinance. Planning & Zoning Administrator, Rora Canody, said, "What we have in the ULO, I thought was appropriate. With the Board adopting the amendment, it did make the ULO a misdemeanor." This will make it more enforceable for law enforcement.

ROAD DEPT: Bill Jones said that it was about 50-thousand hours to clean up the Banks/Lowman Road this year, and that it was "extensive." He said there was still damage from the spring.

PLANNING AND ZONING: Ms. Canody said they were busy, up to 130 building permits so far this fiscal year, 100 in the last month. "Things are hopping," said Canody.

ASSESSOR: Chris Juszczak said they had an "extremely busy month." They had minimal appeals, but that they can't make everybody happy. "Every area went up a little bit different." Appeals will be coming up.

SHERIFF: Jim Kaczmarek said that the call volumes are picking up. One dispatcher is graduating from the academy. More activity on Arrowrock Road.

CLERK: Mary Prisco went over revenues and how they are allocated. She spoke about PILT funds and said, "We don't know whether we're going to receive that." Clerk Prisco gave a rundown, "We're looking at a total of \$4,322,039 in fiscal year '18 thru property tax."

LIABILITY: An insurance agent for the county spoke regarding supervisor hiring, conducting background checks, and contacting references. He said, "When we look at our serious claims, one of the things that frequently happens, and it certainly could happen here, because many of you know a significant number of citizens in your community. And sometimes we hire people because we know them and we think, *well that's a good guy*. My suggestion is of those you know really well, go through the same processes. Sometimes there are things you don't know about them *that really are important*." He also spoke about "failure to train," miscommunications and misconduct. The representative said it was "unlawful" to require an individual to live in Boise County as a condition for employment.



Sheriff Kaczmarek met with the Commissioners on Monday, June 26th, regarding his upcoming budget. He asked for a raise, for the dispatchers, due to the fact, "We're the dead lowest in the State." Commissioner Jackson commented, "That's a pretty hefty increase." The sheriff will also be looking to replace 5 vehicles, on their 4-year replacement plan and give the deputies a 3% cost of living increase.
