Landscape Changes with Open Pit Mining

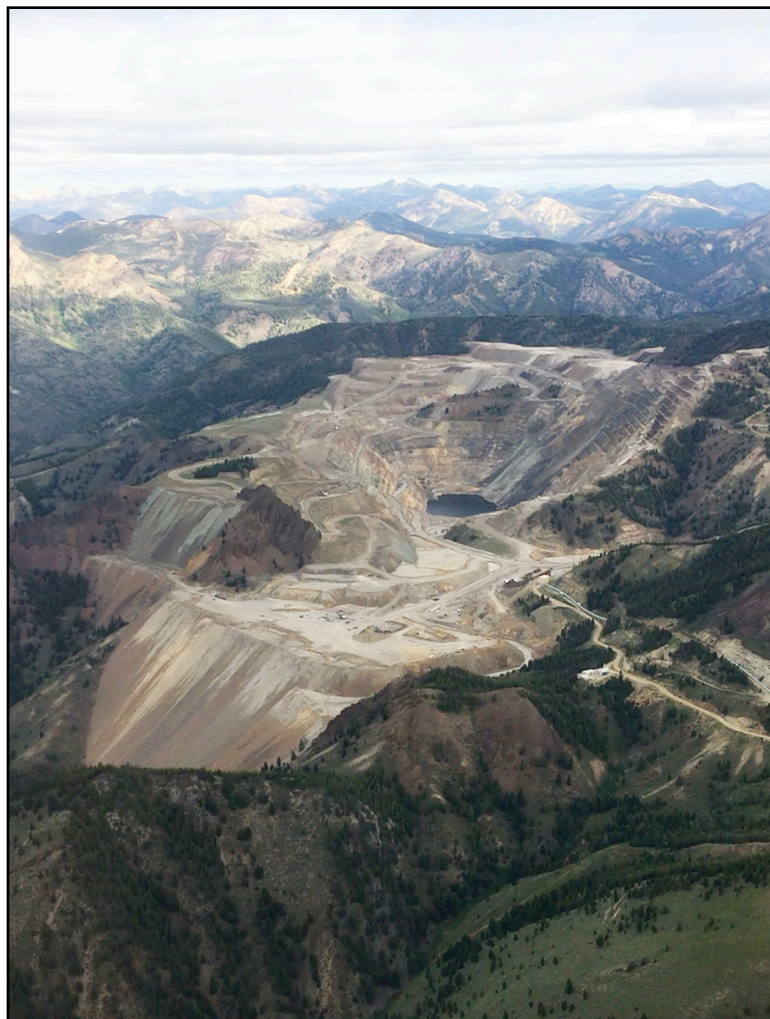
BOISE COUNTY -- The Idaho Conservation League is concerned that the CuMo Mining Project could raise unintended issues, as has happened with the Thompson Creek Mining Company in Custard County. In mining for molybdenum, the ore can be found over 1,000 feet in depth, and much of the "waste rock" must go somewhere, so it fills up the valleys. Problems emerged with the Thompson Creek Mine when they came across acidic waste, and an additional \$4.4 billion was spent to contain this unexpected problem, to keep it from seeping into the environment. There is also concern that the mountain "will

be gone," should this open pit mine be approved. John Robison, with the Idaho Conservation League, stated that the CuMo Mine would be one of the largest open pit mines, approximately five times the size of the Thompson Creek Mine. The worth of molybdenum also fluctuates, creating a "boom and bust," for the local economy.

Boise County Commissioner Laura Baker attended the fly-over of the mine and future area proposed by the CuMo company. Baker later said, "My primary reason for going was to make sure I listened to all sides of the story. I want to be able to hear what CuMo representatives have to say in

favor of the mining and hear the concerns of those opposed to the mining. I have been researching and educating myself on the mining process. I plan to continue to talk with the people who belong to the Idaho conservation group as well as the CuMo Mine's representatives. There is a lot to know and I plan to keep an open mind and ask a lot of questions, so that I can share what I learn with the people of Boise County."

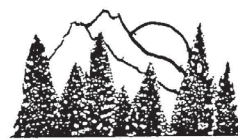

Changes Following the Garden Valley Hospital Taxing District Meeting

GARDEN VALLEY -- The Garden Valley Hospital Taxing District meeting was held on June 26, 2018 at the Outreach Center. Members discussed the issues revolving around the usage of the building and the budget hearing that will be held at the next meeting in July on the fourth Tuesday of the month.

The Outreach Center, formerly a medical clinic, has been emptied with the recent changes made last month to deny a contract renewal for a youth program. With a currently empty building, the District Board is looking at opportunities deemed **medical services to fill the empty space**. The former clinic building has two businesses approaching the Board for use of the space.

Currently, Dr. Stan Carter wants to create a space that will house a full-time dentist office with at least 4 chairs and utilize the entire space of the old clinic. The other building that has been used for a part time dentist would be too small to carry on with his plans of expansion. He would have to make significant changes to the space but would do all changes at his own expense.

Reed Patterson, owner of Achieve Physical Therapy, would like to use most of the space and then other rooms could be used for other services the Board has an interest in. Changes to the building would not be an extensive remodel, but would still give larger space to **expand physical therapy services** and other programs, such as balance programs and medical rehab. Patterson would like to work out a cost sharing remodel plan with the District Board.

The Board wants to keep their **costs related only to walls and floors** with the rest of the expenses to be with the approved renters. The next meeting will look at those costs and get bids from local companies to do any remodeling. The Board will also look closely at which services will tie in with the statute the District must follow to provide "medical services" at recommendation of Board Attorney Ian Gee.

Greg Simone turned in his **letter of resignation** to end his seat as Chairman of the Board and his term of office as he will be traveling most of the winter and will not be able to be at many meetings. His seat is up in 2021, so the person appointed will fill that term out. Interested people who would like

to serve on the GVHTD Board can send their resume/bio to gregsimione@gmail.com for review. Interested people can then come to the next meeting for an open interview process in which Gee said, according to statute, it **should be a public process**.

Attorney Ian Gee addressed some of the legal issues brought up by the public and the group called the "Friends of the Hospital District". One issue was related to the use of **public funds** in connection with a private organization. That matter was a case out of Elmore County which was related to a Recreation District, which Gee said follows a different statute.

Gee reviewed case law facts and recommended to the Board to look back at May 2017 minutes to **resolve some ambiguities in the language**. Gee said, "The May 2017 Minutes declared that the Board took

action to approve the expenditures of \$20,000 to support the start-up of the Medicap Pharmacy. It was approved to fund the telepharmacy equipment." Gee felt the presumption is that the District should be the owners of the equipment and it be specified. Gee explained, "It is my advice and recommendation the Board clarify, for the record, and recommend you need a motion related to your 2017 Minutes. That motion should be that the characterization of the May 2017 Minutes statement supports the startup of Medicap Pharmacy to be understood as **purchasing the telepharmacy equipment** for the provision of pharmacy services in the District. It would be my recommendation that you consider that right now as a motion." Motion of that recommendation was made and approved.

The second recommenda-

tion Gee made was "to review that relationship, in light of the last motion, that he be directed to **draft a contract services agreement with Medicap** and to be consistent with the District's *ownership* of the telepharmacy computer equipment so that the equipment be retained by the District, if and when the pharmacy ceases providing pharmacy services under the contract." Motion was made on that recommendation and passed.

Gee also recommended that in the future business of the

board, that they review all current or past contracts to have consistent policy matter related to how the District has had expenditures in the past, related to equipment that possibly private businesses may still have or if those were to be acquired by private businesses on contract. Gee voiced the concern of the future contracts and **suggested the Board have a goal to be consistent with Idaho Law**. He thought the public inquiries were "worthwhile and good input by the public."

THE HISTORY OF ARROWROCK DAM

The project actually began at the diversion dam about seven miles above Boise. A power dam was built that had turbines for electrical power generation to use at the Arrowrock site. A large canal was built from the diversion dam downstream to Lake Lowell south of Nampa.

The rail line extended from Nampa to downtown Boise on the Oregon Short Line so it had to be extended to the Barber sawmill. The railroad from the Barber sawmill to the dam site was known as the Boise and Arrowrock Railroad. An issue on the railroad spur was that the barber mill owned the road right-of-way east toward Diversion Dam. A joint "ownership" was created between the Barber Lumber Company and the Bureau of Reclamation.

Arrowrock Dam was first listed as a project in 1911. It was a news item in both the Idaho World and Idaho Statesman newspapers up to 1915, when the dam was completed. At the time, it was the highest dam in the US at 350 feet high. It was increased in 1925 by five more feet. It has been modified twice since then, but not the height. We have been over the entire site, observing all that is left. It was constructed on the Boise River between Boise County and Elmore County,

six miles from the confluence of the Boise River and Mores Creek. The old camp site is now obliterated by reservoir water from Lucky Peak from April to October so the site cannot be explored during that time period.

A rail line was first extended from the Barber sawmill site east of Boise to the dam site and a huge camp was built along the river on both sides below the dam. The rail line first crossed the river on a big curve just south of the dam site. Below the rail line and the river, a large number of shops were built. I count a dozen buildings in the photos.

Mail was delivered by train. Two ladies were in charge of the mail – Lettie J. McFadden and Alexandra J. Clifton. Back in those days, if a person applied for a postal permit at a location that did not have a name already, the post office was named per the postal permit request. Places like Lowman were named after Nathaniel Lowman who filed for a postal permit. But the situation here is that the site already had a federal name – Arrowrock Dam, and two ladies were in charge of it, not one person. The mail was brought to the dam via the railroad from Boise. Thus the post office was likely known

as the Arrowrock Post Office – maybe. The data available suggests that the post office was at the Barber sawmill, likely because the sawmill had a Post Office already. I cannot confirm that as fact, however. Since the site varied in size from beginning to end, no census apparently was kept and no specific name for a town was ever mentioned. It was called a camp by the Federal Government. A series of "cottages" were built above the temporary rail line to the cement plant. The bottom line is that the site was Arrowrock Dam and nothing else per the Bureau of Reclamation. Kelsey Doncaster at BLM in Yakima has the photos of what he called, "Arrowrock City". His photos were posted online in 2015. There are too many

quickly rebuilt but no dates for completion are given.

The project staffed some 1400 employees and 200 fami-

ing winter months. A river bypass was built on the Elmore County side of the dam. A small temporary rail line was built up river slightly from the dam to the rock quarry site high up on the hillside above the dam. A huge cut was made on the Boise County side for a concrete overflow system and a county road. Both are still visible and in use today but are a tad spooky when driving through the big cut. No one wants to be greeted by a huge boulder.

For construction, some modern equipment was used. Bulldozers and a huge power shovel are visible in photos. No trucks were to be seen in photos but there were eight Ford trucks and one Buick car on the site. Four more Ford trucks were used elsewhere. Scores of horse drawn work teams were also used on site, according to records.

Unskilled workers earned \$2.40 per day and skilled workers were paid \$3.00-\$4.00 per day. Deductions were made at 75 cents per meal and \$1.00 per day for meals, and dormitory houses were \$1.75 per month. A private room was \$4.00 per month. A hospital stay was \$1.00 per month.

The dam was dedicated October 4, 1915. Some additional work continued after that date. Some 585,160 cubic yards of concrete was used in the dam construction. The dam project cost \$4,796,488.82 according to the Bureau of Reclamation. It was some \$2,000,000 under budget.

The general store and post office were demolished in 1915 and the remaining buildings were demolished in 1916.

A hospital, mess hall, a building (leased to the YMCA), a school of some 90 students at its peak and two teachers, and a hotel were built above the temporary rail line also. For a short time, a small store and a soda fountain as well as an ice house did exist on the lower level of buildings. On Sept. 16, 1911, a fire destroyed a warehouse and the mess hall. They were

lies lived in the camp at its peak from 1912 to 1915. Actual dam work began in early 1912. During the project, twelve men were killed and numerous others were hospitalized.

A concrete plant was built on the Boise County side of the river close to where the dam was built. A complex cable system delivered the concrete to the dam site itself. A part of it remains on the Boise County side but can be seen only dur-

intended needs. Electricity is produced and the dam helps to collect and distribute flood control. So does Lucky Peak and Anderson Ranch. All three provide flood control, some electrical power and provide endless recreation opportunities. I take note of the fact that as terrorist attacks are possible, the gate across the dam is closed in winter when the reservoir is at its lowest levels but

open 24/7 during peak water levels when the dam is at summer levels. *Hmmm.*

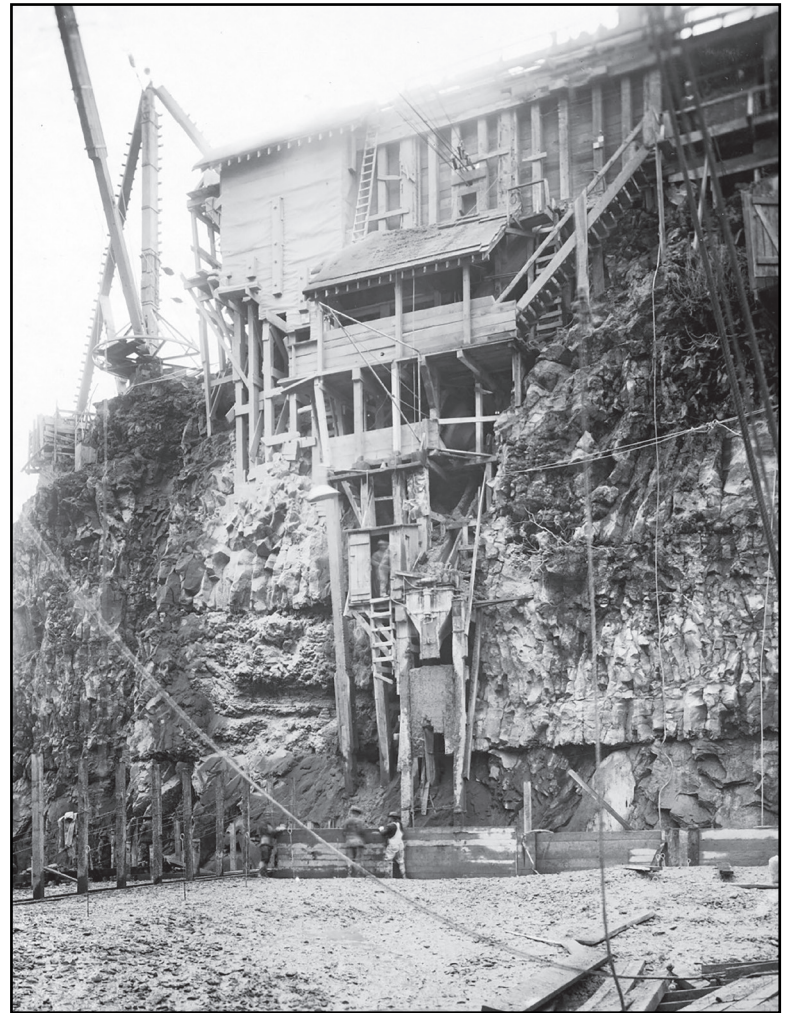

None of the old buildings are visible anymore except for part of the cement plant, which is under water most of the time.

Thus the conclusion of town vs. camp. I have found no specific statement on that issue during the history of the dam construction. It was always called a camp. But given the widespread buildings with normal town status, I cannot deny that the camp did not have town status. *Ya pays yer money and takes yer pick.* The bottom line is that it was an amazing project that took up to four years and cost a number of lives in the process. The dam is not any longer the highest dam in the country, let alone the world. But it still exists and serves its

Idaho City's Reverse Osmosis?

IDAHO CITY -- In August 2017, Idaho City drilled two new wells to increase water for local residents; however, these wells had levels of arsenic and fluoride exceeding the safe drinking water limit. Since then, the Idaho City Council has been working to improve the water and make it acceptable for drinking. The council members, Mayor Canody and their City engineer, Kasey Ketterling, have reviewed

several potential treatment options that will remove both arsenic and fluoride with the goal of determining the most cost effective solution for the City.

The options available to treat fluoride in conjunction with high levels of arsenic are limited. The plan that they decided to use was called "reverse osmosis", this is a special type of filtration that uses a semi-permeable, thin membrane with pores small enough to pass pure water through it while rejecting

larger molecules and other impurities. This RO (reverse osmosis) is very effective in producing highly purified water for drinking water systems.

Working closely with the DEQ (Department of Environmental Quality), Mr. Ketterling has designed and received approval from DEQ for the treatment project, using reverse osmosis, secured a company to provide equipment, and will run a pilot test within the next few months. The City

is looking forward to having the water purified to state standards, and then they will bring the new wells on line for residents of Idaho City to have more water for future use.

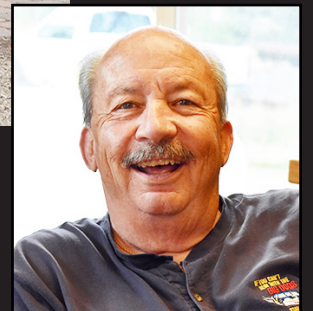

Prescribed Fire Still Smokes North of Crouch

CROUCH -- The Forest Service's Lodgepole prescribed fire, located approximately 14 miles north of Crouch along National Forest System (NFS) road 671, continues to burn and is causing smoke to be visible along the Middle Fork of the Payette and into the town of Crouch.

Recent warmer weather has resulted in needle litter and heavier fuels rapidly drying out, which is allowing the fire to slowly spread into adjacent unburned areas. The fire still remains within the designated project area.

Fire crews are putting in a fireline to reduce its spread and

also work directly on putting out flames found in heavy fuels.

There are currently no closures in effect, however fire managers are assessing possible closure needs due to public safety. The public is asked to be mindful of fire traffic on the road to Silver Creek Plunge.

The prescribed burn took place on April 24 and was approximately 1,250 acres, with the objective to improve forest vegetation and wildlife habitat conditions.

Horseshoe Bend City Council Discuss Law Enforcement

HORSESHOE BEND -- The following is a synopsis of the Horseshoe Bend City Council's 650th meeting on June 27, 2018. After the call to order, Pledge of Allegiance, the council's approval of the agenda, previous minutes, and the city's bills, Mayor Pat Goff called for a new business item to be heard per the agenda regarding the renewal of the Boise County Sheriff's contract. Sheriff James Kaczmarek presented a report to the council with information regarding 2017's incident statistics. According to the report there were 309 incidents within the city's limits, (down 39 from the previous year) not including the 145 incidents reported by the student resource officer (SRO). The report contained statistics for traffic stops which numbered 982

incidents and included 85 public assist calls, 40 arrests, and 11 DUIs. Kaczmarek came before the city council to discuss the rate the city is paying for its current contract with the sheriff's department. The sheriff informed the council that the cost to put a Boise County officer on the road (based on a 40 hour week) cost an average of \$135,000 per year which includes wages, benefits, cost of vehicle, fuel, civil prosecution duties, etc... of which the city is currently paying \$ 63,000 while the additional cost is being subsidized by Boise County. Kaczmarek added that legally his department has to charge everyone at the same rate (forestry service, mass gatherings, etc..) and he was before the council to request an increase for the next contract period which will begin in September of this year. The

sheriff proposed an incremental increase of \$ 23,000 over the next 3 years to bring the city in line with the actual costs incurred by the department to operate in the city. The sheriff also added that legally the city could only carry a yearlong contract with the department. Kaczmarek went on to say that the Boise County Sheriff's Department was in the bottom 3% in the state for wages earned. The department currently employs 13 total law enforcement officers including Kaczmarek and the SRO. An alternative suggestion from the sheriff was that the city explore creating and manning their own police department. The council had several questions for the sheriff including the department's hours of operation within the city. Kaczmarek explained that the staffing is based on peak

hours of service (which comes from dispatch data) from 10 a.m.-12 a.m. but added that the department always had officers on duty in the surrounding county to assist the city. The sheriff was asked about enforcement of the city's ordinances such as the barking dog ordinance. Kaczmarek told the council that if an ordinance is enforceable the department will issue citations. "If there is a barking dog ordinance in the city it's a matter of education" for the officers. Getting back to the subject at hand, Mayor Pat Goff told the sheriff, "Going from 65 to 87 is easy to stomach but 65 to 144? I can't see the city doing that." Kaczmarek responded, "Here's what I would suggest. You guys put together a counter offer to present to the county commissioners." Council member Curtis Corvinus asked "What would be the true impact if the contract isn't renewed?" Kaczmarek replied, "Your numbers are massive, you have Highway 55...your revenue will go down." (Ticket fine revenue to the city amounted to \$ 6,598.93 in 2017) In closing the discussion with the sheriff Mayor Goff stated with some levity, "It would be nice if some of these deputies would wave back when I wave at them." Kaczmarek replied, "I got a lot going on...chances are I didn't see you."

Council member Ryan Stirn brought a proposal to the council from an anonymous group of residents regarding the lack of fencing on the west side (adjacent to Hwy. 55) of the city's park. The citizens were requesting permission from the council to erect a fence matching the fence that the city just had installed along the northern side of the park. The group had indicated that they would fund the expenditure if approved by the council. The city agreed to make the fence an action item at the next council meeting. The city unanimously

voted to accept a new Hazard Mitigation Plan that the Federal Emergency Management Agency (FEMA) had approved for Boise County. The plan helps to mitigate costs to the city due to fires, floods, etc.. This would be by way of grant money from FEMA.

City treasurer Terri Lawson told the council that the 2018-2019 budget would be presented at the next council meeting. Discussions were held with no conclusions regarding the payment of utilities to Valley Christian Church with regard to their rental property that the city is using for emergency management services (EMS) and Bo Fisher presented new city hall sign designs. Mayor Goff, acting as interim EMS director, stated that he was working on getting someone to take over the position. Public works is currently working on weed abatement & tree trimming. New LED lights have been installed in city hall, the water plant is next to get the new lighting. Amy Woodruff, HSB civil engineer, stated that she is working with the Department of Environmental Quality (DEQ) regarding the new city well and is working with the Idaho Department of Transportation on the sewer main on the bridge. HSB's city attorney gave an update regarding the city ordinances that are being worked on and will have a report at the next meeting. Meeting attendee Sandy Fenton asked for clarification of the city's barking dog ordinance. The city attorney stated that it is known as Ordinance 4-5-3 and loosely states that "dogs that howl or bark at night time, or cause damage to a person's property are considered a public nuisance." First offense is a \$100 fine. The meeting was adjourned at 8:43 p.m. The Horseshoe Bend City Council usually meets every third Wednesday of the month at 7:00 p.m. The agenda is posted at city hall the week prior.

Boise County's Measures to Provide Each Classroom with Medical Supplies

BOISE COUNTY -- Special thanks to Sheriff Jim Kaczmarek and Deputy Robert Hastie (Boise County School Resource Officer) who initiated the concern and asked if it would be possible to, through Emergency Management, put first aid kits in each county classroom. Bob Showalter, Boise County's Emergency Manager, took a good look into available grants. A group was assembled, including Sheriff Jim Kaczmarek, to discuss key components and to order the supplies needed.

Angie Dill, East Boise County Ambulance Director, was able to purchase most of the items through her vendor and it was paid for through grant money. There were additional items that

were deemed necessary, which was covered by the Emergency Manager's office. Showalter said, "Once everything was in, we set the date to have a 'bucket party'."

There were 146 buckets filled for each Boise County

classroom with medical supplies, should there ever be an event of mass casualty at the school or nearby where extra medical supplies are needed. The buckets contain first aid supplies and post trauma kits.
