### A Signal on Banks Lowman Road?

**GARDEN VALLEY** -- Idaho Transportation Department [ITD] representatives attended a Boise County Commissioners' meeting on Tuesday, September 4<sup>th</sup>, 2018. Chairman Alan Ward asked that they discuss the traffic merging from the Banks Lowman Road, onto Highway 55. There have been constituents of Boise County, particularly of the Lowman and Garden Valley area, that have complained about the increased traffic. He asked if they had any intent to solve the

problem, stating that traffic can be lined up as much as three miles. Chairman Ward pointed out that “Idaho is the fastest growing state in the union, and of course Boise County was one of the fastest growing in the State of Idaho. We just want to make sure that there's some attention, some understanding that there is an issue there.”  
A representative from ITD said that they recognize this a very important issue to the area of Garden Valley, but there is also a “complexity”

with a narrow bridge and high-speed highway. He described the traffic as a seasonal issue, “thirteen Sundays out of the whole year, when this becomes an issue.” The representative said potential solutions become expensive very quickly, and there is prioritizing throughout the state. He stated that a traffic signal would not solve the problem, but, in fact, comes with its own set of concerns for safety. He read from notes: “The last five years has seven

### Garden Valley Hospital Taxing Board Lack of Quorum Delays Work on Rebuilding

**GARDEN VALLEY** -- The Garden Valley Hospital Taxing District, which is composed of Bill Baker, Helen Beckwith, and Beth Armour, was to have a Special Meeting on Monday, September 10, 2018 at 4:30pm. Baker called the meeting as “acting Chairman”. Beckwith and Armour were not present. The meeting could not proceed with setting duties of the members left on the Board as stated on the Agenda.  
Armour was invited to call in to a “potentially very short meeting” after she responded through an email that she could not attend the meeting. She

declined to call in. Beckwith failed to respond to emails until “about 45 minutes before the meeting”, according to Baker. Baker was given all records and files from the District Board after resignations of Board Members at the last regular meeting. He was suddenly thrust into paying bills, figuring out all the files loaded into his car and subsequently into his home, and figuring out the next steps to operate the Board. He asked for help from the two members left by conducting a meeting to determine positions. Baker is aware these items should be done in an open meeting as required

by law. Both parties failed to respond to any emails until a meeting was established.  
The Agenda was posted and so the meeting still needed to take place. Six community members were present to observe the meeting. Baker called in since he was on business out of town. Baker is determined to keep the District going and he explained that the meetings are needed “to determine the roles of the existing members.” The resignations at the prior meeting sent everything into a tailspin and yet bills needed to be paid and a budget form prepared for the county. Baker appeared to be appointed as the Chair, Treasurer and Secretary when all items were given to him and no one has offered to help with the transition.  
Since nothing could be done at this meeting for lack of a quorum, Baker offered the community members an opportunity to ask questions or make any comments after apologizing that nothing could be decided at this meeting. Several asked what the next steps would be, while others asked that the clinic be a priority. Baker said that “We plan to do things correctly and according to statutes.” Another asked if Baker knew what the steps were to dissolve the District if the November vote decided that direction. Baker named Idaho Statute Title 39 Chapter 13 as an available reference.

The community members at the meeting voiced their desire to see that progress will continue, despite the lack of a cohesive Board at the time. One person was very vocal, off the record, that he wanted to see “the clinic move forward with programs that were badly needed in this community” and also said that he “would hate to see the areas in the District go backwards with health ser-

VICES.”  
At this point, Baker will make plans for a meeting, again, to appoint people that have shown interest to restore the Board of Directors and assume the jobs associated with being on a taxing board. Schedule for the meeting will be posted on social media, the Post Office, Library, City Hall and Mountain America Credit Union.

**EAST BOISE COUNTY --** On Friday afternoon, a little before 4pm, a white Suzuki headed northbound detoured from the road, running up into the rocks. The car rolled over onto its top. The crash at mile marker 28 is still under investigation, but there was a large rock seen in the roadway.

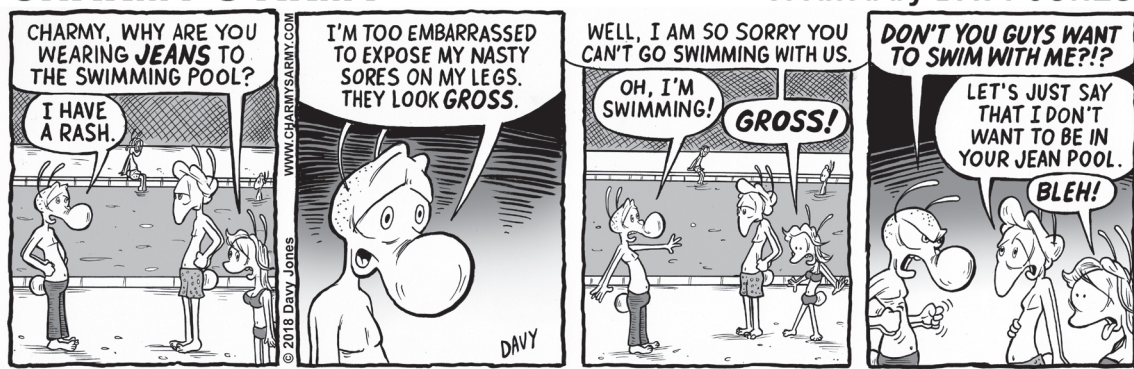

**Shoot better photos ... guide to field guides ...**

**Shoot your limit – of images**

Warm weather means wild-life are up and around during cooler dusk and dawn periods, and most will go to water once or twice a day. If you're a hopeful shutterbug, now's the time and there's the place. My TV camera operators have taught me a lot about getting good images. (I hope you agree when you watch my show!) Here are some of their tips:

- Put yourself and your camera at animal level – nicer body

proportions and a more natural look.

- Anticipate where an animal is going, what they will do next. Set up your shot, and tap the shutter when they enter the frame.

- Always shoot an insurance image – like people, critters will blink, jink, and turn their backs at the wrong time.

- Find a popular food source and arrive well before the dinner hour.

- Stake out a well-worn trail that has fresh tracks. Hide downwind.

- Get closer, physically or with a good zoom lens.

**Guide to field guides**

Whatever their outdoor passion, there's probably a field guide that will increase the enjoyment of outdoor enthusiasts on your shopping list.

Look for a durable, waterproof cover, and ideally, waterproof pages as well. Often, the more geographically specific, the better. If your exploring is done mainly in the Southwest, for example, buy a guide for that area – chances are it will have more accurate, current information. And don't be limited by traditional topics. There are now guides to rocks, shrubbery, insects, weeds, even a roadside guide to cows!

**Campcraft & Outdoor Lore**

- When (not if) you get a sunburn, just add water and alleviate some of the sting. Staying hydrated helps. Cool compresses do, too. And to be on the safe side, get medical help if your body temperature is higher than 101 degrees, blisters cover more than 50 percent of the sunburned skin, you feel dizzy, or have problems with your vision.

- Aurora Borealis, or North-

ern Lights, are the result of material thrown off the sun's surface colliding with the Earth's atmosphere. They appear over northern Finland, Scandinavian countries, Canada, northern United States, Alaska and Siberia.

**Wonders of wildlife**

Deer see orange and red as a sort of green ... blue is the most vivid color their eyes can discern. Wildlife watchers take note. Want to find more wildlife? Look for oak trees. Acorns are eaten by grouse, doves, pigeons, turkeys, deer, elk, wild

pigs, bears, squirrels, gophers, rabbits, pheasants and quail.

Owls are telling you rough weather is on the way, if they screech during the daytime. Young swans are called cygnets. The whitetail deer is one of America's true natives - most other animals likely migrated from Asia millennia ago.

A mountain lion is sometimes called a "painter." Early settlers thought it looked as if the animal's tail had been dipped in black paint. The woodcock is also called "timberdoodle," and by those who have missed shots at them, "bogsucker."

## Extension Educator's Corner: Master Gardeners

I recently received news that my counterpart in Washington County will be leaving University of Idaho Extension at the end of August to pursue opportunities elsewhere. Extension educators often provide leadership across county lines in specific program areas. One of her responsibilities was oversight of the Master Gardener Program in Washington, Payette, Gem, Boise, and Adams counties. In the interim (and maybe long term, we'll see), I'll be taking the lead with the Master Gardeners for Gem & Boise Counties.

So, what does that mean? What are Master Gardeners? For a quick history we'll turn to the University of Idaho Extension Master Gardener website: [www.extension.uidaho.edu/mg](http://www.extension.uidaho.edu/mg) The Master Gardener Program was developed by Dr. David Gibby, a County Extension

Education in King County, Washington. Dr. Gibby was delivering research-based information on gardening to the public through mass-media and the more he taught, the more interest and demand he received for reliable horticulture information. Soon it became difficult for him to respond to all the calls coming into the Extension office.

In response to the growing need, he created a program where he would recruit and train volunteers to respond to gardeners' questions. The first training was held in 1973 where approximately 200 volunteers attended, and the Extension Master Gardener Volunteer Program was born. The Idaho Master Gardener Program began in 1976 in Ada and Canyon Counties and is currently operating in 32 of Idaho's 44 counties. And just like how you can find Extension programs all

across this great nation, Master Gardener programs exist in all fifty states, nine Canadian provinces, and South Korea. That's a lot of quality gardening information!

In Gem and Boise Counties we have several dedicated Master Gardener volunteers. Every Thursday from May-September (except for county fair week), they gather from 1:00-3:00 pm at the Extension office to diagnose, research, problem solve, and answer questions. Our Master Gardeners can help you learn how to grow your best garden and landscape, give practical "how-to" advice on home gardening topics, identify common local insects, weeds and diseases, and suggest research-tested treatment options.

You can drop your problem plants off any time during the week and we'll save them for the Master Gardeners to re-

view at their next meeting. After they figure out what the issue is, they'll give you a call and send you resource materials in the mail. Occasionally, they'll even do a home visit. You won't find a more helpful or knowledgeable group of people.

While the growing season, and Master Gardener help sessions, will soon be ending for the year, I look forward to expanding the offerings next year. What ways do you need

help? What struggles do you face on your property? Let's problem solve them together. Happy harvest!

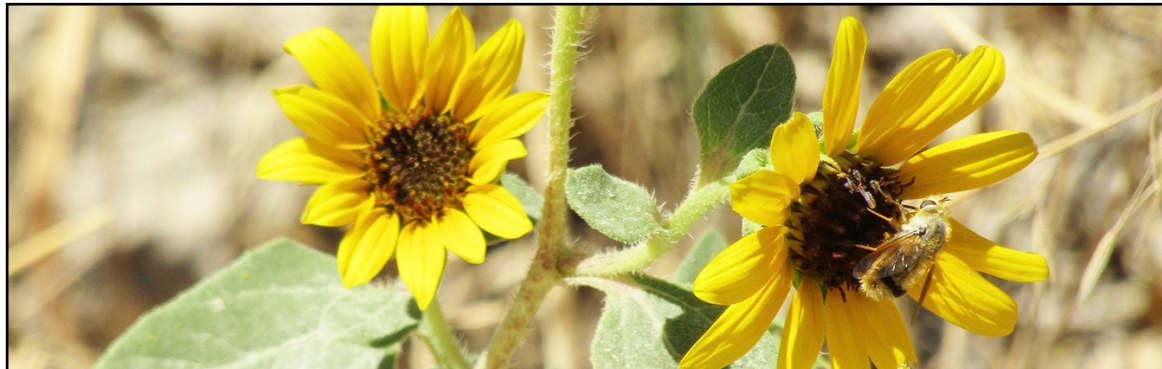

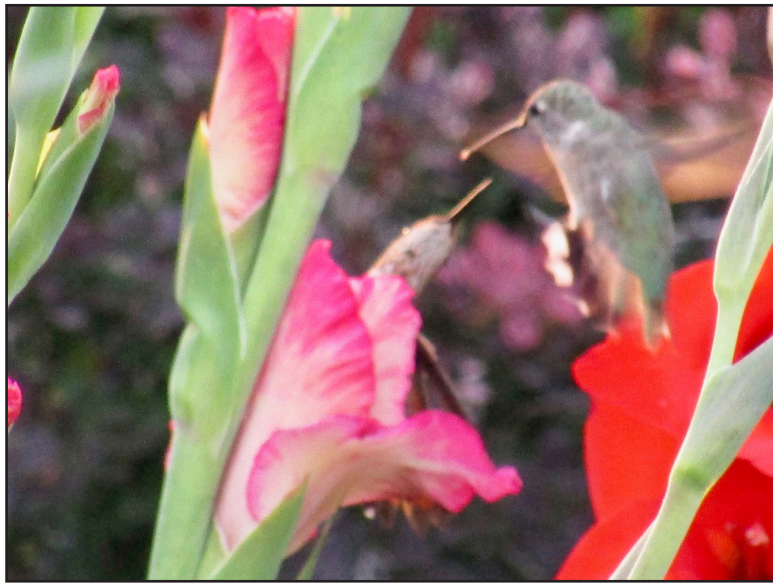

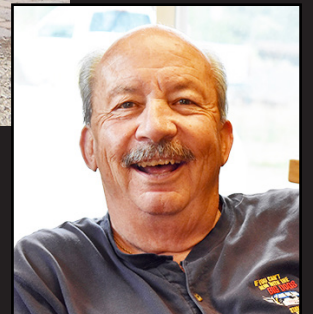

reported serious injuries and this year has, *now*, a fatality.”

Commissioner Roger Jackson recognized that in driving to Stanley, sometimes four times a day, three out of five cars were from out-of-state.

An ITD representative stated, “When we look at this intersection, this is mainly recreating public that’s getting stuck in traffic. So, the value of someone’s time who’s recreating, is not the same as somebody who’s commuting to work, or delivering products and goods. The volume of traffic on that highway does not compete with the larger traffic on other highways.” ITD looks at the cost of construction and the cost of design, then decides whether that ratio qualifies as a positive investment for the taxpayers of Idaho.

ITD elects to use flaggers to move traffic when the traffic is backed up on the Banks Lowman Road. Chairman Ward would like to explore the option of having a signal that turns

on when it needs to, and then would turn off. ITD representatives replied that the drivers are not expecting to stop for a signal there, and would, therefore, cause a significant risk. They advised that advanced warning signals also come with challenges.

One of the three men said, “From 2012 to 2017, we have had 32 crashes in the vicinity, from mile post 77 to mile post 80. The actual crashes are more spread out.” Commissioner Jackson commented, “I’m on the road nearly every day. There’s definitely more cars on the road, *everywhere!* You’ve got people moving in here, *moving into Boise by the thousands.* It’s only going to get worse; I don’t think it’s going to get better.”

Chairman Ward also discussed the possibility of the ITD acquiring the railroad right-of-way for a downstream Hwy 55 road on the right, and a new bridge to be potentially built in Gardenia, which would then merge back onto Hwy 55.

ITD said they had never heard that option, “*but it sounds expensive.*”

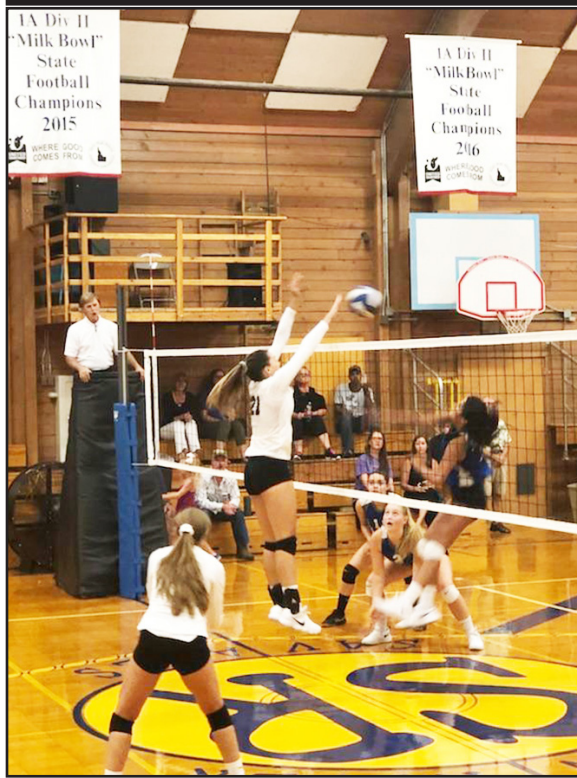
One representative from ITD remarked on the extensive work that would need to be done, “to make the intersection workable, it’s a very expensive fix. In the interim, just throwing a signal out there, although it would alleviate some of the mobility concerns, it would raise safety concerns.”

## Fire Update:

### Boise National Forest U.S. Forest Service BOISE COUNTY -- (9/11)

Progress was made yesterday as firefighters held fire lines through the red flag warning for high winds.

The 115 acre Casner Fire is 30 percent contained and located 13 miles east of Lowman, in an area with minimal road access and steep terrain. Firefighters will continue to work on securing the perimeter line, keeping the fire north of Casner Creek and east of West Fork Casner Creek. Helicopters are supporting over 170 firefighters. There may be some smoke impacts involved with travel along State Highway 21 and within the recreational areas. Visitors are asked to use caution. Expect fire personnel and additional vehicles using the corridor.

The 26 acre German Fire is 90 percent contained. The fire is located 9 miles east

of Idaho City, and under the management of a Type 3 Management Team. Fire managers anticipate releasing firefighters back to their local units as containment is reached.

Aircraft detection flights and patrolling of the fire areas will continue until a significant amount of moisture arrives on the forest.

Higher humidity and cooling temperatures aid with suppression efforts, however the fuels remain extremely dry.

Area Closure near Grandjean for the Wapiti Fire remains in effect.

Stage 1 Fire Restrictions also remain in effect for the Boise National Forest.
