BOISE COUNTY -- Not native to Idaho, the wild turkeys were first released here in 1961. One of the largest of the wild birds, these turkeys stand between 43 and 45 inches tall and can weigh up to 24 pounds. According to the Idaho Fish & Game, the **Turkey Hunt application dates** are:

- Spring hunt application period: February 1 – March 1. Results available by March 20. Any left over permits go on sale April 1.

- Fall hunt application period: May 1 – June 5. Results available by July 10. Any left over permits go on sale July 15 at 10:00am MDT.

Steelhead Season Suspended

The Idaho Fish and Game Commission suspended the fall steelhead season effective midnight December 7, 2018. The decision was made after careful thought in response to a threatened lawsuit over the federal government's failure to process Idaho's Endangered Species Act permit for the steelhead fishery. Steelhead fishing will remain closed in 2019 until further notice.

Having been involved in steelhead management as a professional biologist, and being a steelhead fisherman for over 40 years, I'm well aware how important steelhead fishing is to Idaho anglers and local economies. The loss of that opportunity, even temporarily, due to a lawsuit and unprocessed permit is truly regrettable.

On October 9, Idaho received a Notice of Intent (NOI) to file a lawsuit from six organizations, including The Conservation Angler, Idaho Rivers United, Friends of the Clearwater, Wild Fish Conservancy, Wild Salmon Rivers, and Snake River Waterkeeper. The groups said they would sue Idaho for allowing a sport fishery for hatchery steelhead. Despite harvest of wild steelhead being illegal in Idaho, any catch-and-release of wild steelhead requires a permit from the federal government because they are listed as Threatened under the Endangered Species Act.

Fish and Game attempted to reach a settlement where some fishing on hatchery steelhead would remain open in Idaho, with little risk to wild steelhead, however, the groups that filed the notice of their intent to sue rejected this offer.

For whatever reason, these groups singled out Idaho for their lawsuit threat, and because there is not a biological basis to close steelhead fisheries in the Snake River basin, fisheries in the Snake River boundary waters remain open to anglers licensed in Oregon and Washington in compliance with those states' rules, and tribal steelhead fisheries in Idaho will also continue.

Idaho has long been a leader in wild steelhead conservation. In total over 4,200 miles of the 5,000 miles of wild steelhead spawning and rearing habitat in Idaho is regularly closed to steelhead fishing. This includes areas such as the Middle Fork and South Fork Salmon rivers and the Selway and Lochsa rivers.

Fish and Game uses the best-available science to estimate the total number of wild steelhead that may be killed during the fishery for hatchery steelhead, and we manage the fisheries to keep the mortality rate low. The majority of impacts on the wild summer run steelhead occur in downriver fisheries. Idaho sport fisheries result in the unintentional mortality of about 3 percent of the wild steelhead entering Idaho. Federal and state agency fishery scientists agree this level of handling and mortality does not jeopardize wild steelhead populations.

Idaho's permit for the hatchery steelhead fishery has indeed lapsed. This is not a result of the state failing to play by the rules or disregarding the needs of wild steelhead. Idaho received its first permit for incidental take of ESA listed fish in 1993 and has complied with federal requirements since then. In 2010, Idaho submitted paperwork for timely renewal of the permit for the hatchery

steelhead fisheries.

Idaho has continued to conduct steelhead fisheries consistent with this plan and in full awareness of the permitting agencies. Since steelhead listing in 1997, state and federal agency scientific reviews have found Idaho's management frameworks for hatchery steelhead fisheries do not jeopardize wild steelhead populations.

NOAA recently published Idaho's Steelhead Fishery Monitoring and Evaluation Plan for a 30-day public comment period. This is an important milestone in the permit renewal process and our hope is that we will receive the permit in time to reopen a portion for the spring fishery.

Fish and Game and its commission are committed to the recovery of wild steelhead, but closure of the fishery is not based on a conservation need. It is unfortunate these groups are attempting to portray the lack of a permit as a lack of concern for wild steelhead — a strategy that results in lost opportunities for Idaho anglers and communities.

The commission did not want to go to federal court, lose on a technicality because the federal agency dropped the ball on permit renewal, and have our anglers' and hunters' license dollars pay bills for advocacy-group lawyers instead of conservation.

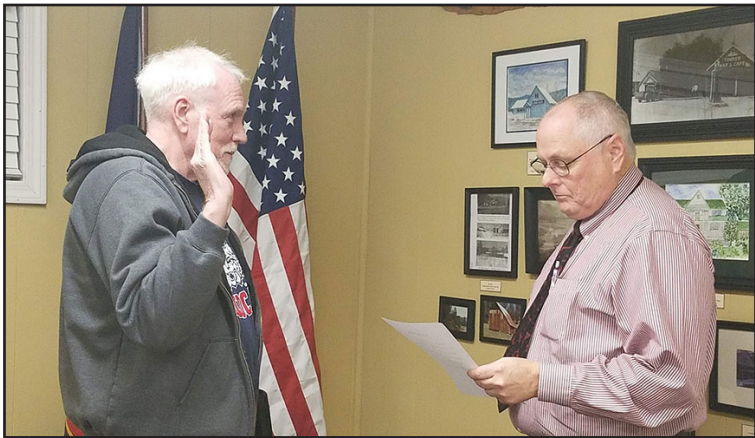

Clear Creek Firefighter Training

CLEAR CREEK -- Firefighters with the Clear Creek Volunteer Fire Department conducted a live-fire training exercise in the Clear Creek/Grimes Creek area of Boise County. Volunteers from Clear Creek Fire, with help from Centerville Fire, set ablaze a condemned manufactured home to teach firefight-

ers about the science and stages of fire, as well as how to run a structural fire incident in the Wildland-Urban Interface. The structure at #4 Frenchman's Flat Road, was identified in 2017 and deemed as a good candidate for training. CCVFD used this structure throughout the 2017 and 2018 training seasons for topics such as incident assessment, ladder train-

ing, entry, search-and-rescue, and more. The homeowner, a former CCVFD assistant chief, worked with the department to ensure that a clean and safe burn could be conducted with minimal impact to the neighborhood. Brush was cleared, potentially toxic garbage was removed, and hazards were minimized.



A first view from the lookout above the burn site. Big picture point of view... we had patrols out covering all angles. The wind kicked up and kept changing direction on us. Lookouts stayed in close communication with teams on the fireground to provide a birds-eye view and expand situational awareness.



We set up a 2500-gallon fold-a-tank to ensure there was more than enough water on-hand, to make certain the fire stayed where it belonged. There was at least 10,000 gallons of water on-hand. — with Steve Moore and Sam Pecorito at Frenchman's Flat.

Hooper was arms-length from me with his light on, and I could barely see that it was there. You're blind in there. The fire was just to the right.

Secure Rural Schools Extension Introduced

Crapo-Wyden legislation extends SRS program another year

Washington, D.C. – Legislation to extend the Secure Rural Schools program by one year, through Fiscal Year 2019, has been introduced by Senators Mike Crapo (R-Idaho) and Ron Wyden (D-Oregon). The Secure Rural Schools and Community Self-Determination Act (SRS) was first introduced in 2000 to assist counties containing tracts of federally-owned land that is tax-exempt.

Critical services at the county level have historically been funded in part with a 25 percent share of timber receipts from federal lands. As those revenues have fallen due to reduced timber harvest, SRS payments have helped bridge the gap to

fund rural schools, road maintenance, search and rescue efforts and other services.

Authorization for the Secure Rural Schools program is expiring. The Crapo-Wyden bill would put in place a one-year extension while more long-term measures can be explored.

“Continuing this program is critical to our rural schools and road programs,” said Crapo. “A renewed SRS commitment coupled with a recovering and healthy timber economy will ensure a brighter future for students and those who enjoy the backcountry alike.”

"This program is critical to making sure schools, law enforcement, and road programs in rural communities in Oregon and around the country have the support they need for

residents' quality of life," said Wyden. "Congress cannot allow the payments from this essential program to lapse. It is imperative that it extend the Secure Rural Schools program and give rural counties the financial certainty they require, while Congress spends some quality time considering other options to support these counties moving forward."

The legislation is expected to draw wide bipartisan support. Last year, 78 members of the Senate and U.S. House of Representatives wrote a letter to the Office of Management and Budget (OMB) seeking to include the SRS program in the President's budget recommendations.

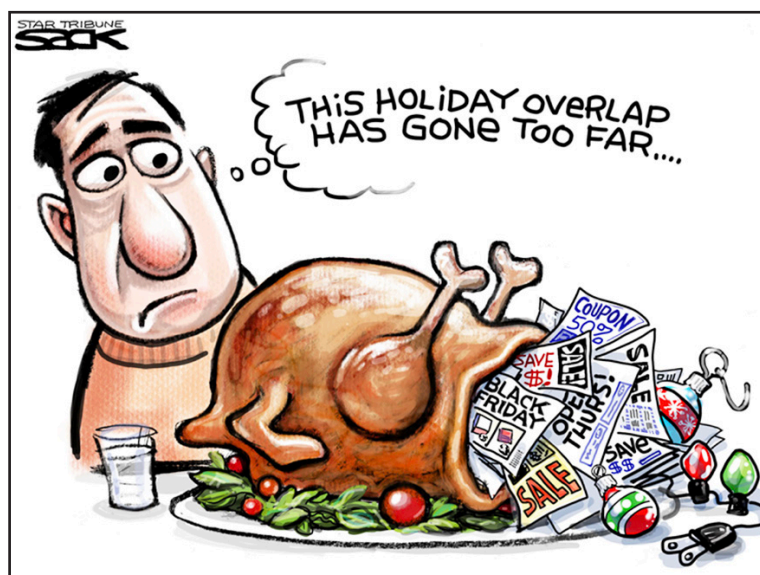

CuMo Responds to: Letters to the Editor

Idaho CuMo Clarifies Processing of Molybdenum Ore

BOISE COUNTY -- The November 7, 2018 edition of the Idaho World contained a letter to the editor discussing the processing of molybdenum ore at the CuMo Project. First, it is important to note that the CuMo Project is in advanced exploration which must complete two more field seasons to compile all the necessary data

to properly map any further development. That means all talk of a mine and its functionality is premature, currently.

However, there are undisputable certainties based on the research and data collected this far in the exploration. There will be no roaster in Boise County. The ore will likely be processed on site using a floatation process and the concentrate loaded on to railcars/trucks for shipping to ports and roasting location. The roaster would be a zero emissions plant used to collect all the Sulphur dioxide to produce Sulphuric acid. Additionally, the plant will process the dust

to produce the rhenium, a critical mineral used in aircraft turbine blades. The location of the roaster cannot be determined at this point in exploration, but it will not be in Boise County.

Before discussing the milling of the ore and the flotation process, it is important to note that all data to-date shows that the deposit is benign with no toxic elements and no acid generating rock due to the low sulphide and high carbonate content. The flotation process uses a tank of water with non-toxic, frothing agents to separate the ore. All water in the mill complex is reclaimed and recycled with very little water losses.

Any discharge to the environment must meet stringent environmental requirements.

When exploring the topic of ore processing at the CuMo Project, discussion must include the important optimization of Ore-sorting technology. The CuMo deposit has been analyzed and determined to be perfectly suited of this optimization which will greatly reduce the overall footprint of the project and increase the profitability up to 60 percent.

Molybdenum is an important, strategic mineral essential to U.S. infrastructure, economy and national defense. To date, tailings testing for the CuMo

Project shows their potential to be a non-toxic natural fertilizer that increases large crop production up to 60 percent.

In alignment with CuMo's commitment to transparency, Idaho CuMo Mining Corporation has provided this information to the author and the community. Extension Educator's Corner: *Pesticide Recertification Class*

Each December University of Idaho Extension, Gem County Farm Bureau, and Valley Agronomics sponsor a pesticide recertification class in Emmett. According to the Idaho State Department of Agriculture website (<https://agri.idaho.gov>), individuals with a private applicators license need 6 hours of recertification

training during their certification period to maintain their certification. Professional applicators need the equivalent of 15 hours of training to recertify. The recertification process is intended to ensure licensed applicators maintain their competency as well as keep current with changing technology.

This year's pesticide recertification class is scheduled for Tuesday, December 11, 2018 in the conference room at the USDA Building, 1805 HWY 16, in Emmett. Three recertification credits will be available for individuals who complete the class.

Check-in will begin at 8:45 am with presentations beginning at 9:00 am. The registration fee for this year's event will

be \$10. Participants can pay with cash or check at the door. We have three presenters coming to cover currently relevant subjects including: glyphosate usage, reducing pesticide risk to pollinators, and aquatic noxious weed management. There will be light refreshments provided during check-in and a lunch at 12:20 p.m. after the concluding presenter.

BOISE, Idaho—The 2019 Gubernatorial Inauguration Ceremony for the Governor of Idaho and State of Idaho constitutional officers will take place promptly at 12 p.m. on the south steps of the state Capitol Friday, Jan. 4.

The ceremony will include the swearing in of the governor, lieutenant governor, secretary of state, state controller, treasurer, attorney general and superintendent of public instruction.

The event is free and the public is encouraged to attend. Jefferson Street between 6th and 8th Streets will be closed from 8:30 a.m. until approximately 3 p.m. to accommodate public viewing. 8th Street between Jefferson and State Streets will be closed as reserved parking for those with disabilities.

The Inaugural Procession and Ball will take place Saturday, Jan. 5, in the Capitol. This non-partisan event continues Idaho's long-standing tradition of honoring our state's elected

officials. The Inaugural Ball was first held in the newly-built Capitol building in 1913, when John M. Haines was inaugurated as Idaho's 10th governor. According to a newspaper report of the time, the traditional Grand Procession "wound up and over the spacious staircase ... like a many-colored serpent of various hues." This 48th inauguration is much the same as it was then.

The Idaho National Guard's 25th Army Band will provide patriotic music at the Inaugural Ball and a professional photographer will be on hand to capture lasting memories of this event.

Doors open promptly at 7 p.m. Members of the public intending to arrive early are advised to dress warmly as the Capitol will remain locked until this time to ensure security. The Grand Procession of elected officers, legislators and distinguished guests will commence at 8 p.m.

Jefferson Street between 6th and 8th Streets will be closed,

as well as 8th Street between Jefferson and State Streets. Free parking is available at all Capitol Mall parking lots, including the garage at 6th and Washington Streets.

The Inaugural Ball is financed by ticket sales, and admission to the Ball is by ticket only. Tickets are \$25 for adults and \$10 for children 12 and under. Tickets are available for sale to the public online at <https://inaugural.idaho.gov/> or by sending a check payable to:

Power Outage: West Boise County

WEST BOISE COUNTY--**

Phones started ringing all over the towns of Horseshoe Bend, Banks, Lowman, Crouch, Garden Valley, and Middlefork on Friday, November 16. A prerecorded message alerted Idaho Power customers of a scheduled outage planned for Wednesday, November 21, starting at 1:00 p.m. and continuing until 5:00 p.m. the day before Thanksgiving. Residents of the towns impacted by the electrical outage quickly took to Facebook with a litany of complaints. "This is stupid", "I remain dumbfounded", and "Super inconvenient" were some of the most common protests. A spokesperson from Idaho Power apologized for the inconvenience but stated that two structures were in need of immediate repair before winter weather arrives. The repairs need to be completed to avoid a significant outage at a later date. Three power poles damaged during the Mile marker 73 fire in July will also be replaced. The poles will be brought in via helicopter. Idaho Power advises customers

that scheduled outages may not start or end at notification times and that power may go off and on more than once during the outage. If you intend to use a generator during the outage, Idaho Power recommends that you verify that it meets the National Electrical Code Articles 701 & 702. (For more information regarding the use of generators during a power outage go to www.idahopower.com/outages/scheduled-maintenance/) Idaho power also suggests that you keep your refrigerator and freezer doors closed, learn how to manually operate security gates and garage doors, notify your home/business security company, and protect your electronics (TVs, computers, etc..) by unplugging them prior to the outage. Maps of the proposed outage areas are available on Idaho Powers's Facebook page. Customers can go to www.idahopower.com/outages/ for updates and to sign up for text alerts. If you believe you are in the outage area and did not receive a notification call, contact Idaho Power at 1-800-488-6151 to update your information.

District Court:

Gaitlin Gehrls – This case has been set out a month for sentencing after a guilty plea to a felony charge of Child Sexual Battery.

Daniel Weatherwax – This case has been set out a month for sentencing of a guilty plea to two charges for possession of a controlled substance.

Jered Hendryx – Having spent a year in jail, he was released after he was given good marks from the completion of a program. He had been sentenced to rape and lewd conduct with a child under 16.

Gregory Loveland – He was released due to his good work in the rider program he attended while in jail. He was convicted of two charges, Lewd Conduct with Child Under 16.

Michael McAllister – He has two charges, one of Aggravated Assault and another felony count of Assault – Great Bodily Harm. McAllister remains out of custody and his lawyer assured the judge that this case will not settle. A three-day trial is planned for March 2019.

Christina Robinson – She was not in court, but was being held in jail. Unable to get a transfer to Boise County court, her arraignment will be held in December. She is being held on two felony counts of “Battery on a Law Enforcement Officer” and “Arrests & Seizures – Resisting or Obstructing Officers.”

Stephen McChain – Out of custody, he was charge with the possession of a firearm weapon after he said some friends took him out for his birthday. He explained that he had been previously convicted in Utah of a felony for the possession of Meth. He was given a 22 caliber long rifle to shoot in the woods and someone posted a photo to social media. Sentencing will be done in February 2019.

Timothy Sanecki – He testified to waste of big game. Sanecki said his companion shot and killed a cow and calf moose in the Centerville/ Placerville area, out of season and without a tag. He said it was too heavy to pack out the meat, so he left it to rot. He will next come before the judge on February 15, 2019.

Scott B. Young – Is being charged with Sexual Abuse of a minor under the age of 16. His lawyer desires to exclude expert witnesses, stating it’s hearsay and an “opinion”. The defendant is expected to testify in this case. The case will go to trial on November 28th.

Wayne Bell – Plead guilty of shooting a deer after dark. This had been a Fish & Game violation and a set up with a fake animal. Officers were waiting and charged him with "Attempts to Take Simulated Wildlife" and "Shooting from or across a Public Highway." Bell was charged \$880 in fines.

Garden Valley Recreation Taxing District Project Report

Garden Valley, ID -- Garden Valley, Idaho is very fortunate to have a beautiful community park for our residents and visitors to enjoy year-round. Weilmunster Park, under the guidance of the Garden Valley Recreation District, was formed in 2000. Over the past eighteen years this open area has been transformed into a beautiful community park. A walking path, parking lot, restroom, horseshoe pits, beautiful pavilion, restroom and firepit have been improvements over the years. Additional improvements have been accomplished through the hard work of your Garden Valley Recreation District Board and many local contributors, contractors, and volunteers. The Garden Valley Recreation District Board members are: Leigh Ward, President/Director; Steven Menlove, Vice-President/Director; Sandy McLain, Treasurer/Director; Don Weilmunster, Director; Thor Oden, Director; Julie Hutchcroft, Secretary. Jamie Andersen, a former GVRD Director, was recently appointed Trails Coordinator. Ron Elmore has volunteered his time and utilized his equipment to mow Weilmun-

ster Park; GVRD Board would like to thank Ron for well over a decade of dedication to the beauty of our community park.

Several important improvements have been completed or are underway at Weilmunster Park. In 2016, Gary VanDyke approached the GVRD with the suggestion of building a basketball court for public use. This idea was enthusiastically received by the GVRD Board and approved. Paul & Kyle Sheperd provided the excavation work and Marshall Hersom poured the concrete for the basketball court. Gary returned with a group of young men from our community who volunteered to paint the court and complete this addition to our park. In 2017, Chris and Gene Foster in conjunction with the women of the Garden Valley Syringa Club, approached GVRD with the suggestion of a Veteran's Memorial. Another fantastic idea, GVRD quickly approved this project. Chris Foster, in conjunction with Syringa Club, worked tirelessly to complete the first phase of the Garden Valley Veteran's Memorial at Weilmunster Park. Each branch of the service is represented, as well as Veterans, through the installation of individual bricks that sup-

ported this project. The second phase of this successful project currently underway.

Jay Rais approached the GVRD Board and volunteered to build wood duck boxes, which he installed in the spring of 2018, greatly improving the beauty of our park trail and improving the park through his generous donation of time and experience. Jay's work tied into the Bluebird Trail established by former Director Linda Bass and the Bluebird Box Project in honor of Linda Yearsley. 25 trees were planted in 2016 with additional trees planted in 2017 and GVRD would like to recognize Warm Springs Greenhouse for their support of GVRD over the years.

In 2017, GVRD was awarded a \$2500 matching grant from the Idaho Community Foundation to support an electrical upgrade to Weilmunster Park. This grant tied into 2018 projects which include: drilling a well, Allstate Drilling; installation of pump, Custom Pump Services; and ditching/irrigation project Craig Creek Farms/Steve Semels. Steve Semels and Steve McAninch provided significant in-kind work to the irrigation system now installed at Weilmunster Park. Jerry McLain of McLain Electric, Road Runner

Redi-Mix and Marsha Hefner/Middlefork Trading Post have supported our Recreation District through their assistance on these projects. In addition, Steve Pedersen and Brian Payne of Fair N Square Construction were contracted to stain the pavilion after pressure wash/crane service completed by Randy Wade. Scott Leslie/Castle Mountain Homes was contracted to provide and install bird netting in the rafters of the Pavilion. Marshall Hersom was contracted to pour the concrete for the well-house and is currently completing concrete stairs. Tony Anderson/Frontier Communications and Wayne Wellock/Handypros assisted in providing WIFI availability for park events in 2018. Annie Wade/Red Dog Service has been our contracted restroom maintenance and trash removal person for many years and we would like to thank her for her hard work. Don Smith/Summit Construction is working toward completion of the well-house. As part of the electrical upgrade, McLain Electric has added six dedicated outlets along the fence line for vendor and public use during scheduled events at Weilmunster

Park.

The GVRD Grant Program awarded two grants in 2018. \$600 was awarded to the Garden Valley District Library Storywalk Program Director, Kerri Hart, and \$6000 was awarded to Garden Valley School for a softball diamond, project presented to the GVRD Board by Christy and Morris Morgan. These two projects fit very well with the mission of the GVRD.

The GVRD Board will be implementing new rules and regulations starting January 1, 2019 for all users of Weilmunster Park and increasing rental fees for non-residents and commercial organizations. Rental fees for residents of the Garden Valley Recreation Taxing District will not increase. The many upgrades to your community park will serve residents and visitors for the foreseeable future. These upgrades support the mission statement of the GVRD: Enhancing the quality of life for district residents by working in partnership to foster and enrich healthy community environments, protect recreational access and promote activities.

EXECUTIVE SESSION:
Per pending litigation, personnel, exempt records, hiring of new employees and risk management. [Time 9:07 – 9:35am]

CONSTITUENT INPUT:
None

MINUTES: Commissioner Baker made a motion to approve the minutes from Nov. 5. This was approved.

DEPARTMENTAL ISSUES:

JUVENILE JUSTICE:
A report was presented to the commissioners. The annual report for 2018 was approved by a motion.

CLERK: The official results for the 2018 election were presented. “We had amazing voter turnout. Higher than I’ve ever seen in my time here.” The average for all three precincts was 70%. The last time there was such a turnout was when there was a special election for the bond in 2012 for the Alamar judgement. A motion was made by Chairman Ward to approve the canvassing of votes. He thanked the clerk for all her

work on this.
A motion was said to approved a fire alarm system in the Miner’s Exchange building in the amount of \$13,550.
Auditor/ Treasurer Joint Quarter Report: Clerk Mary Prisco said from September 30th, which is later than usual “because we could not produce this report until expenditures were done.” She said Treasurer April Hutchings had also approved it.

PAYROLL CHANGE:
There were two payroll changes, one with the Road Dept. and the other within the Prosecutor’s office.

EMERGENCY MANAGER: County vehicle has significant issues and Chairman Ward would like to know its value and options. Commissioner Baker agreed. State surplus is also being considered. Ward stated, “We’ve had a catastrophic failure in the Emergency Management vehicle” and asked Mr. Jones from the road department to share the state surplus website with Mr. Showalter – Emergency Manager.

GRANT: Chairman Ward made a motion to approve the child pedestrian safety grant through the Garden Valley Recreation District. He also

motioned to approve a Boise County Resolution to support this grant.

AGREEMENT: Election System Software – Chairman Ward pointed out, “It costs a lot of money to run an election, doesn’t it?” A woman said, “*It does!*” Commissioner Baker asked if we were ever going to get away from paper ballots. Clerk Prisco replied with a chuckle, “Theoretically, probably. That’s definitely the way things are going. Our county needs to go there in a slow, methodical way.” They have new equipment that can be used by all voters and is ADA compliant. Commissioner Baker made a motion for the amended sales agreement for a total of \$25,926.

A Lowman election judge stated that the machine was used by a third of the voters and was very well received.

NOXIOUS WEEDS: Idaho Transportation Department pays the county annually for the treatment of noxious weed within their right-of-way, \$5,100.

EAST BOISE COUNTY AMBULANCE DISTRICT: The Board of County Commissioners serves as the EBCAD Governing Board. A “successful” meeting was discussed,

and 15 individuals, including Dr. Sturkie, were present. A new director for the district is being sought, (advertisement was in the *Idaho World* on 11/7 & 11/14/2018). The drug policy will be changed to a urine sample, rather than a hair follicle.

Yearly annual maintenance was discussed and their “struggle with batteries.” A representative said she thought it had been two years since there had been any work done on the ambulance. “Unit 15 is in service, like 90% of the time.” There is a concern for back injuries, when loading patients. This was discussed, and the money to cover an expense for some kind of tool used by Ada County emergency medical. They feel this will help them do their job better. Commissioner Laura Baker said was in support of this. It was mentioned that cardiac issues in Boise County are automatic air medical.

EXECUTIVE SESSION:
Per pending litigation, personnel and risk management.

ROAD MAINTENANCE:
Mr. Jones said that he doesn’t

care what time of day it is, he will be there if someone has rolled their vehicle or is injured. He went at 1am to help an officer who had slid off of Alder Creek Road and was stuck. The road department’s normal route begins at 3am.

He said that their snow plowing and sanding policy is on the Boise County website. They sand from 5pm to 6pm. The line is hard to draw, whether it’s a road issue or overdriving for the conditions. The road department’s priority is to get the bus route ready.

IDAHO CITY -- Jim White served two tours for the U.S. Army, from 10/67 to 9/70. At 18, he enlisted because he wanted to fly helicopters. He was sent to Ft. Ord, California for basic training. He then went to Ft. Gordon, Georgia for Advanced Individual Training. In February of 1968, the Tet Offensive derailed his helicopter training and he became an infantryman. In March of 1968, he was able to come home briefly, but then in April was sent to Vietnam/Cam Ranh Bay, where he was assigned to the 4th infantry division. There he was a “FNG”, but later became a machine gunner and was awarded the Army Commendation Medal.
White’s first exposure to combat was in May of ’68. His most memorable and worst night was on 9/24/68, when his two best friends were killed when they were ambushed by the enemy.
His 2nd tours as an MP at Cam Ranh Bay lead to his long career in law enforcement. Jim White was honored with two Purple Hearts for his service to our country.
