# Idaho Power Restores Service After Storm Causes Boise Basin Outages

**BOISE COUNTY** -- Wet snow and wind knocked out power to more than 1,800 Idaho Power customers in Idaho City, Centerville, Placerville and other parts of Boise County Dec. 1st through 3rd.

Heavy snow on Saturday night caused trees and branches to fall into power lines. A tree that fell on Highway 21 took down a power line and briefly closed the highway. Other outages were caused when heavy snow that accumulated on power lines eventually fell off, causing the lines to spring up and hit other lines. Much like when a short-circuit causes a breaker to trip in your home, these lines coming into contact

with each other trigger equipment designed to prevent additional damage to the electrical system. Crews must then patrol the line to make sure it's clear before safely restoring power.

Idaho Power dispatched two crews and five individual linemen to Boise County Saturday evening. Crews worked through the night and into Sunday and Monday until all customers were restored by noon Monday. During widespread outages, it is difficult to estimate how long restoration will take as new outages occur.

The company strives to provide reliable service to all its customers, but storms can create unforeseen challenges.

"We appreciate our customers' patience during these events," said business and community development advisor Bryan Wewers. "We know it creates a hardship and can assure you our crews are working hard to safely restore your power."

Ada County experienced numerous outages at the same time. At one point, more than 4,500 customers were without power in Ada and Boise Counties.

## SHERIFF'S OFFICE CORNER

### Officers Pursue High Speed Chase & Resort to Tasering Suspect While Fleeing on Foot

**BOISE COUNTY** -- On 11-29-18, the Boise County Sheriff's Office was given information for an attempt to locate a suspect from Ada County. The suspect was fleeing from an occupied dwelling home invasion / burglary in the Boise area.

The Boise County Sheriff's Office located the suspect vehicle travelling north bound on Highway 21 at approximately mile post 26 and attempted to conduct a traffic stop. The vehicle fled from the two Boise County units and a pursuit was initiated.

The suspect vehicle travelled in excess of 100 miles per hour, and was weaving in and out of traffic on a narrow, two lane highway while fleeing from Boise County Sheriff's Of-

ice units. A Boise County unit deployed spike strips south of Idaho City in concert with the pursuit to attempt to stop the vehicle from entering Idaho City, where there is more traffic and pedestrians. The spike strip was successful in deflating one of the tires on the suspect vehicle.

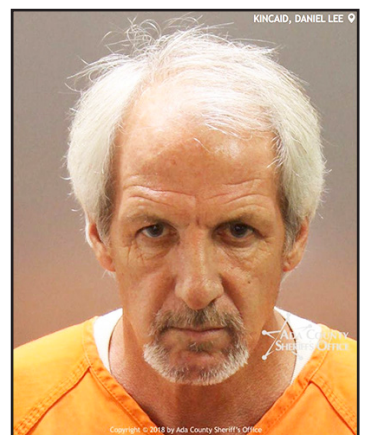
The suspect drove at high rates of speed through Idaho City and the Boise County Sheriff's Office units continued the pursuit after slowing through the city. When the suspect vehicle turned onto a US Forrest Service Rd north of Idaho City, Boise County Sheriff's Office units followed.

Approximately one quarter of a mile from the highway, a PIT (Pursuit Intervention Technique) maneuver was initiated by the pursuing Boise County units. The suspect fled on foot and a Taser device was deployed during the foot pursuit.

The suspect was taken into custody and booked into the Ada County Jail on Felony Eluding charges from Boise County and accompanying charges from Boise City Police. The vehicle and its contents were turned over to Boise City Police.

**Editor's Notes:** Daniel Kincaid, 57, was cited in this case. He will not be released out on bond, as December 3rd, citing: "This individual will not be released from custody due to a nonbailable charge(s)." The case will be handled in Ada County court.

There were many witnesses in this highspeed chase. Luckily, there was no one injured during the 100+ mile per hour pursuit through Idaho City and along Highway 21.

Kerry LaMana found herself suddenly single, starting her life over and single-parenting a young son last May. Since then she has generated income in a variety of ways and tried to make plans for the future. Photography, selling eggs at the farmer's market, driving a school bus, serving food at a retirement home and cleaning homes and businesses were all considered. She joined a cleaning company for the short term. She really likes cleaning. She loves the challenge of making places that were dingy "sparkle." However, the cleaning company did not allow her to clean "the right way." They were all about cutting corners and maximizing profit.

Kerry's thoughts turned to being her own boss, doing the job that was needed and still making enough money to live on. She started her new company, "K&L Complete Clean," got a business license, liability insurance, and beautiful orange plastic business cards. Looking forward, when she starts to add employees, she will make sure that everyone working for her business is bonded. As an extra incentive, she often brings her fourteen-year-old son, Vincent along to help and to do extra chores as needed. She wants to make sure he understands that it's hard work to earn a living.

When prospective clients call, she tries to be flexible and work around their needs. She assesses what the clients need

and how they want her to work. Each home is unique and clients differ in regard to their requirements and their willingness to pay for what is needed. In that house she does only the "extra" items such as cleaning under the refrigerator, the base boards and "corners" that might be overlooked otherwise.

On the other hand, she did a "move out" clean in Ada county, where the renters of the home had had two dogs and at least one cat. It was crusty with grime and covered in pet fur. There was cat litter in the air conditioning vents. When she walked in the door, the odor of wet furry animals assailed her. Food was crusted on the stove and she had to empty the vacuum at least three

times in the course of the day. Even the refrigerator had not escaped the animal hair. Under the vegetable bins it looked like a hair carpet had been purposely installed.

Most of her clients are just busy and need a little help to keep their homes functioning and pleasant. Many of her clients work at home and simply do not have the necessary time to clean their homes. ## HSB Senior Signs Letter of Intent

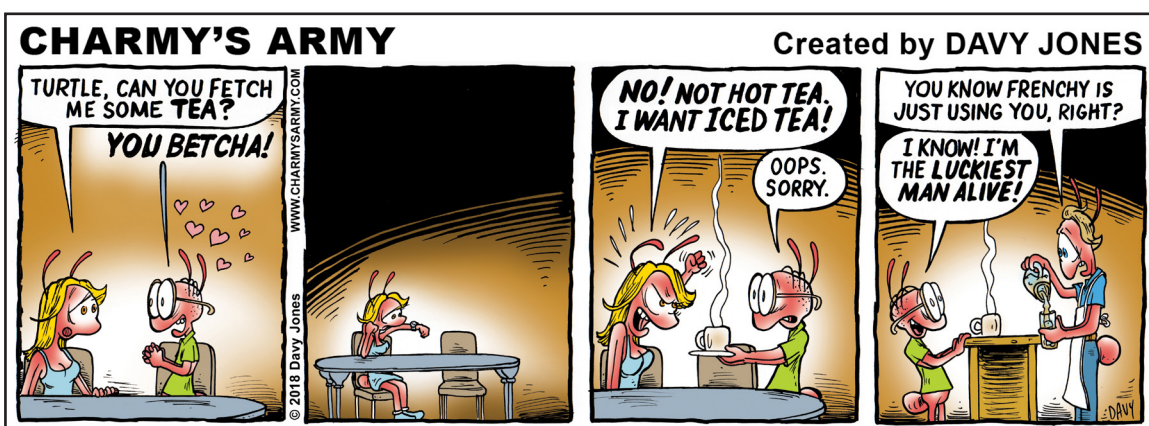
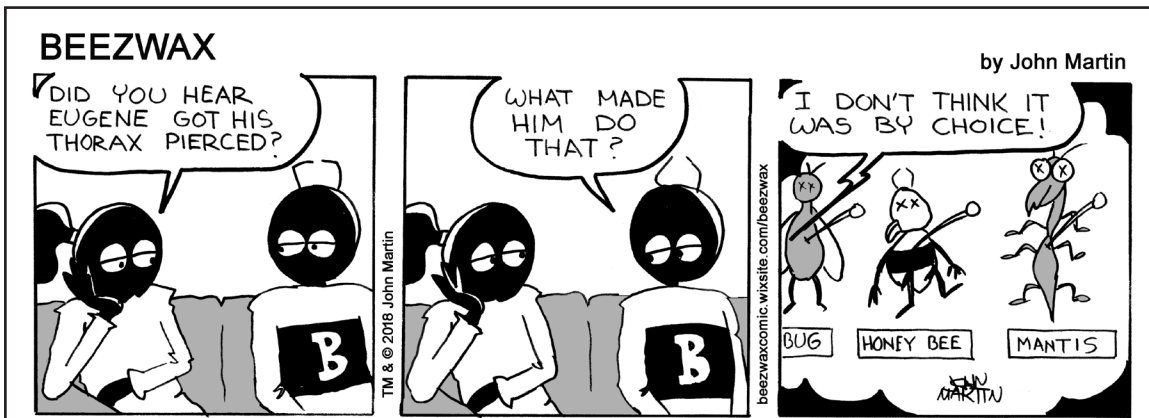

## Removal of AED Equipment Causes Big Uproar

**GARDEN VALLEY & LOWMAN** -- The Automated External Defibrillators [AED] in Garden Valley and Lowman sit on a wall and have not been given much thought or notice until the past week when AED's were pulled, temporarily after a decision was made by the Garden Valley Hospital Taxing District Board. Until then, most people did not know where these AEDs were housed. Removal of the potentially life saving devices, even a temporary removal, caused a big stir in the community. Social media lit up despite knowing little about what was really going on.

The new Board has been trying to get their "ducks in a row" after a tumultuous year for the Garden Valley Hospital Taxing District, including a petition asking the question of whether to dissolve the District completely or not, which then lead to a ballot measure. The dissolution was defeated. The new members on the GVHTD Board have been grappling with some items that had very little information provided to them.

The AED program was started approximately ten years ago. Purchases were made to buy AEDs for the Lowman and Garden Valley area. Subsequent years, there were a few more purchased. With no other information to go on, other than bills for AED items and paying a couple of people to do routine checks on the serviceability of the AEDs, no other documentation has been found. The new Board needed information from service logs, which were not available. The concerns were about the AEDs, what has expired and what work needed to be done with the units, if any.

Reasons for apprehension were due to possible liability if the units were not function

properly. No one knew if AEDs were being checked monthly and there wasn't an organized way of making sure the proper measures were taken. The Board made the decision at their last meeting to resolve the issue, particularly after they were pressed by the insurance company regarding liability without regular checking of the units.

The Board agreed that the last thing they wanted was a lawsuit from improper maintenance and then out of order AEDs when needed. So, to do proper checks and learn what is needed for each unit meant they felt the best thing was to remove the units temporarily. This cause an outrage from places like the Library and the Market, who housed the units. Some felt there was no warning and were upset to have the life saving units removed for any period. The GVHTD Board saw it as an important measure to make sure a proper check and maintenance plan could be made. Comments on social media divided the community.

The Board worked on an organized way to document and keep track of inspections. Ultimately, the GVHTD called a Special Meeting to put on the record what transpired in creating a Custodial Agreement if a business or other entity wanted to keep the AED location. Bill Baker, GVHTD Chairman, admitted that if he had to do it all over, he would have given the custodians of the AEDs more notice of the plan. His intentions appeared to be good, but he saw the repercussions caused by lack of notice.

At the meeting, the plan was to reinstall them promptly, as soon as they got a log set up for each unit and a way to inform custodians what the check practices should be. The Garden Valley Library had several representatives attending the meeting, including Kerri Hart,

the Librarian Director. The GVHTD Board graciously accepted questions from the audience in order to make sure everyone understood what was happening and why. This seemed to ease a lot of frustrations felt by everyone involved.

The plan is to fix the problem of requiring monthly checks of the custodians of the AEDs. A log will be provided to make sure pads and batteries are checked. Some units are different or were bought at different times, though the documentation and systems of check are about the same. The new log will set a baseline. Volunteer members of the community will assist with helping to instruct AED maintenance to the AED custodians. By having organization, instruction and documentation, the AEDs will remain a functioning life saving device.

Fixing this problem includes getting people to step forward at each location and agree to do maintenance and document it. Then a situation can be avoided like the one that happened at Terrace Lakes. Their AED was not in a useful order and started beeping because of

expiration of the battery. Regular checks would have qualified this problem. It could have been brought back into working order without a lapse. If someone had needed the AED at that moment, it would have done no good since it was not operational. This highlights the reason the GVHTD Board has taken these measures to make sure the AED maintenance is done systematically and monthly.

At the special meeting, The Board was able to return the AED to Garden Valley District Library. The Library, in turn, signed a contract assuming responsibility for the monthly checks of the unit. The Library will be following the schedule of maintenance. They were quite happy to be involved in this way since they took on the responsibility to be a custodian of an AED in the first place. They left the meeting with the AED and thanked the GVHTD Board for the meeting to air our complaints and resolved them immediately for them. The Board wished other businesses would have done the same and could have attended the meeting instead of complaining on

social media. They could have gotten their plan of maintenance that evening and walked out with their unit as well.

The AED removal was only temporary and the GVHTD Board learned a lot about AEDs. The goal is to have everyone stay organized and protect the District from any fallout of improperly working AED units. The Board invites the public to attend their meetings. The input of the public is important to the Board. Baker said, "I would like to see people come to the meeting and fill up the room."

## Horseshoe Bend City Council Meeting

**HORSESHOE BEND** -- The following is a synopsis of the Horseshoe Bend City Council's 658th meeting on November 28, 2018. After the call to order, Pledge of Allegiance, the council's approval of the agenda, previous minutes, and the city's bills, and with no new business or old business on the agenda, Mayor Pat Goff opened with department updates. Council member Ryan Stirm spoke on behalf of the

EMS team, reporting that there had been a couple of small accidents and a few house calls. "There hasn't been much going on", he added. Goff stated that he was in the process of pursuing some grants but didn't elaborate. Public Works spokesperson Michele Brothers told the council "We're getting ready for winter, making sure everything is good." Brothers stated that the copper dam is starting to get pulled. "It's pretty much all out by now," she said add-

ing "Nothing too exciting is going on." City Engineer Amy Woodruff reported that preliminary reports for the production well were currently underway. She went on to say that there was a January 28 deadline for the city's Quality Assurance plan and the city's Operation and Maintenance plan had not been started but just needed updating. Woodruff informed the council that she was looking into the Emergency Response Plan and Public Notification

Plan with Brothers and Jobie Catherman. The city's attorney apprised the council that a letter had been sent to the owner of a property located on Hoff Street but that, while no written response had been received, he had spoken to the owner who stated that they were not engaged in running a half-way house in the city and that "further conversation" will be needed. Goff announced that the city had a bare bones website up and running on [http://](http://www.horseshoebendidaho.org)

[www.horseshoebendidaho.org](http://www.horseshoebendidaho.org). The city will soon be uploading ordinances, city financials and other pertinent city information. E-mail addresses for all council members will soon be available as well as links to the library, businesses, etc.. The meeting adjourned at 7:07 p.m.. The city next meets on Wednesday, December 20 at 7:00 p.m.

## Idaho Power Warns Against Utility Scams

**BOISE COUNTY** — Idaho Power reminds customers to be vigilant of scams year-round, but especially at the holidays. The busiest shopping time of the year is often the busiest time for consumer scams, including those involving Idaho Power.

**Be aware of these common scams:**

- Scammers call customers demanding immediate payment to prevent shut off. They ask for payment using Green Dot Cards or other pre-paid methods. Idaho Power does not request payment through pre-paid cards.
- Scammers ask for up-front, cash payments for Smart Meter installation. Idaho Power does not bill customers for meters of any kind.
- Scammers posing as Idaho

Power inspectors request access to customers' homes to check on wiring, heating units, meters, etc. They claim the item needs to be fixed and paid for right away.

- Scammers post shut-off notices on customers' front doors and demand immediate payment over the phone to prevent a disconnect. Idaho Power will always attempt to contact you via phone and mail before posting shut off notices and never demands immediate payment over the phone.

Always ask to see Idaho Power identification, and when in doubt, close the door or hang up, and call Idaho Power Customer Service immediately at 208-388-2323.

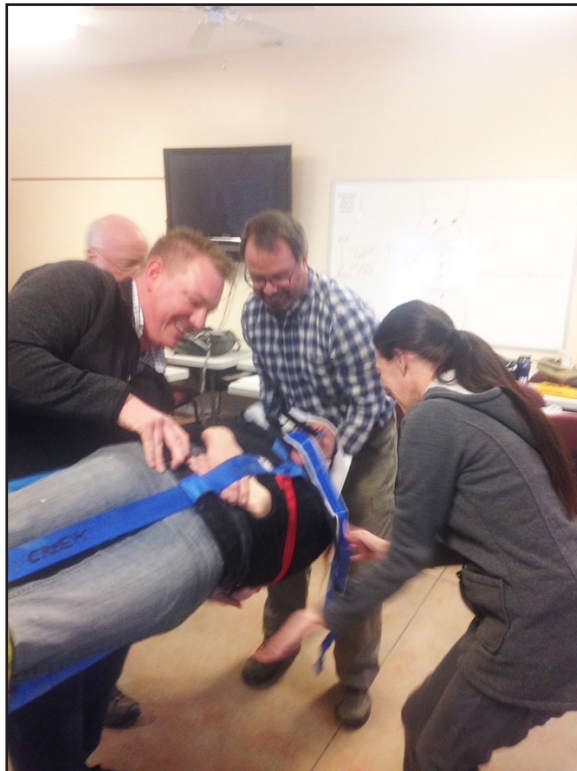

## Masonry Mastermind of Local Construction

**IDAHO CITY** -- Back in the 1970s, Robert Wyllie was working with the U.S. Forest Service to fight fires, and then tended bar at the Miners Exchange in Idaho City. One day he happened across an opportunity that would change his life. He learned about masonry. Wyllie picked up the craft quickly and completed several archways in the Miners Exchange building, and at the old Mercantile building across the street. He was then hired to build another large archway, a 2-foot thick stone wall, within which space, a restaurant was later built. Surprisingly, Bob has done work at four different Boise parks: Manitou Park, C.W. Moore Park, Quarry View Park and Albertsons Park.

Having an eye for stonework, Bob was asked to work on other masonry jobs, all of which were secured by word-of-mouth. Never having to advertise, he began to put down roots and started construction on his own home located south

of Idaho City.

A feather in his cap came when he was asked to work for Carole King, a famous song writer and artist, on her home's new construction in Robie Creek. The two remained good friends and he later came to work during the summers on her home at the Robinson Bar Ranch, located downriver from Stanley. He was able to design a recording studio like no other, and even put in stonework for a greenhouse and patio.

Wyllie was later asked to help develop *The Springs*, a hot springs retreat, located near Idaho City. Kurt Gindling, Manager of *The Springs*, immediately knew this man's vision would move the work forward so that they could once again open the resort. It was decided to remove the old existing building and to tap into the natural resources of the land. Recyclable materials were used in the construction of the main building, allowing

it to "breathe" and for the underlying hot water to warm the building naturally. Finding that there were several springs on the property, they were able to plan for future endeavors and potential growth.

Four private pools were constructed, recently, unlike anything that had ever been seen before. Gindling was amazed with the rough drawings by Wyllie, which were basically

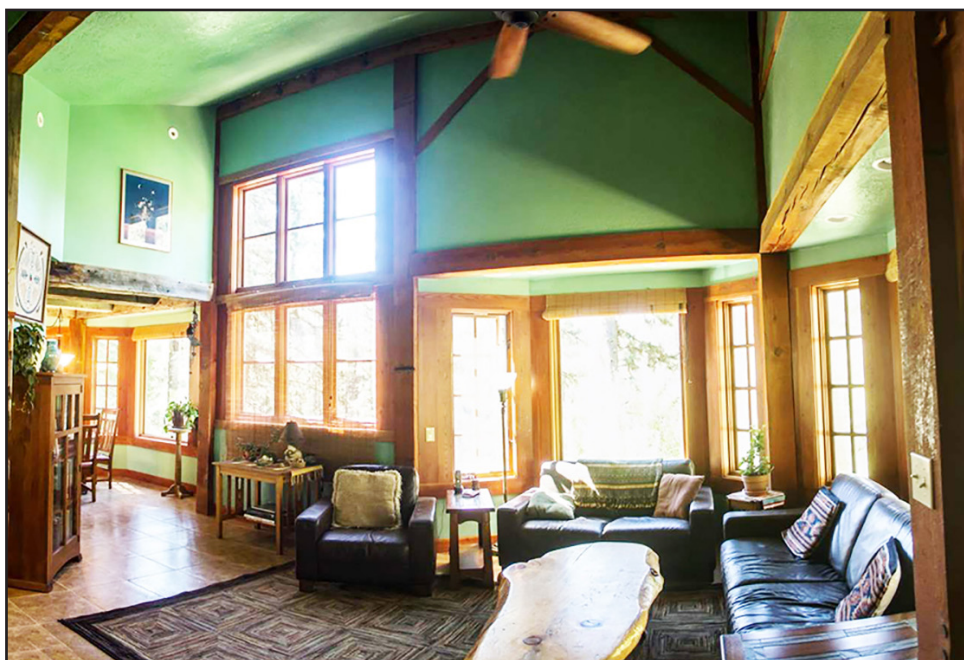
the ideas that they went with for construction. It was designed for privacy, but opened up to the back hillside. The structure separating the four pools is very sturdy in its construction, enough to hold soil at the top and allows for planting trailing vegetation.

At 64 years of age, Bob

Wyllie decided to retire from 40-years of construction work. He is selling his beautiful now working on building a new home for himself and his wife, Kim. Still having a hard time sitting still, Wyllie disclosed that he was very much looking forward to having more time to be creative and make things.

Grant says, "Although it looks scary, it's one of the safest knives, because your fingers are not in the path of the blade." It has "automatic double action out the front." It sells online for \$1200.



Grant & Gavin Hawk describe themselves as "mechanically minded," engineering designs that are both new and different. They have sold their designs to several top companies in the nation and are even known worldwide for their unique designs. Brandi is assembling one part in the process to manufacture these knives, which are "sold out"! She is also wearing a designer knife, that resembles jewelry, with inlaid abalony shell.



Gavin grew up in Idaho City and would help his father after school, learning to make knives. He is now a designer and promoter. They attend several knife shows a year. When asked which is his favorite knife, he admits, "My favorite is always the one we're working on."



Metal is bought in thick sheet, cut into appropriate sizes and used to fabricate knife parts with the use of several machines.



This is their newest 2018 machine that takes in computer coordinates to make and design metal pieces for assembly.



This is their most famous knife design. It has been duplicated and replicated in China many times over. Grant says that friends often send them knives that resemble this one, which they pick up at places like truck stops.



Metal filings are filtered out in this closed system that recycles the lubricant and water.

Grant and Gavin developed the design for a multi-tool with large knife that was sold at Walmart for Father's Day five years ago. That special sold 250,000!
