Metro Meals on Wheels Menu: Thursday, April 11; Roast Beef & Gravy, Mashed Potatoes, Mixed Vegetables, Ice Cream, Roll and Milk. Tuesday, April 16; Monterey Chicken Breast, Roasted Potatoes, Corn, Jell-O Salad, Roll and Milk. Thursday, April 18; Polish Sausage & Sauerkraut, Baked Beans, Dilled Carrots, Fresh Fruit, Bun and Milk. The meals are for anyone of all ages who wants to enjoy a healthy meal with sizable servings. This is not just limited to Seniors. Anyone under 60 years can come and eat at a simple \$6.00 cost. Seniors are \$4.00. Cooks come each week from Boise and prepare these meals. Standards of nutrition are set ahead of time. These meals are not institutionalized food, but prepared fresh.

Granny's Closet is still going strong, with open hours from 11 am to 5 pm on Friday and Saturday. Come check out the selection. Spring and summer items will keep filtering in from storage, so there is something new to see very often. There is more sorting, cleaning and store arranging

than volunteers can keep up with at times. If anyone is interested in working in the store from time to time or helping with items, just let the Senior Center know. It is a fun process and it becomes a social time.

Speaking of Social time, the FAST (Friday Afternoon Social Time) is still going strong. A time for snacks and any beverages you would like to bring and enjoyment of friends every Friday creates strong bonds of friendships. When everyone lives miles from each other, the Senior Center provides a place for social activities. Sometimes people's homes are not large enough to accommodate many couples, so there is a comfy corner in the Center to meet up. The time for this FAST event is from 5:30 pm to 7:30 pm every Friday and is free. Unwind and enjoy great conversation.

The Wednesday dancing aerobics class is another social activity that allows a bit of fun while sweating it out. These exercises are made for having fun and are for any level of ability. Some people have injuries

that prevent them from doing exercise standing, so they can do exercises from a chair. As long as there is movement, the ability is negotiable with each individual. Come on out and be a part of a fun process every Wednesday afternoon at 4:00 pm.

A **Spring Clean Up work party** will be Monday at 11 am on April 22. The Center needs a little sprucing up on the inside. Hoping there can be a chance to do outside as well, but weather and volunteer dependent. Many hands make light work and a lot of laughter. Volunteers have stepped up, but the Center can always use more and hopefully the tasks can be completed quickly. Remember, Garden Valley, this is your Senior and Social Center.

The state of our county roads needs attention. How best to plan for the future would be 2 options as I see it.

Option 1

A levy for a fixed amount every year. This would put the money under the control of the County Commissioners. So far they have had EBCAD under their control and no Ambulance in operation in their \$300,000

Placerville Ambulance Building since it was built. One of the Commissioners stated that just because they were elected from a certain district they represent the entire county and not that district.

Option 2

Put in a Boise County Highway District with 5 Commissioners that mirror the Republican Precincts. This would

give each area of the county an equal voice in maintaining and repairing of the roads. It would also secure a reliable funding for the future instead of relying on the whims of the Federal Government. This option might cost every property owner \$50 to \$100 a year but would be well worth the investment.

Opinion ~ Author Speaks Out About Depression

GARDEN VALLEY -- A new inspirational writer has joined the ranks of published authors in Garden Valley. Sharon Svenson is one of twenty-five contributors to a newly published book: *Rise—In Pursuit of Empowerment*. As you read, you are shown many different perspectives from women who have come to realize that joy is a process. They are united in the desire to share with others the beauty of living free of the fear of “not being good enough, not being strong enough, and not being rich-skinny-pretty-clean-smart-accomplished-educated-nice-sexy-well-liked-nurturing-capable...enough.”

In Sharon’s story, she writes about finding joy by overcoming severe depression, crippling panic attacks, and suicidal thoughts. She was the devoted mother of two young children and she wanted to do the “right” things for herself and her family. She decided that none of the usually-recommended paths exactly suited her situation, but she kept searching and was amazed to find the power she needed within. The book goes on to relate how depression came to rule her existence. By releasing negative thought patterns, Sharon has let go of social anxiety, depression, binge eating, extra weight, allergies, asthma, migraine headaches, and back problems. With the release came fun, energy, creativity, and the inspiration to follow her dreams. It led Sharon to learn to play the guitar, write and perform her children’s stories, take up yoga, attend fire

dance camp, and create Svenson Hypnosis.

As a hypnotist, Sharon has worked with over 1,000 clients who have reclaimed their health, gained freedom from crippling depression, eating issues, anxiety, and negative thought patterns. She has testimonials from clients thanking her for helping them obtain the lives they had only dreamt of before coming to ask her help. Now they can make those dreams become their reality.

Rise—In Pursuit of Empowerment will help readers develop a sense of what life can be by:

Lowman is Preparing for Spring

LOWMAN -- It's springtime in the West Central Mountains and local Lowman businesses are gearing up for the spring and summer to come! With the arrival of warmer temperatures, seasonal businesses are readying everything to greet the summer visitors and recreationists. The back-basin river drainages on the south slopes of the Sawtooth mountains have snowpacks ranging upwards of 150% of 'normal,' meaning the runoff should create some fantastic springtime kayak and river rafting. The runoff normally gets underway on/about the end of April into early May. Rafting Season extends until September-October, depending on river conditions

The snow around Lowman is receding fast and the south-facing hillsides are all but bare. Still, there can be quite a bit of snow on the north-facing hillsides and in the shade on the valley floor. Forest Service campgrounds will remain closed until the snow is completely gone and maintenance is done for opening. However, that means private business is already picking up a bit on the weekends for the lodging, motel, B&B and eating establishments. South Fork Lodge, Haven Hot Springs, Sourdough Lodge, and Eagle Horizons Mountain Oasis B&B staff are

all seeing spring traffic beginning to pick-up. All those establishments are now open partial or full-week schedules.

Several have sleeping accommodations and eateries, with the Lowman Inn having pizza, beer, and wine, along with local entertainment. Local folks say, "The best pizza within 50 miles!" Some have partial menus, others have full, regular menus, with some carrying weekend specials. Folks just have to call to check (See list of establishments) on accommodations, hours of operation, prices, availability, etc.

As the back-basin snowmelt starts bringing the river up, so too, will Payette River Co. begin spring rafting season. The Lowman canyon always brings great Class III-V conditions depending on which parts of lower canyon one wants to try. Above Lowman, conditions vary greatly with each passing week depending on day/night temperature variance. Further up, Sawtooth Lodge in Grandjean opens a bit later into May, depending on the snow conditions.

Sawtooth Lodge offers everything from cabins to camping and pack trips into the Sawtooths (SNRA). Along the way are the different Hot Springs camps and facilities at the Haven HS Pool, Kirkham campground, Bonneville, and

Sacajawea on the way into Grandjean. Sourdough Lodge and Southfork Lodge each have a restaurant, cabins, and motel. In addition, the Sourdough offers a quickie store and liquor sales. At the junction of Banks-Lowman Road and Highway 21 the "Open Door Store" offers a wide variety of groceries, goods and supplies along with fuel

After the private facilities, of course, there's plenty of regular and forest camping soon to be opened from Lowman to Grandjean, through Forest Service campgrounds. The Lowman District Office also offers wood and timber permits for cutting and collecting firewood during the season.

Obviously, there's no shortage of things to do in the spring and summer around Lowman and all of the various enterprises invite their Boise County friends, neighbors, and the Treasure Valley dwellers up for a visit this summer to check them out!

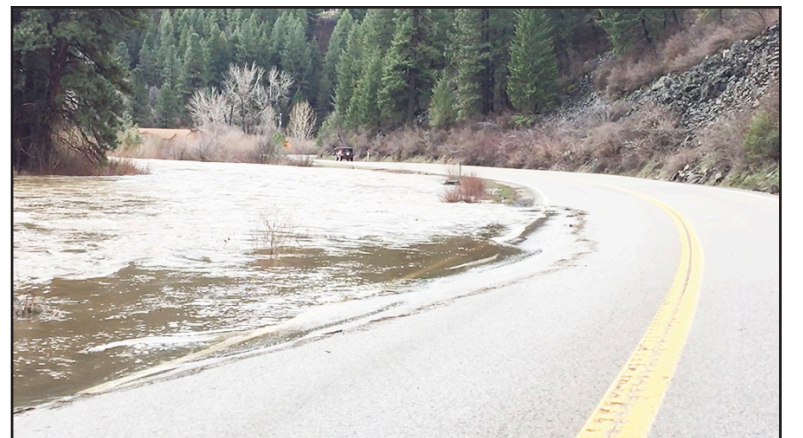
