Accident on July 3rd, K9 Sweep Indicated Drugs May Be Involved

CLEAR CREEK -- Rick Anderson of Boise was headed to the Clear Creek area on Grimes Creek Road on Wednesday afternoon, July 3rd, when he reportedly "blacked out" and struck a large pine tree. He was attended to by an East Boise County Ambulance and the Wilderness Ranch Volunteer Fire Department. The patient did not need to be extricated from the Chevy truck, although it received significant damage to its front end.

Anderson was then transported by ambulance to an awaiting Life Flight helicopter in a landing area nearby. He was flown to a nearby Boise hospital for further medical care.

Records show that on July 1st, this same individual was involved in an early morning slow pursuit into Ada County. Again, he had come out of the Clear Creek area, between

two and three o'clock in the morning, and was stopped by law enforcement. The Chevy Tahoe which Anderson was driving had a strong odor of marijuana and other indicators of a drug distribution. In addition, the occupant had a large roll of twenties in his back pocket, separate from his own cash in a front pocket.

On that day, Anderson decided to leave the scene, after the traffic stop, and was pursued by a Boise County Sheriff's Deputy, traveling under the speed limit, all the way into Ada County. A spiked strip had been put out by Ada County officers near the High Bridge to puncture the tires of the vehicle. However, the 57-year-

old man continued on the rims, finally coming to a stop near Gowen Road. Rick Anderson was charged with two misdemeanors: Eluding - under 40 mph and Driving Under the Influence.

On July 3rd, after the accident on Grimes Creek Road, a Boi-

se County K9 did a sweep on the truck, and alerted on a cell phone and notepad for possible drug residue.

As of Tuesday, July 9th, Anderson is still in the hospital, but has a court date of July 15, at 9:30 am in Boise County Magistrate Court.

who did not cite them.

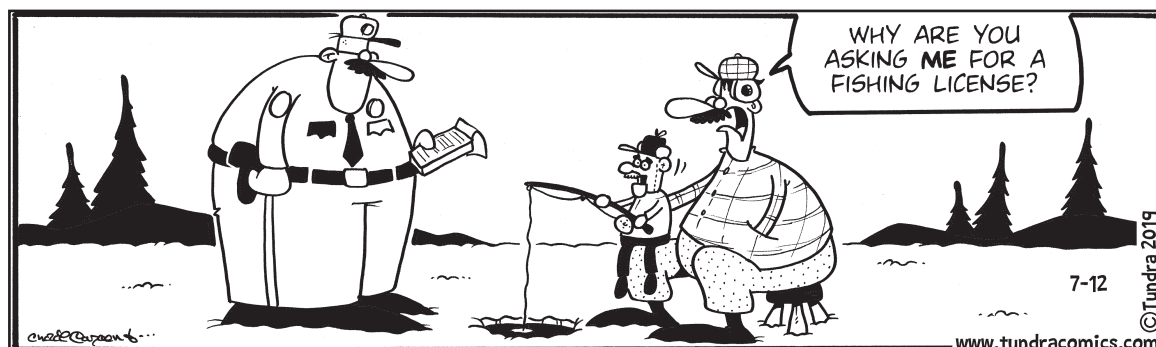
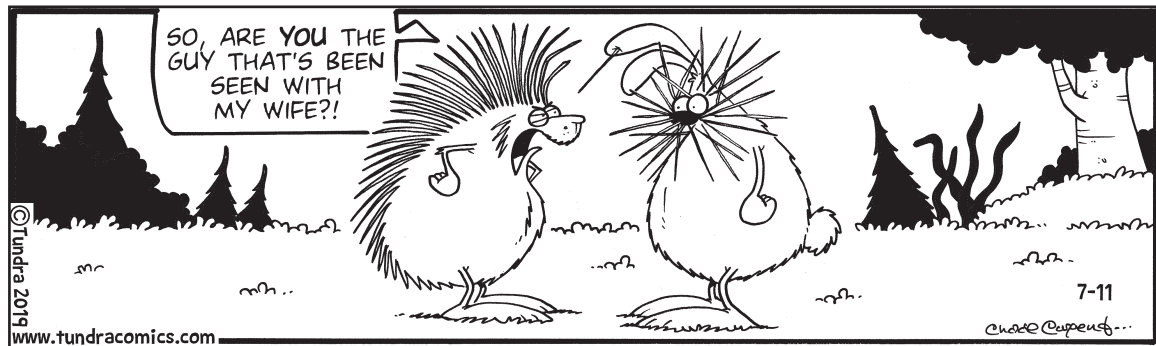
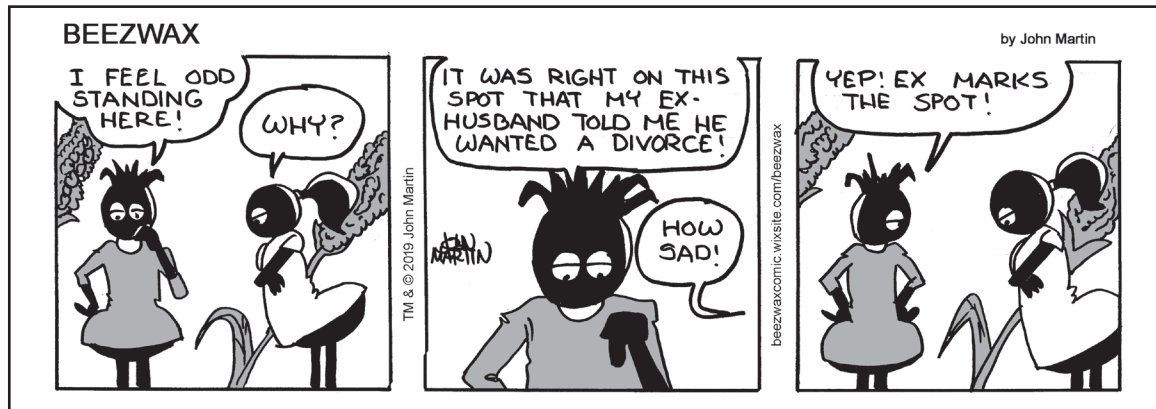

Mountain Kids Day Camp in Idaho City

IDAHO CITY -- The last week of June was an exciting one for Idaho City area kids and teens, as Mountain Kids Day Camp had another great week of camp. You'll no doubt see many kids walking around town proudly displaying their bright green camp t-shirts. There were 74 campers and about 120 volunteers learning about the life of Jesus and having lots of fun at Camp Ivydale, June 24-28. Of the 120 volunteers, about half were counselors, and most of those were local teens who volunteered their time to make a difference in the lives of Idaho City kids. Many of the teens were once campers when they were younger, and this was a chance to give back to their community. Campers are ages 6 - 11, and they were "lavished with love for a week."

Campers enjoyed many activities such as archery, pottery, woodworking, swimming, making sock puppets, doing origami, finger-knitting, and making bead creatures. They painted, they glued, they decorated hats and t-shirts, and made a large variety of crafts. A spin art machine made by local resident Floyd Hope was a huge hit with everyone - those pictures turned out beautifully, and each was unique. Krista Young showed the kids how to make gorgeous colorful tiles painted with ink and rubbing alcohol. On Monday, geologist Joe Puccinelli talked about rocks with interesting displays. On Tuesday, Heather Hayes, a biologist with the Intermountain Bird Observatory came to catch and band hummingbirds so the campers and counselors were able to see them up close and even touch several hummingbirds. MJ Oresik came on Wednesday and Thursday afternoons with interesting information about bee keeping, a great thing for all the

MKDC was fortunate enough to have 12 brand new colorful ukuleles donated this year. Retired Boise music teacher, Paul Olson, came each day and patiently and enthusiastically taught campers and counselors how to play several chords and songs. There was even a "ukulele concert" at the Thursday evening family dinner.

Many local Idaho City area folks helped out as volunteers this year. Local adult counselors included Ray Eklund and Chris Heacock. Jim Bronson and Gary Campbell, assisted by Erin Capson, supervised woodworking and helped kids make bird feeders. Arts and Crafts Coordinator, Tonya Caward, led a huge contingent of volunteers who did arts and crafts with the kids. Rhonda Jameson led early morning games; Krista Young led mid-morning games. Kendra Lanham and Lynette Claypool helped kids make clay pots on two pottery wheels

Re-Channeled in Garden Valley Area

GARDEN VALLEY / CROUCH -- On Tuesday, July 9, the Idaho Public Television signal broadcasting to the Garden Valley/Crouch area was re-channeled.

Following the July 9 re-channeling, viewers in the Garden Valley/Crouch area who receive IdahoPTV via an over-the-air antenna will lose their signal and will need to perform a rescan of their digital TV sets or tuners in order to receive the updated channels. After rescanning, viewers will continue to find IdahoPTV on broadcast channel 4.

Information on performing a rescan is located here: fcc.gov/rescan.

K41EO-D is the translator in the Garden Valley/Crouch area for IDPTV, currently broadcasting on frequency channel 41 (but received by television tuners on channel 4). Telecommunications company T-Mobile has purchased that frequency and is paying for us to relocate to a new channel (frequency channel 8, which will also be received by television tuners on channel 4).

In 2017, as part of the FCC's nationwide Broadcast Spectrum Incentive Auction, T-Mobile purchased spectrum in the 600 MHz block across the continental United States to bolster their cellular network. The Garden Valley/Crouch transla-

tor sits in the middle of T-Mobile's purchased spectrum and is required to change channels or terminate operations entirely. IdahoPTV was successful in applying for and receiving a new channel assignment to continue broadcasting in the area.

"A nod should be given to T-Mobile in that they graciously offered to pay for the equipment and services necessary to relocate our service to a new channel," says Rich Van Genderen, IdahoPTV's director of technology. "So although this is an inconvenience, at least it isn't an unfunded mandate for us to meet."

Address Given at the Flag Raising in GV

Bob Seal gave a beautiful address at the well-attended dedication, in honor of the 4th of July:

Good morning, it's an honor for me to be here with you today as we celebrate Independence Day.

On some Federal holidays we celebrate someone else's birthday, on others we recognize those who died in the service of our County and those who served in the military, on yet others we recognize a European explorer, the labor movement, a day for giving thanks, and a Christian holiday. But Independence Day is OUR DAY, a day for each and every citizen of the United States to celebrate our Nation's independence.

Increasing tension between

the Colonies and Great Britain resulted in open combat in April 1775, when the British attempted to disarm the Massachusetts militia. Fighting continued for more than a year before the Continental Congress issued a Declaration of Independence on July 4th 1776 that formally announced the Thirteen Colonies were at war with Great Britain, and that they regarded themselves as thirteen sovereign states no longer under British rule. The Revolutionary War continued another seven years until September 3, 1783, when Great Britain formally recognized the independence of the United States.

The independence that we celebrate today did not come easily and has not been eas-

ily maintained. Peace for the newly founded United States lasted only a few short years before its independence was again challenged by war with Great Britain. The War of 1812 lasted three years, and although the British attacked Washington, DC, and burned multiple buildings, including the White House and the Capitol building, the war ended in a draw.

Perhaps the greatest challenge to the United States as we know it occurred during the Civil War that lasted from 1861 to 1865, and found over two and a half million Americans at war with each other. The Union prevailed and the States remained united as one Nation. Special to me is that on this day - July 4, 1863 - one of my ancestors who was a soldier in the Union Army, was killed in battle defending the preservation of that union.

In the 154 years that have followed the Civil War, the independence of the United States was again tested by two World Wars and several regional wars. On each occasion the citizens of the United States have bound strongly together to face the challenge and our independence has continued to flourish.

In 1777, during the War for Independence, the flag of our Nation was born when the Continental Congress adopted the stars and stripes, and it has since become an inseparable symbol of our Nation and our

independence. The Flag represents the founding principles of life, liberty, and the pursuit of happiness, as well as the freedoms we enjoy each day; freedom of speech, freedom of religion, freedom of the press, and the sanctity of our homes. We truly live in the land of the free and the home of the brave.

In a few minutes Bud Paine and Jon Metz will raise the American Flag and the Starlight Singers will lead us in the National Anthem. As the flag rises and then furls at the top of the staff, reflect on the courage, dedication, and foresight of our Founding Fathers. Then as you listen to the National Anthem, carefully consider the words penned by Francis Scott Key

as he observed the Star-Spangled Banner that flew over Fort McHenry in Baltimore Harbor during the War of 1812.

It doesn't matter if your ancestors have lived on this land for eons, if they arrived on the Mayflower, or if you became a citizen last week - as a Citizen of this great Nation today is YOUR Day to celebrate!

I wish each of you a wonderful Independence Day and thank you for allowing me to share part of this special day with you. God bless you and your families, and God bless the United States of America.

Caught in Los Vegas, Headed to District Court

IDAHO CITY – Jeremy E. Hansford, 49, and Bessie M. Peterson, 41, were taken into custody in Los Vegas after fleeing from Idaho City, in which they lived for less than a year's time. On April 25, 2018, the city of Idaho City adopted a zoning ordinance, known as Ordinance No. 352, in accordance with Title 67, Chapter 65 Idaho Code (local land use planning act), Title 50 Chapter 13, Idaho Code (plats and vacations), and Article 12 Section 2 of the Idaho State Constitution, as currently comprised or as subsequently amended.

If you live within the city limits or have a business within the city limits, you are required to obtain a building permit. Repairs generally do not fall within this category, but most new construction does.

Failure to do so would be in violation of the city ordinance and penalties may be applied.
