Paraglider has Fatal Accident in Horseshoe Bend

HORSESHOE BEND --

Horseshoe Bend Flight Park and the surrounding community suffered a tragic loss on Monday, July 15. Paraglider Justin Boer, co-owner of the flight park (along with Scott Edwards), had a fatal accident, which apparently was caused when a reserve chute failed to deploy during flight. Edwards said, "It was a tragic accident, a tragic situation."

Edwards and Boer had been friends for over 7 years and

started the flight park together in 2017. Boer was a United States Hang Gliding and Paragliding Association certified pilot, as is Edwards. Edwards was flying with Boer and landed next to him, as he had in June of 2013 when Boer had a previous paragliding accident that left him with a severe spinal cord injury. After that accident, Boer moved to Maui to begin his recovery, and with intensive therapy he was able to paraglide again. "He was an inspiration, he would not

stop," Edwards said of Boer.

Horseshoe Bend Flight Park, Boer, and Edwards have been big supporters of the community and Edwards vows to continue on, stating: "We have a solid team behind us, including the Boise County community."

The Boise County Sheriff's Department and the coroner's office are still investigating. Edwards is planning on halting flights at the park for a short while, but he will be at the park for those that want to stop by. The park is located at 235 Old Emmett Road in Horseshoe Bend, adjacent to the Horseshoe Bend Waste Transfer Station.

A memorial service for Boer will be planned for a future date. During a previous interview with *The Idaho World*, Boer wanted would-be paragliders to "get ready for a life changing experience." He added, "It's the best thing I've ever done."

Office statement: The incident occurred yesterday at the Horseshoe Bend Flight Park, Boise County Emergency Dispatch was called at 11:07am.

The man was identified as 38 year old Justin Boer, he was pronounced dead at the scene. The family was notified and it is an ongoing investigation.

Garden Valley Fire Dept. Update:

GARDEN VALLEY -- The week of July 7 through July 14 was a busy week regarding water emergencies on the Payette River. Starting on July 7, Garden Valley Fire was dispatched to Banks Beach for a possible drowning. On arrival, the victim was being attended to by river users as well as Bear Valley Raft and Cascade Raft employees. Garden Valley Fire EMS personnel, along with Air St Luke's, were able to perform a successful resuscitation. Outcomes like this is why we do what we do. (see more on pg 5)

Unfortunately, a few hours later that day, Garden Valley Fire was dispatched to Chief Parish Day Use Area for a possible drowning. Garden Valley Fire EMS personnel, along with Air St Luke's personnel, worked for approximately one hour to try to resuscitate the victim; however, we were unsuccessful.

On July 14, Garden Valley Fire was dispatched to mile marker 25 on the Southfork of the Payette for a possible drowning. The victim was lo-

cated near mile marker 23 and CPR was initiated. Garden Valley Fire EMS personnel, along with Air St Luke's personnel, and Payette River Company worked for about one hour;

however, we were unsuccessful. We were able to determine the victim had been in the water for about four miles after the raft he was in went over Big Falls.

It takes about that same number to run Granny's (storekeepers as well as behind the scenes people who sort and restock the store). Currently we have five trained volunteers to run Bingo. When we do our annual fundraisers, such as the 4th of July Pancake Breakfast, about 13 people are on the crew list.

The GVSC is not the only organization in town that depends on volunteers to meet the goals of the specific organization. Other examples

Going Above and Beyond Saved a Life

GARDEN VALLEY -- It was the perfect day for the Sparks family to go the cabin in Garden Valley on Sunday afternoon, July 7th. The warm weather had them packing for a picnic lunch by the beach. Nick Sparks went out with his 9-year-old daughter, Kennadie, into the water. He dove under the water, came up and then went back under. His wife,

Melissa, thought they were just playing, but then saw Nick floating face down and sinking. McKynlee, 12, was able to get to her dad first and brought him up, with the help of others who helped carry him to shore.

Several individuals began CPR, and when Garden Valley Fire Rescue and EMTs arrived, they continued these efforts. Melissa was able to flag

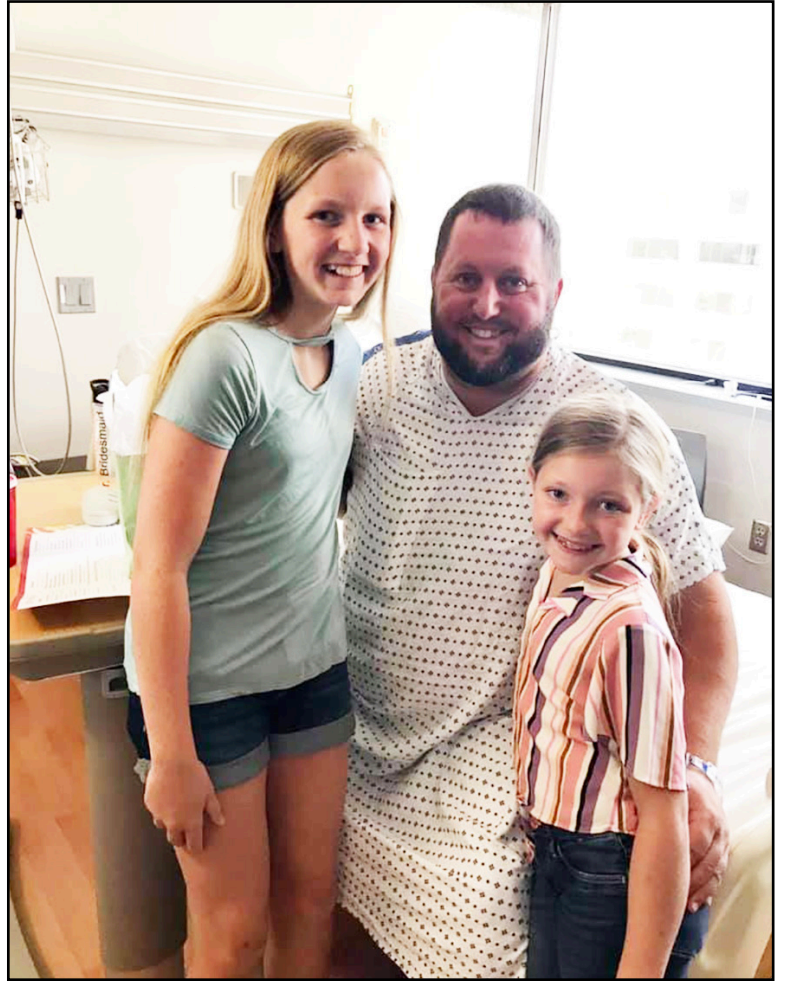
down a raft on the river from Cascade Rafting, which had a defibrillator onboard. Nick was given CPR for 30 minutes and five charges with the defibrillator. Other people on the beach were very kind to distract and take care of the children.

When Nick was stabilized, a Life Flight helicopter flew him to St. Alphonsus Hospital in Boise.

Within the hospital, the family learned that Nick had two abnormalities of the heart that were spurred on by the cold water, triggering him to go into a cardiac arrest, and caused him to nearly drown.

According to his mother, Vicki Sparks, Nick had an internal defibrillator implanted on Tuesday.

He is recovering well at home in Meridian. Vicki said, "I'm not burying my son this week. There are no words to express how grateful our family is for the rescuers and all the kind people at Banks Beach that day." However, she thought her granddaughter Kennadie said it best, "Thank you for saving my Dad. You are my heroes."

Beat the Heat with Summer Energy-Saving Tips & Programs from Idaho Power

BOISE COUNTY -- Hot weather has arrived, and that can mean increased energy use as we keep our homes and businesses cool. Idaho Power has a few tips for staying cool and managing your summer energy use (and bill!) when it's hot outside.

- Close doors, windows, and blinds during the day when you're out of the house, especially on the east and west sides. If safe to do so, open them at night or in the morning to let in cooler air.

- Consider installing an attic fan to draw hot air out of the house.

- Consider installing a ceiling fan in rooms used frequently. Moving air can feel up to four degrees cooler than still

air. Ceiling fans are effective in homes both with and without air conditioning. Turn them off when you leave the room.

- Turn the air conditioner off when you're going to be gone for an extended period. Make it easy by installing a programmable thermostat to allow for higher temperatures at night and when you are away, without sacrificing comfort when you need it.

- Change the air filter in your heating/cooling system. Dirty filters reduce a system's efficiency.

Not sure where to start? A home energy audit is a great first step if you want to make home improvements to save energy. An audit can determine where your home wastes en-

ergy and how you can change that.

- The program offers a reduced price for a home audit done by an experienced, certified professional.

- The total value of the audit is \$445, but participants pay only \$99 for all-electric homes and \$149 for homes with other fuels.

- The auditor will come to your home and identify key energy-saving opportunities like insulation, windows and doors, lighting, and heating and cooling systems. The auditor may also install energy saving items like LEDs, showerheads, or pipe wrap.

FIRE Ignited Boise National Forest



BOISE COUNTY -- July 16, 2019 -- Fire crews are responding to several new wildfires reported within the Cascade and Lowman Ranger Districts.

The Canyon Fire located south east of Bull Trout Campground within the Lowman Ranger District was reported at approximately 5 p.m. on Sunday afternoon, July 14. Crews have arrived on scene and reported the fire has grown to approximately 137 acres.

The fire is located 14 miles west of Stanley, Idaho in very steep terrain, making access for firefighter difficult.

Currently, there are 113 personal on scene, including hand crews, helicopters, and engines

with additional resources ordered.

Within the Cascade Ranger District, firefighters are also responding to several smokes reported near Warm Lake. Initial reports indicated fires were less than an acre in size.

There are no threats to life or property and the cause of the Canyon Fire was lightning. Remaining fires are under investigation.

Forest officials ask the public to be extremely careful with all flammable materials. With the increase in temperatures and decrease in humidity, fuels are drying out quickly and the potential for wildfire ignitions rises daily. Smoke may be visible along State Highway 21.

Extinguish Campfires

Forest Service wants the public's help to extinguish campfires

BOISE COUNTY -- Fire managers want to urge forest visitors to completely extinguish campfires before they pack up and leave the woods. With higher temperatures, fuel conditions are expected to dry out, increasing the risk of wildfire ignitions. Over the 4th of July holiday, Boise National Forest employees discovered multiple abandoned campfires.

"We are at that turning point where temperatures are rising and forest vegetation is drying out; add unattended campfires to the equation and the risk of a human-caused wildfire increases significantly," said Ste-



ve Baran, Assistant Forest Fire Management Officer. "We are asking the public to help us by ensuring their campfire is out and cold to the touch whenever they leave camp. Otherwise, someone should stay at the site if the campfire is burning or holding heat."

While fire season has been a slow start in Southwest Ida-

ho, Boise National Forest fire crews have already suppressed a number of lightning-caused fires.

Last year within the Boise National Forest, firefighters responded to 18 human-caused wildfires which burned more than 6,000 acres compared to the 13 lightning-caused fires which burned about 152 acres.

Magistrate Court Update:

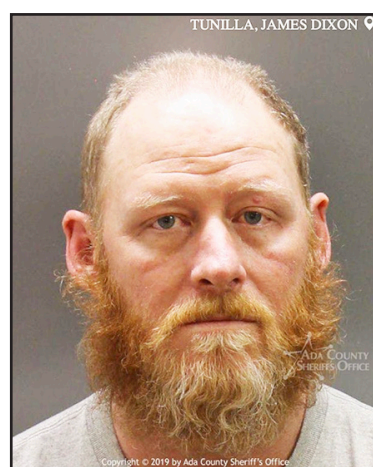
IDAHO CITY-- Mr. James Tunilla, of Idaho City, was in court on Monday, July 15th, per sixteen felony counts of video voyeurism. He is also being held at the Ada County Jail on three felony charges of intimidating or threatening individuals from testifying in this criminal or juvenile case.

SD cards had been found, made by the suspect, containing videos of underaged girls showering in his bathroom. The girls testified that these were certainly made without their consent and they had no

knowledge of a camera being inside a speaker, which was set out on the counter of the bathroom.

The two SD cards had been turned over to law enforcement, and brought to a crime lab for further examination to verify date stamps.

Magistrate Court Judge Roger Cockerille found that the State provided "substantial evidence" and would bind this case over to District Court. Tunilla will be arraigned in District Court on August 16th at 10am.

A Brand New Life for Judy Hansen

GARDEN VALLEY -- Judy spent six years on a list, waiting for a new kidney donor. There was a criteria for each step of the process, but now she was near the top. Her specialist, Dr. Chris Keller, a Nephrologist, told her that when she received her new kidney, "You will not believe how good you feel!" Judy says he was absolutely right, adding, "It was a long, hard journey, but oh, how worth it."

Judy was living a reasonably blissful life with good health, as far as anyone knew. There were no symptoms, nothing to disturb her hectic routine of work, family, and church. The first sign of trouble came in the form of a phone call. Her daughter received a diagnosis that prompted the family to talk about the possibility of an inherited disease, called Polycystic kidney disease (PKD).

Judy started seeing a nephrologist regularly. When her kidney function declined, she signed up with the University of Utah Transplant Program. As time went on, with no match, she signed up with the Swedish Hospital as well. Soon after that, she qualified for the National List.

To ensure that no kidney is "wasted," each one has to be matched to each eligible recipient, as closely as possible. There are many extensive procedures in place and each trans-

plant center has its own rules. For example, the University of Utah does not do transplants for people over age seventy. Other centers have rules concerning cancer or the number of antibodies.

Judy and John received "the get in your car call," from a member of the Salt Lake City team. Because this had happened before, they were hesitant to get their hopes up. The first time, when they arrived in Salt Lake, they went into the surgery prep room only to be told that the doctors had done a last-minute calculation and the tests showed that the kidney was not a match after all. They returned to Garden Valley with heavy-hearts and disappointment, but still hopeful that next time would be the "real deal," and the real-life miracle they were hoping for, that would provide Judy with a renewed sense of life, health, and vitality.

The call came while Judy was in the middle of her dialysis treatment. The medical techs told her, "You don't even have to finish your treatment. Just go get your new kidney!"

Judy said, "I could just tell that this time was different. Everything was falling precisely into place like it was meant to be."

They arrived in Salt Lake City at 10:30PM at night on March 21, 2019. The operation typically takes between six and

eight hours. Everything went well.

When the doctor came in to give her the post-surgery update, the surgeon said he had struggled a little to find exactly the right place to put the kidney. On her tiny frame, almost every place seemed too small. But, he was satisfied that the perfect spot had been found.

Protocol required that she remain in the hospital for four or five days, and then remain close to the hospital for twelve weeks. Post-surgery requires frequent lab draws and visits with the transplant team.

Hansen's recovery was so remarkable that she left the hospital after only four days, and was required to stay in the Salt Lake area for only a month, before she was allowed to go home to Garden Valley. Because of the cooperation between the clinic staff and doctors here in Boise, many of the tests have been done here in Idaho, minimizing the required trips to Salt Lake.

Judy says, "The best part was seeing the joy on the faces of everyone I knew, and hearing them say, "I prayed for you! We all fasted and prayed. As a result of this experience, I feel I can see far beyond this life. I can see the remarkable connections we all have with each other and the meaning of my life is magnified."

"Before I had problems with PKD, I felt healthy. and I had

a good life. But I have never experienced the pure joy that this transplant has given everyone who comes to see me, everyone who knows me or even knows about my journey." She added, "Before I became affected by this disease, I did not

check the organ-donor box on my driver's license application. I just felt that I should take care of my body and keep everything in it safe, where it belonged. Now, I would welcome, with joy, the opportunity to give someone what I have been given—literally a new

Paul Allen Frentress
1926 - 2019

Paul Allen Frentress, 92, of Centerville, Idaho passed away July 6, 2019 at home.

Allen was born 12/11/1926 in Caldwell, ID to Paul and Hazel (Piersall) Frentress. In 1932 Allen and his parents moved to Idaho City, ID so his father Paul could work the Idaho Canadian dredge, worked building the highway to Lowman, and working for the Depression-era Works Project Administration putting water lines. Allen had the best time growing up in Idaho City, ID. He could sit out on the porch with the old-timers, and listen to their history; where they spit tobacco juice, sometimes taking a chance on getting spit on while retrieving the nickels dropped through the cracks in the walkway. Where for 10 cents a movie you could go to the Old Weigel on Saturday nights. He would trip passersby with sticks in the boardwalk, ride sleds behind the milk delivery, catch snakes, steal cigars, play the penny slot machines. At age 10, Allen started driving and delivered groceries to the miners up on Spanish Fork Ridge working for the Mercantile (driver's ed course Allen would say.) While Allen's father helped build the Idaho Canadian dredge, Allen and his friends would ride their bikes and watch it work; and Allen worked on it after World War II ... until it tipped over one day. Allen attended school in Horseshoe Bend. However, there was no high school, so Allen stayed with his uncle in Nampa and went to Boise with everyone else.

Allen enlisted in the U.S. Marine Corps Jul 1945. He threatened to lie about his age, so his mother consented. He went to Saipan and Okinawa earning a presidential unit citation there and in Japan. Married Patricia A O'Brien Aug 17, 1946 in Caldwell, ID; later divorced Mar 11, 1960. In their fourteen years of marriage they had sons Matthew and Mark. While working at Bach's Photo Studio he was introduced by a friend to Barbara (Turner) Wiker, they were married Dec 18, 1961. At which time, Allen

took over as father to Curtis and Dennis Wiker. During their marriage, Barbara and Allen had a son, Duane Allen.

Allen worked at Bach Photography Inc., Boise Basin Mercantile, Ballou-Latimer drugstore in Boise, and retired from the Transportation Department after 30 years of keeping the Idaho City highway cleared and repaired. Allen loved spending time with his parents and Barbara at Lake Coeur d'Alene where his uncle Charlie lived. His second favorite place was Dworshak reservoir; where he introduced his family members to a fun and good times on the reservoir. In 1956, his parents moved and retired to Centerville, ID, where Allen lives today next to the house his dad built. He and his wife, Barbara, moved there to take care of his parents, who died in the 1990s. Allen and Barbara celebrated their 50th wedding anniversary in 2011. After seven months of driving his wife daily to Garden Valley or Boise for chemotherapy. She died April 18, 2013, after 29 days in intensive care. She was a baby, only 72.

Without his dog Zoey, Allen would have given up, but with family and good neighbors looking in on him and a tree to drink a beer under, Allen continued to live a good life.

Allen was preceded in death by; his parents Paul and Hazel, wife Barbara, son Duane Allen and Brother-in-law Wayne Turner.

He is survived by Sons: Matt Frentress, and Mark Frentress (Debbie) Curtis Wiker (Debra) and Dennis Wiker (Debbie).

Grandchildren: Stephanie, Preston, Kimberly, Jesse, Theresa, Trudi and Michael.

1958 - 2018

Curt grew up in Boise, where he attended Koelsch Elementary School, Fairmont Junior High School, and Capital High School. He graduated from Capital, where he also played football, in 1976. He next attended Oregon State University, where he graduated with a B.S. in Chemical Engineering in 1980. He later received a Master of Business Administration from the University of Nebraska, in 1998.

During his last year of college, Curt was commissioned into the United States Navy, where he served from 1979 to 2001. He entered Officer Candidate School in 1980 and began a successful military career, rising through the ranks and retiring at the rank of Commander while stationed at Bangor Naval Submarine Base. Along the way, Curt received naval graduate degrees in both nuclear and physical engineering, as well as numerous honors and medals.

During his naval career, Curt proudly served as an officer in the nuclear submarine fleet and was deployed all over the world. He served on both fast attack submarines, beginning with the U.S.S. Drum, and on Trident missile submarines, including the U.S.S. Henry M. Jackson. In the later years of his naval career, Curt redirected his intelligence and his engineering prowess to military satellites, serving at the U.S. Strategic Command in Nebraska and helping to command satellite communications for the Navy.

While in the Navy, Curt also had a family that included four daughters, born in different parts of the country, depending upon his deployment: Jennifer, born in 1982 in San Diego, California; Laura, born in 1985 in Idaho Falls, Idaho; Jacque, born in 1988 in Groton, Connecticut; and Brittany, born in 1998 in Omaha, Nebraska. He

regularly signed his cards and correspondence to other family and friends as "Curt and the girls." As they grew older, he traveled with them on long trips to different parts of the country, wanting his girls to see a country and a heritage that he loved.

Following his retirement from the Navy in 2001, Curt returned to Idaho and began a second career in business and technology. He began this second phase with Positron Systems, Inc., of Boise, where he also co-authored several published papers. He later worked with both Intellex LLC and Lightning Solutions LLC.

Although his Navy career took him all around both the country and the world, his heart lay in Southern Idaho and, more specifically, at the family property on the Middle Fork of the Payette River in Garden Valley. As a child, he spent many weekends and summers at both his grandfather's and his parents' cabins on the river. Later, in between military deployments, he would often spend his precious time off in Garden Valley, usually taking his girls with him and staying with his aunt, Effie Clayton, at her cabin. When he relocated back to Idaho, he again spent much of his spare time "up at the cabin," this time happily taking possession of and caring for the cabin of his grandfather, Jack Davis.

Curt used his time at the cabin to introduce his girls to the outdoors--swimming, fishing, and floating down the river with them, and often ending the day with a campfire and s'mores under a mountain sky studded with stars. He also hunted, skied, rode motorcycles both small and large, and engaged in serious spelunking throughout the Pacific Northwest. He was truly adventuresome.

Curt had the mind of an engineer and could make almost anything work, from a submarine reactor to a lawnmower. He was always tinkering, with a set of tools readily at hand. At the same time, he enjoyed his

friends and was always willing to share a joke (whether good or bad). He had close friendships not only with his peers, but also with the elderly, for whom he was always supportive and helpful. And he loved dogs and enjoyed the affectionate companionship of many, including Peggy, Heidi, Scuffy, Icehouse, and Molly.

In recent years, he suffered complications from health conditions that compromised his quality of life, but he continued to spend time at his cabin and also managed to volunteer with the Disabled American Veterans chapter in Boise. And he kept his lifelong sense of humor.

He is survived by his daughters Jennifer Anne Rideout, of Washington, Laura Lynn Spoklie and Jacqueline Marie Rideout, both of Idaho, and Brittany Marie Beard-Rideout, of California; by his grandchildren Karmynde Lynn Spoklie, James Max Spoklie, Aydan James Garner, and Revan Malak Ockerman, all of Idaho; and by his brother John Christopher Rideout and his sisters Teri Lynn Rideout and Joni McRoberts, all of Washington.
