### Commissioner Ward is Charged with Stalking

**BOISE COUNTY** -- Alan D. Ward of Garden Valley was arrested last Thursday morning by Idaho State Police officers on two charges of stalking in the second degree. Later that day, July 18<sup>th</sup>, Ward set bail from the Ada County Jail in the amount of \$1,500. Presently, there is not a listed arraignment date, but the case is expected to fall under the charge of an Elmore County Judge.

The Boise County Courthouse employees explained that this is currently a closed case to the public.

Ward, 61, was elected for a second time in 2016, to serve a four year term as a Boise County Commissioner.

Opinions on social media in Boise County have been divided, most willing to offer Ward the right to innocence, until proven guilty. There are others that seem to think that these charges are some sort of roust, or trap. On the other hand, there are members of the community that have insisted that the Gar-

den Valley School Board have been well aware of persistant issues over the past year.

A petition is said to be circulating for the removal of Ward from both the Garden Valley School Board and Boise County Commissioners' Board, in which he was selected as Chairman for both.

**According to Idaho Statutes:** 18-7906. STALKING IN THE SECOND DEGREE.

(1) A person commits the crime of stalking in the second degree if the person knowingly and maliciously: (a) Engages in a course of conduct that seriously alarms, annoys or harasses the victim and is such as would cause a reasonable person substantial emotional distress; or (b) Engages in a course of conduct such as would cause a reasonable person to be in fear of death or physical injury, or in fear of the death or physical injury of a family or household member... (3) Stalking in the second degree is punishable by

imprisonment in the county jail for not more than one (1) year or by a fine of not more than one thousand dollars (\$1,000), or by both such fine and imprisonment.

Those individuals convicted of a felony forfeit many of their rights, including the right to hold a public office. However, these charges of stalking are not considered felonies, but are classified as misdemeanors.

This is an ongoing case that remains sealed at the time of publication. However, a charging document of the criminal complaints were recently released, describing in detail a series of non-consensual acts on the part of Alan D. Ward, which occurred on two occasions during the month of April, 2019. This document was signed by David J. Morse, Deputy Attorney General & Special Prosecuting Attorney for Boise County, and Hon. Roger Cockrille, Boise County Magistrate Judge on July 16, 2019.

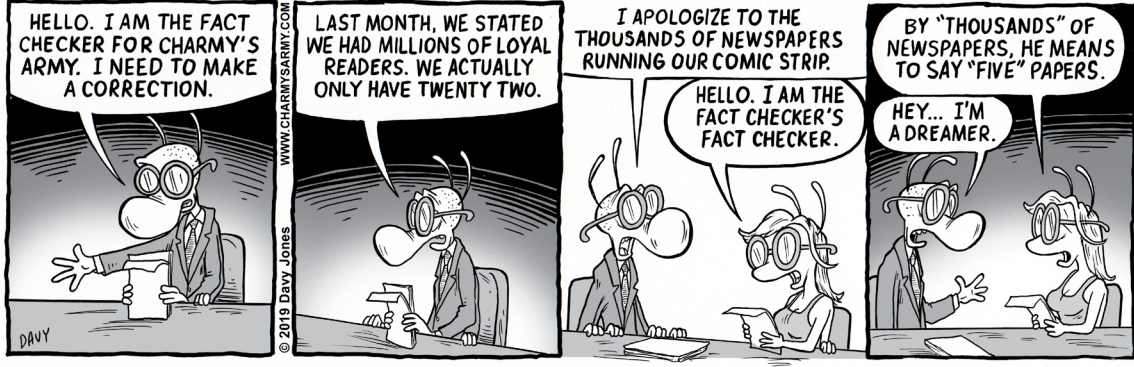

## Hummingbird Banding in Idaho City

**IDAHO CITY** -- Idaho City is one of the only known places where the Calliope Hummingbirds come to breed each year. These are the smallest hummingbirds in North America and little was known of them before 2012. Studies have been ongoing in Idaho City, in a partnership with BSU, the U.S. Forest Service, and the Hummingbird Monitoring Network. Special thanks to Jennifer Alban for the use of her residence to observed Calliope Hummingbirds each year.

A group comes to net the hummingbirds several times throughout the summer. In addition to Calliope Hummingbirds, which weigh about the same as a penny, they also catch Black-chinned, weighing about the same as a nickel. These hummingbirds fly all the way to Idaho from western Mexico to breed.

Whether that's a school field trip to meet the scientists at one of our banding stations, a Curlews in the Classroom activity, or a summer visit to our Hummingbird banding project, we need your help."

## Idaho History Brought Together in Idaho City



**Justin Scott Boer**  
1980 - 2019

Justin Scott Boer was 38 years old, born in Portland, Oregon. He was residing in Horseshoe Bend, Idaho with his soulmate Rathdavanh Vongvilay. On July 15, 2019, Justin was involved in a fatal paragliding accident.

Justin was born in Portland, Oregon on July 30, 1980 to Dan and Tami Boer.

Justin found his motivation to fly in 2008 after conversations he had with his grandfather. He decided to skydive and from that moment on, he had a new purpose. Skydiving led to base-jumping and from there, Justin became a certified paragliding pilot. Through all of his time flying, his love to soar drove him to a partnership with FlyStyle.

In 2013, Justin was involved in a tragic accident, which left him paralyzed from the knees down. Doctors told him he would never walk again. During this time, Justin had the privilege of working with the "Fly Again" project. Justin knew this was his calling and a direction he needed to pursue. AccesSurf and "Fly Again" inspired Justin to make this dream come true.

Shortly after, Justin and his good friend and partner opened the largest flight park in the Northwest, Horseshoe Bend Flight Park. With Justin still in search to fulfill his passion, on a mission to help those less fortunate, he finally started a non-profit business called Sky ThAIRapy. Justin had so much compassion for those with disabilities, his true life-goal and dream was to find a way to help others in similar situations by finding the freedom and excitement he found in the sport and in life.

On Saturday, July 20<sup>th</sup>, there was a great little get-together in John Brogan Park attended by fellow historians, members of the community, and so on. Gracing Idaho City was our very own former Idaho Governor, Butch Otter. He shared his great love for the Gem State, and to no one's surprise, had a wealth of knowledge of Idaho History. He was a tremendous speaker, although he was a little hoarse from singing along at the Garth Brooks concert the night prior. Butch included a story of when he and his brother played baseball in Idaho City years ago: "If you hit a homerun, you had to cross an irrigation ditch to catch it! It was a tough field. It was great coming here."

"Looking back over the history of Idaho, actually, it started a little earlier than 1862, in Peirce, Idaho. That is where the first gold was found, way up in northern Idaho, just off the Clear Water River, a beautiful little town... What started the migration to Idaho was the subsurface wealth that Idaho had and because of its geology. There was a lot of precious metals to be found. Obviously, we are familiar with gold, we are familiar with silver, and the great role that both gold and silver played in our national defense. The Silver Valley that was turned on *big time* in WWII in order to provide the

necessary money in the form of silver and gold, to have the money to prosecute that war *and to bring peace to the world*. Idaho has a rich history in the defense of this country and the growth of this country."

Otter served Idaho and held office for 36 years.

I was working as a timing captain with my crew, on the Spanish Fork race which was at Elk Creek Road. On Saturday we were doing the finish and Mr. Payne drove up the road through a "Road Closed" barricade and proceeded to interrupt me. He said that he had a "naughty list of those who had raced down the road after the race." I asked him for the numbers, which he did not have. I informed Mr. Payne that we were literally telling every driver to follow the speed limit after we handed them their timecards, and if they did speed, they would lose seconds on their timing scores. The officer who was on duty was Officer Bryce Johnson, and he talked to Mr. Payne, asking him not to cross through

the barricade, and that the crew had responsibilities, and to talk to him instead. Two more times on Saturday, Mr. Payne drove up to our site and complained about the racers speeding. Officer Johnson talked to him twice and again he found me and told me about the racers, and I informed him that we were making sure the drivers were aware of the speed limit.

The next day, Sunday, June 23, my crew was doing the start of the race. Mr. Payne drove up to our area again and tried to intercept me, but I was not able to talk to him because I was busy with the racers. Officer Jason Ward was on duty and again Mr. Payne was warned not to cross the barricade, and could he help him? Mr. Payne was very impolite, and I heard some expletives. Mr. Payne left and returned later during the last race and complained again. He parked below the

barricade in an area of the road that blocked the Rally drivers' route for their race.

I never witnessed any of the Rally drivers urinating in the woods as they lined up and waited many minutes before they could approach the start, nor have I ever seen any "misconduct" from drivers in the 3 years I have worked as a timing captain. When I left the racing area, and drove slowly down Elk Road, I noticed Payne's car with his Utah license plates parked by a RV under a tree about 200 feet off the road.

I appreciated the support from the Sheriff's officers who supported and helped me, my crew, and the racers. They were professional and considerate in all their duties

I have worked with the Idaho Rally for several years, I have witnessed polite and courteous behaviors from the drivers, organizers, and volunteers.

I feel that this race is an asset for our community, not only in revenue but media attention to Idaho City and our area. I hope that the Idaho Rally can continue for many more years.

## Estimating Wolf Populations with Game Cameras



*New survey methods will help produce the first estimate of total wolf numbers since 2015*

**IDAHO** -- How many wolves populate the landscape in Idaho? That's an often-asked question that Idaho Fish and Game is aiming to answer using game cameras during a new statewide population monitoring program.

In recent months, Fish and Game staff have deployed over 800 game cameras in a high-

density grid throughout the state, which will take millions of pictures. When Fish and Game staff collect the cameras at the end of September, researchers will download and analyze the photos and apply statistical modeling to estimate the population.

Sifting through millions of photos will be labor intensive, but

Fish and Game Wildlife Research Manager Mark Hurley is aiming to, early next year, have the most robust and accurate count of wolves ever in Idaho, and the first scientific population estimate since 2015.

Wolf monitoring evolves with changing wolf populations

Wolves were federally reintroduced into Idaho, Wyoming, and Montana in 1994. Between 1996 and 2005, Idaho's wolf population was estimated using a "total count" technique to generate a minimum estimate of the statewide population, which was appropriate when the total population was small and many wolves wore radio collars. Biologists could track individual animals back to their packs, get an estimate of pack sizes and then estimate the statewide population.

From 2006 to 2016, Fish and Game's wolf monitoring program remained under federal oversight. Until May 2016, the department was required to maintain a minimum number of radio-collared wolves, with a goal of having at least one collared wolf in each pack in Idaho.

"This kind of monitoring was really targeted at federal Endangered Species Act recovery goals — that's why we were doing that. That sort of effort works with very small populations," Hurley said.

During this period, biologists counted the number of wolves within each pack from aircraft, or on the ground, during early winter, and used that information to calculate an average pack size. While they continued to count the actual

number of wolves they spotted during surveys, wildlife managers also began using a new technique to estimate the statewide wolf population, which was better suited to larger and more dispersed populations. They applied the average pack size in areas known to have packs, but where individual wolves were not necessarily seen and counted by a person.

As Idaho's wolf population continued to grow, however, it became increasingly difficult to maintain radio-collared wolves in enough packs to monitor statewide populations in this manner. After wolves were removed from the endangered species list, Idaho took full management of them and hunters and trappers began harvesting wolves, which made keeping radio collars on wolves more difficult and costly.

"That monitoring used to cost about \$750,000 per year, a large portion of which came from federal funding," said Toby Boudreau, Fish and Game's Wildlife Bureau Chief. "That funding tapered off from the time wolves were delisted in 2011 until it was eliminated in 2016."

Idaho's wildlife managers knew they would need to monitor wolf populations using a more cost-effective and efficient model than one based on radio collars, and the focus of their monitoring shifted to "occupancy" — or estimating the number of wolf packs in the state, rather than establishing a total wolf population estimate.

Beginning in 2016, researchers

began using a grid of about 200 game cameras to detect whether or not wolf packs were present in predetermined areas scattered across the Idaho, which biologists call "occupancy cells."

By determining what percentage of Idaho was occupied by wolf packs and monitoring changes over time, while also monitoring wolves' impact on elk and deer populations, wildlife managers observed large-scale trends in the statewide wolf population, and managed wolves based on population trends, i.e. whether the overall population was stable, growing or shrinking.

"If the wolf population contracts, occupancies should contract, in the same way that they increase," Hurley said. "You can also estimate the number of packs. That is what we can do with patch occupancy, because your occupancy cells are the size of a whole pack territory."

Biologists also used DNA analysis from scat surveys and harvested wolves, allowing them to estimate pack counts, reproduc-

tion, and the number of wolves in small areas. Using these methods alone, however, it was difficult to get an overall, statewide wolf population estimate.

That situation changed recently after researchers developed population-estimate techniques by using game cameras, similar to how biologists are already using cameras to count and monitor elk and deer populations in Idaho.

For the new method to work, wildlife managers needed to dramatically increase the number of cameras in the field devoted to wolf monitoring, which is why Fish and Game staff deployed hundreds of additional cameras this summer.

"What we've done is split these occupancy cells up again, and added additional cameras within them," Hurley said. "That will give us enough cameras to generate an abundance estimate, which we can't get with just the occupancy cameras."

## Lowman Fire Along Hwy.

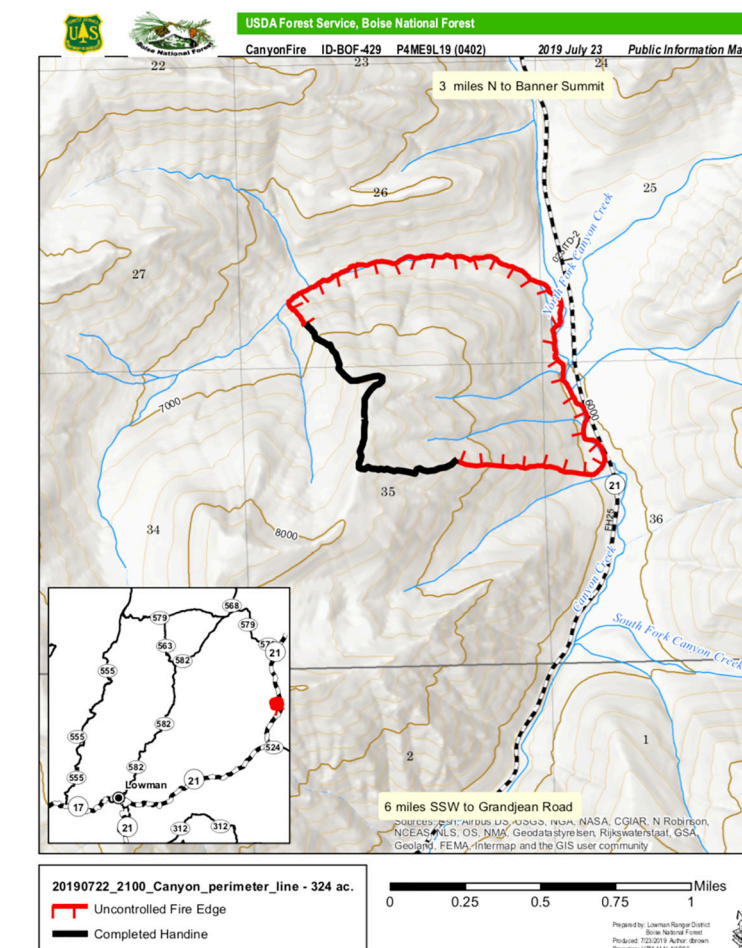
*Firefighters brace for high winds during red flag warnings*

**LOWMAN, Idaho, July 23, 2019** -- During the next few days, with predicted high winds and possible lightning storms, crews on the Canyon Fire will continue to focus efforts on securing and holding established lines on the northern edge, and monitoring hot spots along Idaho State Highway 21. Aviation resources are still being utilized. Fire managers anticipate some demobilization of resources to local units if lines hold during weather events.

Firefighters continued to monitor and secure handlines along the West Fork of Canyon Creek after successful burn operations on the northern edge. Fuel pockets within the fire perimeter will continue to burn for several days, producing scattered smoke plumes.

The fire is 324 acres and 32 percent contained. Currently there are 206 personnel on the fire including six hand crews, four engines, and four helicopters.

Both lanes on this section of Idaho State Highway 21 are open. Please slow down for firefighter and public safety. Bull Trout and Martin Lake Campgrounds are open. Please use bear awareness in the area and store all food ap-

# BOISE COUNTY COMMISSIONERS

Transcribed by Eileen Capson

July 16, 2019

**Present:** Commissioners Alan Ward and Roger Jackson

**Absent:** Commissioner Ryan Stirm was at a National Association of Counties conference in Las Vegas.

**Pledge of Allegiance**

**EXECUTIVE SESSION:** Per pending litigation, hiring of new employees, personnel, exempt records, and risk management. [Closed session from 9:03am to 9:34am] Chairman Ward said coming back into session, "No action required."

**CONSTITUENT INPUT:** None. Chairman Ward stated, "We have had like *months* of no constituent input."

**MINUTES:** The July 8<sup>th</sup> and July 9<sup>th</sup> meeting minutes were accepted.

**DEPARTMENTAL ISSUES:**

**EMERGENCY MANAGEMENT:** A training was requested to attend in Boise for "continuity of operations," said Bob Showalter, Boise County's Emergency Manager. It includes infrastructure and should an emergency disaster occur, and he said this would be a pertinent class. Sheriff Jim Kaczmarek suggested that they try to bring the class up to Boise County and that way they could have better attendance. It was approved for Showalter to attend.

**SURPLUS:** Mr. Showalter suggested picking up a part to fix a truck, which then they could then sell for more. Mr. Ward said they were responsible to the taxpayers to make a little be back on it.

**SHERIFF:** Jim Kaczmarek met with Wilderness Ranch community, WRFPD, and Idaho Dept. of Lands in regard to an evacuation plan and policy. The Reverse 911 was discussed and the sheriff said it was well received. He said they were willing to go out and talk to other communities, and also discuss preparedness.

**JOINT AUDITOR/ TREASURER REPORT:** Clerk Mary Prisco stated, "Same old, same old." The quarter ended on June 30<sup>th</sup>. She said they had an "odddity of \$8, but it turned around in July." The report was approved and signed.

**ROAD & BRIDGE:** A job applicant was approved to fill a vacancy. Mr. Jones discussed putting together a building for the snow groomer, with boxes, for approximately \$50,000. Mr. Ward thought Conex box was a "very good idea" to save mon-

ey. "Good, moving it forward."

**AUCTION ITEMS:** Assessor Juszcak said they would like to bring in the football players to move out some heavy items out of the basement of the courthouse. Clerk Prisco said they have reached out to the athletic department in the past and then made a contribution. Chairman Ward teased, "If you want to get it done quickly, you can get some of the Garden Valley football players over here too." Sheriff Kaczmarek joked about having a little competition afterwards. Ward said, "When did you last see a lamp make a 50-yard pass?"

**UPDATING POLICIES:** Clerk Prisco disclosed, "Our ordinances and our policies are not indexed. So, trying to update them, is just like, you would hate that." The sheriff would like to include something on patrol vehicle maintenance. A travel policy will also be considered. Full-sized tires, instead of "donut" spare tires, were also discussed for emergencies.

**NOXIOUS WEEDS:** Chemicals were discussed and a contract with Idaho Transportation Department for noxious weeds.

**WEBSITE UPDATE:** There is a contract that has been reviewed by the prosecutor. The individual said that they weren't going to "re-invent the wheel", but use existing county websites for our "new facelift." Ada County's website will be used as Boise County's template. His goal is to eliminate phone and foot traffic into county offices, whether through forms or other means. Clerk Prisco said they had budgeted for this updated website for 2019 and 2020, in the amount of \$13,950. A motion was made to enter into an agreement.

**SHERIFF'S OFFICE:** An electrical project will be completed.

**BILLS:** Paid

**ISSUE TRACKING:** EBCAD Ambulance was discussed. Ward added, "I think they are moving along and doing the best they can." Emergency Manager Showalter testified that they are doing a lot better and are more organized.

**RECORD SURPLUS:** Clerk Prisco said it was a never ending project.

**HIGHWAY 17 vs ITD:** Chairman Ward said, "We're still working on that." A meet-

ing is trying to be arranged.

**CuMo MINE:** Nothing has been heard. Chairman Ward would like to put in an update.

**BOISE STREET BRIDGE:** Showalter said so far he has a lot of interest, but still needs letters of support from the residents, fire department, and constituents signing petitions, "the more ammunition" he'll have. Of the Horseshoe Bend city funds, 25% can be used towards the bridge.

Showalter spoke about emergencies and how the Horseshoe Bend School was in the floodplain.

**LETTER OF SUPPORT:** The Edge Resort was hoping to get some grant money for wetlands, and get a letter of support from the commissioners.

**EXECUTIVE SESSION:** [Closed session from 10:59am to 11:56am] Per exempt records, pending litigation, personnel, hiring of new employee and risk management. Ward said no action required, except for under exempt records, a case was approved and another case had liens.

**C O N G R E S S M A N FULCHER:** A representative gave a quick update, including talk of budget caps and cuts. He was aware of the Highway 17 issue with ITD, regarding who has ownership of that road and/or a cost match. Chairman Ward stated ITD have put in some pretty substantial requirements to turn over the road, ones that he doesn't feel can be met. Ward encouraged the representative to go through the area to see what the road crew is cleaning up after just a year's worth of activity, cleaning out the barrow pits. He said it was a huge amount of rock and debris. The representative stated there was a contract that said if the county provided a certain amount of the maintenance requirements they would take it over. Commissioner Ward said they were trying to get them to take it over in sections, for example the section from Banks to Crouch was a State Highway at one time and it was given to Boise County in about 1960. Ward said there was an issue on right-of-way with several agency easements. "When we began to look at that, the Corps of Engineers and the BLM said that they couldn't give you that road, they didn't have the right to give it to you in 1959. It was never approved by those two federal departments." Commissioner Jackson recalled that

between 2003 and 2005 as a commissioner, it was going to cost between \$2 million dollars to work on the Davy Bridge, "and now it's up to millions... They were supposed to take the road over by 2013, all they do is say is all you need to do is \$70 million here and \$10 million here, and \$20 million here. I don't know where that came from. That was not in the original agreement that we signed." Ward said rock mitigation, easements, and guardrail have been done.

The representative asked about CuMo, and Ward responded that they hadn't heard from them in a while and were going to invite them back for an update. "The latest we've heard is things are going, they're still exploring, looking for funding, that the ore is still vast and they're still trying to find out just how much they've got." The representative said he had "heard different things from different sources." The assessor said he thought they were permitted for drilling and had done a few more test holes for exploration: "I think there were twelve or twenty more test holes on that chunk of private ground up there."

There was some talk about Secure Rural School [SRS] Funds not being available in 2020. Ward said not having that funding would be a "disaster for us." The representative said they have "a little different leadership in the House," but there are some things in legislation. He will look into this and try to get more information to the counties.

Commissioner Jackson inquired saying: "We have a twenty acre parcel that we want to trade the Forest Service for, for twenty acres to put a solid waste site on it. What would be the chances of Senators and Representatives putting that in an Appropriation Bill and get it done in a week, instead of three or four years, is what the rangers have told me it's going to take?" Ward encouraged that it would be a fine trade, because the county would offer land surrounded by forest. The representative said he would chat with the congressman and the D.C. staff to move that process along. Jackson said he knows of another time this has been done before with an appropriations bill.

**RIDE IDAHO:** Commissioner Ward suggested sending a letter to the bicycle group: "A least make sure they understand that if they're going to send that kind of a group of people, even if it doesn't qualify for a mass gathering permit. That the traffic and the safety concerns were too much and we have to have a better understanding of what they're doing and of the days. I don't want to make them feel unwelcome, that's not the goal. The goal is just to have better organization."

**BUDGET:** The department heads and elected officials will meet on July 29th and July 30th to discuss the county's budget.

**EXECUTIVE SESSION:** [Time 2:05pm to 2:52pm] Per personnel issues and risk management. Commissioner Ward said, "No action required."

**Recessed until July 23, 2019.**
