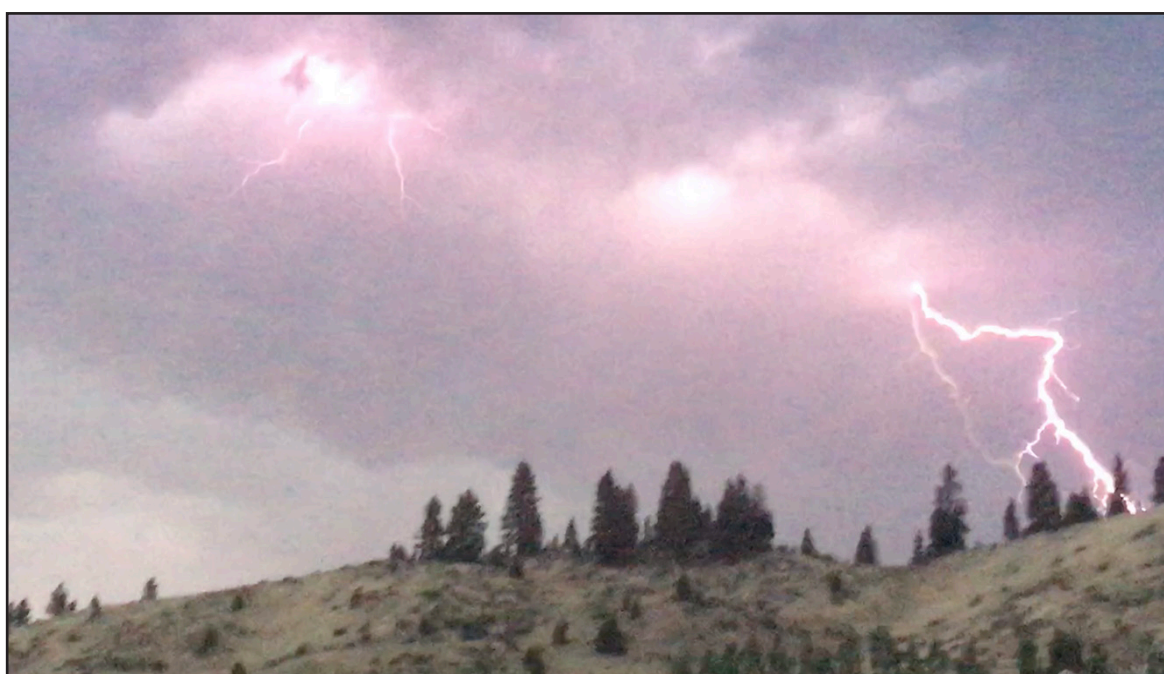

Goathead Weeds Found in Garden Valley

GARDEN VALLEY -- Goathead plants have been found in Garden Valley. If you're from Horseshoe Bend, or have ever biked or walked your dog in the rural areas of Boise Valley in summer, you've probably come across goathead -- also known as puncture vine. Crossing a ten foot patch of goathead can give your bike tires 100 punctures and send your dog yowling from all four paws.

Five goathead plants with thorns were found in Crouch, between the Laundromat and Dirty Shame, on August 11th. Four more were found on the

path by the Garden Valley Library. Goathead has also been found along the South Fork below the Middle Fork, and around Lucky Peak Reservoir.

This invasive plant annual thrives in hot dry summer climates like Boise, Tri-Cities, Lewiston and Riggins. It grows along the ground, spreading as much as five feet from the base. Its thorny seeds grow to about 3/4", (2mm) about the size of a garbanzo bean (chick pea), and remains viable for up to six years. It has very small oval leaves roughly 1/8th inch by 3/8th inch, (3mm by 1cm), and tiny yellow flowers. One plant may produce hundreds

of thorny seeds.

Goathead is among the weeds designated noxious by the state of Idaho, who provides some limited funding to help control them.

In the valley, Boise Bicycle Project is fighting to eradicate the weed, offering rewards for those who collect the most goathead plants. 10,000 pounds have been collected in the two summers since the campaign begun.

Goathead has not yet established itself in a big way in Garden Valley. Let's not let it happen here. *If you see it, pull it!*



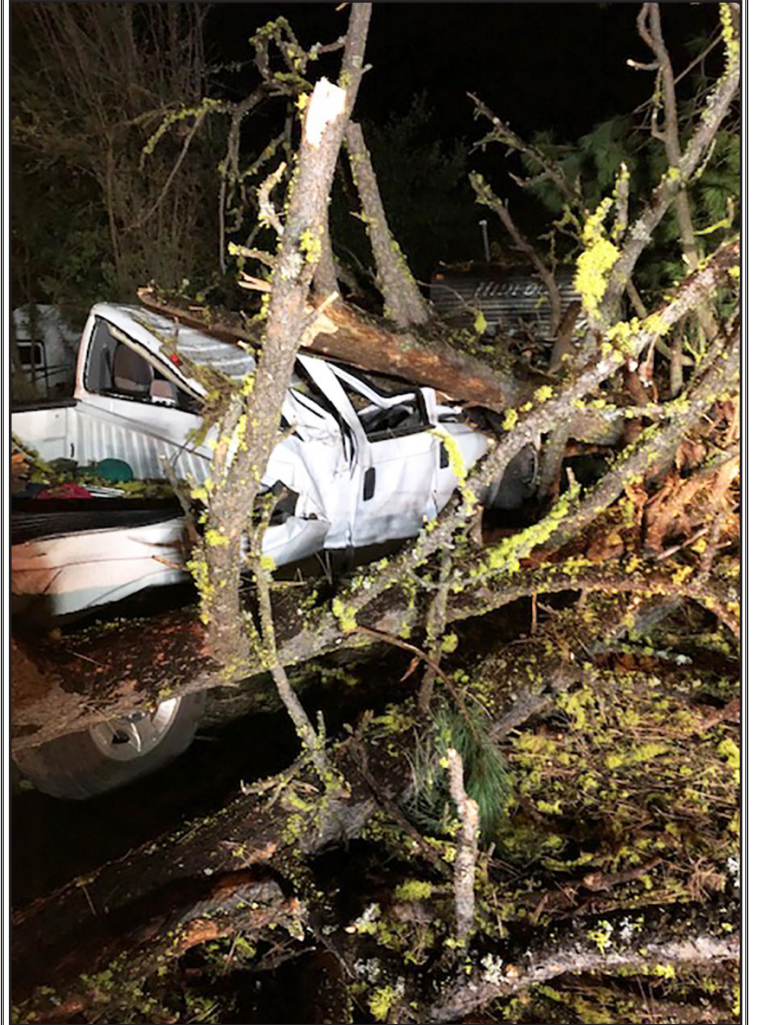

University of Idaho Extension Hiring Four Additional Staff to Deliver Science, Technology, Engineering, Art, and Math Programming

Funding provided by an AmeriCorps grant awarded to the University of Idaho 4-H Youth Development program, and additional funds from Gem County and the Horseshoe Bend School District, will provide one full-time and three half-time positions beginning in September.

The AmeriCorps funding is focused on strengthening communities by “engaging...rural, economically disadvantaged, and socially isolated youth in 4-H out-of-school time programs.” The educational opportunities provided by this funding are meant “to help [youth] build important life skills and impactful relation-

ships with positive adult role models while working with science, technology, engineering, art, and mathematics (STEAM) projects.”

As an AmeriCorps member, successful candidates receive a living stipend during their term of service and an educational award at the end of their term of service. For example, in addition to health care benefits, the full-time position will receive a bi-weekly living stipend over the course of the 11-month position totaling \$14,000, and at the conclusion of the term, will receive a \$6,095 educational award that can be used toward schooling expenses (such as tuition or student loan debt). The educational award may be used by the AmeriCorps member or transferred to a family member. The half-time positions receive a total living stipend of \$6,600 over the 11-month term and a \$3,047 educational award upon successful completion of the term of service.

In Horseshoe Bend, the focus will be on Lego Robotics, computer coding, and short, discovery-based experiences for youth of all ages. The two staff members will be housed at the school district and work up to 20 hours per week September 2019 – July 2020. The full-time position and an additional half-time position will be housed at the UI Extension

office in Emmett and will be focused on partnering with local entities like the Emmett Public Library, Gem County Recreational District, Emmett School District, and others to deliver STEAM programs and recruit 4-H volunteers. There will also be opportunities to do programming in Garden Valley and Idaho City in hopes of expanding the programs to those areas in the next grant cycle.

Applications are being accepted for all four positions. To see full position descriptions and to apply, go to: <https://my.americorps.gov/mp/login.do>. Once on the site, click “Search listings”, select Program Type: “State/National” and find “Idaho” on the dropdown menu. There are several positions open across the state; the positions specific to Gem and Boise Counties and Horseshoe Bend have those locations listed in the title.

Applications will close August 31, 2019 but applicants may be interviewed, and positions filled prior to the deadline, depending on applications received.



Back to School Life Lessons:

School is back in session, but is your teen getting the financial education they need? Even if communication between parents and teenagers can be challenging at times, it’s a critical age to learn practical financial lessons that are essential in adulthood.

“From getting their first part-time job to choosing a college, teens are faced with some pivotal decisions,” says Michael Sullivan, a personal financial consultant with Take Charge America, a national nonprofit credit counseling and debt management agency. “Parents can offer valuable insights and lay the foundation for financial independence – all while giving their teens enough space to find their own way.”

Sullivan outlines opportunities to impart valuable financial lessons:

How Credit Cards Work – Show your teen how credit cards work (and the importance of paying off the balance on time), by allowing them to purchase an age-appropriate big-budget item – such as music festival tickets or a new smartphone – with a secured credit card. With parental guidance, they can learn how to pay the bill, how interest works and the importance of building credit.

Wise Comparison Shopping – Teach smart, cost-effective

shopping by giving teens the responsibility of shopping for a week’s worth of groceries for the family within a strict budget. With this activity, teens will learn how to comparison shop, allocate money according to necessity, and distinguish between needs (milk, bread) and wants (ice cream, expensive snacks).

Budgeting for College – If college is in your teen’s future, have them research salary expectations in their desired field. Then, help them set up a budget for their first semester of college: how much money do they have for tuition, housing, books, food, and entertainment? Do their funding options cover these initial costs, or will they need to take out student loans? Upon graduation, can they pay off the loan reasonably with their expected salary?

Avoid Online Comparison – On social media, it’s easy for teens to get caught up in comparison. When parents notice their teen fixating on others’ online lifestyles, start an open dialogue about reality vs. the curated aspects of someone’s life. Teens need reminders that attempting to match another’s lifestyle can lead to frustration and debt.

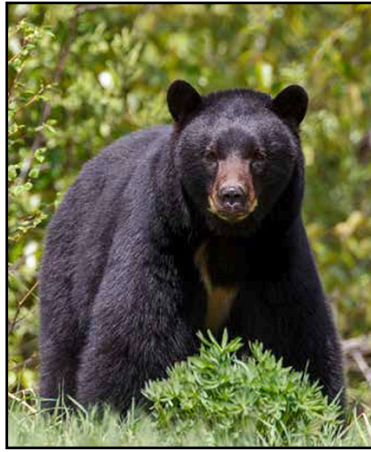

Campers Encouraged to be "Bear Aware"

BOISE COUNTY -- August 12, 2019 – The Boise National Forest is reminding visitors to be extra cautious this summer when storing their food to avoid attracting black bears.

Bears possess an extremely keen sense of smell, and can find food from great distances. Once a bear finds food near humans, it is likely to come back. The result is a dangerous situation for both the bear and the people. Bears that repeatedly come into conflict with campers have to be trapped and euthanized.

Campers can protect themselves and others from unwelcome nighttime visitors by storing their food properly. In developed campgrounds, campers should store all food in their vehicle, trailer, or camper with windows tightly closed. Stoves, cooking utensils, personal items such as toothpaste, and pet or livestock feed should be protected in the same manner. Garbage should be disposed of in the trash containers in campgrounds and never left out unattended. If a

trash container is full, please pack your garbage out.

In the backcountry, food and garbage should be kept out of bears' reach by hanging it in a tree, at least 100 yards from the sleeping area. Food bags should ideally be 10 feet above ground and 4 feet out from tree trunks. Food can also be stored in an approved bear-proof container. Backcountry campers should attempt to reduce or eliminate food odors on themselves, their clothes, and near their sleeping area. Do not store food in tents.

For the safety of the public (and the bears) we urge Forest users to be "Bear Aware" and use common sense when camping in bear country. For more information visit: <https://www.fs.fed.us/visit/know-before-you-go/bears>

der a recreation exemption, but their roller coaster may not fit under that and is being looked at by legal. Stirm said it was "really unrealistic for anyone from Boise County to respond there, because we would have to go all the way around and all the way up through Ada County. It isn't reasonable." Ada County has an agreement to maintain that road. Chairman Ward partially joked that they could let that run out and then close the road, "I'm tired of it." There are 42 houses. Chairman Ward said, "Why make the Boise County taxpayers pay for something that's 99% Ada County. It doesn't make any sense and it's a non-profit." Prosecutor Strong will double check the statute. Ms. Potts said she was very glad to find out that Bogus Basin was not their area. Even Boise County Dispatch has dispatched them out there.

BUDGET DISCUSSION: Clerk Mary Prisco discussed adding back other expenses

for the Road Department. The PILT funds, put into a trust fund, were added in June in the amount total of \$371,000. SRS funds are expected to come in. Different job positions were discussed and the costs, including offsetting comp time. Clerk Prisco clarified, "Comp time is not in cash." Commissioner Jackson stated that if a guy is grading between Idaho City and Centerville during the wintertime and it comes to the end of his shift, "he's not going to just park the grader and walk home." Clerk Prisco said, "I don't think we should be adding any employees right now. *The money's not there.*" Commissioner Ward said it was clear enough and added, "It suits me." Vacation and comp time is at 51,000 [hours?].

In 2019, the county spent \$36,000 for the security panic buttons in multiple buildings. There was an electrical upgrade in multiple buildings, costing \$47,000, and there is additional work that needs to be done. Upgrades were ex-

pected to cost \$100,000, so about \$50,000 will be left. Chip readers need to be ordered for credit cards. Miner's Exchange upgrade is \$40,000 for the paint and new carpet in the Assessor and Treasurer's side. There is \$50,000 for the upgrades on the boardwalks. Regarding vehicle replacement, Clerk Prisco thought the bulk of the budgeted amount would be spent. She added, "So, we're really dealing with \$200,000, plus \$50,000, budget in 2019, that we can choose other projects to roll into '20, or use in '19 for other projects." She asked if there were any other projects, and there was no comment. Cameras will be set up at the Road Department Shops. Prisco wanted to discuss a personnel issue in executive session.

EXECUTIVE SESSION: [Time 2:05pm to 3:28pm] Per personnel and risk management. Chairman Ward said coming out of closed session that no action was required.

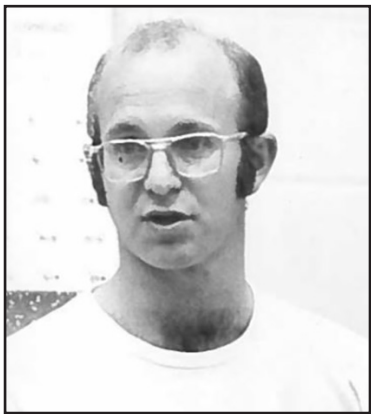

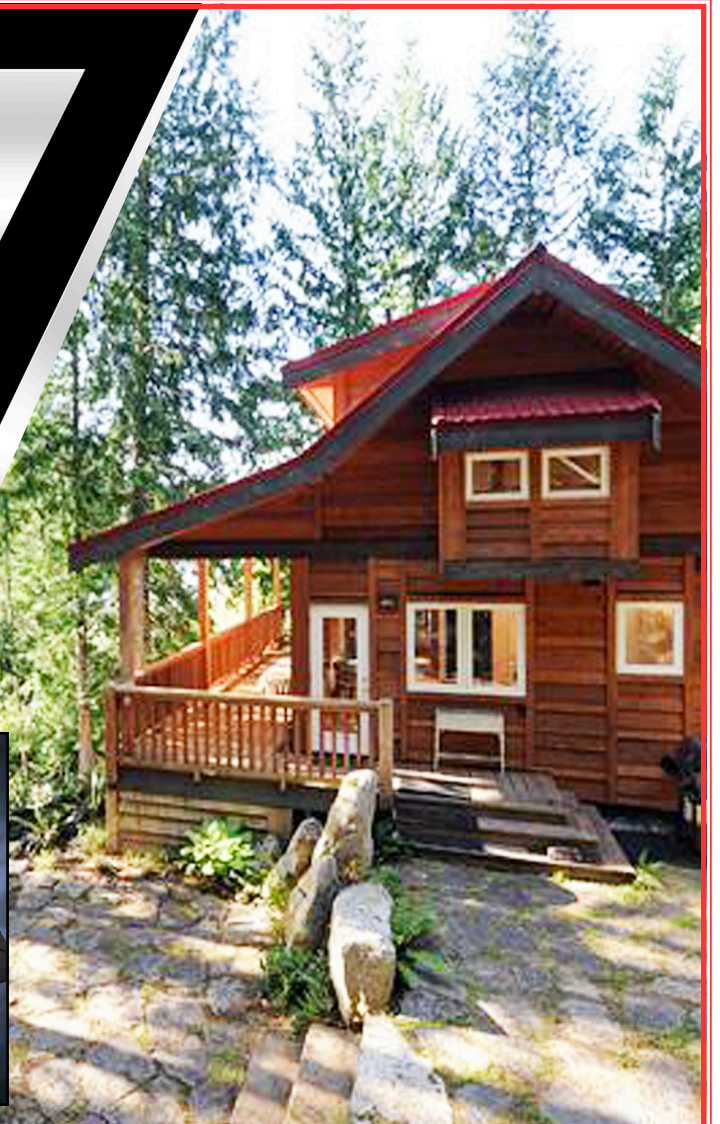

August 6, 2019**Present: Commissioners Alan Ward, Ryan Stirm and Roger Jackson****Pledge of Allegiance**

AMENDED AGENDA: Per discussion for the placement of liens. Chairman Ward said, "The good-faith reason is that the property in this case does not have a lien on it and it was noticed that it was for sale. We need to put a lien on that to protect Boise County."

EXECUTIVE SESSION: Per pending litigation, exempt records, personnel, hiring of new employees, and risk management. [Time 9:02am to 9:21am]

Coming out of the closed session, Chairman Ward stated, "No action required."

CONSTITUENT INPUT: None

MINUTES: The July 30th and July 29th meeting minutes were approved through a motion.

ROAD DEPT: Skid-steer / mulcher discussion. Clerk Mary Prisco said Title III funds likely won't be able to be used to cover \$58,000. Commissioner Ward said they would have to come up with the money from somewhere to move forward. Mr. Jones said they could use the machine in the spring, not when it gets hot because they could spark and start a fire.

PLANNING & ZONING: Job description updates for Code Enforcement Officer/ Building Inspector and Planning & Zoning Administrative Assistant. "I've looked through it and I think it looks fine," said Ward. These changes were approved through a motion. The title of P&Z Administrative Assistant Tech was changed to Planning and Zoning Permit Technician.

ROAD DEPT: Through a motion, an individual will fill a job vacancy in Idaho City.

JUVENILE JUSTICE: Ms. Leader asked that an individual in her office attend a conference at Fort Hall.

SHERIFF: An air conditioner, one of the two, has quit. Sheriff Kaczmarek presented some quotes. The conference room does not have any air conditioning during the hottest part of the year. A motion was said to approve the request to replace the air conditioning unit in the amount of \$6,370.

BOARDWALK: Some other options were discussed, including having Boise County employees hired to do the

replacement. Commissioner Jackson suggested the inmates could do the work. Commissioner Ward was going to get some measurements, and check on the price for boards. Commissioner Stirm pointed out that the bid did not include any repair work that may need to be done in the frame work below. He said, "It could add another \$50,000. When they get under there, all those supports are rotted. Because then you're talking pouring concrete, digging holes, and basically building a whole entire new boardwalk."

Assessor Chris Juszczak suggested having a race with two Idaho City High School shop classes to put the boardwalk in. Sheriff Kaczmarek suggested it as a senior project.

SHERIFF: Horseshoe Bend Sheriff's Station is coming along.

Sheriff Kaczmarek said it costs a little over a hundred dollars to house a prisoner, and the cost did not change.

CERTIFICATES OF RESIDENCY: There were four students motioned and accepted.

ALCOHOL LICENSES: A "pile" of licenses were approved for alcohol distribution.

DEMAND WARRANTS: \$800 was spent for the reader board in Horseshoe Bend.

EXECUTIVE SESSION: Per exempt records, personnel, pending litigation, risk management, hiring of new employee. [Time 10:17 to 10:38am] Under exempt records, Ward motioned to sign the liens.

ROAD & BRIDGE PURCHASES/ PROJECTS: Chairman Ward made it known that he was contacted by a reporter that works for *The Idaho Statesman*, but lives in Washington, D.C., and he is writing a story on the Secure Rural Schools funding. Ward said it was the same questions: How do you use the money? How does it impact you? "We've had the same calls before," said Ward. He encouraged him to come out and see the dirt roads we maintain, and forest access. "How incredibly important it is, and how \$70,000 bucks to a school district in a year is just incredible. And how hard it is to budget when you don't know if you're going to get it or you aren't... Apparently there is a lack of motivation at the time to fund it."

Mr. Jones stated, "We are increasingly doing more work." He said that some employees

work 12 hours and then get called out again, working 18 hours. These employees have built up quite a bit of comp time, that Mr. Jones would like to "pay down." With one certain employee has two hundred and thirty hours comp. time.

The Idaho City loader at the transfer station is getting older, 1999 or 2000. The new one would come to Garden Valley and that one [2006] would come to Idaho City.

Preparation work has been done on the Middlefork Road for chip sealing. It's about a 3,400 foot project. Water control is being considered.

Jones was concerned about communicating with employees with radios using the narrow bandwidth. A new repeater was discussed. "Essentially, they get into those areas and we don't have radio communication with them." Chairman Ward said he purchased a satellite phone for \$1,200, which is \$60 a month for minutes that roll over, "but there's no place that I can't call out of." Mr. Jones said that communication was critical and didn't realize the phones were that inexpensive. Clerk Prisco asked about a possible grant and Jones says it's difficult, because they are not considered emergency services.

NEW CELL TOWER: Commissioner Ward stated that a new cell tower was being built at Hwy. 21 and 17 in Lowman.

Mr. Jones said, "Oddly enough, most of our guys don't have cell phones, mostly because they don't work." He hopes that the cell phone coverage gets better and then they will consider it.

WATER TRUCKS: Mr. Jones says one is broken so bad it might come off its frame and it leaks so badly that, "You can stand beside it and take a shower." They were considering using existing trucks and adding tanks. The Road Dept. would like to keep the old water trucks, because they use them while running graders, "which are essentially useless in the summertime if you don't have water." They are looking to buy two 4,000 gallon tanks.

Mr. Jones said their pickup trucks are getting pretty tired and old, but it's not critical. They would like some ¾ ton trucks.

MIDDLEFORK ROAD: Cut out some and patch some asphalt. There were seven

truckloads. They are fixing water issues, and pulling some material. Crack sealing will be done from Banks Lowman Road to the joint, "That's probably some of the oldest asphalt in the county. That's the original 1960 asphalt." It will be crack sealed and chipped the last week of August. Some overlay will be done.

ALDER CREEK ROAD: There is a section that is lower than the creek, which will be raised up and the drainage fixed this fall.

EAST BOISE COUNTY AMBULANCE: Ms. Potts reported that it's trauma season. She would like to take the Idaho City ambulance, when it's not staffed on the weekends, and bring it down to Wilderness Ranch so when that ambulance goes out on a call they will have a backup, because all the EMTs are down there. She will notify everyone of the change of location. The Board thought that was a good idea.

They are trying to stir up some interest for EMTs and a class in Lowman.

Bogus Basin Road was discussed with State EMS, which Potts said was "basically worthless." In showing a map, "As you can see that there is *no ambulance coverage at all for Bogus Basin*. It's not an EBCAD district like we all thought it was. So, us making a mutual aid agreement with them doesn't do anything, because it's not our area. We always thought it was our area." Commissioner Jackson suggested letting Ada County take that and run an ambulance

up there. Potts stated that Ada County does not want it, but acute rescue and injury care do want it. These are private ambulances and not licensed 911 calls, but support. Bogus Basin would need to be brought into the EBCAD district. Most of the area is tax exempt, but they may receive a little revenue from it. Bogus Basin area residents are part of Horseshoe Bend and actually (the ones not tax exempt) are paying for their hospital district. Commissioner Stirm said that they don't have a hospital district. Clerk Prisco corrected, "There is a Horseshoe Bend Taxing District and *obviously* the Bogus Basin area... so they are paying *some* amount of taxes." Stirm said that GV Medicine will not touch one of their Horseshoe Bend ambulance patients. He added, "We have a real line, like a black line that says, 'If we come into your clinic, they can pick up a patient, they are no longer your patient. They are our patient, and vice versa, *but they will not accept a patient from us*.'" Stirm said, "The ambulance doesn't get money from Bogus Basin at all, in any shape or form." There was some consideration to annex the area, but the clerk said that wasn't possible. Chairman Ward stated that he was "tired of it, they don't pay any taxes," and suggested they exclude them. Prosecutor Strong suggested that technically they aren't within their service area, and have no responsibility to respond. Bogus Basin is un-
