Tragic Vehicle Accident on Hwy. 21

EAST BOISE COUNTY--

A horrific accident occurred on Sunday afternoon, August 25th, that closed Highway 21 for over three hours. A man driving a 2007 Chevy Trailblazer with a 2B license plate veered over the center lane into oncoming traffic, colliding nearly head-on with a 2012 Toyota Rav4 near milepost 14.

A reserve deputy for Idaho City happened to be near the vicinity, traveling back to Boise after his shift, when the accident occurred. He recounted that Jerry Neher's Trailblazer had flipped over onto its top and then caught fire, off to the side of the road. A vehicle towing a boat happened to have a fire extinguisher and

put out the fire, while other northbound travelers initiated CPR on the man. There was a propane tank in the trunk, because he had been camping, that one person said sounded like an explosion.

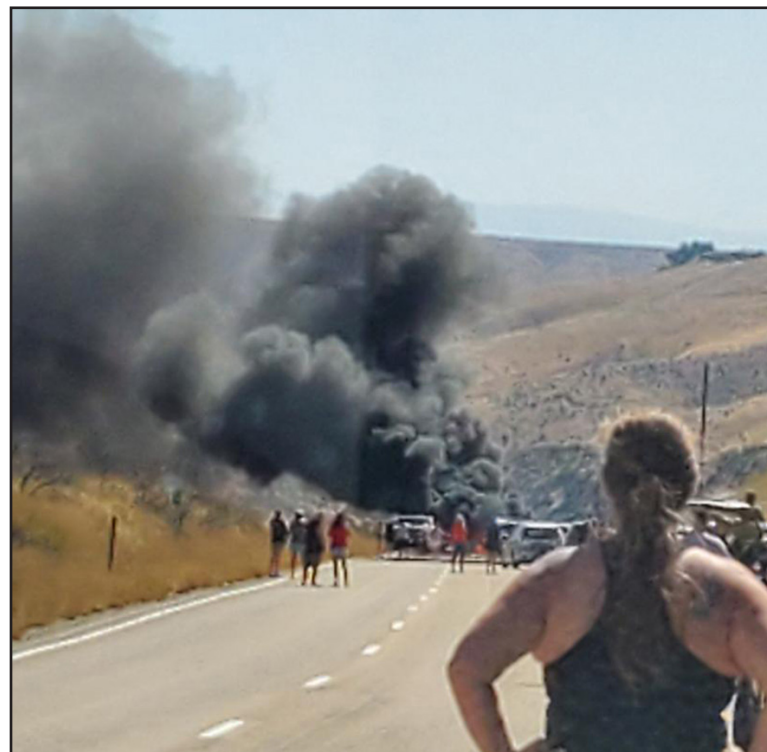
The Rav4 then also started to smoke and caught on fire. According to an eye-witness, a man was dragged from that vehicle before it became fully engulfed. Peter Tanorikiho, 67, and his wife, Lelelewa Tanorikiho, 60, succumbed to their injuries at the scene.

Jerry Neher's dog died at the scene, and the following day he too succumbed to his injuries, after being transported by ground ambulance to a nearby hospital. Idaho State Police

indicated that Neher, 51, was from Nampa.

Traffic on Highway 21 was blocked for three hours, and back roads were utilized, although several motorists became lost. The gridlock on Rocky Canyon held for 5 hours, according to Sheriff Kaczmarek, due to a jackknifed vehicle. Harris Creek was also reportedly treacherous on the narrow dirt road with everything from motorcyclists to large motorhomes.

Approximately twenty-five officers had responded to this accident scene on Sunday in Ada County. A large scorched black scar now mars the center of the roadway where the Rav4 caught fire, south of Hilltop Station.

HUMAN-CAUSED FIRES



BOISE COUNTY -- Two fires were fought on Monday, August 26th, one in Clear Creek and the other in Star Ranch. Local volunteer firefighters were first on the scene to protect structures and slow the progression. The AlertSense notification system within the Sheriff's Office notified residents of Star Ranch of imminent danger. There were three or four structures in danger, but nothing caught fire, according to the Placerville Volunteer Fire Department. They were later joined in the efforts by Centerville VFD and Idaho Department of Lands firefighters. The Garden Valley Middle School Challenge Day is a program to provide our community's youth with interactive learning and entrepreneurship experiences. Inside our rural valley, career and educational opportunities are sometimes scarce. Challenge Day teaches students to reach out into the world and create opportunities for individual, group, and humanitarian improvement. This program also teaches our youth how to respect, enhance, and change the community we live in for a better future. Every Friday, this group of devoted students meets to learn new traits, plan community events, and explore the world of entrepreneurship, giving them a fifth day of learning.

Challenge Day was founded in Garden Valley in the fall of 2017 when the JA and Kathryn Albertson Family Foundation provided a grant to "leverage learning on the 5th day." It started as a hit, with engaged Middle Schoolers excited about the new program. One of the first meetings was a chance for students to collaborate and decide what they would collectively like to focus on during Challenge Day. There were subjects such as pottery, self-defense, and learning Sa-

moan. Certain activities were then chosen and throughout the rest of the season's Fridays, we were able to pay for educators to come in and teach the youth. These talented instructors enlightened and engaged students at the Garden Valley District Library and the Garden Valley Public School. There was always the question of "Could I apply this skill to my future career?" and "How can this help my community?" We had many exciting visits from skilled artists and even a magician! But eventually, we realized that with all we were attempting, it was necessary to get a permanent location to host all these amazing events.

The journey to find a permanent space all started with the loft. The Garden Valley Public Library was very supportive from the start and decided to donate a space in their Community Room so Challenge Day could build a second-story tree house loft. There was much excitement, but eventually major obstacles arose. The problems seemed unavoidable and would cost much more than Challenge Day could afford. Many plans were created and each eventually was brought to a halt. It seemed that the Middle Schoolers of Garden Valley could never have a place to call their own.

However, in the fall of 2018, an anonymous donor with-

in the valley reached out to Challenge Day and offered us the supplies and eventually the money to create a building dedicated to our Middle Schoolers. But there was one catch- to see if we are committed enough to the project, we have to raise half of the funds for construction of the building and the donor will match it. So Challenge Day is rising to the challenge. Six dedicated Middle Schoolers have been working diligently for over a year, and together they created a body of Council Members that collaborates to make decisions for Challenge Day. Thanks to this council, Challenge Day is now a student-led organization determined to get a space of their own, but we need your help. Please help us by donating or attending our fundraising event.

"Taste of the Mountains" is scheduled for September 7th from 5:30pm to 8:00pm at the Garden Valley Public Library. Dinner will be served from 5:30-7:00, which will be catered by some of your favorite local restaurants and chefs, including Debbie Updike, Wild Bills, Fusion, and The Dirty Shame. AN ORDINANCE ENTITLED THE ANNUAL APPROPRIATION ORDINANCE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2019, APPROPRIATING THE SUM OF \$2,136,545.00 TO DEFRAY THE EXPENSES AND LIABILITIES OF THE CITY OF HORSESHOE BEND FOR SAID FISCAL YEAR, SPECIFYING THE OBJECTS AND PURPOSES FOR WHICH SAID APPROPRIATION IS MADE, AUTHORIZING A LEVY OF A SUFFICIENT TAX UPON THE TAXABLE PROPERTY, PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES, DIRECTING THE CITY CLERK TO FILE CERTIFIED COPIES OF THIS ORDINANCE WITH THE COUNTY COMMISSIONERS AND IDAHO SECRETARY OF STATE, AND PROVIDING AN EFFECTIVE DATE.



BOISE COUNTY**Horseshoe Bend City Council Meeting**

HORSESHOE BEND -- The following is a synopsis of the Horseshoe Bend City Council's meeting on August 21, 2019.

Council member Curtis Corvinus was not in attendance until 8:10 p.m.

After the call to order, Pledge of Allegiance, the council's approval of the agenda, previous minutes, and the authorization to pay the city's bills, Mayor Pat Goff proposed a change to the normal agenda order and opened with public comments. Jon Dufresne of Eagle spoke regarding the executive session on the agenda, "in case it's about my lawsuit against you guys." He told the council, "I can tell you exactly what it will take for me to stop, stop billing me for water I'm not using."

A few residents spoke regarding the proposed animal ordinance, with one saying they didn't need the government to control what they have on their property. Another asked the council where the permit fees would be going and city attorney Tony Pantera responded, "To cover the cost of administering the permits." Someone

mentioned the current fees for dog licenses and asked where those fees went since the city does not currently have a dog catcher and Pantera replied that the fees were "so the city can track and find out who the dog belongs to." Pantera also suggested that the sheriff's dispatch be called to catch loose dogs.

Last to speak during the public comments portion was Milo Kennedy who offered the use of his land to 4H students who might have animals displaced due to the pending animal ordinance.

Goff then opened the public hearing on the fiscal year 2020 budget. Dufresne was the only one in attendance who chose to comment, asking where the "\$8,000 for dog catching" went. Sheriff Jim Kaczmarek was in attendance and stated, "We respond directly to dog at large calls," indicating that the city was called if the need arose to take the dog into custody.

There were no public comments regarding the city's taking \$3,000 in foregone property taxes to paint public buildings. Both public hearing items were passed unanimously by the

three council members in attendance.

The mayor then asked for information regarding a city employee wage study. A three percent increase was included in the 2020 budget, but the city treasurer told the council that raises could be instituted any time during the year. Council member Riley suggested that evaluations on city employees be conducted so the council could say: "A merit raise is deserved here." The rest of the council agreed.

Kaczmarek came before the council in regards to the Boise County Sheriff Department's 2020 contract with the city. He led with comparisons between Idaho City's Police Department and the Boise County Sheriff Department. He discussed the amount of traffic going through Idaho City versus Horseshoe Bend. He stated that Idaho City budgeted \$116,000 for one full-time and three part-time employees with 60 hours of coverage versus the \$70,000 that Horseshoe Bend pays for 40 hours of flexible coverage. Kaczmarek told the council that the pros of Horseshoe Bend starting their own police force would be that "they would work for the mayor and are dedicated to the town" but the cons would include the city's liability insurance premiums, startup costs, and lack

of experience. He went on to tell the council, "In comparison to Idaho City, you're getting good product for what you are paying." Some council members complained about a lack of presence from the sheriff's department anywhere but on Highway 55. Kaczmarek explained that the current contract calls for flexible hours and that a lot of them were at night and that they targeted areas where their presence will have the most impact. He went on to suggest that if the city doesn't want to take on the liability of its own force that they may want to "explore taking on more contract hours" with the sheriff's department. Goff mentioned that the city had not been getting monthly reports from the sheriff as the current contract calls for. Kaczmarek promised to correct that and was open to adding to the contract that he make quarterly reports during council meetings, per Goff's suggestion. The sheriff asked the council for a list of current ordinances and the fines associated with them so he could present them to the county prosecutor to make sure they were enforceable. Pantera told the sheriff that the city was still working on updating the ordinances. Kaczmarek concluded by telling the council to call him any time they need anything.

The council approved allotting up to \$1,200 for the city's EMTs to attend a Mental Health and Wellness Training in Garden City and were looking into the costs associated with a trauma training in Hailey this November.

A scheduled workshop on water and sewer rates was continued until a rate study can be conducted by an independent 3rd party.

A draft of the new animal ordinance was given to the council by Attorney Pantera. He explained to the council what was added/amended. Council member Riley told the council, "Personally I'd like to throw the whole ordinance out and let the nuisance ordinance and the noise ordinance take care of it." The crowd responded with applause. Council member Corvinus agreed stating, "I think people should have their animals." Council member Marty White requested time to familiarize himself with the original ordinance and asked that another public hearing be held on the matter. The rest of the council agreed.

The EMS Department told the council they had been on 17 runs so far this month.

Public Works is completing a few small projects and getting ready for fall.

City Engineer Amy Woodruff told the council her best guess for a start date on the Highway 55 bridge would be during low water in the winter or spring.

The council went into executive session at 8:50 p.m.

The Horseshoe Bend City Council meets next on September 18 at 7:00 p.m.

LOWMAN FIRE DEPT.

FUNDRAISER THIS WEEKEND

LOWMAN -- The annual Lowman Volunteer Fire Dept. (LVFD) Fundraiser will be held Sunday, Sept. 1 at the Station 80 Firehouse, 8 miles above Lowman. The Fundraiser is held every year to raise money for various projects and is necessary to supplement volunteer and equipment needs for the Department. LVFD is entirely funded by grants, donations and the annual subscription dues of the community members. No tax funding is used to support the Department.

The notice for the event reads: "There will be Bratwurst, Corn on the Cob, Beer/Soda, food ends at 7:30, Bingo starts at 8:00 pm great prizes

and a raffle for a BIG wood-splitter." That wood-splitter looks like a beaut. Bruce Alkier will also be there to supply a little Bluegrass & Country melody backdrop to the food and fun.

In 2000, the LVFD officially formed to develop a more effective fire-fighting capability to assist in providing some local protection for fires of the Lowman Fire magnitude and larger. Such fires seem to sweep through the area with more regularity than decades ago. Local resident and Volunteer Bruce Lund said, "We hope that our residents can rest a little easier with us on duty." The District was laid out to encompass the 12-square mile in-

habited stretch between Lowman and Hanging Valley (MP 72-91)

This year is the 30th anniversary of the monster Lowman Fire that consumed more than 72 square miles and jeopardized nearly the entirety of the valley community along 10 miles of the South Fork Payette River valley. More recently, in 2016, the Pioneer Fire charred more than 192,000 acres and directly threatened homes and businesses in the river valley all around Lowman. Between the two massive fires, Lowman has seen a continuing series of small to medium fires (1000-5000 acres) threaten various parts of the valley all the way up to Grandjean.

Also, such fires have many follow-on effects, from rock and mud blowouts due to quick, severe thunderstorms, to snow avalanche and rock fall increases in burnt-out snow chutes. All the effects can directly threaten community member's lives and property, as well as cause great inconvenience if long road closures and power outages occur.

Additionally, there is the ongoing danger that homeowners experience with house and property fires that the LVFD exists to serve. With the range of threats that present challenges to anyone who lives and works in the mountain areas of the state, it is important for the whole community to support such volunteer organizations. Thus, the constant search for both money and manpower.

Station Chief Paul Rekow explained how there is a need for volunteers with clerical, mechanical, building maintenance

and other skills along with having familiarity with fire-fighting. "We have three Fire Engines, three Water Tenders and all sorts of ancillary equipment that needs maintenance and upkeep," he said. "We don't just need the fire-fighting skills, we can train folks for that. It's everything else that goes into running a rural, mountain Department like this."

Each year, along with the big fires that come along, the Department handles from 1-3 property and building fires of various types, and 6-10 medical assists or other type calls. To do this, the LVFD has 14 volunteers. Chief Rekow says they are always on the hunt for funding and personnel to fill-out and keep the Dept. running. Come-on out and join in this weekend, it should be a great cookout and chance to meet the neighbors, along with support a good cause.
