Firefighters Respond to Fires Near Lucky Peak

EAST BOISE COUNTY --

Fire lit up the hillside in three places along Arrowrock Road, early Thursday morning, on August 1st. These fires are still under investigation, but arson is suspected. The first fire near the Spring Shores Marina was snubbed at a tenth of an acre, the second at twenty acres, but the third grew to 104 acres before it was fully contained. The Robie Creek Volunteer Fire Department was paged out and among the first to the scene. They attempted to get a line and hose around the Lucky Fire, but then the wind picked up and shifted the flames. No structures were threatened by

these fires.

The page went out to Robie Creek Fire Department just after 1am on Thursday morning, to respond to a 30 to 40 acre fire. It was located before the Spring Shores Marina on Arrowrock Road. The crew quickly began attacking the fire on the west flank by digging handlines. Robie Creek Firefighter Cole Reeder said, "We almost had the handline dug all the way around the west side. At this time, the Forest Service arrived with a 30 person crew. The fuel load changed and winds started to blow against us, forcing us to retreat down the mountain to

where we met with the Forest Service. The Forest Service was going to run hose up the mountain, so we grabbed hose packs and began to help get hose laid. Once we were able to get the hose up to the top of our hand line, the fire really blew up, burning down the draw, and forced all of us back down to the road, burning up all the hose we just setup. The fire began to spot, throwing embers in front of the head of the fire. We all retreated to [Highway] 21 and Arrowrock [Road] to come up with another game plan. The Forest Service ordered a dozer and hotshots. The plan was to put in a dozer line on the west side and back burn off from the dozer line. With our tenders on scene, we had large volumes of water available. We staged below the back burn in case any water was needed. The back burn was successful. The hotshots were also able to get a handline around the east side. By this time, it was about 9am. We continued to offer water support, refilling Forest Service vehicles while mop up efforts began. Idaho Power had also begun to bring in a fleet of vehicles and equipment to replace burnt up poles. At one point, they had a downed line across Arrowrock Road caus-

ing the road to be closed to all traffic (including fire personnel) until the line could be removed and repaired. We stayed on scene until 3pm."

These fires are still under

investigation by the Bureau of Land Management, having burned U.S. Forest Service and State Lands. The fire was fully contained and is no longer active.

Due to the hot and dry conditions, there was a concern that the fire may spread to the surrounding forest. Thorn Creek and Clear Creek Volunteer Fire Departments were quickly on the scene with water tenders.

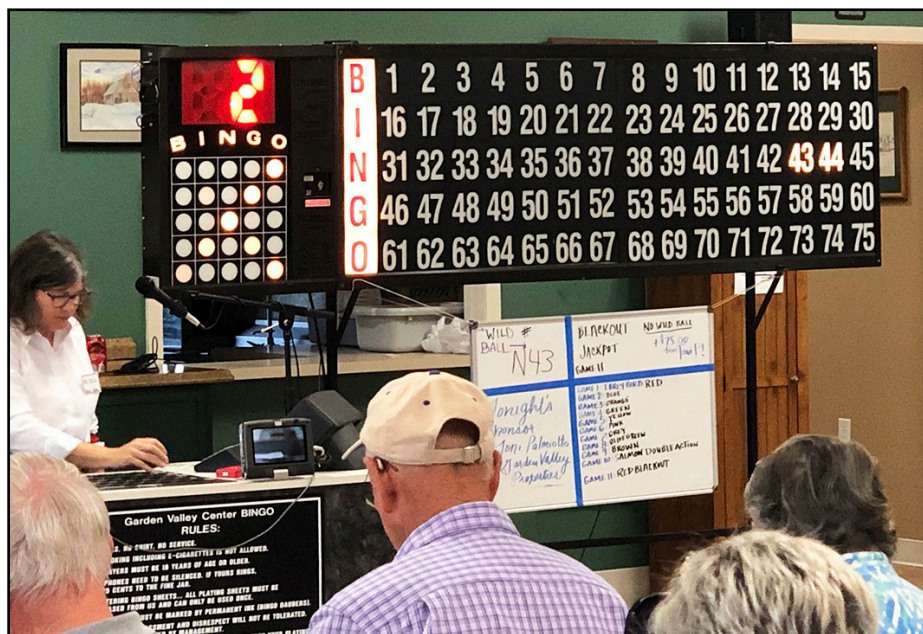

BOISE COUNTY COMMISSIONERS

Transcribed by Eileen Capson

July 30, 2019

Present: Commissioners Alan Ward, Ryan Stirm, Roger Jackson

Pledge of Allegiance

EXECUTIVE SESSION: Per pending litigation, personnel, exempt records, hiring of an employee, and risk management. [Time 9:01am to 9:32am] Commissioner Ward said, "No action required."

CONSTITUENT INPUT: None

MINUTES: The July 23rd meeting minutes were accepted.

MOTION: Commissioner Ward made a motion to have Ms. Leader from Boise County Community Justice enter into a certified public management program through the Human Resources program.

ROAD AND BRIDGE: Mr. Jones spoke about surplus items they were looking to buy, including a "reader board" and roller. "I think it would be better for our [road] chips," for the roller, said Jones. A motion was made by Commissioner Jackson to purchase the roller and reader board.

SRS FUNDS: Clerk Mary Prisco said to be in compliance with restricted funds, the SRS [Secure Rural Schools Funds]. She stated she had written out a motion.

Dust Abatement was discussed. Jackson said one night, he thought Idaho City was on fire because of all the dust.

Chairman Ward made a motion to delegate SRS funds to be used by the Road Department for the chip-seal projects, in the amount of \$250,000.

Clerk Prisco said that some amount will be received next year for SRS funds, "but there is no long-term solution."

COMPREHENSION PLAN: Commissioner Ward said, that the Planning & Zoning Commission has gone through it and updated the plan, which needs to be done periodically.

IDAHO WORLD PROPERTY: Clerk Prisco said last winter one of the snow plow operators destroyed one of the ramps. The intent of the county was to replace the ramp with similar wood material. She said the Day family, owners of the World building, went ahead and replaced both ramps with better material that would likely last much longer. They only asked that the county pay half. She said it will be paid out

of the building attendance account, about \$500.

BOARDWALK REPAIR/REPLACE: There were five buildings that were taken into account for this project. Miner's Exchange - \$40,723, Planning & Zoning Area - \$6500, Prosecutor - \$6,300, Community Justice - \$6,000, and Courthouse - \$59,000. "We've been talking about this for a *really long time*. And I think it's pretty obvious to all of us that if we *own* the boardwalk or *we don't own the boardwalk*, there is a potential liability out there, in several places." It was discussed that the Idaho City Historical Foundation required a non-standard timber, certain kind of cut and type of wood for the boardwalk. Stamped concrete, to look like wood, was discussed, which would last longer. Clerk Prisco commented, "Based on experience, I don't think the Historical Society would in any shape, way, or form agree with concrete." Mr. Jones stated, "Coloring and stamped concrete looks really, really good. Stamped planking looks like wood. It's amazing!" Chairman Ward asked about the price comparison. Jones said it would likely be a little more, but the longevity was a consideration. Commissioner Stirm offered: "There might not be that big of price difference, just because, the concrete is not going to require as much work to get it raised back up and leveled out." The quote is for fir boards. Emergency Manager Bob Showalter suggested having the boards milled locally, like they were back in the day. Commissioner Jackson stated, "I know those boards have been on there for 70 years, in and around the courthouse.

BACKUP GENERATORS: Mr. Showalter discussed getting letters of support for grant money per the purchase of generators for the schools.

CONFLICT CONTRACT FOR PUBLIC DEFENDER: Clerk Prisco said this was due to a specific case that needs to conflict out, because the other two defenders are not qualified to handle this case. A motion was said to approve the contract.

SHERIFF: The E911 Contract Grant for \$17,400 to replace the three main dispatch computers. Sheriff Kaczmarek said they were currently applying for this, and they had a fairly good chance of getting

the grant. He said they would only take down one computer at a time to transfer data. Commissioner Stirm motioned to approve the 2020 dedicated enhancement communication grant fee fund application of \$17,471.75. Chairman Ward said the grant would be between the community of the public safety communications commission and the Boise County Sheriff's Office.

DEMAND WARRANTS: Commissioner Jackson made a motion to pay for public defender's services in the amount of \$11,031.77. Motions were also said to reimburse employees for food and fuel while receiving training in Boise. A motion was said for a deputy coroner to attend a FBI training conference and mileage to a couple funeral homes in the amount of \$899.

RIDE IDAHO: A letter was put together requesting more information from this bicycle group, even though a mass gathering permit is not needed. Commissioner Stirm stated: "I would make a motion that we would sign the letter to Ride Idaho regarding complaints regarding bicycle riders on the Middlefork Road, from the Board of Boise County Commissioners."

EXECUTIVE SESSION: Per indigent and exempt records. [Time 10:14am to 10:28am] Chairman Ward said no action required.

TREASURER: Gina Turner said they have been doing a lot of collection calls, to try to get payments. She said it has helped tremendously.

EBCAD: Melissa Potts said she attended a City Council meeting and let them know how dire EMS services were in Idaho City. "Lowman is really dire also," said Potts.

Commissioner Stirm further explained about critical care, "Whenever they can't fly [Life Flight], those nurses and paramedics are stationed at the airport. So, they have to drive a unit, an ambulance, that's out to that airport, pick up that paramedic and drive here. So, it adds like 30 to 40 minutes to their response time."

COMPUTER TECH: John spoke about an email cyber security test was done. He was surprised to find that the application browser used of 36% of the time was Safari, which is through Apple. "The county doesn't have Apple equipment. So, there's a lot of people us-

ing their own personal equipment, checking the email." He warned that he didn't have any control over those devices. He learned that the county has iPhones. The sheriff said there were twenty-three iPhones.

PLANNING & ZONING: An update to the Comprehensive Plan had been completed was discussed by the administrator. It now comes to the Board for their consideration and public meeting. Bret Caulder said, "It's more of a technical update, in the sense that the charts and graphs. Nothing major in the sense of structure."

Conditional Use Permits are coming in for more communication towers, and rumors of others. There has been lots of activity with realtors. "On the building side, Bogus Basin is pretty robust right now." He discussed the Morning Star Chairlift, or replacing it, which has kept the department busy. Building is also robust.

SHERIFF: Calls for service are typically up this time of year, June thru September.

The Horseshoe Bend Annex remodel is nearly complete and he says it's looking pretty good. Carpet will be replaced in the Sheriff's Office.

He reported that a deputy would be graduating from POST Academy.

The auction brought in a total of \$23,819. "We sold every single item." There were about 75 people.

JUVENILE JUSTICE: They spend a lot of time prepping for the auction, with community service hours.

SOLID WASTE & NOX-

IOUS WEEDS: They have been spraying, and will be sending people up the Middlefork of the Payette, "because that knapweed has just gone crazy."

They hauled 100 tons of garbage out of Horseshoe Bend, and about 40 tons out of Idaho City.

ROAD DEPARTMENT: They are finishing up Hwy. 17 ditch cleaning. Hope to re-asphalt the Middlefork, from Crouch to the top of the hill, just an overlay. They are going to crack seal between Hwy. 17 and into Crouch, and chip-seal the whole length, about 10 miles, including Warm Springs Rd.

They had a new truck come in, which the dealer is taking a look at.

PROSECUTOR: Adam Strong spoke about an increased workload with the Sheriff's Office, which translates to an increase for them. There have been six mental holds in the past four weeks, and those are time consuming.

The office will be upgrading their software.

EMERGENCY MANAGER: Several representatives from the county attended the Firefighter's Association meeting in Lowman to learn about projects, including commercial logging, "believe it or not." Bob Showalter said this will include some thinning and proscribed burning. He added that it's a process that takes time, because there are a lot of groups that want to stop it,
