Neglect for Speed Limits Lends to More Accidents Local Man Loses Life While on ATV in Lowman

LOWMAN -- A longtime resident and community volunteer was tragically killed early Wednesday afternoon, September 4th. It was another vehicular traffic accident on the same stretch of Highway 21 in less than a week. The crash occurred not 100 feet from the injury accident that was reported in this paper last week.

Herbert "Duffy" Zeiber, 76, was killed instantly when struck by a westbound truck/camper on Highway 21. Zieber was crossing the road on his ATV, a short distance above the Sourdough Lodge. Witnesses said Zieber had just departed from friends off Southfork Drive, headed home, when he crossed the road and was struck by the pickup. The pickup continued another 200 feet down the roadway, after striking Zieber, then rolled off into the bar ditch where the camper separated from the truck. The ATV and Zieber came to rest behind the overturned camper.

The driver of the pickup/camper said he was returning from a visit to Grandjean, 20 miles upriver from the accident location, when the accident oc-

curred. He was apparently uninjured in the accident and was checked by emergency personnel. It is unknown, pending investigation, if there were any other factors involved in the collision. An investigation into the cause and events leading up to the collision is being conducted by the Boise County Sheriff's Office. However, skid marks in front of the impact point indicated very little reaction time.

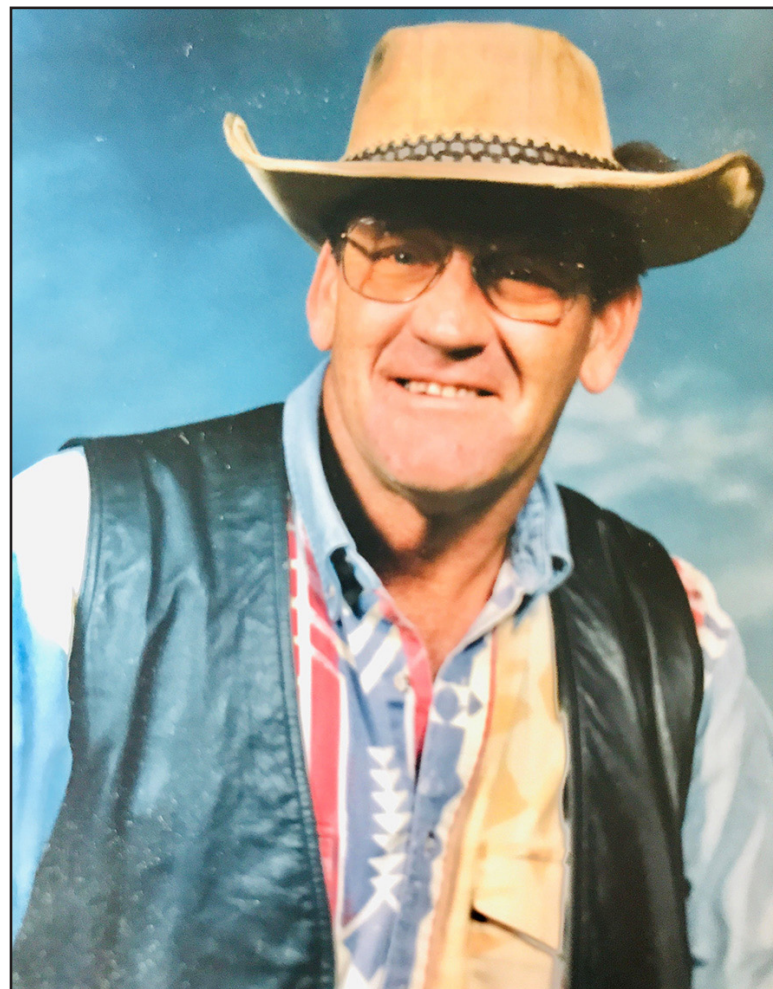
The body of Mr. Zieber was transported by ambulance to the Summers Funeral home in Meridian. Funeral service was conducted Tuesday, Sept. 10, at 3629 E. Ustick Rd. with burial in Caldwell, to follow.

"Duffy" Zieber was a ten-year volunteer with East Boise County Ambulance District as an ambulance driver. He was a long-time member of the Lowman Community Church and volunteered for many community activities. Other residents recall "Duffy" as one of the friendliest, outgoing, yet quiet members of the Community. He leaves behind his wife, "DJ," along with adult children and grandchildren in the Treasure Valley. Duffy and

DJ were co-drivers for many years, owning and operating their own rigs as independent long-haul truckers.

With the ongoing rash of "senseless and needless" accidents in Boise County this summer and for many years, many residents are angered and frustrated by the apparent neglect of speed limits, safety precautions, and traffic control at various point throughout the County. Local residents in Lowman have complained for years, decades even, of the lack of proper signage, warning indicators, and speed limits on both State Highway 21 and Banks-Lowman Rd. (Highway 17) through Garden Valley and along Highway 55 from Horseshoe Bend to Cascade. That includes the Highway 55 - Banks-Lowman Rd. intersection, a perennial blood clot on Summer weekends and holidays.

Several residents immediately mounted an informal petition, describing and indicating the specific steps that have been repeatedly requested, to be delivered to County and State officials. It is hoped (even demanded) that the common-sense steps provided are acted upon by all involved parties.

The new general manager at the Sourdough Lodge, Amy Alandt, had this observation, "Every day I can watch and hear the cars and trucks accelerating flat-out when they enter the straight section in front of

the Lodge. I see people nearly getting rear-ended just trying to turn into the parking lot. It's utter mayhem. We need to get the speed down in this residential section. We need to, 'Do it for Duffy.'"

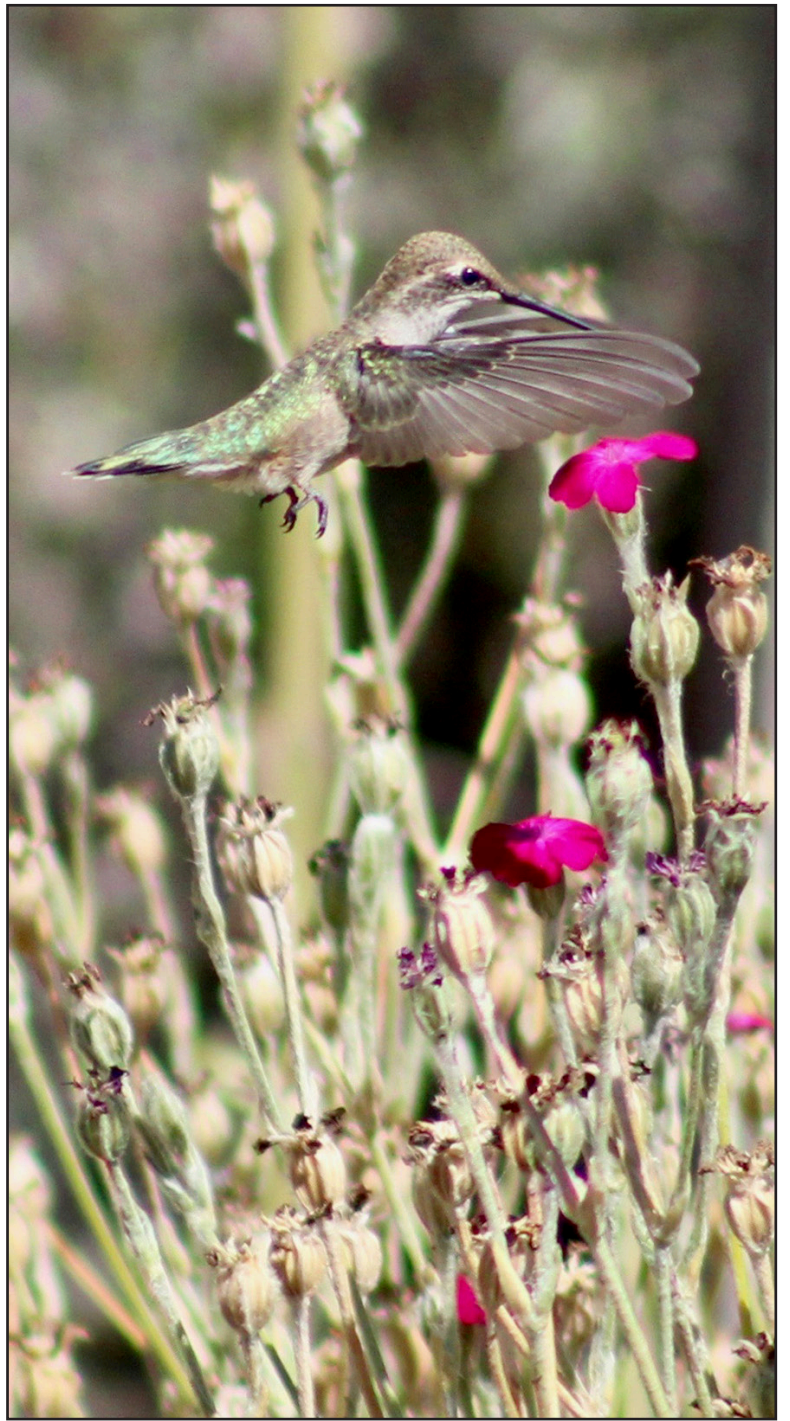

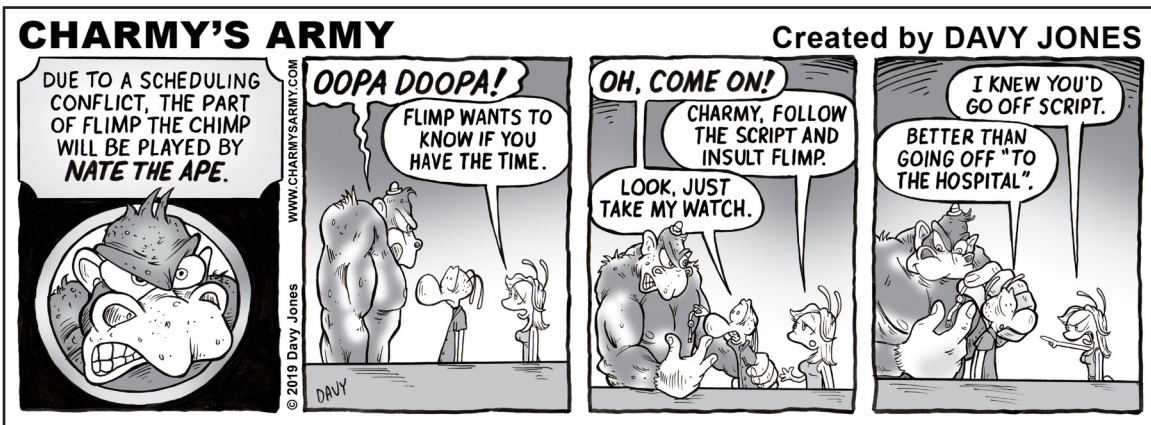
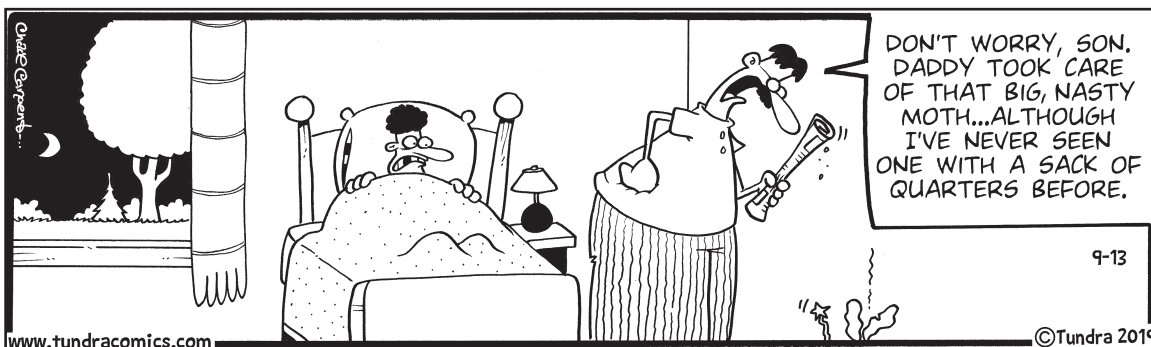
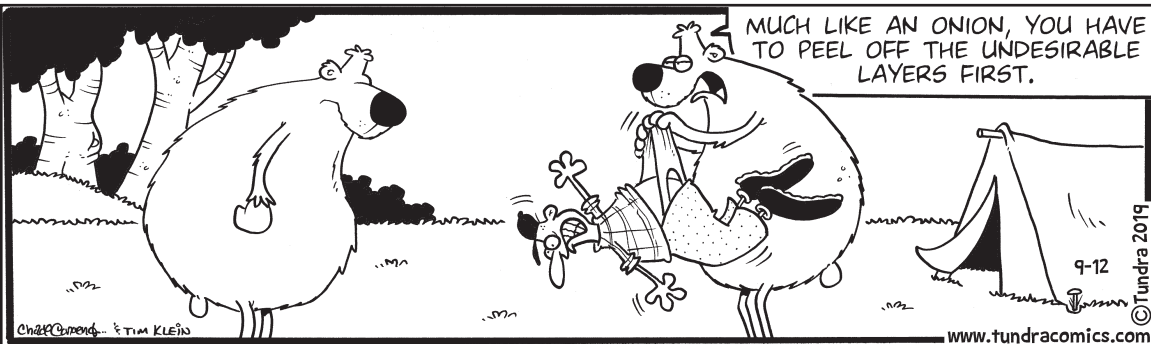
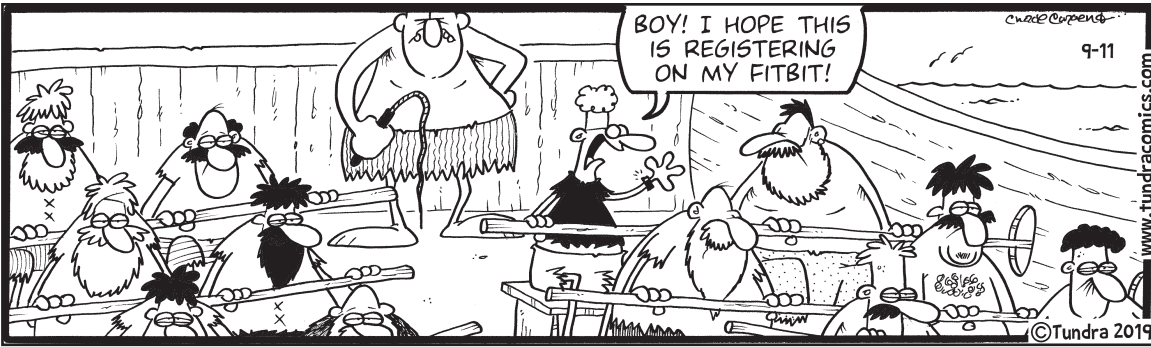
Her heart is deep with patriotism, having had three sons serve in the U.S. military, as well as her brother and 92-year-

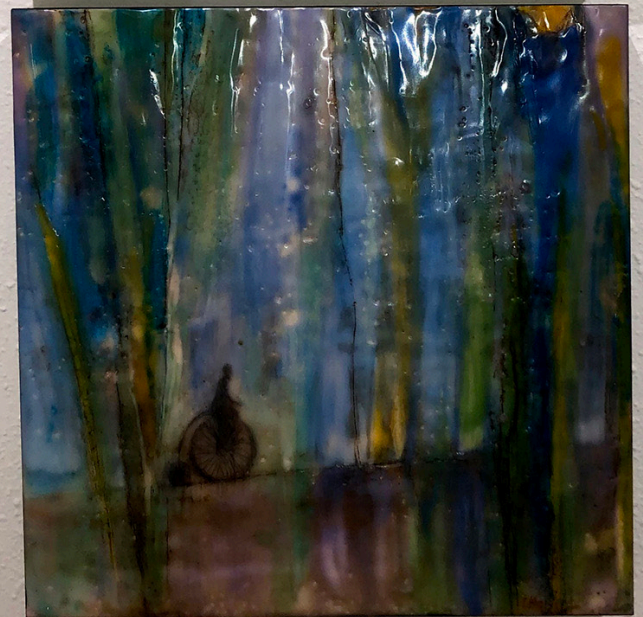

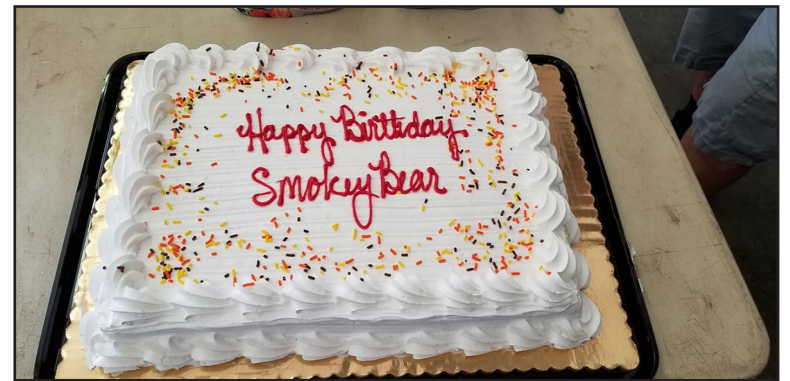

BOISE COUNTY COMMISSIONERS

Transcribed by Eileen Capson

September 3, 2019

Present: Commissioners Alan Ward, Roger Jackson and Ryan Stirm

EXECUTIVE SESSION: Closed session per exempt records, personnel, pending litigation, hiring of a new employee and risk management. [Time 9:04am to 9:28am] No action was required, coming back into session.

MINUTES: Commissioner Jackson made a motion to accept the August 27th meeting minutes.

BOGUS BASIN EMERGENCY RESPONSE DISCUSSION: Emergency Manager Bob Showalter said the county didn't have the authority to enter into a memorandum, instead that falls to the city of Horseshoe Bend for taxing purposes. Showalter talked with a representative from Bogus Basin who discussed the possibility of having their own ambulatory service. Chairman Ward considered the fact that the Board could draw the boundaries of the proposed district, "that would encompass that area, which would take care of everything that isn't being met now." Sheriff Jim Kaczmarek recalled there had been two calls within that area in the past 17 years, questioning, "If they are willing to take that on, and there's no benefit for them to take that on. They are outside the boundaries of Bogus Basin." Director for

East Boise County Ambulance, Melissa Potts, said that they already have a number of EMTs up there, and would just need the equipment and a Quick Response Unit.

CONTINUITY OF OPERATIONS: Showalter discussed information gleaned from a class and spoke about other online courses offered. He encouraged continuing plans for government operations, should something happen to this location.

ROAD & BRIDGE: A deicer truck was discussed, costing \$5,000, which would go to Garden Valley. A motion was said for the 1996 Mack dump truck deicer unit.

Paving was said to be going well.

FIRE: Commissioner Ward asked what caused the fire in Garden Valley. Sheriff Kaczmarek said it was still under investigation, but recounted that it appeared that a camper trailer came unhitched, "bounced along, still chained to the truck. They drug it off the road. Those sparks started a fire... the guy got it hooked back up and drove off. We have information on that that we're working on." The road was closed, and they had a pilot car from the Road Department. The sheriff concluded, "It was a good concentrated effort on one of our busiest weekends." Fire Chief Jon Delvalle and his Garden Valley Volunteer Fire

Department was very involved with laying a network of hose.

"We have a congestive problem on heavy weekends and in the winter," Kaczmarek said. "ITD have got to pick up the ball on this and start taking some responsibility for it." The traffic count on Highway 55 is for 12,000 cars maximum capacity, but it's running 10,500 this year and continues to increase each year.

ADJUSTING THE INDIGENT FUND: Chairman Ward made a motion to adjust the Boise County Indigent Fund for the FY2019 budget.

ADJUSTING THE RESERVE MASS GATHERING BUDGET: A motion was made by Commissioner Jackson to adjust the FY2019 Sheriff Reserve Deputy Department budget for Mass Gatherings.

ADJUSTING THE COMMUNITY JUSTICE / COURT FUND: A motion was said by Commissioner Stirm to adjust the FY19 budget for Community Justice Department.

RESOLUTION INCREASING FEES: Chairman Ward made a motion to increase fees for the Solid Waste Department, "as corrected. Just changing that one word from 'more' to 'less.'"

CERTIFICATE OF RESIDENCY: Approval of one student application.

LIQUOR APPLICATIONS: There were several

business applications approved.

DEMAND WARRANTS: Employees were reimbursed for attending their conferences.

EXECUTIVE SESSION: Closed session per exempt records, pending litigation, hiring of a new employee, risk management and personnel. [Time 10:19am to 11:03am] Commissioner Ward said no action required, but there were motions made under exempt records.

EAST BOISE COUNTY AMBULANCE DISTRICT: The purchase of uniforms was discussed for \$2,700. They have \$4,000 for uniforms in the budget. Even with all the traffic, it was a quiet weekend for EMS.

They attended an event in Placerville, hosted by the fire department, and spoke about a class that they will be offering and trying to man the ambulance again. They have two possible applicants for EMTs. A representative of EBCAD said, "There was no negativity. A lot has happened, and we said it was time to forgive and forget. I said, it takes us from Unit 15, fifty-five minutes to get there. *That's just too long. Somebody could be dying at that point.* So, I'm really optimistic about it. So, I hope so."

Commissioner Stirm said he's been noticing more medical calls from there. They have Search & Rescues, ATV accidents, etc. Stirm added, "It would benefit them greatly to have an ambulance to cover that middle ground... *That's a big step for the county,* is con-

tinuity of operations, as far as coverage goes... There are areas that are really, really, really remote, that nobody can really get to."

There are about 20 people interested in the class, 30 may be considered the cutoff.

ADOPTED BUDGET: The county will wait to the last opportunity to publish the budget, to catch anything prior. Commissioner Ward commented, "We didn't hear from the Tax Commission this year." Clerk Mary Prisco replied that she thought it had actually been two years in a row, "but there's still time though." They have until the end of October to approve the levies.

CLASSES: A plan was put into effect to have a short session on September 24th so that the Board could attend some classes by the Idaho Association of Counties. One class Commissioner Alan Ward was interested in attending was in regards to social media and elected officials.

MINER'S EXCHANGE BUILDING: It was said that the building was repainted a third time under the eaves and looked much better.

LAND TRANSFER: Chairman Ward made a motion to send a letter to the Idaho City District Ranger, Brant Petersen, discussing the desire to move forward with an application process for a special use permit for a transfer station around Grimes Creek, and eventually trade a 20-acre parcel of land owned by Boise County, to the Forest Service, for that parcel of land.
