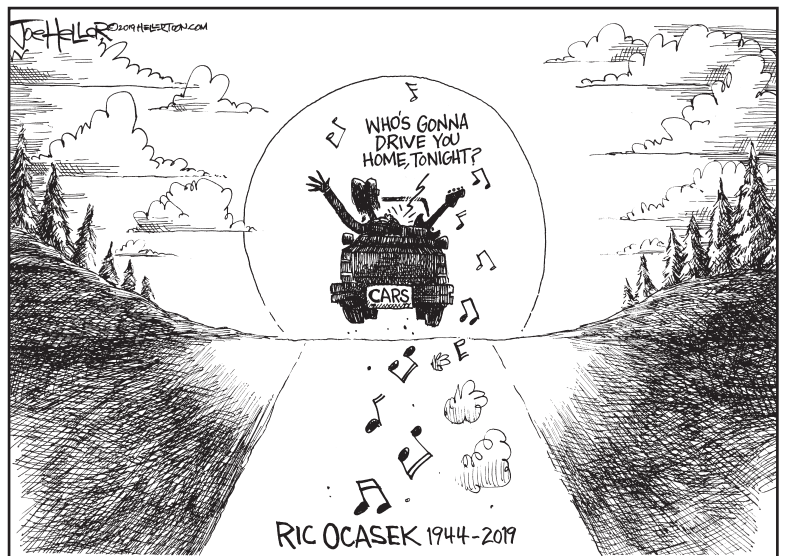
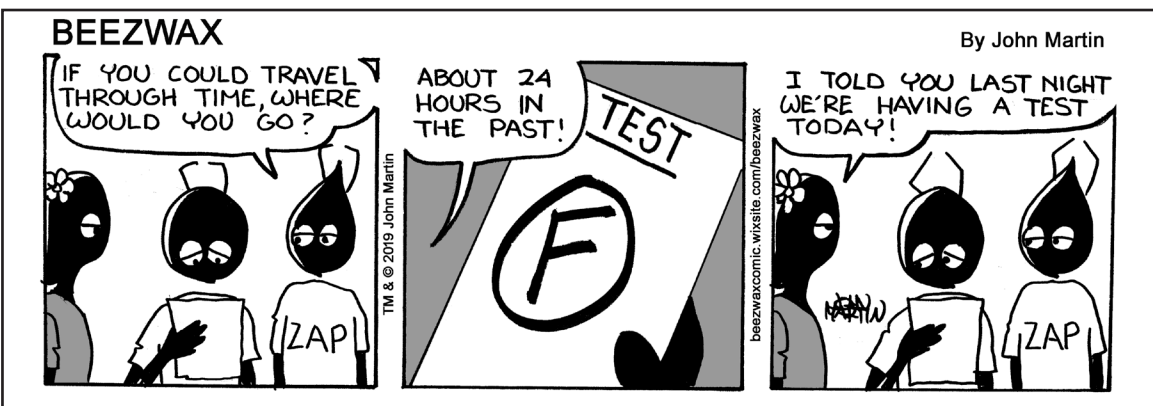
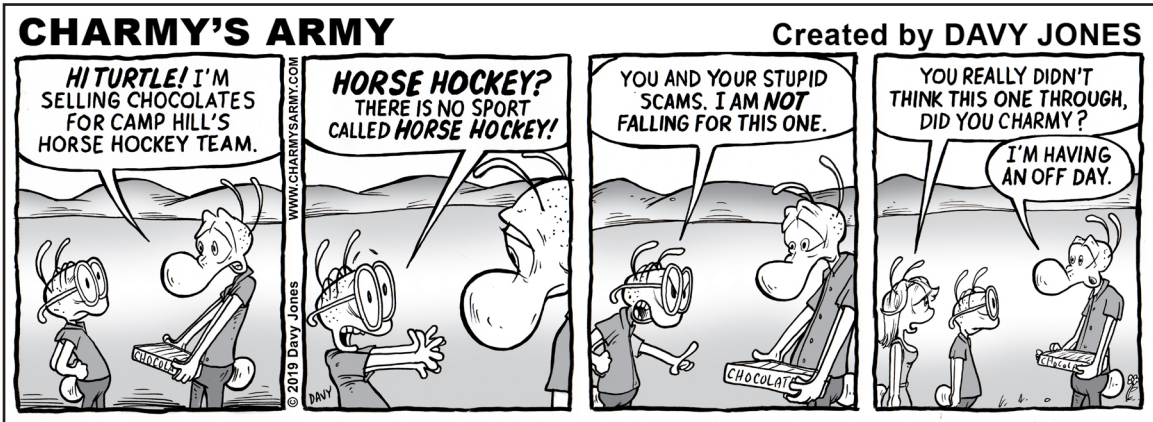

This event includes many activities that benefit the scholars. This affair is used to teach students helpful outdoor skills and subjects. It is also used to promote our excellent STEAM (Science, Technology, Art, Engineering, and Math) Program. Every year is a different ICOE, so we try to always change it up. We get people from throughout Idaho, to do activities like bug identification, hiking, dog search and rescue, zip-lining, and other exhilarating ventures. After lunch, the STEAM Projects go into action, Art and Crafts, Outdoor Building, plus various others. ICOE keeps the students interested in education while having a significant amount of enjoyment.

Living in Idaho City and going to school up here comes with a lot of unflattering stereotypes. Some of those stereotypes include that we are uneducated, that we lack
