RETURNING TO THE SKIES IN HORSESHOE BEND

HORSESHOE BEND --

The Horseshoe Bend Flight Park is taking to the sky again after a two month hiatus. Owner Scott Edwards is soloing now after the tragic death of his business partner, Justin Boer, in July. Despite the setbacks incurred, Edwards has big plans for the flight park. Beginning October 4 and continuing until October 6, the park will be the host of the World Accuracy Cup. Those paragliders who participate in

the competition must accurately land on a target pad and are scored based on their landing's proximity to the target's center. According to Edwards, it will be the first of its kind in the United States. The event is set to run for three days from 9-6 p.m. and Edwards is planning on having musical entertainment at times during the event. Spectators are encouraged and welcomed to the event. (There will be designated areas for spectators to watch/park-no seating will be provided but

those attending can bring their own). Edwards hopes to make this an annual event. There will also be a memorial for Boer during the event. VOLUNTEER FIREFIGHTERS TRAIN IN HSB

HORSESHOE BEND --

The Horseshoe Bend Volunteer Fire Department underwent training exercises related to rescues on September 21 and 22. Elite Extrication & Equipment from Nampa conducted the multi-agency training that also included firefighters from

Montour and Robie Creek. Elite Extrication & Equipment sells the tools utilized in rescue extrication and provides training as well. The firefighters received training on how to safely enter vehicles involved in crashes. Some of the information related to how to locate air bag cylinders that failed to

deploy, how to turn off keyless and electric powered vehicles, how to remove both safety and laminated glass windshields and side windows, and how to cut seat belts. Elite Extrication emphasized what they referred to as “customer service”, which included how to talk to and reassure victims.

The fire departments worked on several donated vehicles that had been involved in accidents and deemed unsalvageable. The Horseshoe Bend Fire Department was also accepting donations to benefit the local Optimist Club.

The department also welcomes donations to the HSB Burn Out Fund. The Burn Out Fund helps community members who have suffered a house fire by way of short term help with shelter, clothing, and food. Transportation department to host public meeting Sept. 27 regarding ID-55, Banks-Lowman Road intersection

GARDEN VALLEY -- The Idaho Transportation Department (ITD) is holding a public meeting on Friday, Sept. 27th, to discuss concerns about the Idaho Highway 55/Banks-Lowman Road intersection.

The meeting will be from 4:30 p.m. to 6:30 p.m. at the Garden Valley High School in the multi-purpose room, 1053 Banks Lowman Road.

ID-55 is used to reach popular outdoor and recreational destinations, and experiences significant traffic during the weekends in the sum-

mer months. The highway is used to get to Garden Valley, Crouch, Cascade, Donnelly, McCall, and New Meadows, as well as other communities. Congestion increases during the summer weekends at the ID-55/Banks-Lowman Road intersection.

At the meeting on Sept. 27th, ITD staff will be available to share information, hear concerns, and engage with citizens and businesses on ways to manage congestion, including exploring creative ideas in the short-term and long-term.

ICVFD: Fire Prevention Week 2019

BOISE COUNTY -- Decades since the Great Chicago Fire. It began on October 8, 1871, and was the impetus for the designation of a National Fire Prevention Week back in 1922. The themes this year, 2019, are two fold; "Not every hero wears a cape", and "Plan and practice your escape".

Numbers over the past several years have shown that, on average, seven people per day are victims of fires. That only accounts for deaths, however. Many more are injured as a result of fires. As recently as 2017, U.S. Fire Departments responded to 357,000 home structure fires.

With modern construction methods and modern furnishings, you only have one or two minutes to get out of the house once a smoke alarm is activated. That puts emphasis on the "Plan and practice your escape." theme this year. Your planning should include having two ways out of every room, if at all possible. We all know there are rooms without windows and only one door, so plan accordingly. Closing doors behind you is vitally important as well, because that will slow the spread of a fire that has started.

"Not every hero wears a cape" in this scenario refers mostly to the firefighters that will respond to your emergen-

cy. Teaching children what firefighters look like wearing their turnout clothes and equipment is something your children need to be informed about. Children have been known to hide from firefighters searching for them because of the appearance and sounds they make while searching.

A few tips for the person seeing a fire start at home or where ever they may be, are mostly common sense, but seem to be overlooked or even ignored in too many instances. One of the most important, especially here where we live and rely on volunteer fire departments, is to be sure to report the fire immediately. If it is small and can be fought effectively with a fire

extinguisher, by all means do that. Just make sure to call 911 BEFORE trying to extinguish that small fire.

Why not just put it out and not call 911, you ask? Pretty simple, really. You might not be successful in getting the fire out and the time you spend before calling 911 is time the fire department could be on its way to your location. The fire department does not object to responding to a successfully extinguished fire, and firemen have equipment to ensure that the fire has been successfully extinguished.

So, if you have a large, or even a small fire on your hands, get out as soon as you can and

get that 911 call made. A fire response from most taxing fire districts, Wilderess Ranch, Idaho City, and Placerville for example does not cost you anything if the fire is out when they get there, and the cost from a fire will always be less if the fire department gets there sooner rather than later.

I sincerely hope this helps clear up any questions you may have had about these situations. But above all, I hope that everyone takes it to heart to plan your escape if that bad day comes, and do your best to prevent fires that are so much more dangerous in these modern times.

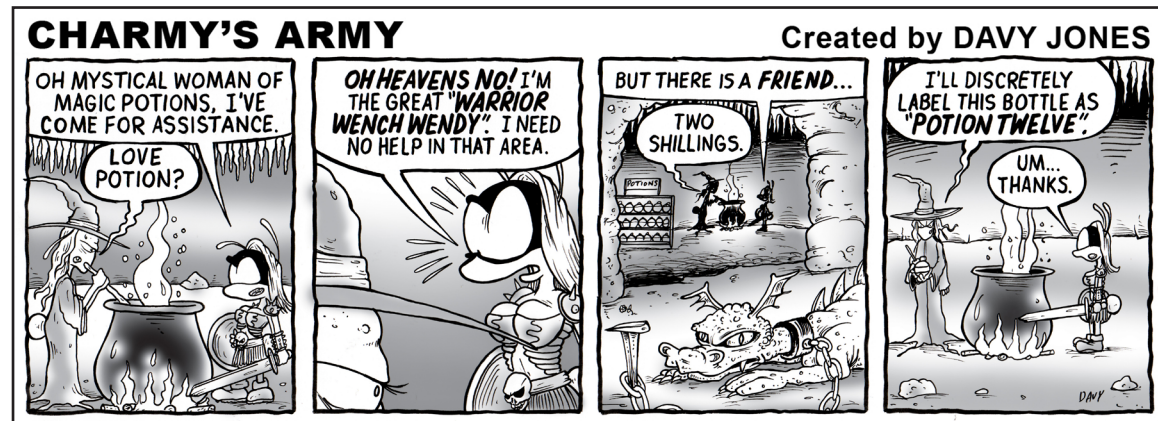

BOISE COUNTY**What to do Before the Fire Department Arrives: Part 1**

BOISE COUNTY -- This is the first in a series of three articles that will discuss what you can do in an emergency before the fire department arrives. This article deals with what to do if the emergency is a structure fire.

The first and most important thing you can do is make sure everyone is safe from the threat of the fire. That may mean getting people out of the structure or at least away from where the fire is now and is likely to spread. If you have to evacuate your home, do so quickly, everyone needs to be out in 5 minutes or less. As you move through the building, be sure to check closed doors with the back of your hand to see if they are hot. If the door is hot do not open it and enter the room, the room is probably already involved in the fire. In any event of opening a door, do it care-

fully and be prepared to shut it quickly if you open it and see that the room is involved. If the room you are going through has smoke, get down low and crawl. The lower you get, the less smoke and the cooler the temperature.

When everyone is safe, call 911. In today's homes a fire can double in size every 30 seconds. Our homes burn faster and hotter because of all the synthetic materials within. What looks like a small fire can become an inferno quickly. We live in a rural area and are served by a volunteer fire department. That means it will take some time, in the best of circumstances, for firefighters to arrive. No firefighters are going to be angry because you called them and when they arrive you have put out the fire. Get them coming as quickly as you can.

Now that everyone is safe and the firefighters are on their way, it's time to determine if you can fight the fire yourself. If it's a small fire and you believe you have the equipment to put it out yourself and you can fight it safely, you may decide to try fighting it. Some fires call for the use of a fire extinguisher. At this point, you need to know what is burning: a liquid petroleum, an electrical fire, magnesium, or wood. What is burning determines what to use to extinguish the fire. Water isn't always the right answer. Do you have an extinguisher rated for the type of fire you face? The most versatile, and expensive, extinguisher is one rated for A, B, & C fires. You can use that one on almost every type of fire, except a magnesium fire. The next question; is the fire extinguisher in working order? Does the pressure gauge regis-

ter in the green? Is the chemical in the extinguisher still OK or has it caked up? Finally, do you know how to use the extinguisher so you don't spread the flames? This is especially true for liquid petroleum fires. The main purpose of a fire extinguisher is not to help you fight a fire, but to help you escape from a fire. Don't assume you have to stay and fight the fire just because you have an extinguisher. If you decide to fight the fire, never let the fire get between you and your escape route!

Let's say you decide to not fight the fire, what can you do? The best thing you can do, if and only if you can do it safely, is to close all the windows and doors in your house. Effectively, this tends to reduce oxygen to the fire and will slow the extension of the fire from the room of its origin. If you choose to

do this, be sure to feel all currently closed doors with the back of your hand. Remember the "hot door rule" discussed earlier. Once all the windows and doors which you can safely close are closed, get out!

When the firefighters arrive on scene, be sure the first thing you tell them concerns whether everyone is out and accounted for, or if someone is missing and where you think they might be in the building. Once you are out of the building, stay out. Every year, people die going back in to a burning building to save stuff. When you go back in, you put yourself at risk and the firefighters who will have to search for you. Stuff can be replaced, lives can't.

In an earlier article I talked about a "go-bag" for each member of the family, and your pets. While the concept of a go-bag is for wildland fires, it is also useful in the case of a structure fire. Have one ready and conveniently located so you can grab and go in the event of a structure fire.

Finally, in an earlier article I also stressed the importance of having working smoke detectors, where to put them, and how to maintain them. There is no doubt about it, smoke detectors save lives by buying time with an early warning that there is a fire in your house.

Throughout this article, I have tried to stress the issue of your safety. Getting everyone out alive and uninjured is of paramount importance, not you fighting the fire. If you can't safely do anything but get out, no problem. Leave the fire to the firefighters who are trained and equipped to do the fighting. BE SAFE.

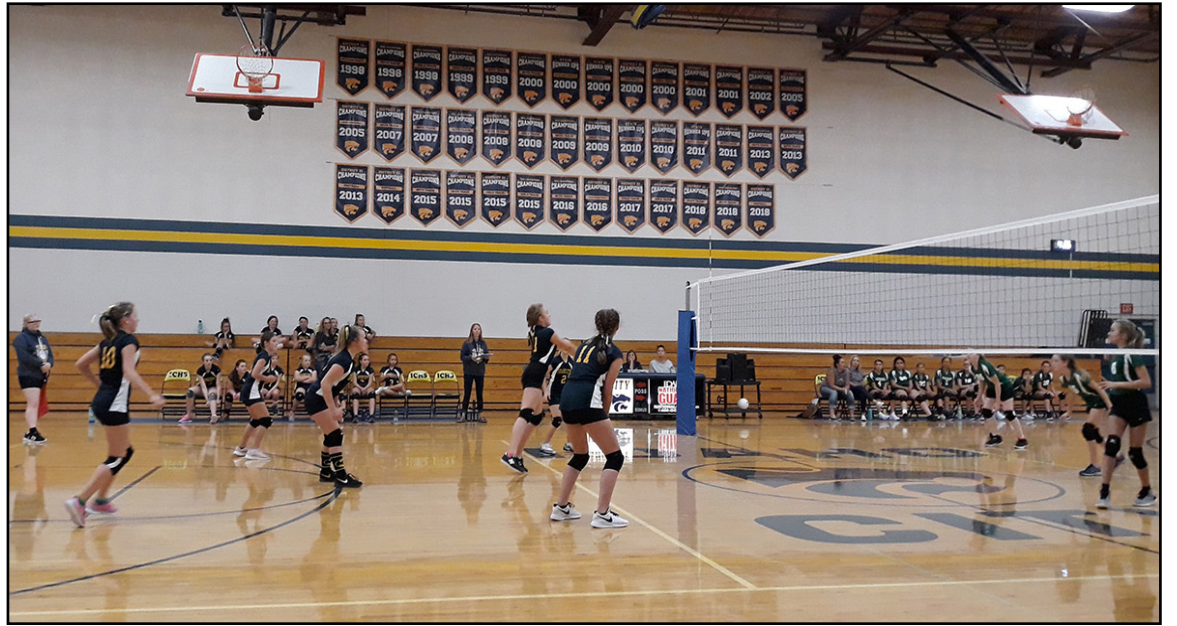
On our Wildcat Middle School volleyball team, there are also two other teams - A and B. The B team won one set, which was awesome!

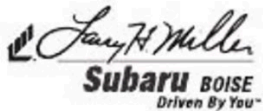

Present: Commissioners Alan Ward, Roger Jackson, and Ryan Stirm

Pledge of Allegiance

EXECUTIVE SESSION: [Time 9:01am – 9:36am] Closed session per Human Resources update, pending litigation, personnel, exempt records, hiring of new employee, and risk management. Chairman Ward said after coming back into session, “No action required.”

CONSTITUENT INPUT: None

MINUTES: The September 10th meeting minutes were accepted by a motion.

ROAD DEPARTMENT: The department logged more than the expected hours of overtime. Mr. Bill Jones explained that it was

difficult for guys to take time off, because they were shorthanded. He added, “We had a pragmatic spring, with a lot of damage to the roads that we had to take care of.” Jones would like to pay that amount down, which is over \$27,000. [This issue of overtime pay was put back on the agenda to be addressed in two weeks.]

Middle Fork Road was finished up with the fog coat.

The road equipment will be moved to Robie Creek, to lay asphalt, “better than half a mile.”

VOTING MACHINE: It was said that a voting machine was needed for either Mores Creek or Garden Valley. Commissioner Jackson made a motion to buy the voting machine.

FORESTER: An extension will be asked for the Clear Creek /

Robie Creek Project for one year. The Forester said the project was going well.

SHERIFF: Jim Kaczmarek gave an update on the Horseshoe Bend substation and said the flooring was getting close. He stated that there was some damage to the bricks.

IDAHO DEPARTMENT OF LANDS: Memorandum of Understanding for a grant for the Forester to take advantage of, particularly with the Robie Creek project. The memorandum was accepted with IDL in the amount of \$240,000.

PATHOLOGY AGREEMENT: The issues of pathology have been tabled.

JUVENILE DETENTION HOUSING: The agreement was reviewed by Prosecutor Adam

Strong. Commissioner Ward motioned to approve the Boise County/ Canyon County juvenile detention housing agreement for 2019/2020.

EMERGENCY MANAGEMENT GRANT: The amount of \$23,462 was received through a grant by the Idaho Office of Emergency Management through a motion for Boise County Emergency Management.

CERTIFICATE OF RESIDENCY: One was accepted, [per college assistance out of county].

MAKE BOISE COUNTY SPECIAL: Events were discuss, along with draws, such as wildlife and recreation. Commissioner Ward filled out the form.

DEMAND WARRANTS: **TRUCK:** Paid \$5,000 to the Idaho Transportation Department for a dump truck.

MOUNTAIN STATE COUNSELING: The amount of \$750 was paid for a psychological evaluation.

INDIGENT EXECUTIVE SESSION: [Time 10:01am to 11:31pm] Closed session per indigent cases, pending litigation, personnel, hiring of new employee, and risk management. Under exempt records, one case was suspended, another was released from a lien, and another was signed as an emerging case. Otherwise, there was no action required.

EAST BOISE COUNTY AMBULANCE DISTRICT: As the EBCAD Governing Board, the commissioners inquired about the ambulance district. Ms. Melissa Potts discussed a Garden Valley mutual agreement for Lowman.

An EMT class is scheduled and she said there has been a lot of interest from Idaho City and some from Placerville. Unfortunately, there wasn't much interest in Lowman, but they are trying. Chairman Ward stated, “If the community wants a service, they

have to help provide it.” Ms. Potts responded, “Lowman doesn't really get that many calls. We've responded there three times in the last two weeks.” Garden Valley has only been called out about three times this year. There is a cost of \$400 that was discussed, as a flat fee for the patient, but there are other options being discussed.

She continued, “We all know that we lost an ambulance driver in Lowman, and it shook the community pretty good up there. *It shook us up pretty good...* I didn't know it was him until I pulled the sheet back... The community is kind of suffering and I kind of would like to do something to memorialize him.” Because he was very involved in a church there, some consideration was going into what to do there to memorialize “Duffy” Zeiber.

The attorney cautioned there is a complication with using public funds.

There is an appreciation account, as a reward to people for their service, so that is where the money may come from. Ms. Potts will come up with some ideas.

The Command Vehicle was discussed and how it can be transported from her residence, because she's always on call.

SOLID WASTE/ MILLER ENTERPRISES: Mr. Miller passed out papers and spoke about “how much money I'm losing.” The contract with the county expires at the end of the year. Commissioner Ward challenged that it always takes money to start up. Miller would like to have the ton weight lowered to \$60.16, “to stay afloat.” No decision was made by the commissioners.

GROOMER SHED: Five bids have come in for the new groomer shed Garden Valley. Completion of the shed is expected by Dec. 16, 2019. [An advertisement is in this week's Idaho World legal section.]
