Damaging Winds Take Roof Off School

HORSESHOE BEND --

Horseshoe Bend Middle School sustained damage on Saturday, October 19 when strong winds blew off the eastern side of the school's roof. Some of the metal roofing sections landed on adjacent Highway 55, as well as on Sonora Restaurant's property. No injuries were reported. Luckily, the school still had its original asphalt roof under the metal sheets. The school was open Monday and the damage had little impact on student attendance.

Dennis Chesnut, Horseshoe Bend's Superintendent / Middle-High Principal / Athletic

Director stated: "While we were certainly shocked and dismayed by the wind damage to the roof of our middle school, our patrons can rest assured that our insurance policy will fully cover the roof replacement, and it will not be a financial burden on our district. Additionally, the original asphalt shingles are still on the building, and we feel confident that the building is sufficiently dried-in for the short period of time it will take to have the roof replaced; we estimate about 7-10 days to have the new roof completed. The middle school building is open and fully-functional."

National Weather Service & Idaho Transportation Dept.



ITD tracks avalanche danger along the Hwy. 21 corridor.

BOISE COUNTY --

The Boise National Weather Service [NWS] invited media outlets to attend a presentation on Thursday, October 17th. Meteorologists discussed a seasonal outlook that predicted an average precipitation and snow pack year. All the stream flows in Idaho appear to be running at normal, and the reservoirs are presently above average. They were hopeful of some more rainfall, which would help with the soil moisture and a good spring runoff. Currently, Idaho is drought-free across the state. The meteorologists expect the forecast to remain neutral, not impacted by an El Niño or La

Niña year, but models show above normal temperatures this winter.

During the winter months, the NWS forecasts twice daily information that may be es-

sential in predicting avalanche danger along Highway 21, specifically between Lowman and Stanley. A representative of the Idaho Transportation Department [ITD] addressed many of the issues they face in this corridor where avalanches are frequent. The highway historically remained closed in the winter until 2000 when an avalanche program was initiated tracking approximately seventy paths along Canyon Creek.

A team of three ITD employees ski to different locations, dig snow pits to examine layering, hardness, and temperature gradients. They track and study fractures and whether the snow pack is weak or strong to better predict avalanches.

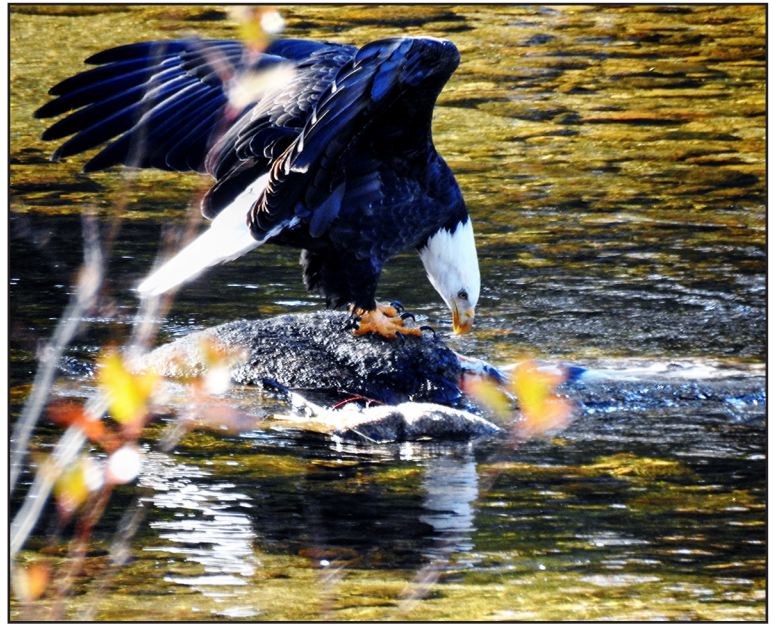

The Great Cardboard Cut Out

Elementary Students Create and Learn with Cardboard

IDAHO CITY -- Last week in Idaho City, the elementary school gym was transformed into a game arcade. Students grades K-6 laughed and hooted as they played miniature basketball, claw machines, and marble runs. Lucky winners received prizes ranging from a cardboard token to an origami rose. All of the games and prizes were imagined, designed, and created by elementary students using only found and recycled materials.

This fun gathering marked the second time Basin School District has joined the Global Cardboard Challenge, an annual event in which students across the globe learn engineering and math skills through creative play. Grant writer and sixth grade teacher ReBekha Lulu wrote a grant to the Science, Technology, Engineering, and Math (STEM) Action Center to obtain the funds for Idaho City students to participate.

This year's project was inspired by a short film called *Cain's Arcade*, featuring a child in California who entertained himself by creating arcade games out of the waste cardboard at his father's repair shop. The young Cain inspired his California community to appreciate imagination and do more with less. This fall, Basin Elementary students got to do the same.

Third through sixth graders were provided cardboard, tape, glue, plastic water bottles, straws, and old CD's and instructed to make a game that other students would be able to play. Fifth grade teacher Megan Hunicke said the project helped the students learn cooperation and problem solving.

On the event day, younger

students got to come and play all of the games. Teachers followed them from room to room, watching the students get excited to win paper balls and taped-together CD's as

Appropriation Ordinance 2019-01

AN ORDINANCE ENTITLED THE ANNUAL APPROPRIATION ORDINANCE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2019, APPROPRIATING THE SUM OF \$47,867 TO DEFRAY THE EXPENSE AND LIABILITIES OF THE CITY OF PLACERVILLE FOR SAID FISCAL YEAR, AUTHORIZING A LEVY OF A SUFFICIENT TAX UPON THE TAXABLE PROPERTY AND SPECIFYING THE OBJECTS AND PURPOSES FOR WHICH SAID APPROPRIATION IS MADE.

BE IT ORDAINED by the Mayor and the City Council of the City of Placerville, Boise County, Idaho.

Section 1: That the sum of \$47,867 be, and the same is appropriated to defray the necessary expenses and liabilities of the City of Placerville, Boise County, Idaho for the fiscal year beginning

October 1, 2019.

Section 2: The objects and purposes for which such appropriation is made, and the amount of each object and purpose is as follows:

Section 3: That a general tax levy on all taxable property within the City of Placerville be levied in an amount allowed by law for the general purposes for said City, for the fiscal year beginning October 1, 2019.

Section 4: All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed.

Section 5: This ordinance shall take effect and be in full force upon its passage, approval and publication in one issue of the Idaho World, a newspaper of general circulation in the City of Placerville, and the official newspaper of said City.

PASSES under suspension of rules upon which a vote was taken and duly enacted an Ordinance of the City of Placerville, Boise County, Idaho at a convened meeting of the City of Placerville City Council held on the 21st day of September, 2019.

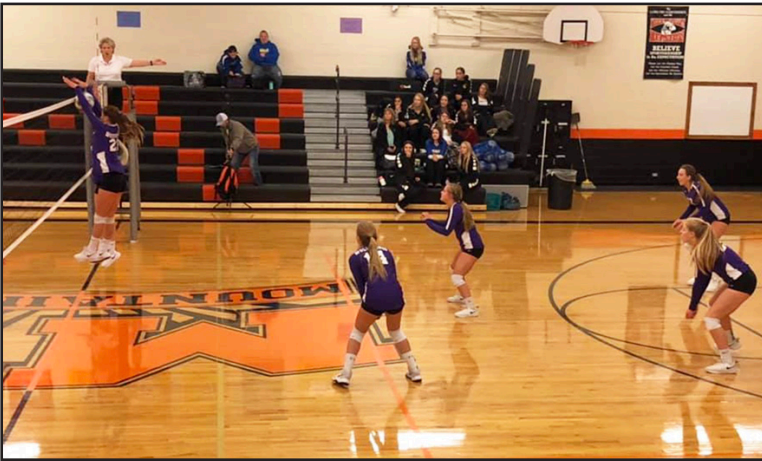

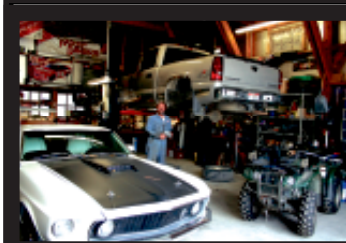

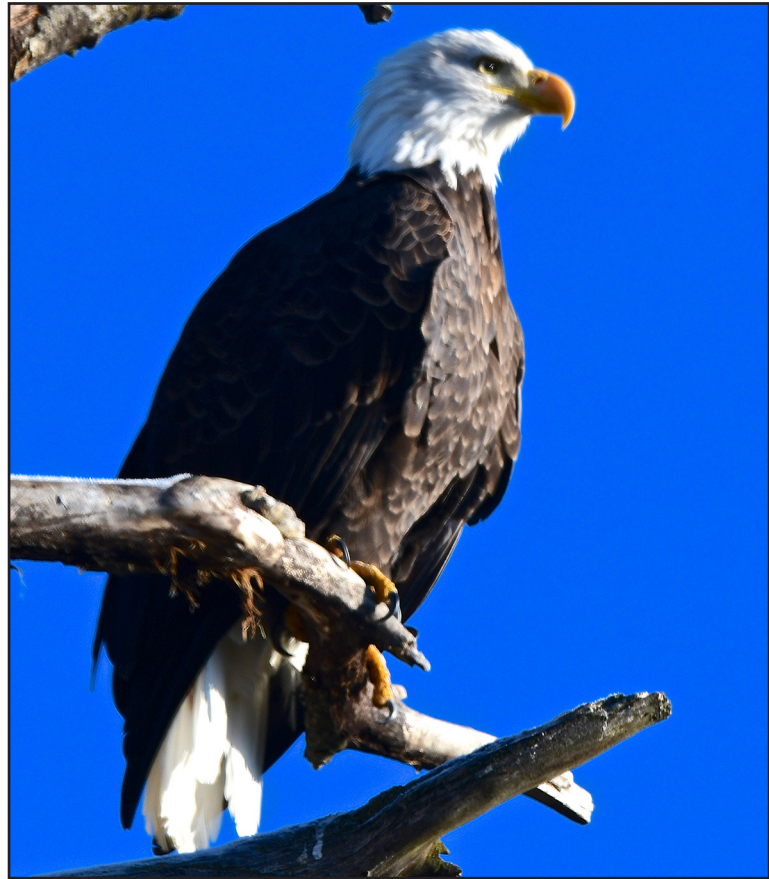

Lowman Ranger District of the Boise National Forest Intend to Submit Grant Proposal to Idaho Department of Parks and Recreation

BOISE COUNTY COMMISSIONERS

October 15, 2019

Present: Commissioners Alan Ward, Roger Jackson and Ryan Stirm

EXECUTIVE SESSION: [Time 9:03am to 9:35am] Closed session per pending litigation, personnel, exempt records, hiring of new employees, and risk management. No action required.

CONSTITUENT INPUT: Greg Keefer of the Clear Creek/Grimes Creek area said he filed a complaint with the county over an employee, Emergency Manager Bob Showalter. Keefer said, "His actions online and posting my medical history or his interpretation or a variation of that is completely unacceptable. Him insulting a combat veteran is completely unacceptable by every constituent in all three districts in this county. He's in gross violation of your employee handbook, as I'm sure you're all aware of." The constituent running for the political office of Boise County Sheriff stated that Showalter violated HIPAA protected records. "I've had my website and my Facebook page and my phone BLEW UP for the last two days. From people from city council meetings, to the city council elected people, saying that this individual should be FIRED for his conduct. It's a reflection of every elected..." Chairman Ward interjected: "Are we stepping over the line here for personnel?" Keefer continued, "I'm not dictating what this board should do, but 99% of the employees of this county are great people. They work hard, they abide by professional standards, including

elected people of this county. This one individual has done this repeatedly, I say repeatedly, online. I've also witnessed it in a public hearing in front of a city council, interrupting people and dictating what people should do, and it's unacceptable. And I ask this board to take action, because we are trying to be a professional county. We are trying to represent taxpayers, and everyone is entitled to have people that are elected or appointed that are confident, professional, and ethical. And integrity is not something that you can fix. You either have it or you don't. If you don't have it, you don't have it."

MINUTES: Commissioner Jackson made a motion to accept the October 8th minutes.

EMERGENCY MANAGER: Mass Gathering permits were discussed and whether the property was owned. Bob Showalter said one place had a Conditional Use Permit [CUP] for 150 people and below for weddings. The place is looking to increase the number to 225 people, so they applied for a Mass Gathering permit. Chairman Ward said he didn't think it was a problem on 35 acres. Showalter contacted law enforcement, and the Sheriff stated that it was a wedding, they had CUP clearance, and that he didn't believe that they needed an agreement. A motion was said to approve the Mass Gathering and it was approved.

The Polar Bear Challenge on New Year's Day Mass Gathering was applied for this year for the first year, although the event for charity has been going on for many years. Showalter said he asked them to apply

for a Mass Gathering, because they are over the limit on the number of people. He said because they are a non-profit, he asked that the county wave the fee of \$100. "Again, I checked with the Sheriff, and he didn't believe because this event is in its nature of mass gathering, with crazy people who are getting into cold water and he didn't think law enforcement would be required." Showalter spoke with East Boise County Ambulance Director, Melissa Potts, who said it would be their standard non-charge accompanying their crazy event. It was agreed by Commissioners Jackson and Stirm that anyone interested in jumping into the ice-filled reservoir should go right ahead. The proceeds go to Make a Wish foundation. The commissioners approved this mass gathering per a motion of the Polar Bear Challenge.

Showalter spoke about a non-charge contract with a business for recovery after a disaster. He said there was no obligation to provide a free "snapshot" of the Miners' Exchange and Courthouse. Nothing was signed or approved, permission was given to Showalter to proceed.

CONTRIBUTION TO ATHLETICS: Football players from Idaho City helped move large items out of the courthouse basement to the Sheriff's office for the auction that was held at the end of the summer. Clerk Mary Prisco stated that it was going to the athletic fund and not to any one individual. There were approximately 6 or 7 players that helped the better part of a day. The commissioners approved

her suggestion to donate \$1,000 to the Idaho City football team for removing all the stuff from the basement of the courthouse to the sheriff's office.

GROOMER SHED: Mr. Jones said that they received no bids for the groomer's shed in Garden Valley. The sheet wall and back wall need to be built. There were a few people interested, but who did not bid, so he will be reaching out to them.

BOISE COUNTY POLICIES ON SOCIAL MEDIA: Chairman Ward started the Social Media Policy discussion, with the resolution, "and it highlights our social networking access." Clerk Mary Prisco said it could be posted on the website. She added, "I thought it would be a good time to at least explore whether our or not we want to move forward. Obviously, there are plenty of other counties that have a social media policy." The county's insurance company has a templet of a social media policy, but she stated that they need to talk about it and decide whether the Board would like to pursue this. Chairman Ward would like Ms. Prisco to reach out to Valley and Adam's county, and other similar counties to see what their policies are. He said today it was just information only and they would discuss it at a later date.

NOVEMBER 5 ELECTION IN LOWMAN: Commissioner Stirm made a motion to accept the agreement between Lowman Station #80 for a polling place.

SURPLUS: A vehicle surplus for the Assessor depart-

ment, Ford Explorer 2005 and 2006, to sell at live auction.

PROSECUTOR'S OFFICE: Commissioner Jackson made a motion to pay \$10,204, the second payment for the Prosecutor's office. This will take care of the software upgrade.

EXECUTIVE SESSION: Per indigent cases, pending litigation, personnel, hiring of new employees and risk management. [Time 10:06am to 11:06am] Commissioner Ward said no action required, except in an indigent case in which a case was signed for a lien.

UNIVERSITY OF IDAHO'S ANNUAL EVALUATION OF COUNTY CHAIR: Chairman Ward spoke about a letter of praise they normally send regarding the 4-H program, Gem / Boise County Director Rebecca Mills. Clerk Prisco said she had personally read several articles in *The Idaho World*. Ward said it was good to have these articles in the local newspaper.

PARKS AND RECREATION SNOW GROOMER: There were no bids for the Garden Valley snow groomer shed, but they are opening it up. Containers and trusses are coming. Mr. Johnson said they are trying to find someone to manage the program better. Winter and summer access by Terrace Lakes was discussed. Rubber tracks were discussed. Chairman Ward said the program would be limited if they couldn't move up and down the highway. They currently have metal tracks. There's a DF road that is no longer open for the
