EAST BOISE COUNTY

-- The Boise County Sheriff's Office received multiple reports of a black bear cub that had been on the side of Highway 21 for multiple days without relocating. It was later discovered that a sow had been hit by a car in that same location

around the time the cub was first reported. With the help of Fish and Game, the cub was captured. He was a spring cub, weighing 30 pounds, who would not have made it through the winter on his own. The cub was taken to a rehabilitation center with the hope of being re-released this spring. Boise County Sheriff's Office is always here to help

out the community. Naturally, living in Boise County, wildlife is considered a part of the community too. We are hopeful the bear will now have a nice place to stay this winter where he can learn the bear necessities needed to make a successful release happen this spring.

EDITOR'S NOTE: This was the second young black bear in the last few weeks to be taken from Boise County to be rehabilitated.

On October 19th, there was a black bear cub with an injured leg that was carried by a hunter out of the Garden Valley area. This bear was also a good candidate for rehabilitation.

Idaho Fish & Game says it's illegal to remove big game animals from the wild. Injured animals are to be left alone and officers notified.

Tokens of History

IDAHO CITY -- The Idaho City Historical Foundation held their annual meeting on Sunday, and invited guest speaker, John Mutch, a noted collector of early Idaho tokens. Beth Wilson, President of the ICHF, stated that the organization was in good standing and recognized volunteers at the museum for their contributions. The gift shop has done remarkably well, along with a local brew sold at Idaho City events. She divulged that many of the members had adopted and become members of the Independent Order of Odd Fellows to protect the Pioneer Lodge from being discontinued. Wilson stated that she was surprised by the enthusiasm and pride in this organization, and that it was contagious. It became obvious why the early miners and pioneers relied on this organization. She recognized the importance of maintaining history, "These buildings are a physical vessel for stories, and we are adding chapters every day."

The organization will have their annual St. Patty's dinner on March 14, 2020. Next year, the National Convention of Smoke Jumpers will be coming.

John Mutch explained his token collection, saying: "Your average person has never heard of them," but they were widely used as a substitution for currency. Each small town produced their own form of token, to conduct business. He recounted that back in the 1860s, it was much more important to bring in supplies for the miners than a wagon load of currency.

Crouch Community Hall Receives a Facelift

CROUCH -- The Crouch Community Hall has a newly resurfaced floor in the main hall, just in time for the busy holiday and meeting season. The wood floor has stood the test of time and even shows some of the hatchet markings near the stage where the wood was chopped. The wood was fed into a fireplace near the stage.

It is this same fireplace that had water leaks in late summer, which damaged the floor. The floor needed cleaning up from that leak, so not only did the floor get a light sanding and finish, but the side flooring by the stage was replaced. Laminate flooring has now replaced the old vinyl tile. More plans are underway to spruce up the hall and kitchen.

Many events happen in the hall, once known for being a roller rink. Now there are dances, weddings, meetings, a monthly flea market, memorial services, family reunions, birthday parties, community events, and bazaars held in the Crouch Community Hall. At one time, elections were held in the hall, too. The Community Hall remains a centralized

location for events in the Garden Valley area.

Crouch Residents Meeting: November 6th, at 6:00, in the Community Hall, there will be a Public Meeting for Crouch residents to come participate in a question and answers discussion about a Community Development Block Grant (CDBG) in an amount not to exceed \$500,000. This grant could go a long way to service the potential need and growth of the City of Crouch water system.

Crouch residents and businesses face failing older wells or have iron water. Crouch passed a City Bond last year to allow for the city to seek grants that could build a system to service 100 more customers. **The current system is maxed out for new customers.** Public participation is part of moving forward with the grant process. The Hearing will include a discussion of the application, scope of work, budget, schedule, benefits of the project, how ICDBG funds will benefit low and moderate income persons, and location of the proposed project. The application, related documents and the ICDBG Application

Handbook will be available for review.

The same night there will also be a **Public Hearing** concerning a change in the Business License Fees and Liquor Fees. The hearing has been scheduled for Wednesday, November 6th at 6:00pm to be held at the Crouch Community Hall, 329 Village Circle, Crouch, ID 83622. Verbal and written comments will be accepted prior to and at the Hearings.

Rental of the Crouch Community Hall is a nominal fee of \$10.00 per hour with a breakdown of 24-hour usage. These fees help in maintaining the Hall for future use and also cover utility expenses. Waivers can be considered, but the organization must come before City Council as stated in a city ordinance established many years ago. Applications for rental may be picked up at the City Hall during regular business hours, Tuesday through Thursday from noon to 4:00pm, or sent through email. HORSESHOE BEND -- The Horseshoe Bend Varsity Mustang Football team traveled to Garden Valley on Friday, October 25 for the annual Timber Ax Classic game against the Wolverines. The Wolverines have had possession of the coveted Ax trophy for the past year and the Mustangs came to take it back and win the title of Long Pin Division District Champions. They did both. In the first quarter, Horseshoe Bend scored first with a touchdown by senior Austin Fry followed by a conversion for 2 points by senior Ethan Smith. Garden Valley followed with a touchdown of their own but the kick for an extra point was blocked by senior Calvin Drake. Senior Ben Howerton scored a touchdown in the first and Garden Valley countered with a touchdown and a successful kick for the extra point and the quarter ended 14-13 in favor of Horseshoe Bend. Howerton scored first in the second quarter, putting the Mustangs in the lead 20-13 but Garden Valley came back with a touchdown and the score was 20-19 with Horseshoe Bend in the lead by 1

point. After trading touchdowns Garden Valley hooked up two in a row and took the lead 20-25. Howerton came through again and Fry connected for the conversion and the Mustangs took the lead again, 28-25. On the subsequent kickoff Garden Valley scored on the return and took the extra 2 points on a conversion taking the lead for the last time in the game, 28-33. It would be their last time

to score in the game. Quarterback, sophomore Colten Meyer connected with his brother, freshman tight end Blayne Meyer and the Mustangs were on top 34-33. Howerton came up with another touchdown and Fry had the conversion and the scoreboard read 42-33. With 30 seconds left in the second quarter, junior Hunter Howerton intercepts Garden Valley quarterback Corban Fields and

Horseshoe Bend takes a knee to end the first half. The third quarter had one touchdown by Smith and the scoreboard read 48-33 when the quarter ended. No score was recorded in the fourth and final quarter but Hunter Howerton snagged another interception, as did Fry. A fumble recovery of a Mustang possession by Garden

Valley with about 5 minutes on the clock led to a final interception by senior Hunter McKee and the Mustangs took the 48-33 victory. The team advances to the State 1A Division Semi-Final with a bye this week and begins the single elimination tournament on Friday, November 8.

OBITUARY

Charlie Turnbull
1933 - 2019

Charlie and Marlene Turnbull were residents of Boise County - living in the Crouch Idaho community from 2002 - 2012.

Charles "Charlie" Vincent Turnbull, died on October 16, 2019, at the age 86, from pancreatic cancer at his residence in St. Peter, MN. He was born May 13, 1933, to Charles Vivien and Lucille Fran-

ces (Dallas) Turnbull. He had two sisters, Helene Vivien Turnbull and Kay Lucille (Turnbull) Moe.

He married Gloria "Marlene" Tilley July 21, 1956, and they had four children, Charlene Kay, Charles "Vincent," Terry Lucille, and Mary Marlene. They celebrated a loving marriage of 62 years prior to her death October 8, 2018.

In addition to their children, they raised nine teenaged foster daughters from 1958-1967. Throughout the course of their lives together they lived in Lexington Village, New Sweden Township, Noreland, Faribault, and St. Peter, MN, Couch, ID, and Dunedin, FL.

Turnbull grew up in Minneapolis prior to the family moving to Constance, where he attended Anoka High School and graduated in 1951. He worked at De-Vac Window Company prior to enlisting in the United States Marine Corps from 1953-56. He attended the University of Minnesota and received a Bachelor's of Arts degree in 1960 and a Masters of Social Work in 1962.

Charlie enjoyed an extensive professional career designing and

implementing service delivery for persons with intellectual disabilities. He worked at Cambridge State Hospital "CSH", as a Unit Director from 1962-1967, and the Director of Rehabilitation Therapies from 1967-1968.

In 1968, Charlie accepted appointment to the position of Program Director of the Minnesota Valley Social Adaptation Center "MVSAC," a 400-bed facility, in St. Peter, Minnesota. There, his team of professionals utilized a multidisciplinary approach in the design of therapies, supports, and day activity center services for residents from 1968-1973. Concurrently, he served as Program Consultant to the Rochester, MN, Social Adaptation Center, from 1970-1971, and the Program Director at CSH from 1973-1974. Further, he provided consultation to other states including the St. Louis State School and Hospital from 1973-74.

Turnbull was the first person in Minnesota appointed to run a state hospital who was not a Medical Doctor. In 1974, he accepted appointment to serve as the Chief Executive Officer of the Faribault State Hospital, a 1600 bed institution, in Faribault, MN. He ran the FSH, later known as the Faribault Region Center "FRC," from 1974-1984. During his tenure, Turnbull was instrumental in creating Day Activity Centers that provided full time training for the residents in a work-like setting. In 1984 he left FRC and served as the Hospital Administrator of the Minnesota Veterans Homes in Minneapolis

and Hastings until 1985.

Turnbull ran for and served as Mayor of Lexington Village, MN, from 1962-64. In 1972 and '74 he ran on the Democratic-Farmer-Labor ("DFL") ticket for the United States House of Representatives for the 2nd Congressional District of Minnesota. Although not elected, he gained political recognition from several Democratic Leaders including: Vice President Hubert Humphrey; then Senators Walter Mondale, Senator McGovern; and Minnesota Governors Wendell Anderson and Rudy Perpich.

Considered a driving force, Turnbull helped in the establishment of the River Bend Nature Center, in Faribault, MN. Turnbull's other civic involvement includes: the Jaycees; Scout Master of the Twin Valley Council Boy Scouts of America; Chairman of the United Fund Drive, St. Peter; Co-chair of the Faribault Bicentennial Horizons Sub-committee; Ducks Unlimited; and Pheasants Forever.

He and his wife owned and ran Turnbull's Shady Acres Resort on Robert's Lake in Minnesota from 1979-1985. After state retirement, he worked with his wife, Marlene, as owner and broker of Turnbull Realty, and later with Turnbull Bedker Real Estate Company in Faribault, MN.

A passionate outdoorsman, he enjoyed hunting, fishing, camping, planting trees and developing natural wildlife habitat on the Turnbull's land in Noreland. Subsequent to Marlene's death, he planted and developed a memo-

rial orchard in her honor with over 44 fruit trees, hundreds of berry bushes and grape vines. When not outdoors he enjoyed quality social time with family and friends.

Charlie is survived by: children Charlene K. (Turnbull) Quade, Charles V. Turnbull II, Terry L. (Turnbull) Leadabrand, and Mary M. (Turnbull) Lager; son and daughter-in-laws Franklin "Kip" Lager, Paul Leadabrand, and Kathy Gelhaye; grandchildren Rachel Quade, Nicole (Quade) Long and husband Aaron, Kaitlyn (Leadabrand) and husband Christian Routzen, and Alissa Lager and fiancé Trevor Plasky, Ashley Lager, and Amy Lager; great grandchildren Skye Lynn, Ryleigh Ann, and Aron Charles "Charlie" Long; brother Jack Mielke; nephew Malai Turnbull and fiancé Catherine Lawler, and nephew Kavi Turnbull. Charles was preceded in death by his parents, sisters Kay (Turnbull) Moe, and Helene Turnbull, and his wife, Gloria Marlene Turnbull.

Full Celebration of Life will be held Sunday, October 20, 2019; visitation at 1 pm, service at 2:00 pm, followed by military salute graveside and sharing of stories among family and friends with light dinner and dessert at Scandian Grove Lutheran Church, 42869 County Road 52, St. Peter, MN 56082. Elk Unicorn That is One in a Million

LOWMAN -- Similar to many long-time residents of Boise County, when Bob Crofutt takes his grandson, Marcus Crofutt, hunting they go looking for "good meat." That was the plan when they set-off from their cabin between Richardson and Ten Mile Creeks.

It didn't take long for them to encounter the herd of elk down along the bottom of Ten Mile Creek. They'd done their 'homework' and knew where the elk moved through and when. So when the elk were spotted, Marcus moved himself into position not far from the herd of mostly cows, to get a shot on the one 'young bull,' he was sure he spotted among the cows.

The Crofutt's are traditional meat hunters. Unlike a lot of elk hunters, "I don't go looking for nice racks, I go looking for good meat," Bob said. A healthy, young bull means plenty of good steaks, sausage and prime parts. Marcus, although a young hunter at just

13, was already a bit accomplished, having started at 10, before he even had to buy a license. He already had several animals under his belt, including a 3 x 4 buck taken just the week before. This young bull could be his latest, as it walked within 100 yards of his position.

He settled into position, took aim and fired, after checking to make sure it was a 'spike' and would be a clean shot. He dropped him right there with one shot, then hurried over to claim his prize. Laying there on its side in the snow, young Crofutt drew in a sharp breath as he walked up and checked on the dead animal. He could see no antler and it was a cow! He couldn't figure it, he was sure he'd seen the spike projecting out of the top of the head before taking the shot! He did know he better get his grandfather real quick.

When he located Granddad and they scrambled back down to the location where the animal lay, Bob said, "My heart just sank when he told me he shot a cow." Bob also saw no antler and the body parts were that of a cow. Then they rolled the animal over and on the left side of the head WAS a spike! Bob had never seen such a thing in elk. In deer, it's not that uncommon to see a spike on a doe but he'd never seen or heard of the phenomena on elk.

Crofutt called the Idaho Fish and Game (IDFG) as soon as they got back to the cabin with

the elk, to inquire as to what to do. The IDFG officer quickly informed him that Marcus was in no trouble. If it had a spike, even a biological cow was considered a "bull." However, it was a real "Unicorn," as Marcus called it. In fact, about a "one in a million" occurrence, according to the IDFG.

Marcus related that he really loves coming to Lowman (he lives in Caldwell) to visit his Granddad and learning all the things he has about the mountains and living in the country. Now, he has one more really special story to tell for decades to come about his "one in a million."



Present: Commissioners Alan Ward, Roger Jackson and Ryan Stirm

Pledge of Allegiance

EXECUTIVE SESSION: [Time 9:02am to 9:17am] Closed session per pending litigation, exempt records, personnel, hiring of a new employee, and risk management. Chairman Ward said after coming back into session, "No action required."

CONSTITUENT INPUT: None

MINUTES: The minutes from the October 15 meeting were accepted via a motion.

SOLID WASTE: Mr. Miller with Miller Enterprises would like to close the large loads off at 4:30pm the in Horseshoe Bend Transfer Station to the public, reducing the time it's open by half an hour. Advertising will need to be done, and signs at the dump. [see ad on this page] Miller has a contract with Boise County. A representative of the county said this was within the scope of work. This will be reviewed by Central District Health. A motion was said to approve this change, per request of Mr. Miller.

FORESTER: The mulcher and skid steer has arrived and will be stored out of the weather. This will help with fire mitigation in Clear Creek and other areas.

CLERK / TREASURER

QUARTERLY REPORT: Chairman Ward asked if there were any problems and Clerk Mary Prisco said there were not. He motioned to approve the report.

PLANNING & ZONING ON THE COMPRENSIVE PLAN DISCUSSION: The public hearing was closed, but changes were discussed. Another hearing date was considered.

TAX DEED OVERAGE DISCUSSION: Treasurer Gina Turner said that the commissioners were responsible for informing tax deed sales notifying all parties of interest of this sale and all excess proceeds. She said, "We have a little bit of a problem with this. We have five interested parties that should get letters, four of them are dead. So, the remaining interested party that is alive is Boise County. So, I don't know if we need to waste the time and the money to send letters to dead people?" Prosecutor Adam Strong stated: "They probably have an estate, so who ever are their heirs." Commissioner Ward said, "I'd still send the letters."

COMPUTER ARTS: Ms. Turner said that there were three problems with the computer program the county uses and she is receiving no support from the company. Sheriff Jim Kaczmarek suggested pushing the Idaho Association of Counties, because many of

the smaller counties contract with this company. Prosecutor Strong is going to look over the contract.

ELECTION FILINGS: There is a mail-out ballot for Placerville in November, and all the registered voters in that district will receive a ballot in the mail. Clerk Prisco stated: "We base our ballots on what we were provided by the City of Placerville, and we just found out the end of last week that apparently" there is a third seat that they weren't notified of. "We cannot change that ballot. We cannot change the election as it's set up. We have passed all those deadlines." The city will have to consult with their attorney to rectify the problem.

There was a written request that was received at the clerk's office to have "watchers" at the Garden Valley and Lowman Precinct for the Garden Valley School District Trustee Zone III election. Clerk Prisco said, "They are allowed that statutorily," however, there are some rules. She added, "particularly in the tally room, and they do want to do this, which could be an issue because of the logistics of it. Typically, our tally rooms are little shoebox sized, and once a watcher goes into tally room, they have to remain there until the polls close for security reasons." There were four individuals. She just wanted to make the commissioners aware that that request had

been made.

AGREEMENT WITH FOREST SERVICE AND LAW ENFORCEMENT: An annual agreement was discussed regarding law enforcement at the campgrounds, should the Boise County Sheriff's Office be called to respond.

SNOWMOBILE GROOMING PLAN FOR IDAHO CITY AREA: There were no changes, so a motion was said to approve the 2020 grooming plan with the U.S. Forest Service for \$17,492.

HOMICIDE CASES: Prosecutor Strong recounted that Coroner Garlock had a concern "that under Boise County responsibilities, it says in homicide cases, the county coroner shall respond for getting police reports to the Ada County Coroner for them to be able to write the autopsy." He said Garlock is not wrong, and that she doesn't have that authority. It should fall to the Sheriff's Office. Sheriff Kaczmarek said that they do that already and have the mechanisms in place to do that. "If it's suspicious,

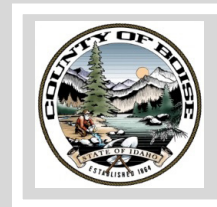
we write it. It's standard that the pathologist looks at our reports, so we write it in there [that report]."

Commissioner Stirm made a motion for pathology services between Boise and Ada County.

COMPUTER ARTS: Clerk Prisco asked that the Board commit to 101 hours of Computer Arts IT Support at \$75 an hour, which will be an amended amount. This was motioned and approved.

BILLS: Commissioner Jackson made a motion to pay unemployment in the amount of \$3,180. A motion to pay Computer Arts for software support in the amount of \$11,750. A motion to reimburse Alan Ward for cell phone reimbursement for a year in the amount of \$600. Idaho City High School athletic fund contribution in the amount of \$1,000 for work done to help with the auction. Jackson made a motion to pay the claims report 2019 in the amount of \$67,851 and another for the physical year 2000 in the amount of \$55,389.
