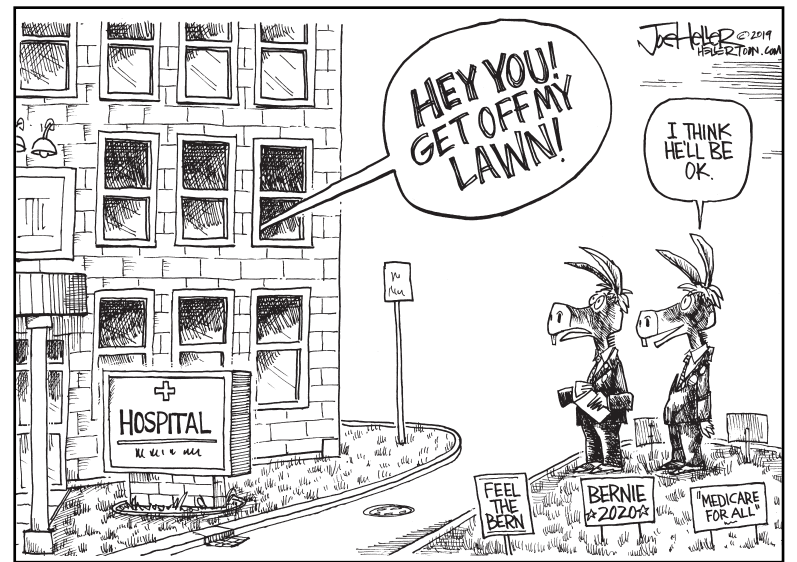
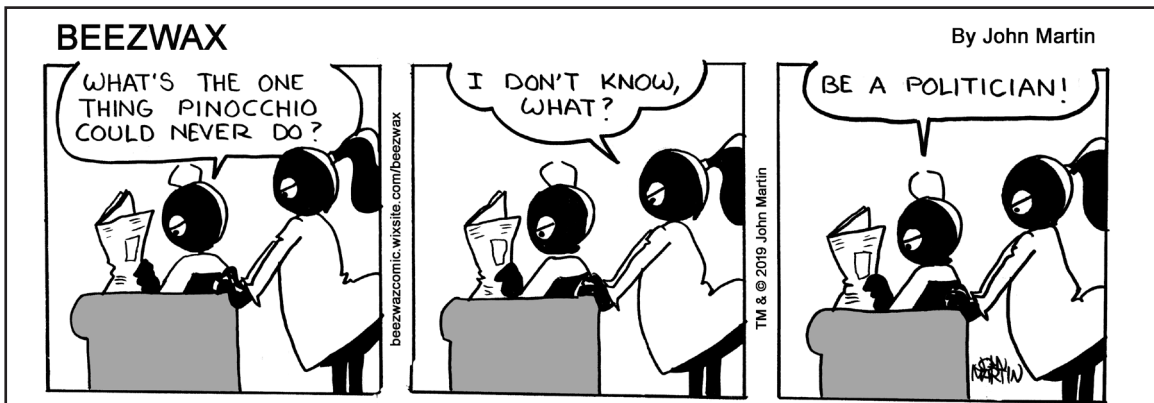
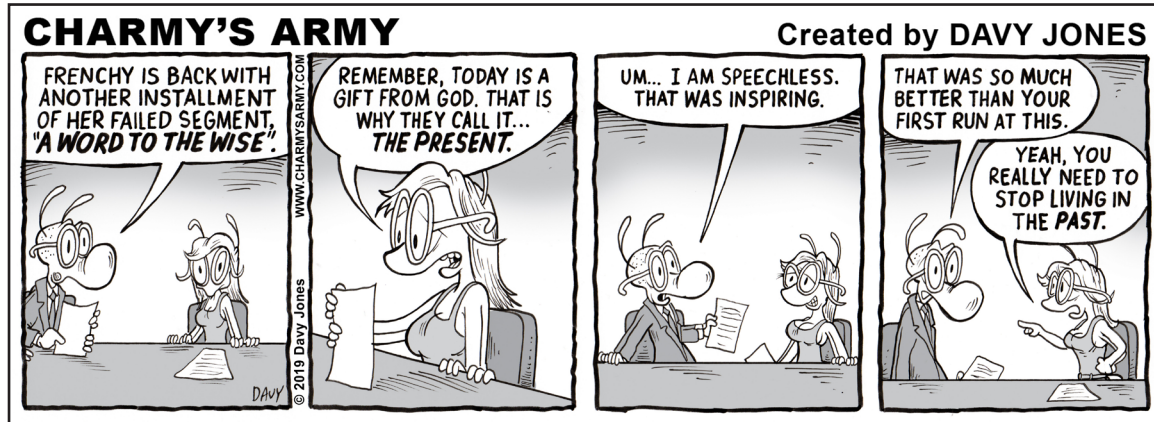
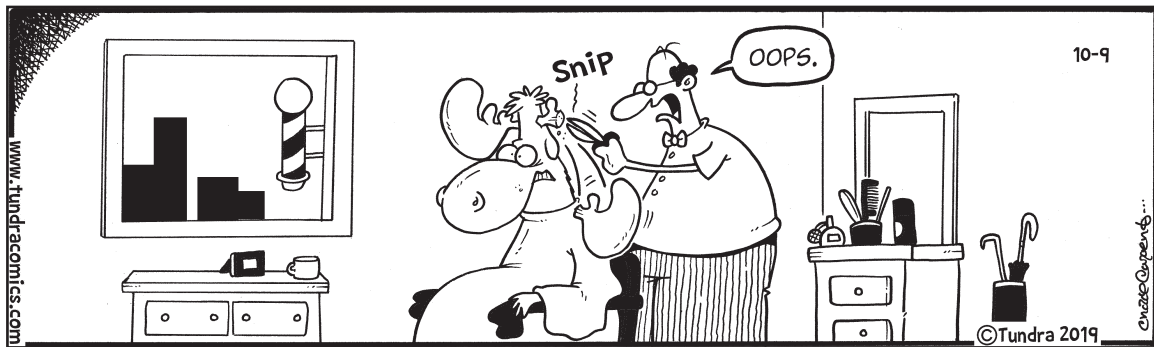

**BOISE COUNTY****Idaho City's Historic Masonic Lodge****By Doug Hammond**

**IDAHO CITY** -- On a cool raining Saturday, September 28, 40-plus Masons from around the State met at the Historic Lodge building for their annual meeting in Idaho City. It is normally scheduled after the annual meeting of the Grand Lodge of Ancient Free and Accepted Masons of Idaho. At the annual Grand Lodge event, the Most Worshipful Grand Master Steven Hall of Ancient Free and Accepted Masons of Idaho was installed as Grand Master.

The Grand Lodge rotates to different locations around the State every year. This year was in Idaho Falls, Sept. 19 through 21; therefore, the 1863 Historic Lodge meeting was the following Saturday. It provides an opportunity to meet in the oldest Masonic Lodge building still standing on this side of the Mississippi River.

Those attending were treated to two events, three counting the excellent catered BBQ. The first meeting was opened in the second degree to accommodate a member, Alex Lewis of Twin Falls who was not a 3rd Degree Master Mason. It is unusual practice for a Historic meeting to be opened on the 3rd Degree.

The Master of Idaho Historic Lodge # 1863 also rotates every year, this past year the master was Worshipful Brother Jeremy Vaughn from Twin Falls. Twin Falls Lodge # 45 had a candidate who was ready to receive his 3rd degree, which was Lewis. To make his degree

more memorable, they decided to hold it in the Historic Idaho City Lodge.

The meetings were even more memorable with the old wood stove in the lodge, which has not been approved for use by the State Fire Marshal until the chimney is modified to meet the new fire code. The Masons on the side lines were permitted to wear hats and coats. It was not cold enough to see your breath as was the 150-year anniversary meeting of the Historic Lodge meeting in December of 2017, but it was close.

One of the first orders of

business discussed in the annual Historic meeting was to get a committee to see what modifications would be necessary to use the existing wood stove in the old building. That single improvement would make future late fall or early spring meetings much more comfortable for all. Also, an engineering firm was employed to check the soundness of the old building and would prepare a report on the condition of the existing building to see where money could be wisely spent on improvements.

The wood stove was the top priority for some present. Oth-

er members are coordinating with the local historic society to possibly secure some funding to help with restoration projects that are needed to keep the building up and in useable shape. A collection was taken up to help fund ongoing improvements to the old building.

One local Mason conducts tours on the weekends during the summer and takes in donations which for now are almost the sole source of money for any repair projects. The Grand Master's wife has taken on the project to raise money for building improvements as a project.

New officers for the lodge were elected and some will be appointed by the new Master. They will be installed in their 1863 Historic Lodge position, when installation takes place in their home lodges.

The large number people attending did help warm up the lodge room towards the end of the meeting. The candidate and two other masons joined the Historic Lodge that day. Most are looking forward to next year's meeting and are hoping for warmer weather, or perhaps a working wood stove.

**What to do Before the Fire Department Arrives: Part 2**

This is the second in a series of three articles that will talk about what you can do in an emergency before the fire department arrives. This article deals with what to do if the emergency is a wildfire.

Again, the first and most important thing you can do is to make sure everyone is safe from the threat of the fire. That may mean getting away from where the fire is at the moment, and where it is likely to spread. When everyone is safe, call 911. Get your firefighters coming as quickly as possible.

Once everyone is safe and the firefighters are on their way, it's time to determine if you can fight the fire yourself. If it's a small fire and you believe you have the equipment to put it out yourself and you can

fight it safely, you may decide to try fighting it, or more likely defending your home from the fire. What options might you consider? The quickest and easiest thing to do is to create a wet line between your home and the fire. Remember, wet fuel is more difficult to ignite than dry. To create a wet line, use your garden hose or sprinklers to wet down the area between the fire and your home. A rule of thumb is that the wet line must be at least twice as wide as the height of the flames. If your line will be in grass and the flames are 6 inches tall, you need a wet line at least a foot wide. The wider the better. While a wet line is relatively quick and easy to make it has some significant shortfalls. First, the heat from

an advancing fire will dry out the fuel quickly, so you need to keep reapplying water. Second, embers from the fire can float across your wet line, land in dry fuel, and ignite. You must be vigilant for these spot fires and extinguish them quickly. A more lasting alternative to a wet line is a hand line. That's where you dig a line to protect your home down to mineral earth. This line will not dry out and ignite from the advancing fire. Digging a hand line is slower and much more exhausting work than a wet line, especially if you don't have the specialized tools to make it a little easier and faster. The depth of the pine duff in this area is often surprising. It looks like you have gotten down to mineral dirt when you actu-

ally are in pine duff which will ignite. Again, the width of the hand line must be at least twice the height of the advancing flames. Embers can float over this line, too. So you have to be alert for spot fires behind your hand line.

If you don't think a wet line or hand line is feasible, and you have some time to safely prepare your home for the advancing flames, you can move flammable materials at least 30 feet away from your home. Propane tanks, firewood, and lawn furniture are common flammable items found on most decks. If you have time, you may want to wash pine needles off your decks. This removes flammable material and wets down the deck. Inside your home remove draperies and plastic

blinds from windows, move flammable furniture away from windows, turn on a light in each room to increase the visibility of your home to firefighters, close all interior and exterior doors and windows, lower and close metal blinds, put sprinklers on your roof and turn them on, shut off propane tanks, put a sprinkler near all fuel tanks and turn them on, seal vents with pre-cut fire resistant material, and if you leave your home, lock all doors. Don't worry, firefighters can get in if necessary.

If you decide to fight the fire or defend your home from the fire, always emphasize doing it safely and never let the fire get between you and your escape route!

## Horseshoe Bend City Council Meeting

**HORSESHOE BEND** --

The following is a synopsis of the Horseshoe Bend City Council's meeting on September 18, 2019. All council members were present. There was a call to order, Pledge of Allegiance, the council's approval of the agenda, previous minutes, and the authorization to pay the city's bills. With no public comments, Mayor Pat Goff moved onto the public hearing on the agenda for a conditional use permit (CUP) for Backcountry Dirt Worx. Applicant Jay Robert wants to utilize the property adjacent to Heartland Fence on Highway 55 to store equipment and to operate a retail establishment offering aggregate, Landscape antiques, and yard decorations. On the advice of the city engineer, Amy Woodruff, the council unanimously allowed the CUP with the following conditions: The company must provide for sanitation services (bathroom/trash), they must comply with city signage and parking requirements, and their CUP must be reviewed every two years. The company must also comply with any ingress or egress requirements by Idaho Transportation Department.

Next on the agenda were Cliff and Summer Ohlers, owners of *The Locking Horns Riverside Restaurant*. The Ohlers purchased property adjacent to

the restaurant for the purposes of overflow parking and were before the council for advice on dealing with a neighbor who has complained about the empty lot being used for parking, which resulted in the Ohlers receiving a cease and desist letter from the city. The neighbor, Jim West was present and stated that his problem was if the Ohlers property was rezoned to allow parking, he wanted the same zoning designated for his property too. The properties are part of a subdivision which has its own covenants and it was suggested that the property could be used as a parking lot if the majority of property owners vote in favor of the change. The council took the matter under advisement.

Resident David Gerber was next on the agenda with a complaint regarding loose dogs which have caused injuries to his dog. Gerber stated that his dog is maintained within a fenced yard and that on numerous occasions neighboring dogs have scaled his fence, causing serious injuries to his dog that have resulted in \$1,600 in veterinary fees. Councilmember Cooper asked if law enforcement had been notified. Gerber relied that he had contacted the Boise County Sheriff's Department and was told "We do not enforce their ordinances (City of HSB), the city does." Councilmember Marty White took

objection with that stating, "I personally sent the dog ordinance to the Sheriff two weeks ago." Gerber added that a Boise County Sheriff told him, "We're tired of addressing your complaints." White suggested that Gerber contact Sheriff Kaczmarek directly. Goff added that he would be contacting the Sheriff and would ask him to have deputies patrol Gerber's street when they are in town.

The Horseshoe Bend School District sent a letter to the council regarding the installation of scoreboards on the softball and baseball fields. Cooper stated, "I see no problem with the softball field, the baseball field I'm not sure." Councilmember Ben Riley added, "As long as it's in compliance with our sign ordinance I don't see a problem." The city voted unanimously to forgo any permit fees associated with the scoreboards.

Copper suggested that there was money for supplies from the sale of the extrication truck.

Woodruff had no update on the construction of the new Highway 55 bridge. City Attorney, Tony Pantera, told the council he was working on completing the city ordinances but "needs a set

The council had a small discussion regarding Chevron selling water in violation of city ordinance. Pantera said he will be in contact with the owners. Cooper asked "Where is the city sign?" The council will find out what is happening with its construction.

Boise County Elections has requested a modification of the November 5th, 2019, City of Crouch and City of Placerville, Council Member elections, as allowed under Idaho Code 34-1413. We requested that both of these elections be carried out as mail-out ballot elections, and both requests, along with our Plan for Modification, have been approved by the Idaho Secretary of State's Office.

Why mail-out ballots? We requested this modification because it is a cost effective manner of administrating the elections and these city districts have only one candidate per seat

(i.e. unopposed). Registered voters within each of these city districts will be mailed a ballot, along with a postage paid return envelope, and instructions on the completion and mailing of the ballots to Boise County Elections. Mail-out ballots are processed and counted in the same manner as absentee ballots.

Registered voters within each of the two city districts will receive a notification letter, which we have mailed from our Idaho City office on October 7th.

# BOISE COUNTY COMMISSIONERS

Transcribed by Eileen Capson

**October 1, 2019**

**Present:** Commissioners Alan Ward, Roger Jackson and Ryan Stirm

**EXECUTIVE SESSION:** [Time 9:02am to 9:29am] Closed session per pending litigation, personnel, exempt records, hiring of a new employee and risk management. Coming back into session, Commissioner Ward stated, "No action required."

**CONSTITUENT INPUT:** None

**MINUTES:** The minutes from September 24<sup>th</sup> were accepted by a motion.

**DEPARTMENTAL ISSUES:**

**ROAD & BRIDGE PAYOUT REQUEST:** "It's a bad one," said Chairman Ward. Commissioner Stirm stated that they've told other departments that they have until December to get it down as far as they can, and then the commissioners will revisit it. Chairman Ward read from the policy that a maximum of a hundred hours may be accumulated at any time of the year. He added, "No other type of payment or compensation time shall be allowed." Clerk Prisco clarified: "For the calendar year." Mr. Jones, department head for road and bridge said, "We'll do what we can. It's a little bit of an issue. When it gets to be wintertime it's kind of hard for us not to have guys there." Chairman Ward said, "It's understood."

**2019 ELECTIONS:** The November 5<sup>th</sup> election was discussed, and ballots will be mailed out to every registered voter in Placerville and Crouch.

This was approved by the state of Idaho. Clerk Mary Prisco said, "It's good news! It will save the county some money to do it that way, because we won't have to staff in those two locations." The law allows for this option, if there are less than 140 registered voters.

Polling places were approved at: Garden Valley High School gym, Horseshoe Bend Ladies Auxiliary Club, Idaho City/Boise County Courthouse, and absentee.

**TAX DEEDS:** There were three tax deeds that came up for auction, and two sold. The quick claims were approved by motions.

**SHERIFF:** Jim Kaczmarek said there was a "significant" crack in the building and they may need to bring in a structural engineer to take a look at it. To look at the crack, an engineering company was going to charge \$800. Sheriff Kaczmarek said he will get a second quote to examine the brick construction.

**SOLID WASTE:** A new door in the amount exceeding \$3,000 from the county's in-

urance. An amount exceeding \$4,000 was accepted for a bid to replace the door.

**COUNTY POLICY:** Clerk Prisco reviewed some changes with the Board.

**AVIMORE:** Clerk Prisco said they recently received a petition of creation for a community infrastructure district. Prosecutor Adam Strong has done some research and stated that the county would need to hold a public hearing sometime before the end of December. The Planning & Zoning Administrator, Bret Caulder, spoke about an assessment to be done. Clerk Prisco said it was going to be difficult, and "We don't have the resources."

**BOISE COUNTY PUBLIC DEFENDER:** The contract was approved through a motion. [no amount given]

**HORSESHOE BEND RESOURCE OFFICER:** The Sheriff said it was the same as the Idaho City and Garden Valley Resource Officer for the Horseshoe Bend and Garden Valley Resource Officer. Chairman Ward recused himself for voting on the GV Resource

Officer position, because he is on the Garden Valley School Board.

**VOTING MACHINE:** An agreement was motioned to accept a bid for \$3,500 for a new voting machine.

**DEMAND WARRANTS:** A motion was said to pay Planning & Zoning \$699 for a building permit for the groomer shed construction.

A motion was said individually to pay Garden Valley Senior Center, Boise Basin Senior Center and the Horseshoe Bend Senior Center a donation of \$500, which was approved.

A motion was said to pay Fred Myers \$459 for a camera to use in "death investigations."

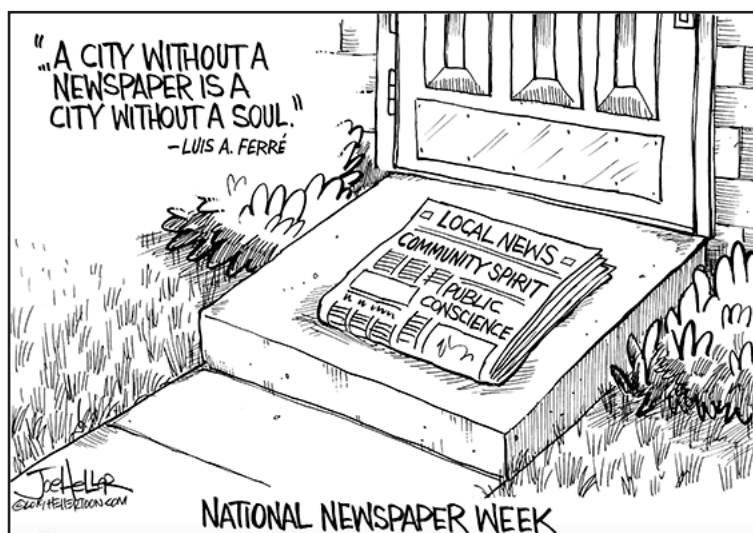
**EAST BOISE COUNTY AMBULANCE:** They have had a good response of up to

25 people for the EMT class, which includes two from Placerville and one from Lowman. Ms. Potts will be attending a class to become an EMT instructor.

**ASSESSOR:** Chris Juszczak said they were out appraising all of the new construction.

**PLANNING & ZONING:** Bret Caulder said it was a busy time of year and there are people inquiring about building subdivisions. They are that "informational source." They have a candidate to fill the vacant seat on the P&Z Commission. He said the building permits are at 200-plus, with a lot of new construction.

Avimore keeps reaching out to P&Z, but a formal application has not been received for the proposed subdivision.
