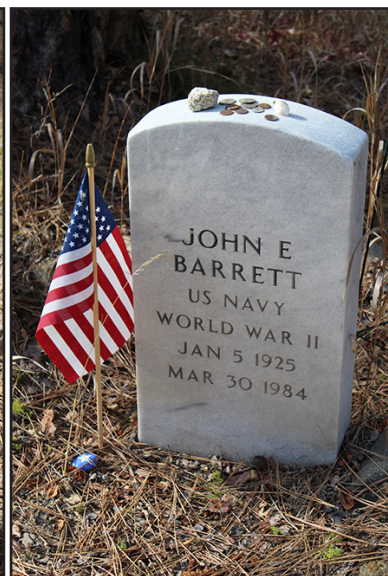

Honoring Our Veterans in Idaho City ~ "All Gave Some - Some Gave All"

IDAHO CITY -- What started out as a simple 11" x 18" plaque with the poem written by Lawrence Binyon in recognition of fallen soldiers has now been transformed into a tribute at the Veterans Park in Idaho City. Scott Jackson was contacted by Craig Smith, a friend and customer of the Idaho City Trading Post, who mentioned that it would be nice to have a plaque mounted at our Veterans Park. Craig said he was willing to pay to have it commissioned. However, after Scott and his wife Lisa spoke with Barbara McClain from the Idaho City Historical Foundation, he discussed doing something on a much larger scale, representing all of the Branches of the Armed Forces, while focusing on the recognition of fallen soldiers. Scott and Lisa decided they wanted to donate this as their gift to the Veterans Park.

Scott proceeded to provide a sketch drawing to the Historical Foundation, which was

approved, and then soon after started purchasing the materials. Carving all the pieces, making the case, mounting the posts, and doing the staining and finish work was very labour intensive. "I have approximately 80 hours of my time donated in what I consider to be a true honor. Cara Woras, her husband, and son, dug the post holes and mounted the post. Once the posts were in, Jim Love and myself mounted

the memorial display case."

Veterans Park in Idaho City is located on Main St. between the Merc and Diamond Lil's.

In Scott Jackson's heartfelt words: "As for myself, it was my honor of giving back, especially to those who gave the ultimate sacrifice while serving this great nation. I'm also please it was completed and ready to view for this Veterans Day."

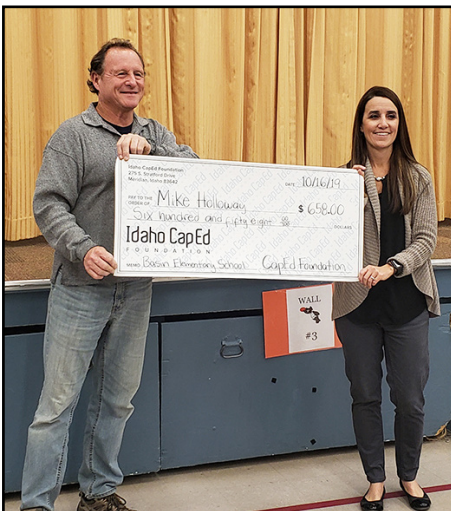

Basin Wins CapEd Grant for Creative Learning

BOISE BASIN -- At a surprise assembly last month, Basin Elementary teacher Mike Holloway received a grant for \$658 from the CapEd Foundation. The funds will buy sumo bots and a large circuit board for the Science, Technology, Engineering and Math (STEM) classroom, known as the "Basin Innovation Station" or the "STEM lab."

The Innovation Station was created this year with \$4000 in prize money from the STEM Action Center. The cash prize was earned by Basin fifth through eighth graders who participated in Idaho's 2018-2019 MakerMinded Competition. Basin took first place in the small middle school classification and was the overall top point earner out of 55 schools across the state.

According to sixth grade teacher and grant recipient ReBekha Lulu, the prize money was used to create an engaging new makerspace, equipped with a huge LEGO brick wall, Makey Makey circuit boards, straw builders, airplane launchers, a Cricut machine, and Oculus Quest Virtual Reality headsets.

Students grades K-8 regularly enjoy structured activities and free exploration time in the newly equipped classroom. Sixth grade student Kendall Exon said, "There is so much to do, so no one should get bored. I never knew that

this much fun could be had in school!"

The additional funds Holloway received last month will only add to the fun, and to the learning. Holloway said he applied for the grant because he wants to provide more fun activities for the STEM lab and for the people who use it. The mini sumo bots are small robots designed to interact with one another, and the larger circuit board will allow students to practice more advanced electrical circuitry.

Holloway had applied for the funds previously and did not know that the grant was chosen to be fulfilled. On a school day morning last month, Superintendent Brian Hunicke told Holloway that the elementary office needed technical assistance. When Holloway arrived to solve the fictitious problem, the school was gathered together with representatives of the CapEd foundation ready to surprise him with the grant. "I was totally surprised," said Holloway, with a smile.

BOISE BASIN -- This fall, Basin students moved through an after-school program called "Art Week" to help them participate in the Reflections Art Contest. level will compete in regional, and potentially in state and national levels.

During art week, students moved through stations led by teachers and parent volunteers. Charles Sepulveda from Old Time Photo came in and demonstrated different photo, video, and music techniques. Parent volunteer Karlee Kopenick showed the students dance techniques. Sarah Nelson helped the students write artist statements. Other stations included painting and drama.

This is the second year in succession that our local PTA has put on the Reflections Art Contest. The final deadline to complete projects will be November 15, and the contest judging will occur after that. There will be cash prizes and a "people's choice" award.

New Imagination Station Preschool Opens

GARDEN VALLEY --

Imagination Station is a new preschool opening in Garden Valley, located on Middlefork Road, at the site of the old red farmhouse. It was bought by the Larsen family, who have embraced Garden Valley life and want to add a little to the quality of life we all enjoy.

With the population growing, the preschool at Garden Valley Schools can no longer serve three-year-old children, unless they have special needs. This leaves parents struggling to find quality preschool placement for their two and three-year-old children.

Two young mothers have stepped forward to fill that gap. The preschool is staffed by Cara Larsen, B.A., and Mandi Patton, a veteran preschool teacher. The cost is \$90 per month. At present, Imagination Station is in session on Mondays and Wednesday mornings with more sessions to open as the enrollment increases.

The Imagination Station preschool serves 2 to 5-year-olds, and provides a classic preschool curriculum, addressing all domains of child development: gross and fine motor coordination, social and emotional skills, academic readiness/cognitive skills, adaptive skills, and language. The children begin their school day at 8:00 am and finish at 10:45 am. The times are coordinated with the public pre-school at Garden Valley Schools to assist parents who have children in both settings.

The children attending Imagination Station preschool are involved in structured activities such as singing songs, listening to stories, and "table work," with fine motor paper-and-pencil tasks, art, puzzles, games, and even participate in special holiday events. The Imagination Station is a joyous, structured program designed specifically for little ones. To register your little one, staff are available at 208-258-5153.

Present: Commissioners Alan Ward, Roger Jackson and Ryan Stirm

Pledge of Allegiance

EXECUTIVE SESSION: Closed session per risk management, personnel, legal updates, hiring of new employees, pending litigation and pending litigation. [Time 9:02 am to 9:32 am] Chairman Ward said there was no action required.

CONSTITUENT INPUT: An individual spoke about a piece of land he bought, and said that he was told, due to the size of the building, he would not need a permit. The cabin is 12' x 16' and a neighbor filed a

complaint against the individual, a disabled veteran who is divorced with nothing. The permit is \$500- plus, but he didn't know he would have to come up with this money because it was small. Assessor Juszcak spoke to the rule that any occupied structure would need a building permit no matter what the size.

Chairman Ward would like an opportunity to look into this, took his information, and said, "We'll be back in touch with you."

MINUTES: A motion was made for two sets of meeting minutes and passed.

PROBLEMS WITH

COUNTY SOFTWARE: Circling the wagons with the other counties to get better software for numerous small counties was discussed, because Computer Arts is not current or functional. Prosecutor Strong suggested reaching out to the other commissioners of small counties.

EMERGENCY MANAGER: To get ahead of the next Pioneer Fire scenario, Bob Showalter suggested a tri-county Mutual Aid agreement between Gem, Valley, and Boise County. This would include all the fire departments and EMS. "In that agreement, it talks about compensation re-

covery," said Showalter. The first twelve hours are free, but with a state disaster declaration, the county could pay out, with 50% from the State, to help reimburse volunteer departments. This would take into account fuel, time, equipment, records, and money. Showalter said this was an agreement that the three counties were about to sign. Chairman Ward stated, "I'm glad you're on it."

Emergency Manager Showalter then spoke about a purchase request, "I would like to use grant money to purchase an evidence refrigerator/ freezer for the Sheriff's Office... The thing there is that we are keeping evidence, whether it's blood or urine in a freezer or a refrigerator, needs to be in a frost-free system." The cost is \$998, without a water or ice dispenser.

Sheriff Jim Kaczmarek stated that there was blood evidence in there from 1978, which is being organized, and there is grant money available for maintaining evidence and DNA. He said they won't have any massive blocks of blood and urine.

Chairman Ward joked, "Do you have any baloney sandwiches in there?" Showalter laughed, "From 1978?"

The purchase will be made through a budget amendment for an evidence refrigerator/freezer and was motioned for approval.

A motion was said for a training request by Mr. Showalter.

It was discussed that the personnel policy may include

disaster training and require several positions to be filled during a disaster.

DEMAND WARRANTS: Motions were made to reimburse county employees for training, travel, and meals.

EXECUTIVE SESSION: Closed session per Human Resources update, Risk Management, hiring of a new employee, pending litigation and exempt records. [Time 10:16 am - 11:26 am] Chairman Ward said, "No action required."

EAST BOISE COUNTY AMBULANCE DISTRICT:

EXECUTIVE SESSION: Closed session per personnel issues and risk management. [Time 1:19 pm to 1:37 pm] Chairman Ward stated after coming back into session, "No action required."

COMMITTEE REPORTS: Commissioners Jackson and Stirm had no updates. Chairman Ward met with a county employee concerning solid waste and costs, "to look for a good fair potential increase in the tonnage," and shortening a contract.

PROSECUTOR STRONG: He stated that he "had something that's kind of special" for future agendas. Mr. Strong has been talking with attorneys for Avimore, a public meeting on December 10th or 17th, and the Banks Lowman discussion to be potentially moved to January 7th. A meeting during the week of Christmas was discussed, and whether it would be prudent to cancel the meeting.

Adjourned at 1:49 pm.
