### Disaster Averted with Assistance from Boise County Deputy

**EAST BOISE COUNTY--** Wilderness Ranch Fire was paged out to a structure fire at a house in Wilderness Ranch on Sunday, November 17<sup>th</sup>. Deputy Sheriff Scott Turner was dispatched as well. As with most rural volunteer fire departments, when the pagers go off, firefighters have to drop what they are doing, grab their gear, and respond to the firehouse. Once there, they have to start the fire trucks, put on their gear, then respond to the fire. All this takes time, and depending on the circumstances, a house fire can double in size every three to five minutes. In most all emergencies, *timing is everything*.

Deputy Turner was in the vicinity of Arrowrock Road and Highway 21 when he too was dispatched to the fire in Wilderness Ranch. He arrived on scene approximately ten to twelve minutes before myself and any of our fire apparatus.

Deputy Turner and the homeowner were outside waiting for us when we pulled up. When I asked for a size-up, he said the

fire was out, and he had put in a call to *Idaho Power*.

The home is a two story structure with a daylight basement. Previously, the homeowner had been outside to meet Deputy Turner when he arrived on the scene. He informed the officer as to where the fire was, which was in the basement. Deputy Turner grabbed his dry chemical fire extinguisher and entered the basement door. He had to crawl on his hands and knees to avoid the smoke and be able to see where he was going, then went to where the source of the fire. He extinguished the flames, which at that point were three to four feet in length, then exited the structure. He then went to the main breaker panel and turned off the power to the house.

That's when I arrived, and met with Deputy Turner. Wilderness Ranch Fire deployed a high volume gas powered exhaust fan to clear the smoke and fumes, and the powder from the extinguisher. The volunteer firefighters were able to remove heat remaining in the wall with hand tools.

This fire was in the basement

of a home, which appears to have originated from an electrical box of some sort. A box or basket was ignited on the floor that then ignited the lower plate of the stud wall, which was the very lowest part of the house. Then the fire started climbing up the studs in the wall. The fire had the best route for disaster, *which was up*. As I had mentioned before, a fire, depending on the circumstances, can double in size every three to four minutes. Deputy Turner had put the fire out in approximately eight to ten minutes before Wilderness Ranch Fire arrived. The fire could have easily made its way into the 1<sup>st</sup> story floor before the fire department could arrive.

I would like to say thanks to Scott for making this one a happy ending. Your quick thinking and actions prevented a lot of damage to this home. Because of you, we didn't have to use any water on the fire, which also causes a lot of damage. The fire damage, besides the electrical box and some wiring, was limited to some insulation and 2x4' studs. There was minimal smoke damage because of your actions and *Idaho Power* okayed the home, restoring power to everything except for the damaged area. The homeowners could actually stay in their home.

*Thanks again, Scott. It made our job easy.*

**Kim and Gary McLean added their thanks:** "We had the unfortunate experience of having a fire in our basement Sunday afternoon (11/17). Boise County Sheriff Deputy Scott Turner was the first on the scene. He entered the basement, full of smoke, with a

fire extinguisher and put out the flames. He put his life and health on the line to go into the smoke and save our home. Thank you, Deputy Turner!"

**Deputy Sheriff Scott Turner explained:** "I have fire training as well, so I didn't put myself in a spot I couldn't deal with."

Turner has been trained and has served as a firefighter with the Idaho City Fire Protection District.

When asked if he had a comment, Deputy Turner replied that he was "just doing what we are supposed to do in the community."

[Deputy Turner will be running for Boise County Sheriff in 2020.]

## Officers Respond to Shooting

**GARDEN VALLEY --** A confirmed call came into Boise County Dispatch at 2:58 pm explaining there was a suicidal subject shooting a gun through the ceiling into the upstairs bedroom. Terry L. Sims, 70, had barricaded himself in his house and was said to be firing randomly.

Sheriff Jim Kaczmarek verified that the Idaho State Police's press release was incorrect. At no time was Sims shooting at passing vehicles. Several caring neighbors also reached out to *The Idaho World* stating that they had been home all that day and had not witnessed any shooting.

There were many agencies

involved in the standoff, including: Idaho State Police SWAT Team, Idaho Fish & Game, Idaho City Police, and five Boise County Deputies. Life Flight was on standby, along with Garden Valley Family Medicine, Garden Valley Fire and EMS.

Officers cleared the surrounding neighbors out and advised them to wait at the Terrace Lakes Lodge until the all-clear was given at 8:25 pm. The conflict was resolved without incident or injury.

Terry Sims was not arraigned in Boise County Court on Monday, Nov. 18<sup>th</sup>. The Ada County jail stated that he was unavailable.

**Solar Customers Proposed Increases**

### Idaho Power Proposes Changing Rules for Existing Solar Customers

Over 4,000 families and  
small businesses would see  
large increases to power bills

Boise, ID -- On Nov. 13, Idaho Power Company (IPC) filed a proposal to change the rules for existing rooftop solar customers. This change would decrease the price Idaho Power pays rooftop solar owners for their excess energy by 50%, causing large increases to the monthly bills for the 4,000+ customers who have already adopted rooftop solar, and leaving an estimated 1,300 of those families and small businesses completely underwater on their investments.

"Idaho families deserve better from Idaho Power and the PUC," said Ben Otto of the Idaho Conservation League. "Idahoans who chose to invest early in their energy freedom should not have the rules changed after the deal is done. Changing the math now is unfair and penalizes those who

are leading Idaho into a clean energy future."

In their comments, ICL and Vote Solar advocate for the PUC to protect existing Idaho Power residential and small business solar customers from new compensation rules that will replace net-metering next year.

"Utilities across the country are trying to stand between customers and clean, local, affordable solar energy," said Briana Kobor of Vote Solar. "Maintaining fair pricing for existing customers is a commonsense compromise that allows both consumers and utilities to keep good-faith agreements."

Net metering allows solar customers to receive a credit on their bill for the excess electricity they send back to the grid. Today, that credit is the same as the rate all customers pay Idaho Power for electricity. However, under a recently filed settlement that value would decrease over time to a rate 50% lower than today.

The PUC has already received 300 public comments on the proposal. The comment period is open until Dec. 3. Refer to docket IPC-E-18-15. There

Idaho Power Company serves over 560,000 customers in Idaho and Oregon. Its service territory stretches across the state from Ontario, ID to Blackfoot, ID, and includes major metropolitan areas, Boise, Twin Falls and Pocatello. The company has committed to providing 100% clean energy by 2045, but by ending net metering and potentially lowering rates for existing solar customers Idaho Power is making it clear that it wants to be the only one that controls that affordable, reliable clean power.

Idaho's solar industry currently employs 557 people and has invested over \$645 million in the state. Idaho ranks 21st in installed solar with over 488 megawatts installed, enough to power 64,443 homes, according to the Solar Energy Industry Association.

## In Honor of Hunting Season ~ "Roping a Deer" The Idea of Corn Feed Venison has Repercussions

I had this idea that I was going to rope a deer, put it in a stall, feed it up on corn for a couple of weeks, then kill it and eat it.

The first step in this adventure was getting a deer. I figured that, since they congregate at my cattle feeder and do not seem to have much fear of me when we are there (a bold one will sometimes come right up and sniff at the bags of feed while I am in the back of the truck not 4 feet away), it should not be difficult to rope one, get up to it and toss a bag over its head (to calm it down) then hog tie it and transport it home.

I filled the cattle feeder, then hid down at the end with my rope.

The cattle, having seen the roping thing before, stayed well back. They were not having any of it.

After about 20 minutes, my deer showed up -- 3 of them. I picked out a likely looking one, stepped out from the end of the feeder, and threw my rope. The

deer just stood there and stared at me.

I wrapped the rope around my waist and twisted the end so I would have a good hold. The deer still just stood and stared at me, but you could tell it was mildly concerned about the whole rope situation.

I took a step towards it...it took a step away. I put a little tension on the rope and then received an education.

The first thing that I learned is that, while a deer may just stand there looking at you funny while you rope it, they are spurred to action when you start pulling on that rope.

That deer EXPLODED.

The second thing I learned is that, pound for pound, a deer is a LOT stronger than a cow or a colt. A cow or a colt in that weight range I could fight down with a rope and with some dignity.

A deer-- no chance.

That thing ran and bucked and twisted and pulled. There was no controlling it and cer-

tainly no getting close to it. As it jerked me off my feet and started dragging me across the ground, it occurred to me that having a deer on a rope was not nearly as good an idea as I had originally imagined.

The only upside is that they do not have as much stamina as many other animals.

A brief 10 minutes later, it was tired and not nearly as quick to jerk me off my feet and drag me when I managed to get up. It took me a few minutes to realize this, since I was mostly blinded by the blood flowing out of the big gash in my head. At that point, I had lost my taste for corn-fed venison. I just wanted to get that devil creature off the end of that rope.

I figured if I just let it go with the rope hanging around its neck, it would likely die slow and painfully somewhere. At the time, there was no love at all between me and that deer. At that moment, I hated the thing, and I would venture a

guess that the feeling was mutual.

Despite the gash in my head and the several large knots where I had cleverly arrested the deer's momentum by bracing my head against various large rocks as it dragged me across the ground, I could still think clearly enough to recognize that there was a small chance that I shared some tiny amount of responsibility for the situation we were in, so I didn't want the deer to have to suffer a slow death, so I managed to get it lined back up in between my truck and the feeder - a little trap I had set before hand... kind of like a squeeze chute.

I got it to back in there and I started moving up so I could get my rope back.

Did you know that deer bite? They do! I never in a million years would have thought that a deer would bite somebody, so I was very surprised when I reached up there to grab that rope and the deer grabbed hold of my wrist.

Now, when a deer bites you, it is not like being bit by a horse where they just bite you and then let go. A deer bites you and shakes its head --almost like a pit bull. They bite HARD and it hurts.

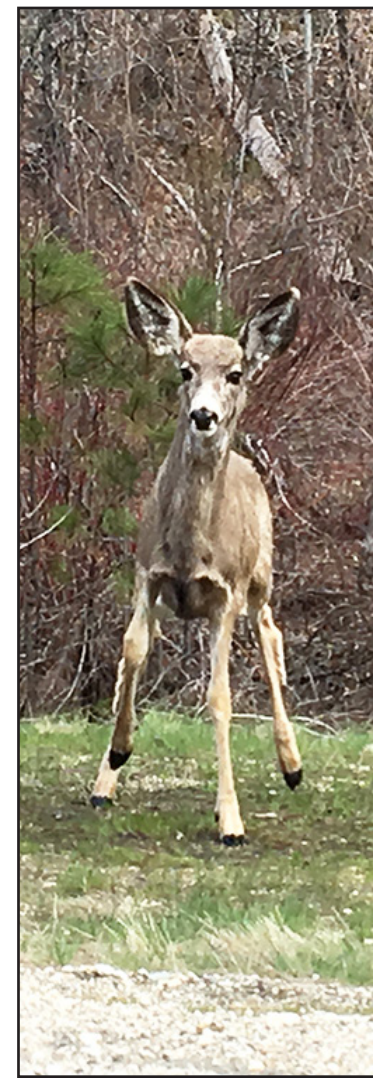
The proper thing to do when a deer bites you is probably to freeze and draw back slowly. I tried screaming and shaking instead. My method was ineffective. It seems like the deer was biting and shaking for several minutes, but it was likely only several seconds.

I, being smarter than a deer (though you may be questioning that claim by now), tricked it.

While I kept it busy tearing the tendons out of my right arm, I reached up with my left hand and pulled that rope loose. That was when I got my final lesson in deer behavior for the day.

Deer will strike at you with their front feet. They rear right up on their back feet and strike right about head and shoulder level, and their hooves are surprisingly sharp. I learned a long time ago that, when an animal -- like a horse -- strikes at you with their hooves and you can't get away easily, the best thing to do is try to make a loud noise and make an aggressive move towards the animal.

This will usually cause them to back down a bit so you can escape.

This was not a horse. This was a deer, so obviously, such trickery would not work. In the course of a millisecond, I devised a different strategy. I screamed like a woman and tried to turn and run.

The reason I had always been told NOT to try to turn and run from a horse that paws at you is that there is a good chance that it will hit you in the back of the head. Deer may not be so different from horses after all, besides being twice as strong and 3 times as evil, because the second I turned to run, it hit me right in the back of the head and knocked me down.

Now, when a deer paws at you and knocks you down, it does not immediately leave. I suspect it does not recognize that the danger has passed. What they do instead is paw your back and jump up and down on you while you are laying there crying like a little girl and covering your head.

I finally managed to crawl under the truck and the deer went away.

So now I know why when people go deer hunting they bring a rifle with a scope to sort of even the odds.

**Present: Commissioners Alan Ward, Roger Jackson and Ryan Stirm**

**Pledge**

**EXECUTIVE SESSION:** Closed session per a Human Resource update, Risk Management update, and hiring of new employee. [Time 10:00 am to 10:10 am] No action required.

**EXECUTIVE SESSION:** Closed session per Pending Litigation, and Legal Updates from Prosecutor Adam Strong. [Time 10:11 am to 10:28 am] Chairman Ward stated a second time that there was no action required.

**CONSTITUENT INPUT:** None

**EAST BOISE COUNTY AMBULANCE DISTRICT:** An EMT class and contract was discussed for Idaho City. Commissioner Jackson made a motion to pay for the EMT training in the amount of \$5,995.

**MINUTES:** Commissioner Jackson motioned to accept the November 5<sup>th</sup> meeting minutes.

**DEPARTMENTAL ISSUES:**

**CANVAS OF VOTES:** The election results from Nov. 5<sup>th</sup> were discussed by Clerk Mary Prisco. She said they would be the official results once the Board approved of them. "Last week, on a Thursday, we did our internal audit. We did make a couple of changes, nothing significant of vote numbers." The Board motioned to approve the canvassing of votes of the election.

**JUVENILE JUSTICE:** The approximate numbers of a report for the department were discussed. There were 17 cases, and several new petitions were filed from out of county.

A job opening for an administrator has opened.

**FORESTER:** The Federal Financial Report was accepted for the BLM grant, \$117,260, was motioned and signed.

**EMERGENCY MANAGER:** Spoke about the grants management training he will take.

**CLERK:** Mary Prisco said

their Subaru Accent had arrived. She asked the board to sign the Sales Retail Purchase Agreement, and the following week, they would have a demand warrant for the cost in the amount of \$31,150.

**SHERIFF:** Jim Kaczmarek spoke about an interest rate of 4.99% for auto(s). He stated that there was an F-150 that was totaled in a crash on Highway 17. There is a replacement cost. The equipment is being tested to see what can be salvaged.

Commissioner Stirm made a motion to approve the purchase of a 2020 F-150 Police model in the amount of \$55,714 per the Sheriff's Department.

**RESOLUTION:** A budget amendment for equipment purchase was made for the Emergency Management Department.

**BILLS:** Commissioner Jackson made a motion to pay the claims in the amount of \$231,468. He added, "The bills are paid."

**HEALTH CARE COSTS BOARD:** Chairman Ward said the current representative was doing a good job and they decided not to nominate anyone.

**EXECUTIVE SESSION:** Closed session per Indigent & Exempt Records. After coming back into session, Chairman Ward motioned to approve an emerging case, and sign liens.

**EXECUTIVE SESSION:** Closed session per personnel issues. [Time 11:15am to 12:04am] Chairman Ward stated, "We had a very positive discussion with the Road and Bridge Department. No action required."

**PLANNING & ZONING COMPREHENSION PLAN:** Chairman Ward said they had recently had a hearing and it was closed. The administrator said there were six points that he would like to add clarity to and recommended that they move forward.

A hearing date was discussed and publication in the newspaper.

**SOLID WASTE PROPOSAL:** Chairman Ward said the

proposals were not what they had discussed. A representative stated that the photos were from ITD [Idaho Transportation District] and said it was showing the current intersection "and why it's bad." More encroachment and turn radius was discussed per ITD. There were three proposals from engineering firms. He didn't expect that \$23,500 would be the final price, because that's the way engineers work.

Building a transfer station was discussed, and hauling from Grimes Creek onto Highway 21. There are fiber optics and U.S. Forest Service land.

Ward recommended putting this on the agenda for next week.

**CORRESPONDENCE:** Commissioner Stirm said, "It looks like the Horseshoe Bend bridge is going pretty good. It looked like, when I came across it this morning, that they were drilling filler holes in the bedrock by the river. They had to drill it and had it going first thing." He added, "It's going to be a one lane bridge while they're building it," with a traffic light. "They sent out a thing saying they were going to do their best to keep it at two lanes as much as possible, but there were going to be times when it was going to be one lane. *I hope that they keep it at two lanes, because if they don't, it's going to be a nightmare.*"

An individual commented that it would "force a lot of traffic down Pioneer Road, which is going to be worse." Stirm was concerned that someone might get stuck on Pioneer Road. The landing has been graded and rock has been hauled in. The Horseshoe Bend Bridge is costing about \$12.5 million. Stirm recounted, "The City of Horseshoe Bend, *we had to get a loan for \$500,000 just to move the sewer pipe.*" Commissioner Jackson commented, "Somebody could make a bundle." Commissioner Stirm said they paid that price because the city had no say in who did the work in relocating the sewer pipe. "It was whoever ITD decided who was going to do it. *We had to pay their price.*" Commissioner Jackson half-heartedly joked, "Well, that's \$480,000 worth of profit."

**GROOMER SHED:** They have a couple of bids coming in and may be able to get it done this winter.

**IDAHO CITY ROAD DEPT:** On of the new hires

has already resigned, due to his wife's health condition and needing around the clock care.

**CHRISTMAS:** The commissioners decided they will not have a meeting the week of Christmas, unless something important comes up. They will have a meeting the week of New Year's.

**REPLACING THE**

**BOARDWALK:** Clerk Prisco said the section in front of the Courthouse should take top priority due to risk. Ward will look into the price of the lumber. Correctional institute or hiring someone by the hour was discussed. Supplying the tools and feeding them was also talked about, along with getting Idaho City involved.
