Logging Truck Accident on Highway 55 has No Injuries

GARDEN VALLEY -- On Friday, November 22nd, both lanes of traffic were closed when a semi-truck carrying a load of logs overturned at a tight turn above Banks, milepost 79. Some of the logs blocked both lanes, while others rolled into the river. There were no injuries in this accident.

The Idaho Transportation Department was able to use a front-end loader, and to have Garden Valley Fire Department assist with the chaining of logs and pulling them safely out of the lanes of traffic to a wider area in the road. An investigation and the removal

of the logs resulted in a nearly four-hour delay for traffic.

Logging operations have been heavy this summer due to bug infestations in the pine trees. This particular load of logs had come from the Sage Hen Reservoir.

Garden Valley Fire Chief Jon Delvalle was impressed that even with the large amount of logging activity, this was the only logging truck accident this summer or fall along the Middlefork and Highway 55. He humorously commented that the only injury in this accident was the pride of the driver of the logging truck.

Emergency Manager's Corner:

BOISE COUNTY -- As we enter the Holiday Season, I want to remind everyone that travel is very dangerous with or without slick roads. Here's some tips; BE PREPARED! Keep a winter kit in your car when you travel. Especially long distances. Have items to keep you alive if you slide off the road and are trapped. Items like food (MRE's are great because they last a long time, and have a food heater), water, flashlight, ice scraper, blankets, gloves, stocking cap, medicine, first aid kit, towels, extra clothing, shovel, safety sweep to help get

traction, road flares or warning triangles, jumper cables, cell phone charger, tarp, 5/50 cord, magnesium block, and matches to start a fire. This list could be even bigger depending on what think is important. Get a vehicle winter maintenance check-up. Don't wait to check your tires, battery, belts, hoses, radiator, fluids, lights, brakes, heater/defroster, and wipers. Keep your fuel tank full. Don't let it fall below half a tank on winter trips. If you are stuck on a rarely traveled road, conserve your fuel. Make sure that your exhaust can ventilate away from your vehicle if you do run your car. Check <https://511.idaho.gov> for road conditions and

road closures for your route. Let people know where you are headed, what route you're taking, and when you expect to be there. Also let loved ones know when you've arrived. Failing to plan out your trip is planning to fail!





Horseshoe Bend City Council:

HORSESHOE BEND --

The following is a synopsis of the Horseshoe Bend City Council's 673rd meeting on November 21, 2019. All council members were present. After the call to order, Pledge of Allegiance, the council's approval of the agenda, previous minutes, and the authorization to pay the city's bills, Mayor Pat Goff opened with public comments. With no public comments, Goff moved onto the public hearing on the agenda, which was for an amendment to the zoning ordinance table. The reason for the amendment is to allow for an indoor/outdoor shooting range within an industrial zone with a contingent upon a conditional use permit (CUP). A representative from American Reserve Munitions (the permit seekers) was on hand to explain to the council what they would be requesting with their CUP (which they plan on filing within the next week). The area in question for the new range is off Highway 55 where the old horse track was once located. According to the company, a sound check revealed that the noise from the range was no louder than the current noise from the highway. The range is set to open after the spring thaw with 8 indoor lanes, an outdoor long range (1,000 yards), a pit for tactical shooting/training, and 10 outdoor 100 to 200 yard lanes. The company plans to have rentals available along with

three classrooms for training (including first aid training). There was no one at the meeting who spoke in opposition of the proposed zoning change. Resident Mike Fry spoke in favor of the change with the exception of asking that concessions be made for outdoor shooting during fire season. It was explained that that would be part of the yet to be filed CUP. The council then deliberated with Council Member Ben Riley stating, "I think it would be a great addition to the city," adding, "I think it fits into the rural setting that we have."

"We're close enough to the valley to attract people," Council Member Teresa Cooper replied. Two ordinances were passed unanimously by a roll call vote dealing with the zoning change. The first one defined what an indoor/outdoor range was, the second allowed for such an enterprise to be located within an industrial zone with a CUP.

The council then discussed what to do with the old railings from the bridge currently being replaced by the Idaho Transportation Department (ITD). Cooper said, "It's kind of a historical thing, we could probably utilize them somewhere." Mayor Goff suggested that they store them and decide at a future date how best to use them. Public works spokesperson Michele Brothers said she would let ITD know of their decision.

The Boise County Sheriff was not in attendance to give

the department's quarterly report. No explanation was given.

The council approved a contract for \$1,478 with cascade refrigeration to replace a backup heater in the water plant, as well as renewing their preventative maintenance & inspection contract for another year. Goff met with a representative from the Americans with Disabilities Act Department (ADA) regarding sidewalk compliance, specifically along Riverside Drive. Sidewalks in the area are not being maintained by homeowners so as not to cause obstruction for pedestrians.

City Attorney, Tony Pantera, told the council that "Municipalities have the right to enact ordinances that require property owners to maintain sidewalks and keep them clean." He told the council that an ordinance would be written re-

garding sidewalk maintenance and what would be prohibited so as to be enforceable. Pantera stated that he would have the ordinance ready by the next council meeting.

City Engineer Amy Woodruff brought an action item to the council regarding a property line encroachment. Watson Road (within the city limits) is currently encroaching onto Duane Brothers' property. Brothers wants to erect a fence around his property and needs the road to be moved. "Mr. Brothers' request is quite simple, it will require Watson Road to be moved to its correct place", Woodruff told the council.

No EMS update was provided.

The Public Works report was regarding getting ready for winter.

Woodruff gave the City Engineer report and told the council

that the new well was delayed but that work would begin the week of November 25. Woodruff also told the council that the cost to install the city sewer main under the new bridge would be closer to 500K as opposed to the original estimate of 350K. Goff asked Woodruff to get more information. City Attorney Pantera again promised a delivery date for updated city zoning ordinances, indicating that they would be done by February's meeting.

Mayor Goff passed out information to the council regarding hiring a grant writer. The cost would be \$1,600 and the proposal called for a 4-way split with the city, the HSB Fire District, the EMS Department, and Horseshoe Bend School District. Goff asked the council to look over the proposal to discuss at a future date.

The council went into executive session at 8:00 p.m.

An agreement for training with a medical technician for EBCAD

was approved. The minutes for Tuesday, November 5th, 2019 were approved. The canvas for election results on the November 5th, 2019 election were approved. Present: Commissioners Alan Ward, Roger Jackson, and Ryan Stirm

Pledge of Allegiance

EXECUTIVE SESSION: Chairman Ward motioned for closed executive session per personnel, and resources update from the HR Director. [Time 9:05am to 9:21am] Coming back into motion there was no action required.

EXECUTIVE SESSION: Chairman Ward motioned to go back into executive session per updates, legal issues, and pending litigation. [Time 9:22am to 9:30am] Chairman Ward said there was no action required.

CONSTITUENT INPUT: None

MINUTES: The November 12th meeting minutes were accepted.

COMPUTER ARTS: The Boise County IT [information technology] technician said that many of the smaller counties do not have an IT person, and Computer Arts is their contact or IT.

SOLID WASTE ENGINEERING PROPOSAL: A proposal was picked and a contract prepared. Bill Jones, with the Roads Dept. was said to be pleased with other work done by this company. Commissioner Ward asked with some humor, "What do you think, commissioners? Do you just want to take an old skid cat down there and build it?" Commissioner Jackson commented, "We could build it for what this engineering costs." A representative from Solid Waste responded, "I absolutely agree." Jackson added, "We could have it all built." Ward said soberly, "We probably should play by the rules." The Idaho Transportation Department cautioned that the county would need to acquire a right-of-way from the U.S. Forest Service. Chairman Ward made a motion to have engineers do the Highway 21 / Grimes Creek redesign in the amount of \$22,500 for solid waste and a future transfer station.

GARDEN VALLEY GROOMER SHED: Two proposals to build the shed were recently received. Chairman Ward advised that there may be another bid soon. This will be addressed at the next Commissioners' meeting.

SHERIFF: A radio and cage were discussed for a vehicle. Commissioner Stirm made a motion to approve the instal-

lation in the county van, per Sheriff Jim Kaczmarek's request.

COUNTY VEHICLE: Sheriff Kaczmarek gave an update on the F-150 truck that was crashed last month. The insurance has agreed to pay \$32,187.90 for the vehicle. The light bar has been destroyed, but everything else can be transferred over to a new vehicle, including the cage, the radios, the truck box, etc. He warned that if the labor exceeds the cost of the cage, they may look into getting a new one, because it is very labor intensive.

"We did order the other four vehicles for this year, and this one we will just have to put onto the end of that," Kaczmarek said.

INDIGENT: Chairman Ward made a motion to approve the "Boise County Indigent letter to the county discussing lien overages," in the amount of \$10,932 and \$35,259.

IDAHO CITY RADIO SNOW GROOMER: It was stated that the radio was stolen when the snow groomer shed was broken into, and will need to be replaced. It was insured. Commissioner Stirm motioned to accept a bid to replace the radio from the snow groomer vehicle that was stolen, in the amount of \$1,324.17.

MEMORANDUM OF UNDERSTANDING: A memorandum was signed with the U.S. Forest Service and Boise County Sheriff's Office to share radio frequencies.

DESTROYING COUNTY RECORDS: Auditor certificates were discussed. The deputy clerk stated, "These are things we are required to keep for five years. Once that is past, we can destroy them." Commissioner Roger Jackson motioned that they adopt a resolution to destroy certain records.

VEHICLES: Jackson motioned to adjust the Boise County General Fund, Capital Projects Dept., FY2020 budget.

HWY 17 vs. ITD: A meeting is to be held the second week in January that Prosecutor Adam Strong will be attending.

CuMo Mine: Nothing
BOISE STREET BRIDGE: Commissioner Stirm stated: "I think the city is okay if the county wants to essentially sign it over to them and make it a city bridge, instead of a county bridge." Chairman Ward said, "We could probably do that." Stirm said he would talk with

the Mayor of Horseshoe Bend and added: "I told him that we had had a discussion about it. That it would probably be easier for them to do it as a city, to get it repaired, and to get the funds, than it would be for us as a county. He said if that's what it takes then he was more than happy to take it."

ROAD DEPT. FUNDING: Nothing to report. Chairman Ward said they are just waiting to hear if the federal government was going to continue SRS and PILT funding.

LETTER: A letter was approved for Miller Enterprises per a change order.

LARRY H. SUBARU: Commissioner Jackson motioned to approve a shared vehicle for Boise County, in conducting county business, in the amount of \$31,150.

MARKETING: Commissioner Jackson motioned to pay West ___ Marketing in the amount of \$5,992.46 for a service agreement renewal "for support of stencil."

BANK OF AMERICA: Commissioner Jackson made a motion to approve charges that were made for October in the amount of \$575.

INDIGENT EXECUTIVE SESSION: Closed session per exempt records. [Time 9:58am to 10:20am] One case was denied after coming back into session.

PLANNING & ZONING: A road name was presented to the commissioners from Smith Creek. There is a potential for addressing issues, "naming of the road is encouraged," said the P&Z administrator. Chairman Ward inquired if there was any gray area with access roads. The administrator stated that they've done their due diligence. Chairman Ward motioned to approve: "Waters Edge Lane as presented on the location off of Smith Creek in Garden Valley, Idaho."

2020 CENCUS FOUNDATION: Lynn M., a representative selected from Boise

County, came to speak with the commissioners. She said there is a once per year meeting she attends: "We review a lot of grants and vote on them. And a bunch of money is given out for various things: education, social, work, libraries, health, just all kinds of things to help the people." The last meeting she attended, they gave out over \$300,000 to various organizations. She was appalled, she saw money getting passed out right and left, but Boise County did not have any good requests for money. Lynn explained that she has made contacts, and although it hasn't been announced yet, Boise County organizations will be getting money this year. They are looking for organizations working with hard-to-count populations.

Commissioner Jackson asked if the county was eligible, and it was, including: "tax exempt organizations, governmental agencies or departments, including public educational institutions and tribes. And then community based organizations working in the identified historically or under-county community or geologies are encouraged to apply."

Commissioner Jackson said they would like to replace the boardwalk around select county buildings. She will send a computer link to submit a grant application. This could also help with historic buildings. Grants are only up to \$5,000 each year, and they don't want to give out money to a project that cannot be completed, as

well as wanting to know what other money is being put towards that project.

She is working with others throughout the county, such as, the Garden Valley Senior Center.

EAST BOISE COUNTY AMBULANCE DISTRICT: Ms. Potts said it had been a rough weekend with two deaths. She presented some reports. Potts said they got an invoice from Garden Valley Fire for \$1,200 for three runs in October due to them being out-of-service. Transport from Lowman and the other two they were told to stand-down, at the station or 15-minutes from. "All three of these calls, [Unit] 14 or 15 were in service," so they could have responded. She had not been able to get ahold of the chief. She thought \$400 was fair, but the others were excessive charges.

Some compensation for volunteers was discussed for runs. A meeting was discussed for December 3rd.

EXECUTIVE SESSION: A closed session for EBCAD per risk management, no action required.

HIGHWAY 55: Commissioner Stirm said that the 24/7 work on Highway 55 was a bother to local residents.

FUTURE AGENDA: Items were discussed briefly, Emergency Manager Showalter would like to discuss radios, and a department head meeting will occur the following week. The groomer shed bids will be reviewed. The meeting was adjourned at 2:13pm.
