### Idaho City Home Saved from Unexpected Chimney Fire

**IDAHO CITY** -- Philip and Carol McKay were enjoying a nice relaxing evening on October 30<sup>th</sup>, watching TV and drifting off to sleep on the couch when Carol noticed a charcoal-like glow in the upper portion of the ceiling. They quickly gathered their dogs and headed to the car, only going back for a few valuables, but mostly for things of historic value that could never be replaced. Philip explained that it's interesting what you find most important in a situation, when you stand the chance of losing everything. Idaho City Volunteer Fire District came to the rescue and were able to save their home. Carol realized, "It could have been so much worse, so I consider us lucky...and blessed!"

Philip stated: "Now that things are a little bit more settled, I want to express our sincere gratitude to the Idaho City Volunteer Fire Department (ICVFD) for their great work in saving our home and to

our wonderful neighbors for their help and thoughtfulness. As for ICVFD, they were just great! They showed up quickly and got straight to work in both a professional and efficient manner. They literally saved our home! In addition, they minimized the damage to our house to only those areas that simply needed to be damaged in order to prevent further danger and loss. When looking over the charring and damage the next day, it was readily apparent that the roof and walls were only ripped out as far as was needed to put the fire out and address the issue of potential re-ignition. I sure hope none of you ever experience the sight of a fire hose spewing out gallons of water in your living room and then watching as your ceiling, roof, and walls are being ripped apart. However, if you do, I hope you are lucky enough to have a fire crew as professional and considerate as ICVFD -- thank

you guys, you are the best!"

"With respect to our neighbors and the community at large, you are wonderful people! As many of our nearest neighbors know, we have spent every free moment... and dollar...fixing up our house over the past seven months. We had just about finished up for the year and had prepared, as best we could, for winter. Like an untested soldier foolishly looking forward to actual battle, I was almost looking forward to the challenge of winter. You can understand our dismay, when with a new insert and install, this fire occurred. Consequently, when it happened, we were devastated, particularly me. However, the sincere empathy, offers of help, and real sense of

community we experienced during and after the fire reminded us of the real reasons we moved up here...to be around good people who like their independence, are true individuals (dare I say even characters), and are largely self-reliant (very rare these days outside IC). You are that and much more, Idaho City. You are indeed a community of largely self-reliant individuals. However, as we can personally attest, when a member of the community is threatened or needs help, you pull together and jump in to help in the best traditions of American generosity and compassion. This, to our minds, is at the heart of the definition of community and is a fine example of human beings at their best. So,

when the smoke and dust settled, I realized what my wife, as usual, knew all along; while the loss of the structure was not pleasant, we have something better, and much rarer...a community of great people. We feel truly blessed to be up here among you -- **Thank you Idaho City!**" - Phil and Carol McKay

On October 30<sup>th</sup>, there was a second chimney fire in the Rim View area of the Wilderness Ranch Fire District. Chief Jim Bryant said, luckily, it was contained to the chimney and when volunteer firefighters arrived, they were able to put out the flames with an extinguisher. This technique can often-times be more effective than water, with far less damage to the home.

## NEW Bridge in Horseshoe Bend

**HORSESHOE BEND --**

Idaho Transportation Department (ITD) has begun construction of a new bridge in Horseshoe Bend. The new bridge replaces the old weakened bridge that spans the Payette River along Highway 55 on the southern side of town. The new bridge will be wider and will consist of 2 travel lanes (one in each direction), a center median, wider shoulders to improve bicyclist safety and sidewalks on both sides for pedestrian traffic. The finished bridge will measure 63' across with 12' travel & median lanes, 8' shoulders, and 5 1/2' sidewalks. The 12.5 million dollar project is scheduled to be completed in the summer of 2021. Construction will take place Monday- Saturday from 7 a.m. - 7 p.m. A portion of the

new bridge will be constructed on the west side of the existing bridge and will support traffic while the old bridge is removed. According to ITD, the Payette

River will be closed during most of the project but they will try to have the river open during the floating season from June-October.

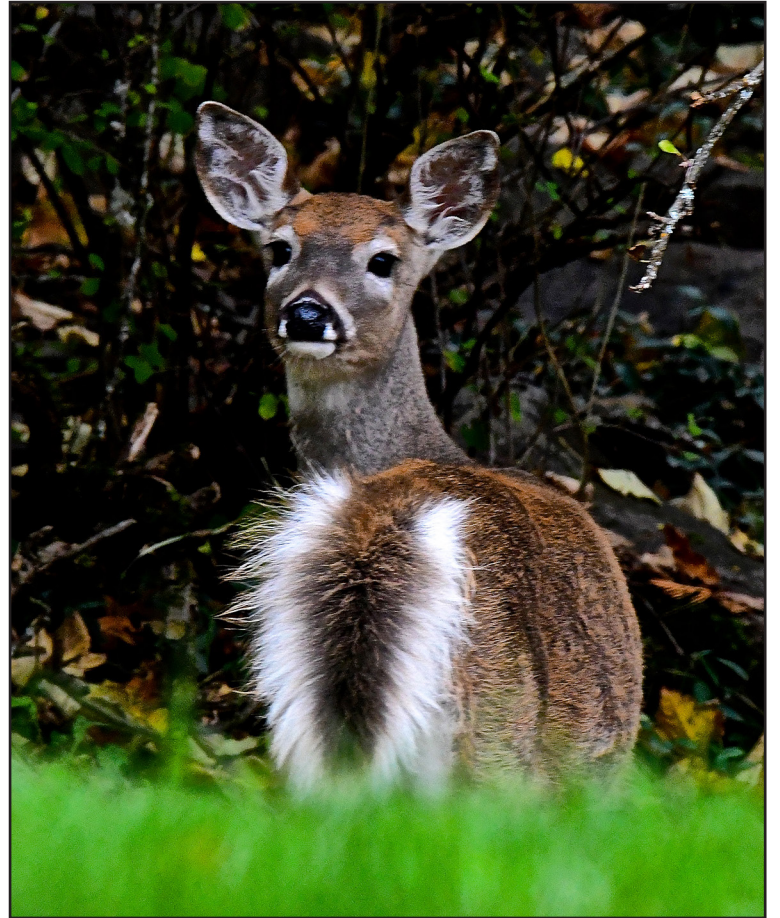

**GARDEN VALLEY** -- John Patton and Deanna Hollist of Garden Valley have started a First Lego League in the area. Special thanks to Payette Forward for providing the initial funds for the start-up cost of the first pilot program, the LEGO Program. They hope to be able to expand next year and provide more programs for the community.

FIRST stands for: For Inspiration, Recognition of Science, and Technology. It also promotes Team Work, Discovery and Innovation, Research, Problem Solving, Coding, and Engineering. These are skills that are viewed to help participants all through their lives, equipping them with the skills to meet new challenges in the rapidly changing world. The focus of the program is on solving real-world problems.

They begin to learn the science behind robotics at their very first meeting, where they build and

program their own robot. There are four FIRST programs in total. The FIRST LEGO program is designed for upper elementary-aged and middle-school students.

Every year, FIRST LEGO League releases a Challenge, which is based on a real-world scientific topic. Teams of children, up to ten, with at least two adult coaches, program an autonomous robot to score points.

Garden Valley children are learning that we must come together to innovate and solve problems. When they join FIRST, students become part of a thriving community and bring their inspiration, hope, and creativity. Their goal is a stronger, more sustainable future.

Hollist and Patton are planning to keep the program running for several years. The program materials that they are using this year will continue to be used by new participants, and the current participants will go on to tackle increasingly difficult challenges.

**Timothy Shane Pierce**  
Feb. 1961 - Oct. 2019

Timothy Shane Pierce 58, passed away in Idaho City, Idaho on October 12<sup>th</sup> 2019.

He was born February 19<sup>th</sup> 1961 to Richard and Jean Pierce in Blackfoot Idaho. He was a beautiful baby and cried when he got his first haircut. He was raised with bravery, love, faith, and served as an altar boy in his church.

In his youth he attended a summer camp called Camp Lonely Pines. His counselor's name was "Uncle Bud". Bud took Shane under his wing. At the camp, Shane had opportunities to go fishing, horseback riding, learn archery, games, and sitting around the campfire roasting marshmallows, telling stories. Uncle Bud said Shane was a special boy and second to none.

Shane had so much enthusiasm and athleticism; from being on the youth Blackfoot Idaho Swim Team, to taking golf lessons from pros and becoming a great young junior golfer, to becoming a junior downhill skier, winning many races. Everyone said, "He sure goes fast".

When Shane was 17, he decided he was going to take it to the next level and try his hand at professional snow machine racing in 1977-1978. He raced many races "All Around" with Artic Cat, Polaris, Rupp, and Yamaha sleds making it to the World Series in West Yellowstone, Montana. The older racers were threatened by this young man who had no fear. He won many races and had the trophies to show for it.

He also became an avid trap shooter under the tutelage of his mother Jean Gleed and his brother Bill Pierce in Montana.

Shane lived in Montana as a younger man and attended school in Billings Montana to accomplish old-school trades. He became very crafty at those trades. Since he was a free roaming spirit he

came back to Idaho to be closer to family and friends, taking on a trade which set his precedence. He learned and was self-taught about the glass business, going on to become a master glazier.

He brought his skills and knowledge of the glass industry back to the Treasure Valley, Boise County area. He settled in this area to be near to his mother Jean and sister Kelle. It marked a new chapter in his life. He met his wife, love, and friend Ellie Darnell. She became Ellie Pierce. Together they started a glass business; "All Around Glass", and it grew steadily. It has been a Boise County standard for nearly 20 years.

Shane and Ellie were blessed with a son named Caleb in 1998. Shane's greatest joys were his family in those years. He loved Ellie, Michael, and Caleb, and his business and customers. ## ATV Accident Results in Severe Injury & Fatality

**BOISE BASIN** -- A terrible ATV Razor accident occurred on Sunday afternoon, November 3<sup>rd</sup>, when the off-road vehicle came around a bend on a Forest Service Road at a high rate of speed and was unable to maneuver through a washed out rut in the gravel road. There were two individuals riding in the Razor. The rut sent the two individuals flipping and rolling down a steep forty-five degree gradient hill faster and faster until they reached the treeline. A man was killed after striking a tree and the woman was seriously injured. Life Flight responded, were able to locate the crash site from the air, then called in help from the National Guard, who were out on a training exercise at the time.

A Blackhawk and a smaller helicopter navigated to get down to the couple. The woman had been trapped within the ATV and was extricated, which took approximately three hours. She had multiple injuries, including a broken femur, and head and back injuries; however, she was awake and responsive. She was eventually raised up in a Stokes Litter basket, into the smaller of the two helicopters. The deceased male was taken out by the Blackhawk in a body bag, loaded on Placerville's new Billy Goat all-terrain vehicle, to be transported out of the area to an awaiting Boise County Coroner.

It was said that the couple had fallen behind from the group and were hurrying to catch up.

There were about twenty people in the group, part of a riding club who came up for the day to travel the backcountry of Boise County near Hawley Mountain Road, on Forest Service Road 374K, and up to the summit.

At the time of publication, Boise County Coroner Pam Garlock had not yet released the name of the deceased male victim in this accident.



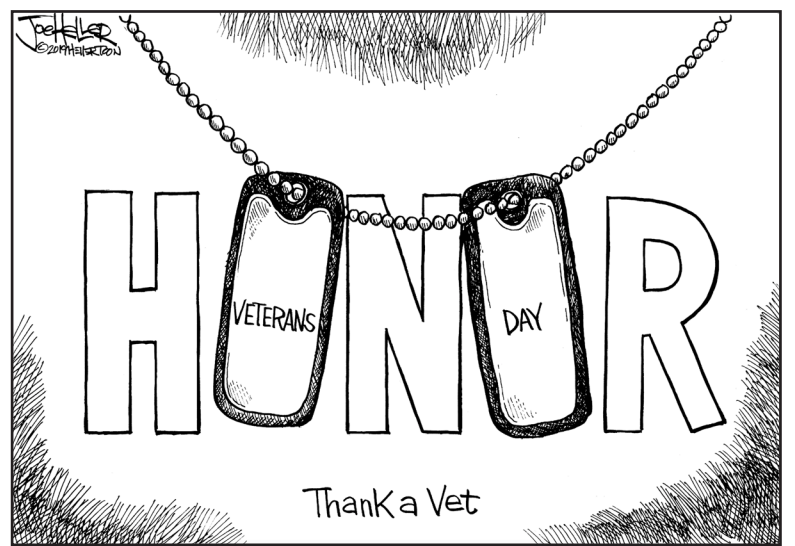
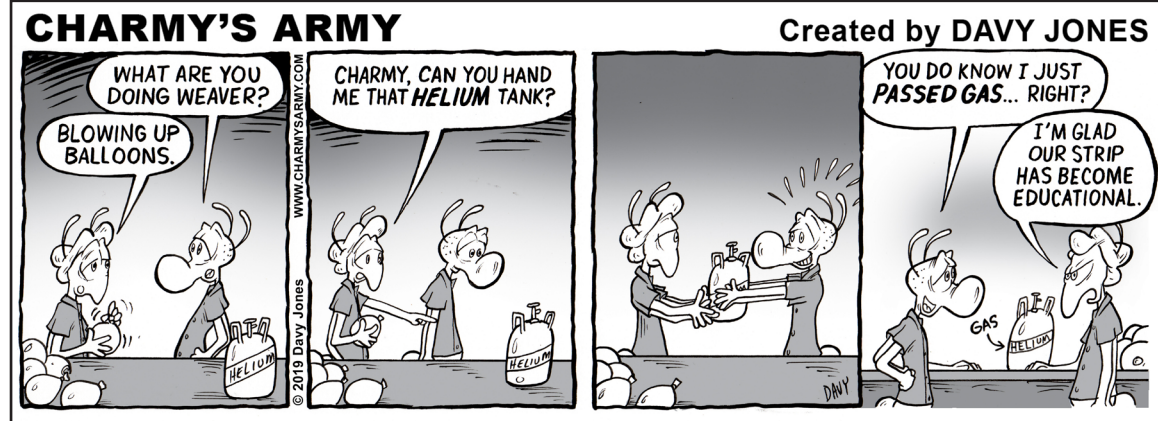

**Present:** Commissioners Alan Ward, Ryan Stirm and Roger Jackson

**Pledge of Allegiance**

**EXECUTIVE SESSION:**  
[Time 9:02am to 9:25am]  
Closed session per pending litigation, personnel, exempt records, hiring of an employee and risk management. Chairman Ward said, "No action required."

**CONSTITUENT INPUT:**

Jane Black with the census bureau spoke with the commissioners regarding the importance of having a complete count for the census. "For every Idahoan that we count, it's \$1,473 that comes into the state. We had an undercount in 2010 of about 360,000, so the state lost about \$560 million dollars, not having everyone counted... Idaho is the fastest growing state in the nation with a 2.1% growth rate. If we can get all Idahoans counted, then there's a possibility of getting an additional House of Representative." In 2010, California lost a representative, but Texas gained four with a full count. "We have an exciting way of responding to the census this year. In 2020, you'll get a post card in March that will have an internet address and an 800 phone number. You'll also have a unique code that relates directly to your residence address. On March 23<sup>rd</sup>, you can logon to the internet site, enter in the code on your card, and your ten question census form will come up. So, you can respond over the internet. If you don't have a computer, you don't have internet access, you

can dial an 800 number, again, put your code in and answer the ten questions."

Regarding confidentiality, Black said: "When you put your name and the members of your household on the form, and you submit the form, your name and anyone's name on the form is actually redacted, or blacked out for 72 years. So, your name will not be associated with the data that you provided until 2092. And we are bound by law, Title 26 - Title 13 of the Constitution, not to let that information get out. So, we don't share with the INS, we don't share with the IRS, we don't share with law enforcement. We have been subpoenaed to provide data and we just don't do it."

Black stressed the importance of the census: "In 2016, Idaho got \$3.6 billion dollars in federal monies out of the pie that's allocated for states based on the census counts." She said it include money for roads, fire protection, "and it impacts every community in the state and every citizen in the state."

They are looking to hire individuals, wanting 7,000 applicants throughout the state of Idaho. Sue, a local census recruiter from Garden Valley, said they are looking to hire a hundred-plus census workers in Boise County. "We really want local representation, because your local people understand where your people are at, as well as, there's a comradery there that works a lot better than if we send in employees from Ada County... They're great jobs, they pay \$13.50 to \$15 an hour. They are flexible."

Hiring will begin in December, and the jobs will likely go thru the end of July. The census will be complete by September. Sue added that the job is very flexible to work nights and weekends, "It is between 25 and 40 hours a week and 58-cents a mile with your car." An individual must be 18 years or older, a U.S. citizen, driver's license, email address, and there will be a background check. Flyers are posted around the county.

Clerk Mary Prisco said there was revenue that came into the county based on a component of population, allocated to the county with a formula based on population, beyond the federal piece. For example: sales tax, net distributions, and grant money.

**MINUTES:** Commissioner Jackson made a motion to accept the amended October 22 minutes.

**COMPUTER ARTS:** Treasurer Gina Turner said she does not have the full use of her programs, because the fix that the computer software company provided last year was wrong. There are continuing issues that prevent county work from being done. The computer Information & Technology [IT] gentleman hired by the county says there are some things he cannot do, and that it is their software which is old. There are no alternatives for counties of this size, and other counties in Idaho dependent on Computer Arts are also frustrated. He suggested banding together with other counties, and pursuing legal action. There is an end date of Windows 7 in Janu-

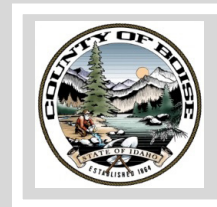

ary 2020, about which Clerk Mary Prisco was concerned. The IT employee stated: "I've already started upgrading to Windows 10; we're on pace for it. Computer Arts, not so much." He added, "The check those people every year is a good-sized check and you are not getting anything." There are other companies, but not in the state of Idaho. Clerk Prisco said that Computer Arts

is tailored to Idaho-specific laws and statutes. Prosecutor Adam Strong commented that the Idaho Controller's office just spent \$8 million dollars designing their own software system. Ada County is updating their software, but not willing to share. Clerk Prisco and Treasurer Turner will look into which counties are contracted with Computer Arts to create some leverage.
