# **Steamboat Gulch Sledding Hill Closes for the Winter**



Idaho's Oldest Newspaper Established 1863

EAST BOISE COUNTY -- The historic and popular Steamboat Gulch sledding hill, located one mile north of Idaho City, will not have open access to the public this year. A sturdy gate across the road, fence cables at the base of the runs, and hay bales staggered on the hillside will be impeding recreation this winter. Last year, the Mores Creek Recreational Foundation (MCRF) lacked the funding and volunteer help to provide the amenities the public relied on, such as snow plowing, a dumpster, and porta-potties. Several trees were shot with ammunition to the point that they died and needed to be removed, trash was left for Idaho Department of Lands (IDL) to pick up, and the sledding runs were damaged by ATV vehicles during the summer months. The IDL expressed that they had put in extensive man hours restoring and maintaining the area.

Todd Wernex, OHV/Recreation Program Specialist for IDL, said MCRF had done a wonderful job, charging \$10 per car load. He expressed a hope that the local community would come together, volunteer, and manage the area during the winter months.

Without a winter operation, IDL decided to close the area due to safety and restoration efforts. It was explained that the gate across the road and cable fencing was intended to protect the area, which had required excessive money to fix. The land had been seeded to help with erosion, but recreationalists on ATVs went off trails and onto these snow hill runs, which caused erosion at great depths.

According to the MCRF

President CarrieAnne Kowalczyk-Gonzalez, there are requirements in order to open the sledding hill, including: funds for insurance, purchasing a land lease from IDL, arranging for dumpster services, port-apotties, and the largest expense: plowing the roads to maintain access. The group also had a difficult time finding a reliable volunteer to oversee the operations on the weekends.

According to IDL: "The sled hill is on endowment land owned by the public school beneficiary. This means the land and its uses are not taxpayer funded, and makes it different than public lands like those operated by the U.S. Forest Service. While IDL provides recreational opportunities when possible, its constitutional mandate is to manage the land in such a way as to secure the maximum long-term financial return to the beneficiary. Money to repair damaged land comes from funds that should be supporting K-12 education."



New signs, cable fencing, and haybales prevent the use of Steamboat Gulch sledding runs. The gate will be opened during the snow-free months, for camping and use of the several ATV trails.





# Idaho City Community Supports Young Artists

Written by Esther Emery IDAHO CITY -- At an awards assembly last month, the Basin School Parent-Teacher Association (PTA) honored Idaho City's own exceptional young artists. Nine local students won prizes in the first round of this year's Reflections Art Contest, which is an annual, national event. "It was an absolute success," said PTA Treasurer Jennifer Olvera. "Our participants doubled in number from 2018, and the judges were amazing."

Olvera explained that a new after-school program known as "Art Week" contributed to the number of submissions. For one week in October, students received direct support in multiple artistic disciplines, including visual arts, dance, photography, and literature. Experts in each of these fields gave demonstrations and helped the students develop their own ideas. Idaho City community members made the program possible by supporting PTA fundraising events, especially BINGO nights at the community center.

"Art Week was made possible by PTA fundraising," said Olvera. "Kids who didn't have parent support were able to contribute projects. We are able to take part in this national contest because of our sponsors and the success of our fundraising." sors this contest in order to encourage creativity and learning in the arts, said contest committee head Sarah Nelson. The competition requires young artists to share their "reflection" on a given theme through their chosen artistic medium. Judges select winners based on creativity, originality, and relevance to the theme.

Twenty-two Basin students entered original art works this year, responding to the prompt, "Look within." Contest organizers at Basin School displayed the art in a conference room to create the feel of a professional art gallery. Photography, music, dance, and film entries were displayed on laptop computers. Teachers brought their classes through the gallery and allowed them to vote for a "student's choice" award. The rest of the winners were determined by a team of qualified judges.

In the primary age group, first graders Minette Olvera, Cabela Steel, and Sadie Fouch took the prizes for visual art, dance choreography, and film, respectively. In the intermediate age group, third grader Iris Olvera won in literature, fourth grader Rainy Adams won in music composition, fifth grader Stella Fouch won in film, and fifth grader Sean Rousset won in visual art. Two talented middle schoolers took prizes as well: Elizabeth Gibbons in visual art and Peyton Withey

in photography. Sixth grader Kennedy Smith earned the student's choice award.

The winners received gift bags containing art supplies and \$10 cash prizes. "It was exciting," said fourth grade winner Rainy Adams. Nelson said she hopes participation will continue to grow next year.

The nine winning art works now advance to the regional level of competition, with the opportunity to advance to state and finally to nationals. "National PTA will notify us in January if we have any winners from our school district," said Olvera. "We are eagerly waiting to hear if any of the entries we submitted win Regionals and go on to State."

# Idaho STEM Action Center Awards Basin Elementary

**IDAHO CITY** -- The Idaho STEM Action Center has awarded 72 grants to schools, districts, libraries, and out-ofschool and youth-enrichment

puter-science programs that are hands-on or project-based. The grant dollars will fulfill everything from 3D-printing initiatives, robotics and drone The foundation is accepting donations, and to date it has received nearly \$1 million through grants, gifts, and sponsorships. In total, the STEM



programs statewide to advance science, technology, engineering, and math education. The Basin School District in Idaho City was one of those recipients, earning a \$2,500 PK-12 Innovative STEM Project Grant.

The organization, part of the Executive Office of the Governor, awarded a total of \$133,324.66 via two grant programs: 45 PK-12 Innovative STEM Project Grants worth \$106,727.70 and 27 Family & Career STEM Awareness Event Grants representing \$26,596.96.

The PK-12 Innovative STEM Project Grants will fund creative science, technology, engineering, mathematics, and comprograms, and coding instruction to acoustics, aeronautics, astronomy, aquaculture, biochemistry, biotechnology, electronics, and e-textiles projects. Applicants could request up to \$2,500.

STEM Action Center executive director Dr. Angela Hemingway said. "It's a competitive process and we had to decline 36 requests -- one out of three applicants. Her agency created the nonprofit Idaho STEM Action Center Foundation two years ago to offer organizations and individuals a way to make tax-deductible donations to the STEM Action Center and enhance the investment the state has made in Idaho's STEM community. Action Center has raised more than \$3.25 million from third parties to enhance its efforts to support STEM opportunities statewide.

Hemingway said there were more than 8,800 unfilled STEM jobs in Idaho in October and that all of Idaho's top-10 hot jobs require STEM skills: Registered nurses, physicians, software developers, information security analysts, computer support specialists, network systems managers, industrial engineers, computer systems analysts, and Web developers. The Idaho Department of Labor predicts upwards of 100,000 STEM jobs will exist in Idaho by 2024. Dr. Hemingway said these jobs represent

### **December 3, 2019**

**Present:** Commissioners Alan Ward, Roger Jackson, and Ryan Stirm

AMENDEDAGENDA:Snow removal bids reviewedfor the Idaho City buildings.

### Pledge of Allegiance

**EXECUTIVE SESSION:** Per personnel and risk management. [9:05 am to 9:15 am] Coming back into session, Commissioner Ward said no action required.

**MINUTES:** None, technical difficulties.

**TIRES:** Emergency Manager Bob Showalter discussed snow tires and what falls within the parameters of the budget. Commissioner Jackson stated that the wider the tires, the worse the traction.

**EMT CLASS:** Showalter will take the class to back up the other two fulltime EMTs. He said the class is only \$150 for those committing to East Boise County Ambulance for two years, but it's \$600 otherwise. Commissioner Jackson said they could use all the help they could get.

**FREQUENCIES** FOR SCHOOLS: There are two repeaters being made available by Homeland Security at no cost for the Garden Valley and Idaho City schools. Sheriff Jim Kaczmarek said they are purchasing the frequencies for them, "What that does is it allows for any major incident at those schools, now we are now no longer relying on spotty radio connections to have everybody responding to that incident. That's fire, ambulance, or law enforcement." There was not a third repeater available for Horseshoe Bend, "which is less of an issue there because of the cell coverage we have

the address doesn't work on the house, they are supposed to post it on a post at the road. I'm not sure how many residents know that." He said what he would like to do is use FEMA money to purchase numbers, free to the public. "I think it's a worthy cause." These would be green reflective numbers for existing structures. Commissioner Jackson thought it was a good idea, and motioned to purchase reflective numbers for addressing in the amount of \$5,200.

**IDAHO CITY SNOW GROOMER:** Commissioner Ward made a motion to approve a snow groomer.

ACCIDENT HWY 55: Sheriff Kaczmarek stated: "One of our deputies was struck while parked on Highway 55 on the weekend. He was there in regards to a motor vehicle accident and was parked in his patrol vehicle off of the highway, and an intoxicated driver came around, lost control and struck the parked patrol vehicle. He was subsequently arrested for DUI. No one was injured, so we submitted the claim. That is the second time that particular deputy has been hit, to none of his fault." Chairman Ward joked about putting guardrail around his patrol car. The Sheriff responded, "We're thinking about a bumper car or a dump truck."

**HEATING:** The heating and control board is not working in the Sheriff's Office.

**PILOT:** There are two licensed pilots in the Sheriff's Office. They discussed the use of drones for Search and Rescue efforts. Sheriff Kaczmarek stated that they could also use it for law enforcement and tactical things, "but I have a pretty

6-inches deep. Sheriff Kaczmarek said that wouldn't work for the Sheriff's Office parking lot, "It's a hole, so you drive in, get stuck, and can't get out." He recommended 4-inches. **EXECUTIVE SESSION:** [10:10 am to 10:31 am] Exempt records were reviewed in closed session. Chairman Ward motioned to sign the liens and to approve the non-medical request.

**VOTING:** Clerk Prisco asked that she and two of her employees go to training for the new voting software, so they will be ready for the Presidential election. She asked that the commissioners have their meeting on January 6<sup>th</sup>, Monday, rather on Tuesday, so that they can attend the meeting.

Clerk Prisco recalled that the commissioners, years ago, had an application in for the repair, but then pulled the application. She stated: "The Road and Bridge funding, their operations funding, still is at risk. Really, nothing has changed. We have no long-term security... The funding for the Road and Bridge, I would think that most of it, if not all of it, has been towards capital, but it has come from the General Fund. Not from the Road and Bridge Fund itself." She addressed social media and property taxes. Since she was elected in 2011, "I think there have been three different years, maybe four, that we did take a small amount of our total property tax dollars and under a very specific statute allocated that to Capital Projects for Road and Bridge. The only reason why we did that was we were in a situation where we had maxed out on what we could levy within other funds. We don't on a regular basis, or standard procedure, levy property tax dollars for the Road and Bridge fund."

**SRS FUNDING:** Commissioner Jackson asked if there was any word on the Secure Rural Schools Funding, and Chairman Ward answered in the negative. Jackson went on to say, "Well, I had a gentleman tell me that he didn't think we were going to get it this coming year, which would really put us
