GARDEN VALLEY --

Future City starts with a question—how can we make the world a better place? To answer it, 6th, 7th, and 8th grade students imagine, research, design, and build cities of the future that showcase their solution to a citywide sustainability issue. Past topics include; storm-water management, urban agriculture, public spaces, and green energy. The 2019-2020 theme is Clean Water: Tap Into Tomorrow. Teams will choose a threat to their city's water supply and design a resilient system to maintain a reliable supply of clean drinking wa-

ter.

Participants complete five deliverables: a virtual city design (using SimCity); a 1,500-word city essay; a scale model built from recycled materials; a project plan, and a presentation to judges at the Regional Competitions in January. Regional winners represent their region at the Finals in Washington, DC in February. This was the 16th Idaho Region competition and 27th nationally. Future City started in 1992-1993 in just five cities and with 200 students. Today, 45,000 students around the globe learn how engineers make the world a better place.

Mentor Meghann Donley wrote:

“The Future City program is near and dear to me since I helped start the Idaho Future City Region back in 2002. I was at the very first planning meeting and held the first competition in January of 2004. I served as the Judging Coordinator for 10 years. When I moved to Garden Valley, I passed the torch over to Mariah Fowler who has been an amazing replacement. I then took on the next challenge to create a team in Garden Valley with the help of Mr. Phil Arnold, the Gifted and Talented Advisor, and started an extracurricular

Another Safety Tip for Seniors:

While life in the mountains is beautiful, serene and peaceful, the frequency of power outages is familiar to us all. Idaho Power does get us up and running again relatively quickly, especially given how far they must sometimes travel to repair the source of the outage.

Meanwhile, most of us have become quite happy with our cordless and/or Smart phones. But the cordless phone will not work in an outage because its base is powered by electricity.

Smart phones may work for a period of time if equipped with a battery back-up system.

If you enjoy the security of being able to have phone service during a power outage, you might consider having at least one corded phone in your home. Yep, I said corded. That's the old school phone that tethers you to its one location. The advantage is that it will continue to function in a power outage as it works through virtue of simply being connected to the phone line. It isn't magic. You will have telephone service in an emer-

gency and it will also provide your exact location while mobile devices can only provide a general area. Of course, you will not be able to speak to those who only have cordless phones as those will not be functioning.

Google this topic and think about going old-school by having at least one corded phone in home. If you have one of the 18-foot cord extenders, don't trip over it. Nothing is perfect, but added security through a relatively inexpensive device could be priceless!

Garden Valley School Board's First Meeting of 2020

GARDEN VALLEY -- The Garden Valley School Board held its first meeting of 2020 on Tuesday, January 21st, at the Garden Valley School building. Present were Vickie Chandler - Superintendent, Morris Morgan - Treasurer, Alan Ward - school board member, Alicia Hunt - school board member, Edie Nelson - school board member, and the GVSD attorney, Steve Meade.

The meeting started with a roll call and the Pledge of Allegiance. Mr. Ward has stepped down as chairman. Skye Davis was not present due to a conflict, but expressed in a letter his desire to be considered for Board Chairman.

Steve Mead resigned as the Garden Valley School Board Attorney, citing the fact that his practice has become much busier and he no longer has the time to go to out-of-town meetings.

Student testing results, specifically Lexile Trend reports, were presented and discussed. Results reflected positively for

Garden Valley students.

A hand-out regarding community relations was distributed. It contained a notice to the public stating the reasons and purposes for executive sessions. Basically, it reiterates the need for sensitivity in handling personnel matters, or possible student family matters. The law also provides a policy regarding the participation of the public in their meetings. Total time allowed for all comments from the public is limited to one hour. The chairman of the board has authority to interrupt or terminate any comment that is profane, irrelevant, or inappropriate.

The board had several routine items of business to consider. Two new board members, Morris Morgan and Alicia Hunt, were sworn in as members of the board. Then several matters of procedure and policy were discussed.

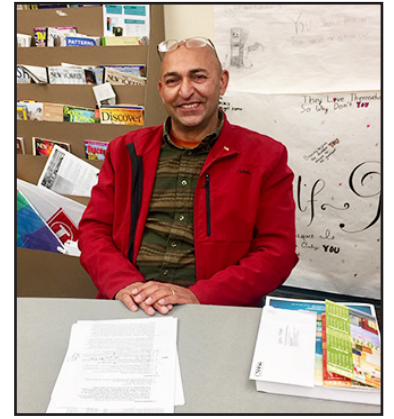
The new Board Meeting schedule was established to be held on the second Tuesday of each month at 6:00 PM.



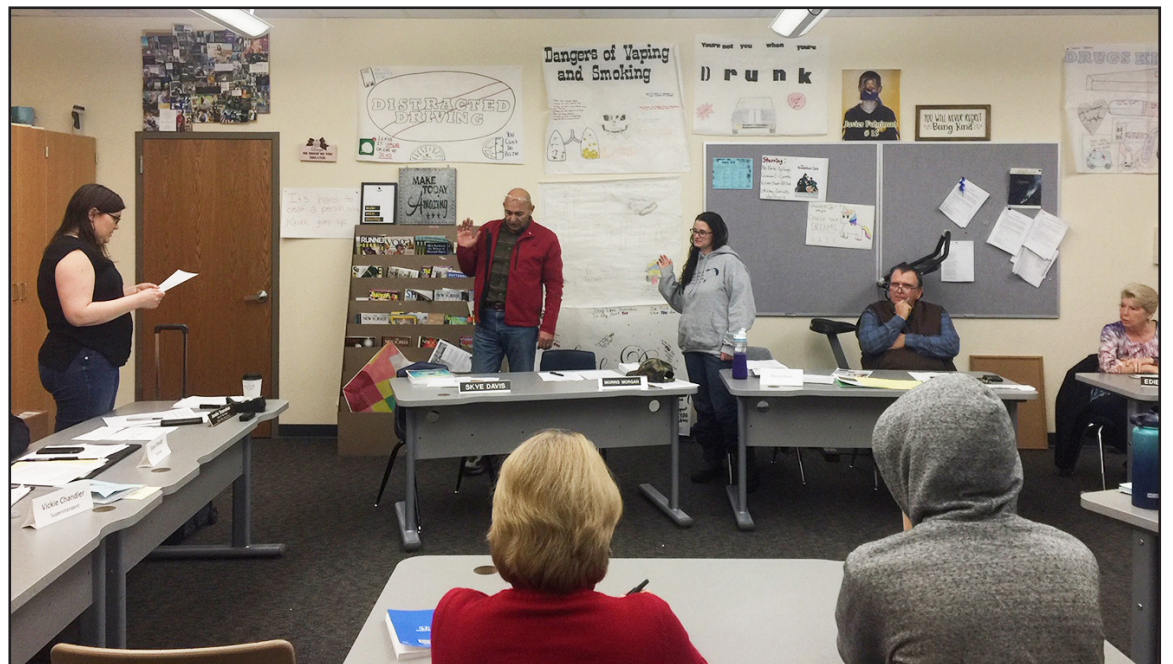

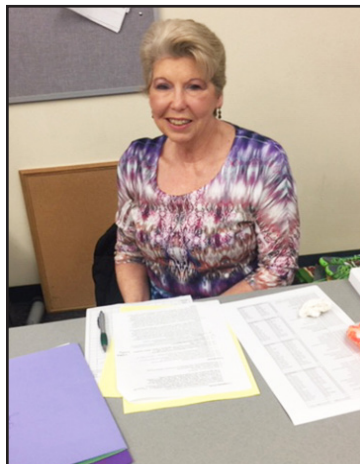



January 21, 2020

Present: Commissioner Alan Ward, Roger Jackson and Ryan Stirm

EXECUTIVE SESSION: Closed session per exempt records. [Time 9:02am to 9:05am] No action required.

EXECUTIVE SESSION: Per personnel. [Time 9:05am to 9:32am] No action required.

CONSTITUENT INPUT: None

MINUTES: The January 14th meeting minutes were motioned and approved.

DEPARTMENTAL ISSUES:

COURTHOUSE HANDICAP RAMP: It was said that it is moving and Clerk Mary

Prisco suggested demolition of the ramp. The Juvenile Justice representative described it saying, "Right now, it's kind of an Evel Knievel ramp. It goes *and it drops*, so it's not really wheelchair sensible." Commissioner Jackson spoke about fixing it. The Clerk said there is another access which is closer to the front doors of the courthouse. She said there is caution tape around it now, because they didn't want the public using it. Jackson said it's part of a historical building and it's been there as long as he has. The issue will be tabled and the commissioners will have a look at it during the break.

SHERIFF'S OFFICE:

They will have radio and fiber internet to create a redundancy and have better internet connection. Sheriff Kaczmarek said strengthen the internet was in the budget for \$239 a month.

IDAHO CITY CHILI COOKOFF: They were asked for sponsorship for the Chamber of Commerce. Chairman Ward asked about past sponsorships. Clerk Prisco said that the county is part of the Idaho City of Commerce. Commissioner Jackson asked about

a particular county fund, and Clerk Prisco said they had an unallocated fund that they had not used yet. The Board agreed to help with \$100 for the chili cookoff.

SHERIFF: Kaczmarek said they had the inmates up to clear off the snow on the roof of their building, Planning & Zoning, courthouse, and school. He said it worked very well.

SNOW GROOMER SHED: A representative said that besides an inspection, the

shed is complete.

MARCH ELECTION: The Board approved the annual four polling election facilities: Centerville Fire Station, the Mutual Improvement Ladies Auxiliary Club in Horseshoe Bend, the Garden Valley School in Garden Valley and the Lowman Emergency Station.

EMERGENCY DECLARATION: The declaration document was discussed, but Emergency Manager Showalter was not present.

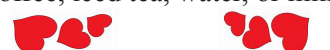

House Fire Ignites Near Idaho City Without Occupants

IDAHO CITY -- A three-story log home caught fire on Monday. To the Idaho State Fire Marshal, the fire appeared to be the result of a portal kerosene heater, which had inadvertently been left on in the garage. There was no telling how long the flammable cardboard material had smoldered near it, but State Fire Marshal Knute Sandahl said it had been many, many hours.

The couple, with their two small children and three dogs, had been away visiting out-of-state when the accident occurred. The sight of rising smoke was identified and called in by the next door neighbor at about 8:30 am on January 27th.

When Fire Marshal Sandahl arrived, he commented that he

had expected to see something "short and black." However, he says that despite the holes in the second and third floors, it appears that the house was repairable.

One neighbor was impressed by the volunteer firefighters and recounted how these "young bucks" went blazing into the house with their water hoses. Then, *with a sigh of relief*, white smoke appeared, which meant they were putting the fire out.

After the danger had passed and the house cooled, this reporter informed the "young bucks" of what neighbors had witnessed. The three could not conceal their, *Yeah, I came and conquered*, smiles. Jason Rowe, of the over-fourty club, commented with a lingering

smile, "I'll take it!"

Sandahl said kudos to all the volunteer firefighters, complementing their training and their mutual aid understanding. There were three fire departments that responded, including Idaho City, Wilderness Ranch, and Thorn Creek. It was estimated that 5,000 gallons of water were used to extinguish the fire.

Ruck For The Fallen Begins Traveling Flag Honoring Fallen Firefighter Here in Idaho.

BOISE COUNTY -- Ruck for the Fallen is a Nonprofit 501c3 that is dedicated to supporting our lost heroes both military and first responders. It was founded by Master Sergeant Mitch Kriebel, a Moscow, Idaho native, and current military member. Kriebel attended the University of Montana on a football scholarship before joining the military in 2004. He has since served two year-long tours in Iraq and a year-long tour in Afghanistan. Ruck for the Fallen puts on Ruck events, where individuals carry a weighted pack, or Ruck, and march in honor of our fallen heroes to honor and raise awareness of suicide in our military and first responders. "Our community of Ruckers raises funds by participating in ruck challenges/races or local events sponsored by a military unit. All donations raised are used for the well-being of our hero's livelihood." The first Ruck For The Fallen event was held in Oakesdale, Washington in November of 2019. "We believe that carrying the burden of loss in our rucksacks to be an Honor, it's with pride we fully accept this task," says MSG Kriebel.

for the Fallen does to honor the fallen. Flags are sent out across the country to honor fallen firefighters, police officers, and military members, they're signed and sent on to the next station or base. The flag is then presented to the family, along with patches that each station or base has sent along with the flag. One such flag has begun its journey here in Boise County, starting with the Boise County Fire Chiefs' meeting.

Jennifer Severns, a former Idaho City High student, athlete and area resident, began volunteering with Ruck for the Fallen several months ago and has offered to help another firefighter from the Darby Fire Department in New Jersey, Aubrey Lehman kick-start this flag's endeavor. She will help the Honor Flag for Fire Engineer Brent Cuba of Plano, Texas start its journey by meeting with the Boise County Fire Chiefs, speaking about Ruck For The Fallen, and having the flag signed. From there, she'll continue to meet with Fire Stations around the Treasure Valley, then the flag will make its journey east across the United States. Jennifer keeps updated maps for each Honor Flag on Ruck for the Fallen's Facebook page and will soon all be on the website. You can follow this flag and any flags path as they travel across the country. As the flags

travel, they are handed off from officer to officer, or firefighter to firefighter, and ride in the front seat to honor their fallen brother so that their dignity and honor is upheld. "It's not about personal recognition, but our ability to HONOR those who have willfully placed themselves in harm's way

or sacrificed their lives for everyone's freedoms and way of life," says MSG Kriebel.

Jennifer plans on bringing a Ruck event to the Treasure Valley this year and is hoping that this will be the first of many to come. With our local military bases, city and rural volunteer fire departments, police and EMS, she believes that they need to be honored and our Idaho fallen need to be recognized. The times and dates have not been set in stone as of yet, but the Ruck is in the works. "Ruck for the Fallen will stay true to our pledge by never stopping until all heroes and their families are wholeheartedly supported," continues MSG Kriebel.

Ruck for the Fallen is hoping to continue to bring more programs to their organization, such as, services to aid individuals with PTSD

and suicide prevention. A call center for military and first responders who are in crisis to call and speak to someone who is or has been in their line of duty. These programs cannot become a reality without donations and sponsors, however. "The pain we feel in our shoulders holds no bearing on the pride and commitment we carry in our hearts. DEEDS NOT WORDS." ~ MSG Mitch Kriebel
