There will be more contestants this year, as well as non-competing pots of chili, that won't be opened up until around 1:00 pm, when some contestants start to run low. HORSESHOE BEND -- The Horseshoe Bend Middle School "A" team faced off against the Garden Valley Wolverines at home on Tuesday, January 28. The teams were pretty evenly matched during the first half with the Mustangs taking the first quarter 17-11 before increasing their lead by 10 points, 26-16 at the half. The second half was all Horseshoe Bend who ended the third quarter in the lead 36-19 and finished strong with a 46-26 win. 8th grader Porter Larson had 16 total points (5 field goals, 6 free throws), 8th grader Layth Bromgard had 12 total points (6 field goals), 8th grader Kaelun Jones had 9 points (8 field goals, 1 free throw), 8th grader Nic Cooper had 7 points (6 field goals, 1 free throw) and 8th grader Carson Drake had 1 field goal. The Mustangs traveled to Meridian on Thursday, January 30 where they took the win 45-21 against the Compass Aviators. Horseshoe Bend is at home on Friday, February 7 where they will take on McCall (tip-off is 2:00 p.m.), in Boise on Tuesday, February 11 where they face off against the Riverstone Otters (tip off 3:45 p.m.) and they'll be in Garden Valley for a final regular season matchup against the Wolverines (Feb. 12 with tip-off at 4:15 p.m.).

The Horseshoe Bend Varsity Mustangs fell to the Cascade Ramblers during home play on Thursday, January 30. Behind by 5 points, 4-9, in the first quarter the team remained behind throughout the remainder of the half and headed to the locker room down 16-25. Showing signs of revival in the third quarter, the Mustangs pulled within 8 point to close the period down 33-41, but they couldn't pull ahead and took the Long Pin Conference play game loss, 50-59. Junior Logan Bromgard (one 3 point

field goal, six field goals, and three free throws) and sophomore Decker Larson (eight field goals and two free throws) were the high scorers with 18 points each. Senior Austin Fry had 7 points (three field goals and one free throw), and junior Hunter Howerton had one 3 point field goal in the third quarter before fouling out in the fourth, senior Calvin Drake and junior Caedmon Graham each had one field goal. BOISE COUNTY -- In an effort to encourage voter participation, we will have two locations open on the west side of Boise County with election information and forms, on **Tuesday, February 11th, 2020.**

Our election teams will have Absentee Voter Application forms available for individuals wishing to absentee vote in the 2020 election year. Our team members can assist in answering questions regarding the completion of the form. Completed applications must be received in the Clerk's Office no later than February 28, 2020, for the March 10, 2020 election. Absentee voting applications are required to be completed annually for those wishing to vote absentee in any or all of the four calendar year election dates. Applications can be mailed to the Clerk's Office at 420 Main St., Idaho City, ID 83631, sent via email to vdresslar@co.boise.id.us, or faxed to 208-392-4473.

For those who are not yet registered to vote, we encourage you to use the Secretary of State's online voter registration at <https://apps.idahovotes.gov/OnlineVoterRegistration/>. We will also have voter registration cards available at both west side locations. If you plan on completing a voter registration card onsite, please remember to bring an Idaho State issued driver's license (with current physical address) or another form of picture identification **and** any document containing a valid residence address within the precinct. The registration deadline, for the March 10th election, is **February 14, 2020.** Voter registration is also available on the day of the election.

Present: Commissioner Alan Ward, Roger Jackson, and Ryan Stirm

Pledge of Allegiance

EXECUTIVE SESSION: Closed session per personnel issues. [Time 9:05 am to 9:33 am] No action required.

CONSTITUENT INPUT: None

MINUTES: The January 21st meeting minutes were accepted.

JOB DISCRPTION: The Juvenile Justice Department submitted a job description for Board approval for the building/ grounds maintenance position.

VOTING: Clerk Mary Prisco stated regarding the March election: "For a number of reasons, we are not going to be able to do an actual in-person poll location in either Garden Valley or Horseshoe Bend. It has to do with the system. It has to do with security. It has to do with a lot of different things." She indicated, "As a second option, what we're going to do is determine a date and time, and possibly more than one day in Horseshoe Bend, I think it will just be one day for Garden Val-

ley, where we notify the public that we'll have personnel at a certain location, certain time, and they will have the information for the registration cards and the absentee voting application, as well as the people there to answer questions. *It's a lot more complicated than it has been in the past.*" This will help people on the west side of the county avoid long lines at the polls.

REFLECTIVE NUMBERS: Offering reflective numbers on homes for free was discussed, because it was a concern to firefighters in Horseshoe Bend. Planning & Zoning in Idaho City would distribute the numbers with verification of an address. City Clerks in Horseshoe Bend and Crouch would follow P&Z instructions and also distribute. The Board made a motion to the Emergency Manager Showalter to purchase 4,000 decals in the amount of \$7,188.

FORESTER: A request for the purchase of a vehicle was discussed. Auctioning off the old truck is being considered.

SOLID WASTE IN HORSESHOE BEND: A document was discussed for

approval, which will be advertised in *The Idaho World*, regarding Miller Enterprises.

COUNTY SERVERS: Three prices were discussed, with a minimum of six drives and as many as twelve. There was talk of a bulk price of ten. A motion was said to approve a ten pack bid for hard drives, Dell 600GB, in the amount of \$1,150.

POLLING PLACE: Mores Creek voting precinct was approved at the Wilderness Ranch Fire Station for March 10, 2020. A supplemental levy will be on the March election for the Basin School District.

SHERIFF OFFICE: Jim Kaczmarek said, "With the snow coming back the way it is, *we couldn't even get the track ATV up the highway when they didn't get it plowed.*" He is submitting an application for a grant to purchase two snowmobiles. Chairman Ward asked what made them so expensive? The Sheriff replied they have the ability to get into powder, extended gas tanks, and extra tracks. There are already four experienced riders on the department in which their personal snowmobiles have been used in search and rescue. The quote includes open trailers.

Chairman Ward put forth a word of caution, "Prepare for some long cold nights." The Parks and Recreation grant was accepted by a motion in the amount of \$27,100.

CLAIMS: The claims approval report was paid in the amount of \$155,642.

HIGHWAY 21: A letter was composed to submit to the Idaho Transportation Department regarding concerns on Hwy 21 and maintenance. Commissioner Roger Jackson stated in the motion that it explains their concern for the condition of Highway 21, for both winter and summer.

HSB CITY COUNCIL

The following is a synopsis of the Horseshoe Bend City Council's 676th meeting on January 15, 2020. All council members were present. After the call to order, Pledge of Allegiance, the council's approval of the agenda, previous minutes, and the authorization to pay the city's bills, Council member Teresa Cooper questioned the forty dollar city park's electric bill but received no response. Mayor Pat Goff opened with public comments. Audience member Jon Dufresne wanted to know what the executive session on the agenda was for and city attorney Tony Pantera responded that it concerned potential litigation. Mike Fry approached the city and asked that the council put into the record that the annex map incorrectly shows a boundary for parcel 7 north, range 2, section 27. Mayor Goff agreed that it will be included on the agenda in February. New business on the agenda included swearing in newly elected councilmembers Ben Riley (incumbent), Martye White (previous appointee), and Stephen Chartier and city staff appointments were made (no changes from previous year).

Jeremy Piersol of RCAC World Assistance Corporation (RCAC is a nonprofit organi-

zation and advocacy group for rural communities) showed the council a Power Point presentation outlining a new rate structure for the city's sewer system. The rate structure recommended was for a flat rate that would assist the city in acquiring a debt reserve and emergency reserve that would be adjusted annually for inflation.

Kit Smith and George Dupont returned to discuss Watson Road. Dupont thanked the city for trimming trees that were encroaching upon the roadway but said that there were still issues, specifically regarding a city ordinance that states that "within 25' of an intersection a fence cannot be more than 3' in height. Dupont stated the fence erected by property owner Duane Brothers was in violation of the ordinance as it stands 6' tall at the N/W and S/W corners of Watson Road. Dupont suggested a prescriptive easement or an eminent domain takeover by the city to alleviate the problem. Councilmember White stated, "We've all discussed it, we're working on it." Mayor Goff said, "No sense in working hard to get it wrong." Councilmember Riley suggested a short term fix of erecting no parking signs or making the street one way. Pantera agreed that the sheriff could make either of those options happen. Councilmember

Corvinus suggested getting a surveyor to access the situation and Goff agreed. Riley concluded the discussion by saying, "Let's get it looked at and see what the sheriff wants to do about signage."


In the EMS update Goff stated that they would be trying to sell the equipment off, the extrication truck, on a government site.

Public works spokesperson, Michele Brothers told the council, "It's been a pretty slow month, we're just keeping things going." No news is good news was the report for the city engineer regarding the new well production.

Pantera had no report for the city.


The mayor's report included introducing the council to the city's new grant writer. Councilmember White objected, saying that it wasn't on the agenda. Goff said he was making it part of his report, but if the council preferred he would add it to the agenda next month. White replied that he "would prefer that." Mayor Goff presented exiting councilmember Cooper with a plaque commending her service to the city before the council adjourned at 8:03 pm to go into executive session.

The city meets next on Wednesday, February 19 at 7:00 p.m.

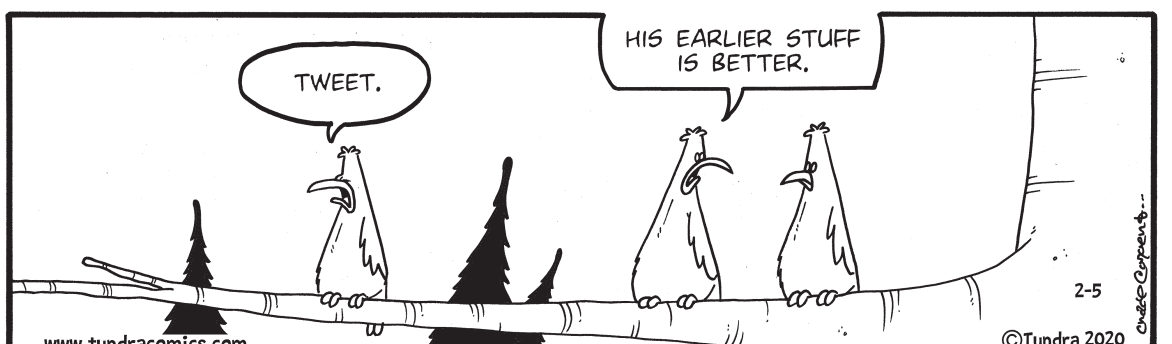

Basin Students "Go Higher" with Academic Achievement

What motivates Basin Elementary students to do their best work in the classroom? Answers vary, but many high-achieving students say they like being on the honor roll, which is an honor given at the end of each trimester to students with all A grades or all A's and B's.

Basin fifth grader Aliyah Stunja has received honors each trimester since the fourth grade, and she said the program helps her stay motivated. "Being on honor roll encourages me to keep on working harder and doing better," she said. "It makes me want to keep on doing what I'm doing."

Sixth graders Liz Turner and Kendall Exon are also motivated by the reward. Exon said she would like to encourage younger students by telling them how good it feels to be recognized. "The achievement you feel is so awesome," Exon said, with a grin.

Her friend Liz Turner agreed. "When you get called up for high honors," she said, "you feel so proud."

Other students agree, but some say the honor roll certificate gives them more than just a good feeling. Honor roll lists give families a marker to see that their students are working hard. Fifth grader Averie Pierce, classmate to Aliyah Stunja, put it bluntly. "My family likes it," Pierce said, "because they know I'm paying attention and not goofing off."

Stunja agreed. "It's important for my family that I'm working hard. They're proud of me and they can help me ac-

complish even more."

Beyond the thrill of the award and the expectations of their families, students are also motivated by thoughts of the future. Details of adult life may be hazy to elementary students, but many of them see a connection between earning good grades in school and having the life they want down the road. Fifth grader Taylor Vigeant said, "Having good grades helps me have more job opportunities. It gives me more opportunities for different things to succeed in when I'm older."

Aliyah Stunja sees her work in elementary as setting herself up for middle school and high school. She said, "If we start now, we can keep doing this and be more successful in the future."

Sixth graders Aiden Pilot and Brady DeWeese are hoping that turns out to be the case. Getting ready to move over to the middle school next year, these young men are already thinking about how they'll pay for college. "I'm afraid of college debt," said Pilot. DeWeese said he is motivated to excel in school because maybe with a scholarship, "You won't have to pay about a million bucks for school."

Down the hall in the fourth grade classroom, Cooper Smith and Jackson Roeber are also thinking about college. They both dream of playing college football, and they say that colleges are looking for smart kids.

"It affects your lifestyle and how you live," said Smith. "If

you have horrible grades you might be a dropout —

"And work at McDonald's," interrupted Roeber.

Smith went on, "Having good grades now helps your future. You can't just go to a college and not have good grades, like... "Hey, can I go here?" You have to have good grades to get what you want."

Basin college and career counselor Laura Carignan agrees with the fourth graders, up to a point. She said it isn't really true that failing to

make the honor roll is going to prevent a student from going to college. "A better way to say it," she clarified, "might be that good grades help a student get into the college that they choose."

Although it may not always be as simple as a perfect report card, Carignan does believe that Basin is nurturing a school culture that values academic achievement. Asked what advice she would give to any student, honor roll or otherwise, she said, "I would tell them to

take school seriously. Embrace their education and get the most out of it that they can."

As good as it may feel to be rewarded for accomplishment, Basin students aren't fooled into thinking that a spot on the honor roll means they're done with learning. Ten-year-old Jackson Roeber may have high honors today, but that doesn't mean he's sitting back. "There's always more than just an A+," Roeber said. "You can go higher."

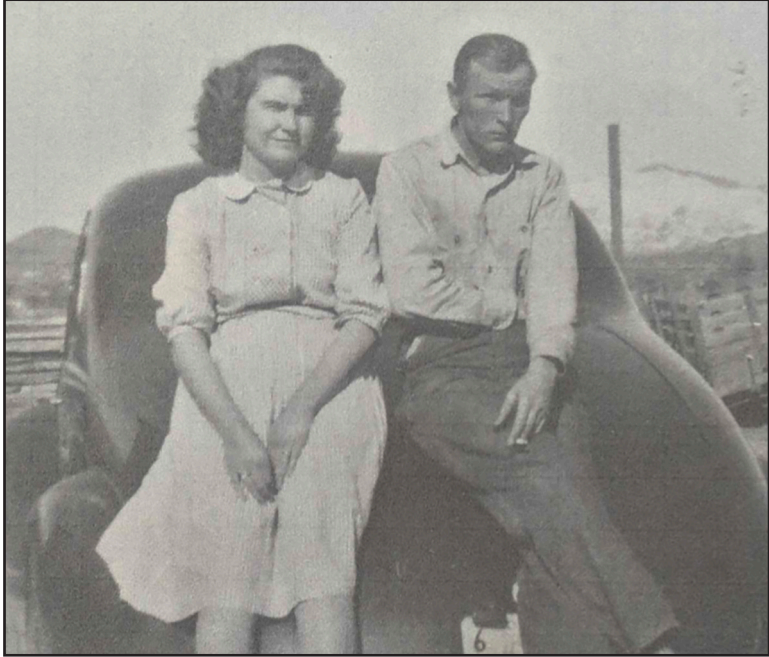

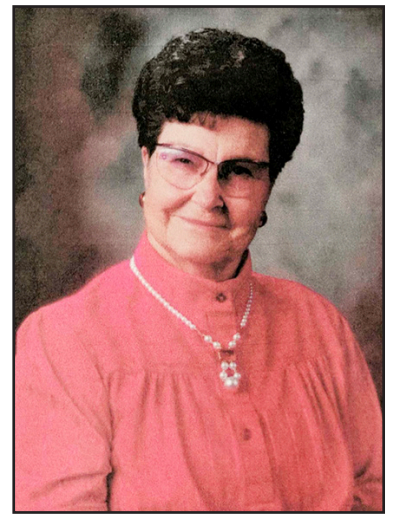
Happy 100th Birthday to Pauline Hull of Horseshoe Bend

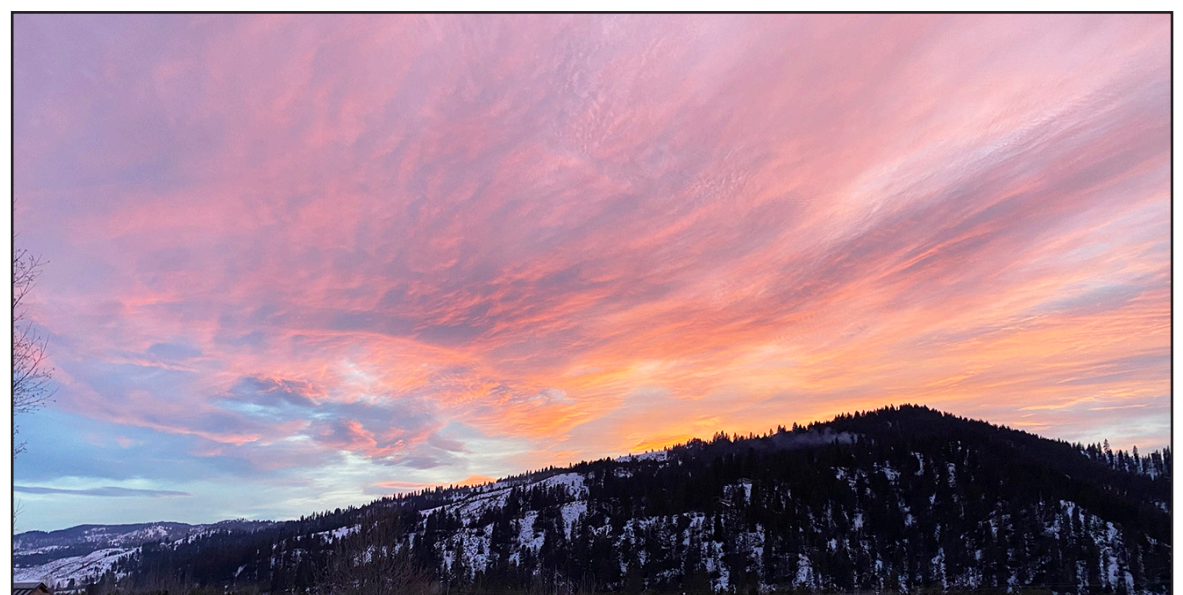

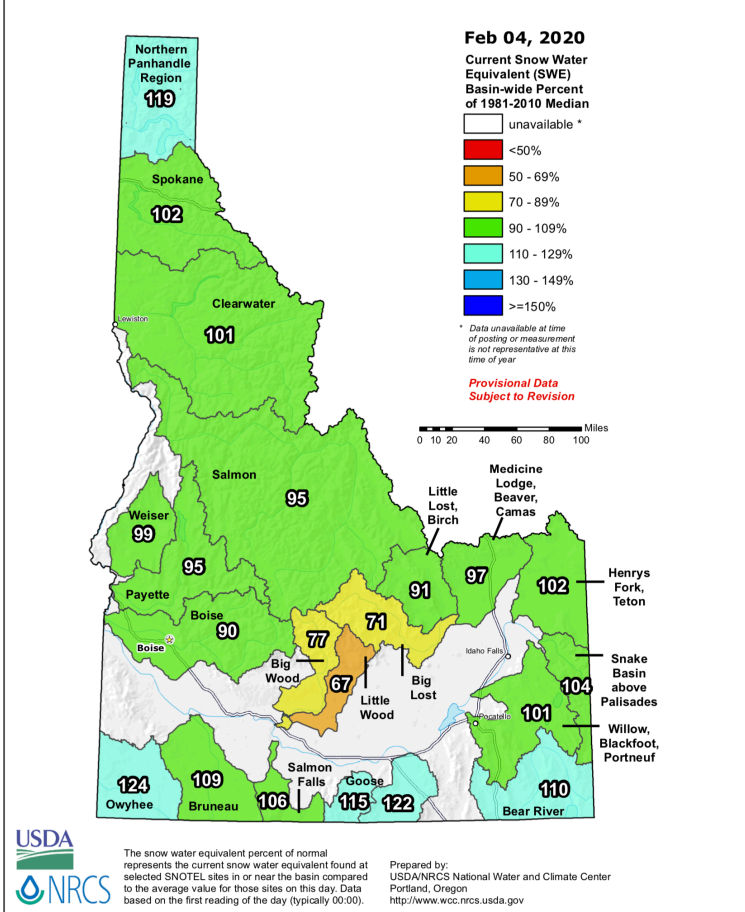
p.m.) and they'll be in Garden Valley for a final regular season matchup against the Wolverines (tip off 4:15 p.m.).
