Garden Valley Senior & Social Center News By Candis Donicht

We cannot turn on the news, check our media newsfeeds, or read the paper without receiving updates on the Coronavirus, COVID-19. I decided to do informal research while working at Granny's on Saturday to see how our locals and visitors are responding to the situation.

I asked our customers (most local, some visiting from the Treasure Valley) what, if anything, they were doing to prepare for the posibility of the virus coming to Idaho.

A majority of respondents reported that they weren't doing anything differently, with the exception of increasing hand washing. Other respondents spoke about keeping their hands away from their faces and using some sanitizer although soup and water would be the first defense. Another

local stated that he did not buy into the media hype, had lived a good life, and didn't worry if "his number came up." One aspiring comic responded that he liked his Corona with lime. Some people responded that they are stocking their pantries with canned goods, dry goods, and essential items that include toilet paper, soap and sanitizer.

While this approach to learning what the 25 people who came into Granny's are thinking was a good local sample, it surely isn't scientific research by any means. And you can see that the responses vary greatly.

One might come away with the message that Idahoans and Garden Valley residents do not panic but are instead self-reliant. There could be many reasons for that. We live

in a sparsely populated area, where as senior citizens, we do not have to be in the presence of large crowds unless we choose to be. We already stock our pantries to some degree. Neighbors help each other in the midst of any crisis. We take care of family and friends.

If individuals are interested in what precautions can be taken, I learned that we can easily make our own hand sanitizer with alcohol, aloe vera, and essential oils. Face masks can be made. Water can be purified. Winter wood can be brought in early. Most pantry supplies remain available. A logical proactive measure might be that we stock for ourselves and put aside some for our families, our neighbors and the food bank. That's truly the Garden Valley spirit.

The tournament continued on into Saturday, though Nate was no longer a participant. The winner of the State Tournament was Trent Meyers of New Plymouth Idaho.

Nate and his family stated that the tournament was a great experience and that they are grateful

that he had this opportunity. Nate will continue training and hopefully return next year! Nate and his family wish to thank Coach Kyle Johnshoy and Coach Castillo for all the training and time spent with Nate and the other Garden Valley Wrestlers. They also wished to thank fellow Garden Valley wrestler, Cole Winslow, who practiced with Nate in preparation for the state tournament, even though he didn't qualify for state himself.
