

# **Boise County Sheriff Kaczmarek Resigns from Office**



**Sheriff Jim Kaczmarek** 

**BOISE COUNTY --** Jim Kaczmarek announced his resignation on Tuesday morning, March 3rd, by submitting his two weeks' notice to the Board of Boise County Commissioners. He had been a write-in candidate for Sheriff in 2016 and won with an unprecedented majority of the votes. His 1.187 votes exceeded that of other candidates on the ballot. [The next candidate on the May 2016 ballot to win with the most votes was Alan Ward, who won in a landslide victory with 1,058 votes for Boise County Commissioner.]

Sheriff Kaczmarek mentioned to the Commissioners that he was encouraging his Chief Deputy, Steve Dorau, to put in to finish up the Sheriff's term through December 2020. "He does not want to be sheriff after this term." Sheriff Kaczmarek added, "And it might be good for everybody if the chief was appointed as an interim Sheriff. He knows the operation in and out, can handle that. And that doesn't put the Re-

publican Central Committee or you guys in any spot of playing favorites." Chairman Ward agreed by saying, "It makes good sense," and would contact the Boise County Republican Central Committee regarding the resignation.

On Tuesday afternnoon, Chief Deputy Dorau confirmed that he would offer to finish out the Sheriff's term of office.

Kaczmarek stated he had reached the goals that he set as Sheriff and looks forward to moving on with a new job he has lined up, starting on Monday, March 16th.








I have 5 children, aging from 7 to 16 years old, who attend the Basin School District. All 5 went to the Preschool and all plan to graduate from Idaho City High School. This school has provided many opportunities for my children, through academics and extracurriculars. Currently, my 3 oldest children are playing sports including volleyball, football, basketball and track and field through the school. I have greatly enjoyed watching my children grow up in this school along with going on field trips with them, watching them play sports and seeing the benefits of the various STEM activities, among many others. I send my children to this school every morning knowing their education has been put in good hands by the staff at the Basin School District and knowing they are safe. The recent installment of Officer Gomez and his knowledge of internet safety, especially, has made me proud that I chose this school.

Without the levy passing, however, many extracurriculars and certain benefits that my children enjoy will not be available. These

extracurriculars contribute to my children's education by providing them with stress-relief, physical activity and fun. There are other extracurriculars such as NHS (National Honors Society), Prime Time, and Club 116 that are also very beneficial to the students. However, especially in our highschool, we are somewhat lacking in clubs or other opportunities for students who do not want to participate in sports. Passing the levy could greatly help with providing these kinds of opportunities. 

# **Boise National Forest Annual Surplus Seedling Sale**



BOISE COUNTY -- Landowners who wish to purchase trees and shrubs to create windbreaks, improve wildlife habitat, and enhance their property are encouraged to come to the Lucky Peak Nursery's annual surplus seedling sale.

The sale begins Saturday, April 4, from 8 a.m. to 4 p.m. Seedlings will not be available Sunday. The sale continues through the end of April; Monday through Friday, 8 a.m. to 3 p.m. The price is \$30.00 for 50 seedlings. Fifty seedlings is the minimum quantity that can be purchased. A bundle of 50 seedlings will easily fit into a standard grocery bag. This year, limited quantities of ponderosa pine and Douglas-fir seedlings will be available on a first-come, first-served basis.

The Lucky Peak Nursery is a resource for the entire Intermountain West, producing over 3 million (1 and 2 year old)

trees and shrubs.

Seedlings produced at the nursery are used for restoration efforts on public lands disturbed by wildfire, timber sales, or other events. Some brush species produced sustain mule deer populations on their winter ranges.

When the nursery has produced more seedlings than its customers need, the surplus becomes available to the public. The seedlings are best suited

for land owners with property in rural areas. They are not intended for homeowners in urban areas to plant in their backyards. Written planting instructions and technical assistance will be available.

The Lucky Peak Nursery is located 16 miles northeast of Boise on Highway 21 (15169 E. Highway 21, Boise, ID 83716). For more information about the annual seedling sale call: (208) 343-1977.

Horseshoe Bend resident Danny McReynolds, age 51, lost his life on Friday, February 28 while walking on Highway 55 in Horseshoe Bend.
