GARDEN VALLEY -- Garden Valley School, much like many other local school districts, is delivering free meals to children and others that need it. They are delivering breakfast and lunch once a day Monday through Thursday (the days the school is normally open). A result of the coronavirus, all local schools including Garden Valley have transitioned to online schooling. It is a blessing that our schools and children are able to participate in this. The alternative consequence may have been for all the children to repeat the grade and/or not graduate on time. Therefore, it is good that this online schooling service is being provided. However, online education affects many in a myriad of ways and is a drastic change for the students. The food service that the schools are providing is, at face value, dispensing nutrition to the children and others who may need it, during a time that may be difficult to obtain food otherwise. But the program is also doing so much more. It is maintaining cohesion amungst school employees. It provides employees the opportunity to help the community and it keeps food service workers, bus drivers, janitors, and food delivery personnel working. For the students and other community members, the food service program provides a connection between the school and the children. The transition to online school for the children (and parents) can be very stressful. Their school days and structure of life have been up-ended. The daily bus offers them a schedule they can count on. Every day at the same time, the bus will be there. The food the children receive is, for the most part, the same that they have always had at school and thus gives them familiarity. However, possibly the most positive by-product (besides nutrition) of this food delivery program is the reassurance to the children, parents, and other

community members that the school is there for them. The school and the familiar smiling faces that greet them at the bus have not forgotten them in this time of upheaval. Thank you, Garden Valley School District, and all other school districts for being the glue that keeps our communities together.

Horseshoe Bend School District #73 - We began our Grab-And-Go meal services on March 30, free for all students, operating Mon-Fri. A combination breakfast and lunch meal is delivered by school bus to regular-route bus stops, and the meals are also available for pick-up at the school cafeteria Mon-Fri from 9-9:30am. We are also using the meal delivery by school bus to pick-up/ drop-off elementary homework packets, deliver Community School resources (Friday food packets for our Friday Back-Pack students, diapers, etc...), and our counselor is riding the bus in order to have brief interactions with students. trict? The students will continue online and/or using paper packet courses developed and presented by teachers until the end of the year or until public health and safety change the date of return. What does this mean for non-teaching staff Paraprofessionals members? are aiding teachers with phone calls, clerical work, and other support. Custodians and maintenance are working hard on cleaning, painting, repairing, and maintaining the building. Bus drivers are delivering food and conducting maintenance on the buses. Office personnel are working on communications with parents, as well as lots of projects the district never gets to, like electronically scanning and archiving thousands of documents. Internet access? Several families do not have Internet access at this time. The district is working with local companies and organizations to come up with solutions for those families so their students can work online instead of via paper packets.

Graduation? At this point we are following the guidelines of the CDC to determine the possibility of a graduation ceremony. As we approach May we will have a better idea of the COVID-19 status.

I served as a Deputy U.S. Marshal (District of Oregon, 1990-2009) and later a Special

Agent with the Office of the Inspector General (OIG), assigned to the Social Security Administration (SSA) in Oregon and Idaho (2009-2017).

The Idaho Secretary of State has determined that all voting in the spring primary election will be done by mail. There will be no local polling places for the primary election. This is an evolving process and is raising a lot of questions in the minds of voters. What I have presented below is my understanding of the process as of the Secretary of State's press conference on April 1, 2020. The process may change.

Step 1: Request an absentee ballot

To request an absentee ballot one option is to go on-line at the Secretary of State's website at https://idahovotes.gov/ vote-early-idaho/ and request your absentee ballot through the Secretary of State's online system. You will answer a few questions, request a ballot and review your voter registration information. If everything is correct, you can submit the request on-line and it will be sent to the Boise County Clerk's Office. To complete the on-line registration you will need to know the last 4 digits of your social security number and your Idaho driver's license number.

You will be given the choice of one of three ballots for the primary, Republican, Democrat, or Constitutional. The Democrat and Constitutional party primary elections are open to any registered voter in Idaho, even if unaffiliated with any party. To vote in the Republican Party primary you must have affiliated with the Republican Party by March 13, 2020.

After you submit the request the Boise County Clerk's Office will mail you the absentee

ballot for the party you requested.

Be aware, the volume of people trying to request the absentee ballot on-line often surpasses the system's ability to respond. You may have to try to log-on more than once. I will tell you my experience was that this was a VERY easy way to request the absentee ballot.

A second option is to download the PDF file of the absentee ballot request form which can be found at https://idahovotes.gov/media/forms/2020 May Primary Absentee Request.pdf

Print off the form, fill it out, and mail it to the Boise County Clerk's Office at:

Boise County Clerk 420 Main Street P.O. Box 1300 Idaho City, Idaho 83631

Option three is to do nothing. If you are a registered voter and do not request an absentee ballot the Secretary of State will mail you an absentee ballot request form. When you get it, fill it out and send it to the Boise County Clerk's Office (see above).

Note: Your request for an absentee ballot must be re**ceived** (not postmarked) by the Boise County Clerk's Office by 8 PM MDT Tuesday May 19, 2020. If you request an absentee ballot by mail, remember that everything that is mailed in Boise County goes down to Boise and is then returned to the Boise County address. This takes at least 5 business days, so submit your online request or get your request form in the mail early! You may also register to vote by the May 19th deadline.

Step 2: Voting

Now that you have your ballot you must fill it out and return it to the Boise County Clerk's Office. To be counted in the vote your ballot must **be received** (not postmarked) by the Boise County Clerk's Office by 8 PM MDT Tuesday June 2, 2020. Again, remember that everything that is mailed in Boise County goes down to Boise and is then returned to the Boise County address. This takes at least 5 business days, so get your ballot in the mail early.

Please be sure to exercise your precious right to vote in our State's Primary Election.
