## School Starting for Basin School District?

### Parents/Guardians,

Since March 30th, the district has been studying, monitoring, and analyzing the coronavirus and its effects on the basin School District. Reflecting on the 1918 flu outbreak, we can expect that the numbers will increase in the fall and once more in the spring during the flu season. What is different about today is the understanding of transmission and genetics which gives our scientists a much better chance to help stop the spread. It is our hope that researchers will develop vaccines and antiviral medication this fall to decrease the number of fatalities and long-lasting damage to health.

As of today, the numbers are very high in Idaho compared to our small population. Due to the uncertainty of local

community spread, the district has to take the safest approach to starting the school year. It is our utmost concern to keep our community healthy and safe. For this reason we will be proposing a delayed start to the School Board next week. We are proposing that, instead of beginning August 18th, we push the start back to August 31st for students. This increases the gap between the time the scientists can develop vaccines and antiviral medication, it gives the community a chance to decrease the spread of the virus, and it gives the teachers two weeks of training for developing hybrid and online curriculum if we have to go that direction.

The district is working with Central District Health to develop an action plan in the event of increased community

spread and possible positive cases with staff and or students. The plan allows the district to move towards a normal, traditional face-to-face learning model if we have no community spread, or the district can move towards an online work from home model if community spread increases significantly. The plan includes a hybrid model where students will be spread out during face-to-face teaching on some days and working from home on other days during increased community spread. At this point, we are in a cautious stage, which could change by August 31st. If we started school today we would run a hybrid model where students would come to school Monday through Thursday face-to-face wearing masks when needed, and work Friday from home on projects

or online. This model allows teachers to train the students for possible online school in the event community transmission increases and or we have a case at school.

Every staff member, student, and parent/guardian wants students back at school in person. We all learned last spring how important social interaction is and how difficult it is for working parents to accommodate online learning. Our staff also learned a great deal about online learning and has been studying best practices and will be working on curriculum for two weeks before school begins. As a community, we all need to do our part to keep everyone as healthy and safe as possible so we can keep students in school and allow parents/guardians to work. For this reason, we ask that everyone practice social distancing, wear a mask when appropriate, wash your hands frequently, and disinfect your surroundings when appropriate. If you or a family member are exposed to a positive COVID case, we ask that you quarantine for the appropriate amount of time before coming to school. Our community is isolated and spread out

but we have many people who work, shop, and visit the Treasure Valley on a frequent basis and this exposes our small community to the virus. If just one or two staff members or students get the virus, it shuts the school down and if some of our vulnerable students or staff members get the virus it could be life threatening.

Our staff will do everything possible to provide the safest and best education with the resources available. We will be posting additional information and updates at <https://basin-schools.net/covid19-update/>. You will be able to find athletic updates as well as general Q & A, and other pertinent information.

Thank you all for being so supportive and flexible during these chaotic times. We all hope we return to near normal times very soon. We will inform you of the school board's decision and official start date on Wednesday, July 22.

## Horseshoe Bend City Council Meeting

**HORSESHOE BEND** -- The following is a synopsis of the Horseshoe Bend City Council's meeting on July 15, 2020. All council members were in attendance. After the call to order and the Pledge of Allegiance, city attorney Tony Pantera announced to the standing room only crowd that due to a publication error by The Idaho World, the city's comprehensive plan would be tabled until the council meets in August but that public comments would still be heard. 35 people were in the council's chambers, including the council, a larger than normal crowd for a typical meeting. Of the 35 in attendance only 3 were wearing face masks and almost no social distancing was being observed. Mayor Pat Goff requested for the council to approve the newly amended agenda that reflected the omission of the comprehensive plan, previous minutes, and the authorization to pay the city's bills, all were approved unanimously. Goff then opened the dais for public comments. Former councilmember Teresa Cooper opened. "I read the comp plan, every bit of it," Cooper told the council. Cooper had objections regarding the comprehensive plan committee that city grant writer Cheryl Pleak had commissioned. According to Cooper, the committee was made up mostly of Horseshoe Bend business owners that did reside within the city limits. In particular, Cooper addressed the use of "zero lot-line" mentioned in the plan. Zero lot-line is an approach for increasing the number of housing units per acre without making the area appear overcrowded. Cooper told the council that this would lead to an urban, instead of a rural, lifestyle. She also brought to the council's attention that the plan has "a lot of mistakes in it," typos, misspellings, and the Payette River being referred to as the "Middle Fork of the Payette River." Others objected to the plan not being in keeping with a rural lifestyle, lack of emphasis on recreational opportunities, and doing away with wood burning fireplaces. Councilmember Martye White asked Goff to explain to everyone why the city was doing a comprehensive plan. Goff explained that the city's plan was

outdated and that in order to be compliant, the city needs to update their comprehensive plan every five years. Goff also told the crowd, "By no means am I looking at this being a finished product. I'd like to stave it and have no growth. It's coming and we need to stay ahead of it. This is just a road map, we can change it at any time." Goff added that the comprehensive plan was needed in order for the city to be eligible to apply for federal grants. Pantera told the audience that the comprehensive plan's "language doesn't have the force of the law." Goff went on to say that there was "close to 800 people in this city and we need to do what's best for everyone." Councilmember Ben Riley asked "This isn't policy but how does it back up our policy?" Pantera replied, "It supports our ordinances and shapes our growth going forward." Goff asked those in attendance to get their comments and concerns in writing and send them to the city. On to new business. The council received copies of the tentative 2020 budget and discussion began regarding that agenda matter. White had the most queries asking about the budget outlay for the ambulance being less than the previous year (it was thought that it may be due to Coronavirus training), budget for fireworks display (no fundraising this year due to coronavirus). White also thought the water/sewer budget was overdoing it. "If we're going to just make something up let's go for a million." Items that were thought to be errors were cleared up after a call to city treasurer, Terry Lawson, was placed. Councilmember Curtis Corvinus questioned Lawson regarding the water/sewer budget mirroring expenditures. Lawson explained that the budget must be balanced and expenditures must equal funding in order to have a balanced budget. The tentative budget was approved for publication and will be voted on at the next council meeting. There was no EMS update. Public works spokesperson Michele Brothers said the levy inspection had been completed and they were waiting on the report, the water plant was currently running 10-12 hours each day, and the department was getting ready to do some tree trimming. Pleak

introduced the new Horseshoe Bend Chamber of Commerce committee leads and newly appointed chamber lead Kimberly Welsh said, "We'll be doing things in a small, very local way." Pleak told the council that the Emergency Medical grant would be announced towards the end of September. She also said that the community clean-up was fantastic and that councilmember Stephen Chartier "mowed and mowed and mowed all day." She indicated that Jobie Catherman and the public works department helped with the clean up along Highway 55, 7 total cars were picked up thanks to Nick Gibler and the Mustang Towing crew. She mentioned wanting to start fundraising for a Sidewalks for Kids initiative to pay for sidewalks and fencing along the Highway 55 corridor using a mix of public funds and grants. Pleak reiterated that the city's comprehensive plan was necessary and that what it includes is determined by law. She also noted that while the plan itself is required by law, what is included in the plan are just options, adding, "This is not a mandate, this needs to be a city effort and a community effort." Goff adjourned the council to go into executive session at 8:04 p.m. closing with "Try and be safe out there." The council meets on the third Wednesday of each month at 7:00 p.m.

If you met Lisa Kirkland 2 years ago, you met an independent, fun-loving, happy Army/ National Guard service member with unrivaled grit, wit and passion. On her way home one evening, she was in a car accident and she luckily walked away with very minor injuries...or so we thought. In the days and weeks to follow, Lisa lost much of her ability to walk and stand without support, has difficulty speaking and concentrating, and was easily overwhelmed by lights and sounds. ## Dangers Associated with Exposure to Heat

**BOISE COUNTY** -- The "dog days of summer" are upon us and many of us will spend more time outside working or recreating. This will expose us to a higher probability of encountering one of the three heat related emergencies: heat cramps, heat exhaustion, and heat stroke. Certain factors predispose people to all three heat-related emergencies, which are particularly likely to affect the very young, the very old, and people with certain underlying medical conditions and/or who are taking certain medications. All three heat-related emergencies occur more frequently when a person exercises or

works in temperatures as low as 80 degrees, depending on humidity and level of exertion. Cramps, including heat cramps are the involuntary spasms of your muscles, usually the calf or abdominal muscles. Heat cramps often occur due to exercise/work in hot weather. The exact cause of heat cramps isn't known but it is suspected that a change in your electrolytes due to exertion and dehydration is one likely cause. Loss of water is normal in hot weather and may affect muscles that are stressed, causing them to go into spasm. Loss of water can also affect the balance of electrolytes. The

steps to relieve heat cramps are as follows: first, move the person to a cool spot, air conditioned is best, out of the sun, then have the person lie down in a comfortable position to relax the stressed muscles. You may give the person water to drink or a diluted electrolyte solution like a "sports drink." Usually with rest and fluids the cramps will go away. If they don't, and if the person is very young or old or has an underlying medical condition, it is best to take them to the family physician or urgent care center for a check-up.

A more serious heat emergency is heat exhaustion. High

temperatures may cause the body to not be able to cool itself by radiation and high humidity may cause the body to not be able to cool itself through sweat evaporation. In this emergency, the person usually sweats profusely, may complain of feeling light-headed or dizzy, may be sick to their stomach, and may have a weak pulse. Body temperature may be normal to slightly elevated from its normal temperature. To treat the person, move them out of the sun and to a cool shady spot, preferably in air conditioning. Treat them for shock by having them lay on their back and raise their legs above their heart level. If the person is conscious and not nauseated and not vomiting, you may give them cool non-alcoholic or non-caffeinated beverages to replace the fluids they have lost. Monitor the person for breathing difficulties and be sure they remain conscious. If the person loses consciousness, has a weak pulse and shallow breathing, or an elevated body temperature, call 911 and arrange to have them transported to a medical facility.

Heat stroke is the most serious of all the heat emergencies.

Heat stroke occurs when the body is subjected to more heat than it can handle and the normal body mechanisms for cooling are seriously overwhelmed. The person will usually have warm dry skin that feels hot to the touch. The person may be semiconscious but as the body temperature continues to rise they will lapse into the unconscious state. They may also go into seizures. Call 911 for emergency transport to the emergency room. Cool the person's body temperature while waiting for the first responders to arrive by moving the patient to a cool place, preferably into air conditioning, then strip them down to their underwear and douse a sheet with cool, not cold, water and wrap them in it. You can fan them, but don't over chill them. If you have ice, you can put ice packs on the groin area and under the arm pits. If the person is conscious you may give them SMALL amounts (sips) of cool water.

Enjoy your outdoor summer activities but stay hydrated and watch for signs of these heat related emergencies in the people around you.

## Clear Creek Volunteer Fire Department

**CLEAR CREEK** -- On Saturday, July 11, 2020, the Clear Creek Volunteer Fire Department held their monthly training. The training scenario consisted of a simulated lightning strike with a wildland fire component along with a medical injury within the incident in the Clear Creek area. As with past trainings, the department has used Clear Creek residents' homes and/or properties for preplanning and tactics within our wildland urban interface. For the July training, we used the upper Clear Creek area off Homestead Drive. For this

joint training, we were joined by the Idaho Department of Lands Engine 6, Crew 6 and leader Bryan Durkin. Training involved locating the strike, identifying lightning strike hazards, digging a fire line around a wildland fire and a medical emergency involving a firefighter injury.

Clear Creek Fire and IDL crews were mixed and divided into two groups. One was for the initial attack and the second was incoming resources. Both crews hiked to the area, approximately one mile up the hillside to the lightning strike.

Keeping the training as realistic as possible, proper PPE, wildland packs, hand tools and chainsaws were carried into the site. Upon arrival, the first crew determined the Incident Commander, instituted situational awareness, scouted the fire, and developed a plan to fight the fire. The first group then deployed and started digging a handline down to bare dirt as the second group arrived on scene. The second group was briefed by Operations on the tactics, communications plan, safety zones, and escape routes and then began digging handlines as well to contain the fire.

After an hour of digging the fire line around the fire, a mock

injury happened involving a firefighter on the fire line. At this time, a tactical pause was taken. Bryan Durkin, IDL Supervisor, gave some training to the IC and Officers on how to run the incident within an incident. When training resumed, IDL EMT's along with Clear Creek personnel tended to the patient as the medical IC notified dispatch of the emergency and requested an ambulance to be dispatched to a safe location for patient transfer. As treatment of the patient progressed, the other firefighters continued to dig a fire line to protect the medical staff and patient. When the patient was stabilized, the crew carried the

patient approximately one-half mile down the hill to the safe zone and awaiting ambulance.

The training exercise was concluded and the crew took a well-earned break in the shade. At this time, an after-action review was held. The training was well received by both crews. Bryan Durkin led the review to help identify areas that needed improvement. Thank you to the Clear Creek Volunteer Fire Department's fire fighters for their hard work and dedication to their community. Special thanks go to IDL, Bryan Durkin, and the crew members from Engine 6 and Crew 6 for their participation in our training session.
