GARDEN VALLEY -- The 37th annual Terrace Lakes EMS benefit golf tournament always starts off with a patriotic golf cart parade. The tournament also hosts a silent auction to raise money for this voluntary group of emergency responders.

Unfortunately, this year the Life Flight helicopter was not able to make their scheduled appearance at the event due to other emergencies on Saturday, July 4th, 2020.


On July 5th, there was a horrific single vehicle crash on Highway 55 at mile marker 76, located south of Banks. Matthew and Katherine Fletcher of Meridian were traveling southbound in their 2002 Ford F350 when the truck left the highway and hit a tree. Katherine, 48, succumbed to her injuries at the scene. There were also two juvenile passengers, and one was transported by Life Flight to a Boise hospital. Garden Valley and Horseshoe Bend ambulances were called to transport the second juvenile and Matthew Fletcher. The four occupants of the truck were wearing their seatbelts at the time of the accident.

The crash is still under investigation by the Idaho State Police.

Traffic was stalled for about four hours on Highway 55.

Clifford Lowell Bledsoe passed away of natural causes on July 2, 2020, at home with his wife of 65 years by his side in Jerusalem Valley, Horseshoe Bend, Idaho. Clifford was born to Floyd Monroe Bledsoe and Edna Mae Loucks in Marsing, Idaho on June 10th, 1934. He was the second youngest of 7 siblings. He spent most of his younger years farming and milking cows. As a sophomore, he left his family home in Marsing, and later from Crouch when his family moved, to board in Nampa during the school year, milking cows before school to pay for board. He graduated from Nampa High School in 1953. At the age of 19, he took the Portland Rose train from Nampa to Kansas City, Missouri to attend Missouri Auction School. On June 12th, 1955, he married Arlene Woods of Jerusalem Valley, Horseshoe Bend. He always said "don't offer a girl a ride home from a dance, you might end up marrying her." As they began their family, he worked

as a logger, in the Sugar Beet Factory at Nampa, Vans Packing House, Davis Custom Packing, Tri City Meats, and Meridian Meat and Sausage. He then worked at Gem Meat Packing House where he became part owner. During that time, he continued with his first passion, auctioneering at Nampa and Caldwell Livestock Auctions. He retired from the packing houses and bought and ran Emmett Valley Livestock. He continued to support the Emmett auction with future owners. Cliff was the senior auctioneer at the Western Idaho Fair, helping at the FFA and 4-H livestock sale for 50 continuous years. He volunteered at several county fairs as an auctioneer, including Valley County, Gem County, and Elmore County Fairs. He never turned down the request to auction for a charity. He was forced to retire from auctioning at the age of 84 due to health, but not before being awarded 4-H Recognition for Meritorious Service and Honorary Chapter Farmer to FFA. He

attended the Livestock Judging Pacific International in Portland his senior year of FFA. He continued to support 4-H and FFA livestock judging throughout his life through volunteer and the continuing of the activity by his grandchildren.

He was proceeded in death by his parents and 6 siblings, Juanita, Irene, Pauline, Frieda, Cecil, and Harold. He is survived by his wife of 65 years, Arlene, son Steve Bledsoe and his wife Dottie, their 3 children, Arlie, Millie and Norah, of Boise, and Sadie and husband Brandon Crusat, his two great grandchildren, Kalea and Nalanie of Kuna; Cristy Bledsoe of Boise and her daughter Adrianna Hennessey of Seattle; Jan and her children, Levi, Koda, Mikaela, C.J. Bledsoe of Jerusalem Valley, Horseshoe Bend. Also surviving are numerous cousins, nieces and nephews.

The family would like to thank the doctors of the past two years, Dr. Travis Williams, Hematologist, and Dr. Christopher Keller, Nephrologist, both who believed in









New Gift Shop **Opens in Horseshoe Bend**

Since its opening at the beginning of June, The All Aboard Gifts and More shop has been presenting a wide selection of offerings to the Horseshoe Bend community and visitors traveling along the Highway 55 corridor. Located on the scenic Payette River at 105A Payette River Road in Horseshoe Bend, the small specialty shop sits adjacent to its owner's larger endeavor, The Locking Horns Riverside Restaurant. All Aboard shares its space with two quaint Airbnb rooms, with all three located in Horseshoe Bend's original train depot which was built in 1908 to serve the town's logging businesses. While small in size, the store provides a substantial selection of items ranging from one-of-a-kind pieces designed by local artisans to an assortment of antiques; a mixture of potato ricers, vintage hats, salt and pepper shakers, glass-

ware, wooden baskets, etc. Doji Pure, a local company that makes naturally healthy, handmade skin, beauty, body, and bath products can be found on All Aboard's shelves as can McCall's Candles and delicious treats from the Idaho Candy Company. Artistic decor, hats and t-shirts celebrating Idaho, purses, lap quilts, and stuffed animals are just a few of the hidden gems you can find there.

Typical hours are daily (except for Tuesday when both the gift shop and the restaurant are closed) from noon to 5:00 p.m. but if the restaurant next door is open, you can usually get someone to let you in to shop. The store likes to feature items that are made locally and their inventory changes daily.

If you are a local artisan that has a product to sell you can contact All Aboard at (208) 793-1507 for information on how to get your product featured in the shop. Next door to All Aboard things are heating up and "cooling down" (thanks to some inside air conditioning provided by Cascade Refrigeration in Horseshoe Bend) at the Locking Horns Riverside Restaurant. Every Wednesday from 5:00 p.m.-8:00 p.m. is Ladies Night where those in attendance can partake of drink and appetizer specials while making a craft and/or socializing. This week, July 8, the ladies will be tie-dying, just bring a white t-shirt to join in. Singer/songwriter Michael F. Rose will be performing on Saturday, July 11th from 5:00 p.m.-8:00 p.m. and the Sockeye Brewery will be doing a tap takeover.

To reduce the risk of COVID-19 exposure to the public and employees, the Boise National Forest is offering multiple choices to purchase personal fuelwood permits. Fuelwood permits are valid within the Boise, Payette, and Sawtooth Forests.



The Boise National Forest offered Free-use Fuelwood Permits from May 15 thru June 30. Free-use fuelwood collected, counts as personal use toward the 10-cord maximum per household per year.

Permit holders are encouraged to cut fuelwood early in the year because fire restrictions may impact the cutting season later in the summer. Fuelwood cutting is not allowed within riparian areas (adjacent to creeks and rivers). A new regulation for this • Emmett Ranger District year is no cutting of Larch (Tamarack) after Nov. 1. Larch lose their needles every fall and appear to be dead, resulting in too many live trees being accidently cut. This new regulation is to prevent the cutting of live Larch trees after they have lost their needles in the fall.








OBITUARY

Guy Ritchie Harris moved to Idaho City in December 1945 from Arkansas with his wife Charlotte, daughters Christine and Mary, and son Guy Eugene Harris. Guy Ritchie had fallowed his family out west, who owned the Harris Brothers Lumber Company in Idaho City from the early 1940s to the early 1950s. In the spring of 1946, Guy Ritchie purchased 350 acres of land on Clear Creek to log the timber. Guy Ritchie then needed to build a sawmill and found a location on Grimes Creek across from Pine Creek which

he leased from the state with a 99-year lease, to last as long as there was a sawmill on the land. In the summer of 1946, Guy Ritchie built the sawmill and what was called the long house south of the mill. This house was also know as a shot gun house since all five rooms were in a row and all the doors from one room to the next lined up. If you stood at one end of the house you could shoot straight down though it. In 1950, they built a new house above the mill which was much nicer. It was a two story house with 3 bedrooms and Char-

lotte wallpapered all the walls. Charlotte's pride and joy was a Majestic wood cook stove which she made many meals and cornbread in.

Guy Ritchie's sawmill had two circle saws, one above the other, to be able to cut the large pine and fir logs from the Clear Creek area. In the early 1950's Guy Ritchie replaced the circle saws with a band saw. The wheels of this head rig were six feet in diameter and the band saws were 38 feet around and 13 inches wide. There was a whole room dedicated to the filing equipment for sharpen-




Guy Ritchie Harris *1932 - 2020*

ing the saw.

The sawmill used water from Pine Creed for the large mill pond where logs floated waiting to be pulled up a bull

ing loggers during this time, so he went to the woods and did his own logging. He ran the logging crew and his company from a 10 x 57 trailer in the logging woods with his wife Betty and his daughter Katherine, and son Guy Joseph by his side. They also had a home above the sawmill and in Boise. In 1979, Eugene moved the sawmill to Federal Way and Yamhill in Boise. This was the big mill you could see from the freeway near Micron. He sold it in 1989 due to him getting Guillain-Barre. Guy Eugene was born August 8th, 1932 in Barnes Arkansas. He passed away on Friday, June 26, 2020. He had an amazing life in Boise County and lived life to its fullest to the very end. Written with love by his daughter Katherine Harris Avison.

chain into the mill. This water was also used under the mill to wash out the sawdust from under the head rig.

Guy Eugene Harris purchased the company from his dad in 1971. Most of the machines in the mill were old and tired by then. Guy Eugene (Eugene to those who knew him) spent the next several years modernizing the mill. Eugene turned the mill into a modern mill that could compete for timber sales against other sawmills in the area, including Boise Cascade. Eugene fought though TV. The Idaho Statesman, and Small Business Administration to establish fair timber sales to all sawmills. Eugene also had difficulty find-
