High-Flying Rescue

BOISE COUNTY -- A call came into Boise County Dispatch on Wednesday night regarding a lost ATV rider that went missing from the nearby campground outside of Idaho City. Sheriff Scott Turner reported that Deputy Gomez headed out on a dirt bike and

Sgt. Anderson patrolled these remote trails on an ATV. Idaho Mountain Search and Rescue also set out in search of the driver who had rolled his ATV down a steep hillside at about 3pm in the afternoon. The hillside was deemed unstable and the Air National Guard was called in with a helicopter equipped with a winch system to hoist out the husky

individual. He was brought to the Idaho City airstrip. The man was checked out by East Boise County Ambulance and released to rejoin his camp.

The man set out on his ATV alone and had been missing for eight hours when friends called dispatch. He was recovered by the National Guard the following day, on Thursday morning, August 22nd.



Deputy Gomez reported: "The helicopter pilots and team were amazing. They inserted a team member into crazy hostile terrain and it looked like they had done it 100s of times."

Central District Health Provides COVID Guidance to HSB School District

Written by Tracy Koslosky HORSESHOE BEND -- Central District Health's Gina Pannell, the State Healthcare Innovation Plan Program Manager, was at Horseshoe Bend School District for a teacher in-service to help explain, clarify, and give guidance on the district's plan for reopening under CDH's Category 2 reopening plan. Pannell stated that following the guidelines was "critical to keep schools open. We know that the best learning opportunities are in person," she told the staff. The CDH is partnering with schools to

try and avoid intermittent closures. She explained that the term social distancing refers to large groups of people and that schools should be practicing physical distancing, maintaining 6 feet of space between students when possible, and using masks when distancing isn't feasible. Pannell stated that if there happens to be a COVID-19 exposure at the school anyone who had close physical contact to a positive case (within the 6 feet boundaries) would be quarantined for 14 days. She recommended making things reasonable

and doable for the students and encouraged teachers to look for opportunities to take classes outside. Pannell suggested using cohorts and keeping students in smaller groups (cohort plans are currently in place throughout the district). Pannell's opinion on masks? "From our view point (CDH), they are a very effective way to prevent transmission." She informed the staff that if there is an exposure, those who have been in close proximity (within 6 feet for 15 or more minutes, cumulatively-CDH inspectors determine risks after exposure

and the need for quarantine) to someone with a confirmed infection would need to be quarantined for 14 days. If symptoms present, they will need to quarantine for an additional 10 days. This is a symptom-based strategy that is being utilized as the state currently does not have the testing capacity to isolate based on testing alone. Pannell endorsed keeping windows and doors open in the school when prudent. She stated the CDH's belief that person to person contact was more likely to transmit the disease than physical contact with a surface. When asked about wearing face shields instead of masks, she said that full face shields may be more appropriate for younger students and would provide some level of protection. She suggested that students be given mask breaks outdoors when physical distancing was possible. Good hand hygiene was also stressed, especially for younger students. Pannell said of the upcoming flu season, "COVID and flu symptoms are very similar but all these measures should help

prevent both." She proposed that students have their own supplies when possible but that those supplies that need to be shared be done so after appropriate hand cleaning with soap and water or hand sanitizer. By following all the measures set forth in the school's reopening plan the levels of exposure can be mitigated, and will determine whether a handful of students are quarantined or if the whole school closes.

Pannell predicted that the likelihood of a vaccine becoming available early next year is unlikely and that we will most likely be living under these guidelines into the next school year.

In closing, Pannell said that all contact tracing with CDH investigators is voluntary, "We're not trying to take children from families," and concluded by telling the staff that the "CDH's end goal is to develop herd immunity, preferably through a vaccine." Herd immunity is considered accomplished when 60-75% of the state's population has immunity. "We're not even close here."

Beware: Wildfires & Storms Can Cause Downed Powerlines



Idaho Power
BOISE COUNTY -- Wildfires and summer storms can cause a lot of damage, and both have the potential to cause power outages. Such severe weather may also cause power lines to fall. Idaho Power wants customers to know what to do and how to stay safe if they encounter a downed power line.

First, always assume downed power lines have energy running through them. Never touch them, and never use objects

to move or hold up a downed line or any object touching a downed line.

Idaho Power advises customers to stay back at least 100 feet and immediately call 911 or contact Idaho Power at 208-388-2323 (or 1-800-488-6151 outside the Treasure Valley).

If someone else touches a downed power line, do not touch or try to rescue them. You risk becoming a victim yourself.

You can find more information about downed power line safety, including a video about how to respond if a downed line falls on your vehicle, on our website.

HORSESHOE BEND**

The following is a synopsis of the Horseshoe Bend City Council meeting on August 19, 2020. All councilmembers were in attendance. After the call to order, Pledge of Allegiance, approval of the agenda, previous minutes, and the authorization to pay the city's bills, Mayor Pat Goff opened the dais for public comments. No one came forward.

Several public hearings were on the agenda with the first being the 2021 Fiscal Year Budget & Foregone Resolution. With no written or public comments from those in attendance, Mayor Goff closed the hearing.

The city's comprehensive plan was opened for public hearing. City attorney Geoff Schroeder gave a staff report and told the council that the new comprehensive plan was structurally the same as the previous one from 2009. He mentioned that during the comp plan workshop held in July, the council and the mayor indicated that they would like to see some brevity and Schroeder agreed that the plan was an "enormous volume of gobble-dyook." Schroeder worked on condensing the plan and had it pared down to 59 pages from 128; however, he indicated that for the purpose of this hearing the public would be commenting on the larger plan that has been available to the pub-

lic. Goff opened the floor for comments. City engineer Amy Woodruff spoke to the council, saying that she probably spends as much time as anyone using the comprehensive plan and requested some time to look over the amended copy.

City grant writer Cheryl Pleak asked to explain some of the things that community members complained about during the last council meeting. She explained that zero lot lines referred to properties with duplexes, triplexes, condominiums, and apartments, not single family residences. She added that the solar energy provision "in no way means that people need to get rid of their wood burning stoves." The solar energy comments were in reference to future builds. Resident Bethany Hardy commented that she liked some of the plan's designs for the future, such as adding more sidewalks and converting the railroad tracks into walking trails. Goff commented that while the city didn't have a lot of money to accomplish some of the design plans, the idea is to apply for grants to make progress. Hardy asked what the next steps would be and how the plan would be converted into actionable steps. Noting that the comprehensive plan is not actionable, Schroeder said, "This is just the foundation of the city's ordinances and those ordinances cannot be in conflict with the comprehensive plan."

Hardy went on to suggest that perhaps the city could annex additional areas to increase the tax base, but Goff replied, "If we annex it, IT puts the water and sewer upside down, it increases the tax base but it won't be enough for water and sewer, so we need to grow this slowly."

Hardy asked about the 1900s design theme, Schroeder said that he believed that had been removed from the updated plan.

A written comment by resident Kim Dewalt was read into the record. Dewalt was concerned about the solar energy provision and the zero lot line writing, "We are a small town and we'd like to keep it that way." Schroeder explained again that the plan is not an ordinance and that set backs are determined by ordinance. Mentioning lot lines in the comp plan gives the council some latitude to waive those ordinances when appropriate. The hearing closed with Goff telling the audience that they should "write in when they have concerns about something so they can stay home and watch *Columbo* as opposed to sitting in on a city council meeting."

Next was a hearing regarding the continued use of a conditional use permit (CUP) at 407 Hwy. 55. Salon 55 wants to continue operating like the current occupant, The Hair Station. Woodruff told the council it was a pretty straightforward deal. No public comments, but a written comment from resident Holly Elliott was read. El-

liott asked that the city restrict the business's access from David Street and use the Hwy. 55 entrance only. Woodruff told the council that the rear of the property along David St. "is on a public right of way and no one gets to pick or choose who can use it."

New business: The CUP for Salon 55, according to Woodruff, was assignable and was granted by a unanimous vote of the council.

Council members Marty White and Ben Riley requested that another hearing be held to approve the shorter, revised comprehensive plan, so no action was taken. There will be a new public hearing in September. The revised plan will be available on the city's web page when revisions are complete. The 2021 Fiscal Budget was approved unanimously with no discussion.

Appropriation Ordinance 262 was approved unanimously by roll call as was the Foregone Resolution 2020-04. (The forgone resolution deals with forgone taxes that could have been collected in previous years but were not. The resolution states that they can be levied for future use.)

Resident Kit Smith was back to get an update from the council on Watson Road. Smith and other residents had previously come to the council regarding the road's narrowing after a resident erected a fence on their property that effectively decreased the width of the road. Smith wanted to get a time frame on when something would be done. Goff said

that making Watson a one way street was all that needed to be done and the city just needed to put up a sign so the sheriff's office can ticket violators.

Michele Brothers gave the EMS report: 18 runs in July. Department wants to dedicate the Lifeflight pad to Carter Duke and the council approved the dedication unanimously.

The council approved no more than 15K for the purchase of a used truck for the Public Works Department. The department is making small improvements to the water system and working on the source water plan. Street sweeping is being scheduled and residents will be notified of the schedule as it affects them. Pleak completed a public works grant to replace the fencing and install an electronic gate around the water plant. She applied for a 6K grant for the EMS Department and said that there was 11K remaining of 26K in the Idaho Rebound Municipal Grant after three businesses received money. Pleak talked about several other grants that she is possibly going to pursue. She asked the council about scheduling another city-wide clean-up but Goff told her he thinks she should hold off "what with COVID going on." Woodruff said they are working with Barreto Industries on sewage requirements as well as updating levee protection and looking into updates for the water treatment plant.

The council went into executive session at 8:37. They meet next on Wednesday, September 16, 2020 at 7:00 p.m.

Partnership Forms to Address Recreation Overuse by Grimes Creek

BOISE COUNTY – Local residents, Boise County, Volunteer Fire Departments and Emergency Managers are partnering with the Idaho City Ranger District to address the heavy recreation use along Grimes Creek. The heavy use is creating sanitation issues and ecological damage.

The heavily used area is popular because it is close to Boise and has numerous open spaces for dispersed camping. Every weekend, the seven-mile strip of land adjacent to Grimes creek is packed with campers and off-road enthusiasts, many of whom are not recreating responsibly.

Boise County Sheriffs and deputies spend a lot of time in Grimes Creek responding to many serious incidents. "Grimes Creek has the heaviest recreation impact in all of Boise County. Unlawful and disruptive activities tax law enforcement and emergency resources, including wildfire responses," said Scott Turner, Boise County Sheriff. "We need to address the destructive behavior and resource damage before it is too late."

"People are leaving campfires burning," said Bob Showalter, Boise County Emergency Manager. "We have homes in the area and do not want a wildfire starting because of someone's neglect."

Area residents are fed up with the destructive behavior and want visitors to be more considerate and lawful with their use. Negative visitor impacts include extensive littering, off road vehicles (UTVs/ATVs) creating illegal trails and exceeding posted speed limits, which damages natural resources and increases potential for accidents.

"With the help of our partners, and the community, we are developing short- and long-term solutions," said Brant Petersen, Idaho City District Ranger. "We want to continue to provide a safe area that people can enjoy, and improve the sanitation issues while restoring riparian areas along the Creek."

The first step in the short term plan is to mandate a temporary emergency closure in damaged areas to address sanitation issues, remove litter, and repair resource damage to the creek and riparian areas. "We want to provide recreation opportunities that are safe and enjoyable for everyone and reduce the negative impacts to local residents," said Petersen.

What can you do to help? Dispose of all garbage, by

BOISE BASIN -- Midas Gold gave a presentation to about 20 residents from the area at the Senior Center on Wednesday, August 19, 2020. Belinda Provancher, the Communication Relations Manager, and McKenzie Lyon, the VP of External Affairs, spearheaded a public meeting on the Stibnite Gold Project.

As Lisa Hansen, the president of the Chamber of Commerce, introduced them, she said that Midas gold had graciously matched the budget with the Chamber for this year's Idaho

City Days.

Their main concept is "to become better stewards of the environment - while mining and bringing employment to Idaho."

They are proposing to mine 4+ million pounds of gold, and 100 million pounds of antimony, in Stibnite, Idaho near Yellow Pine. ORDINANCE NO. 360
AN ORDINANCE OF THE CITY OF IDAHO CITY, BOISE COUNTY, IDAHO, AMENDING TITLE 8 AND TITLE 10 TO PROVIDE THAT BUILDING PERMITS BE ISSUED BY THE ZONING ADMINISTRATOR; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, The City Council finds in order to promote the welfare of the citizens of Idaho City that building permits be issued by the Zoning Administrator,

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF IDAHO CITY, IDAHO:

SECTION 1. That Title 8, Chapter 1 Idaho City Code be amended to read as follows:

8-1-1: TITLE:

This chapter shall be known and entitled as the IDAHO CITY BUILDING CODE ORDINANCE.

8-1-2: CODES ADOPTED:

Pursuant to Idaho Code section 39-4116(1), the following codes are adopted as published by the International Code Council together with any amendments or revisions set forth in section 39-4109, Idaho Code, including subsequent versions of the International Building Code as adopted and amended by the Idaho Building Code Board:

A. 2015 International Building Code, including all rules promulgated by the board to provide equivalency with the provisions of the Americans With Disabilities Act accessibility guidelines and the Federal Fair Housing Act accessibility guidelines;

B. 2017 Idaho Residential Code, parts I-IV and IX; and

C. 2017 Idaho Energy Conservation Code.

The adopted versions of the foregoing codes shall be deemed superseded by successive versions of such codes as they are adopted or approved by the Idaho Building Code Board effective on the date such codes are made effective by the Idaho Building Code Board.

8-1-3: MOBILE HOME, TRAILER OR MANUFACTURED HOME:

Any mobile home, trailer or manufactured home which is proposed to be placed upon property inside the corporate limits of the City shall meet the standards set forth by the Idaho State Industrial Commission. This requirement shall also apply to moving an existing mobile home, trailer or manufactured home from one lot inside the City limits to another lot inside the City limits. Any such mobile home or trailer shall not be older than the year 1976.

8-1-4: BUILDING PERMIT REQUIRED:

No building or other structure shall be erected, moved, added to or structurally altered, nor shall any building, structure or land be established or changed in use without a permit therefor issued by the City. Building permits shall be issued by the City Zoning Administrator appointed pursuant to Idaho City Code 10-3-1.8-1-5: APPLICATION FOR PERMIT: The application for a building permit shall be signed by the owner or applicant attesting to the truth and exactness of all information supplied on the application. Each application shall clearly state that the permit shall expire and be considered revoked if work has not begun within one hundred twenty (120) days from the date the permit was issued. At a minimum, applications shall contain the following information:

A. Name, address and telephone number of the applicant;

B. Legal description of the property;

C. Existing use;

D. Proposed use;

E. Plan, drawn to scale, showing the exact dimensions and the shape of the lot to be built upon; the exact size and location of existing buildings on the lot, if any; and the location and dimensions of the proposed buildings or alteration;

F. Building heights;

G. Number of off-street parking spaces;

H. Number of dwelling units;

I. Proposed sewer and water facilities;

J. Such other matters as may be necessary to determine conformance with, and provide for, the enforcement of this chapter, and other applicable City and County ordinances;

K. Floodplain permit if applicable;

L. Estimated value of new construction, remodel, addition or placement.

8-1-6: BUILDING PERMIT FEE: A fee shall be charged for the building permit as well as for the inspections required under this chapter. The City Council shall set the fees for the permit and inspections by resolution. The permit fee must be submitted with the application in order for the application to be considered by the City. Payment of all fees is required prior to a certificate of occupancy being issued.

8-1-7: ACTION ON APPLICATION:

A. Approval/Disapproval: Within thirty (30) days after

the receipt of an application, the City shall either approve or disapprove the application in conformance with the provisions of this chapter.

B. Commencement Of Work: All building permits shall, however, be conditional upon the commencement of work within one hundred twenty (120) days.

C. Copies Of Plan:

1. Applicant: One copy of the plan shall be returned to the applicant by the City after the City shall have marked such copy either as approved or disapproved and attested to same by the signature of the Zoning Administrator or his/her designee on said copy.

2. City: One copy of plans similarly marked shall be retained by the City.

D. Placard: The City shall issue a placard, to be posted in a conspicuous place on the property in question attesting to the fact that the use or alteration is in conformance with the provisions of this chapter.

8-1-8: EXPIRATION OF PERMIT: If the work described in any building permit has not begun within one hundred twenty (120) days from the date of issuance thereof, such permit shall expire and be considered revoked. No written notice of expiration or revocation need be given to the persons affected.

8-1-9: CERTIFICATE OF OCCUPANCY:

It shall be unlawful to use or occupy or permit the use or occupancy of any building or premises, or both, or part thereof thereafter created, erected, changed, converted or wholly or partly altered or enlarged in its use or structure until a certificate of occupancy shall have been issued therefor by the City stating that the proposed use of the building or land conforms to the requirements of this chapter and with all conditional provisions that may have been imposed. This provision shall not apply to structures already occupied or used prior to the commencement of addition or remodel work.

8-1-10: FAILURE TO OBTAIN PERMIT; WORK CONTRARY TO PERMIT: Failure to obtain a building permit or a certificate of occupancy shall be a violation of this chapter. Use, arrangement or construction contrary to that authorized through the building permit shall also be deemed a violation of this chapter.

8-1-11: PROJECTION OVER PUBLIC WAY:

It shall be unlawful for any person owning any dwelling,

storeroom, warehouse, or other building or any shed or porch attached to such building within the incorporated limits of the City to suffer or permit such building or any part thereof or any porch or shed attached thereto to lean or project over or upon any part of any sidewalk, street, highway, or alley within the incorporated limits of the City; provided, that such building or the projection or leaning of such building or the porch or shed attached to such building shall appear to be unsafe or dangerous to the public or to any person passing by such building.

8-1-12: VIOLATION; PENALTY: The City shall have the authority to take whatever steps are necessary to civilly enjoin any violation of this chapter. Further, violation of any of the provisions of this chapter shall constitute a misdemeanor, punishable as provided in section 1-4-1 of this Code. Each day such violation continues shall be considered a separate offense. The landowner, tenant, subdivider, builder, public official or any other person who commits, participates in, assists in or maintains any such violation may be found guilty of a separate offense.

SECTION 2. That 10-3-2-D Idaho City Code be amended as follows:

Administer and issue land use and development permits, notifications and similar administrative duties, including building permit applications

addressed in Title 8, Chapter 1, Idaho City Code. **SECTION 3.** That this ordinance shall be in full force and effect upon passage, approval and publication according to law.



Editor:
I recently attended a presentation by Midas Gold concerning their plan to reactivate the Stibnite mining operation. As with previous meetings of this type with another mining company (CUMO), the presenters were well schooled in public relations and were able to answer or deflect most questions. Much of the presentation seemed very familiar, and followed the same lines of discussion as before. There were several concerns that were not satisfactorily addressed, at least to me. One of these was the matter of providing financial assurance in the event of bankruptcy. The new law passed last year allows for "Corporate Guarantee" to fulfill this assurance. When asked about this item, the spokesperson said that the conditions to allow such assurance are very strict and virtually no mining company could meet them. Upon reading again the entire text of HO141, I could not find such conditions. In fairness, I am not a lawyer or legislator and may not have recognized the provision.

Another attendee asked questions relating to the economic gain for Boise County

in general and Idaho City in particular. The answer given was very generic and non-committal. They promise up to 500 construction jobs, and about 250 operational jobs. The truth is that only a few of the jobs in operation of the mine would be entry level, and most are technical or college level positions. Since the only access to the mine area is from Highway 55, most commuters would not go through Idaho City, but rather up through Horseshoe bend and on up to Cascade. If Midas holds to its plan to bus workers to the site for 2 week shifts, and house them there, there will be very little impact on the economy from the employees.

I came away with all the same feelings as I did when listening to CUMO. I saw a lot of smoke and mirrors, with not much substance. The Midas plan is now open for public comment. You may comment online at <http://www.fs.usda.gov/goto/payette/StibniteGold>. I know that the mining industry is important to Idaho and the nation, and I am not anti-mining in any way, but I will submit an opposing comment.

Choose English, and click on "SEARCH DATABASE". Access the database by going to "SEARCH FOR COMPANY" and in the "COMPANY SEARCH" box type "CuMo". The report resides at the bottom of the page. The report is very long, contains a lot of very technical information and data. It is not an easy read.

Sections #16, 17, 18, 19 & 20 are very interesting. Paragraph 16.2.6, Figures 16.3 – 16.6 are quite informative as is Section 16.3. Sections 17.5 – 17.8 illustrates the huge size of the Process Plant. The report starts to get very interesting in Section 18, especially Sections 18.2 – 18.6. For the financial types, Section 22 is very illuminating and makes it clear the profits from the mine can be huge. As such, there will be some very strong pressure by American CuMo Mining Corp on Boise County officials as well as State officials. We should hope they do not get starry-eyed over the perceived economic impact and focus on

how to mitigate and handle the disruption caused by mine construction and operation.


Fatal Head-on Collision on HWY 55

BOISE COUNTY -- A double fatality happened on Monday, August 24th, when the driver and passenger of a 2002 Chevrolet Silverado truck attempted to pass going southbound on Hwy. 55 at milepost 83.5, located north of Banks and south of the Valley County line. Garden Valley Fire, Boise County Deputies, and the Idaho State Police responded to this fatality crash at 1:14 pm. The highway was closed for approximately five hours. It appeared that the truck had attempted to pass a 2016 Freightliner Semi that had moved over to the slower traffic turnout. However, ISP reported that the Chevy had crossed the center line into the northbound lanes and collided head-on with a 2019 Kenworth Semi.

The Chevy truck driver, Sophiah Mcvay Castro, 24, and her passenger, Emiko Pecchenino, 23, of Meridian succumbed to their injuries at the scene. Their next of kin have been notified.

The driver of the Metro by T-mobile box truck, a Kenworth Semi, was Paul Gray, 46, of Nampa. He was taken by helicopter to St. Alphonsus Regional Medical Center in Boise. His passenger, Jarren Brenner, 24, of Meridian was taken by ground ambulance to the same hospital.

The Idaho World reached out to a senior communications manager with T-mobile in regards to the condition of their employees, but did not receive a response prior to publication.
