Horseshoe Bend Valley Chamber of Commerce

HORSESHOE BEND --

The Horseshoe Bend Valley Chamber of Commerce met on Thursday, September 10. Chamber member Barreto Manufacturing was the September Spotlight Member. Luke Barreto spoke to the chamber about the origins of the family-run business whose headquarters is in La Grande, Oregon. The company has a distribution and shipping facility in South Carolina and a storage and distribution facility in Horseshoe Bend. Located on the old mill site, Barreto told the crowd "Idaho is a wonderful state to start a business, run a business, grow a business. It has been a joy to run a business in Idaho." The company is in the process of converting the Horseshoe Bend site into a factory and will eventually move

several product lines to be built on site at the facility. They recently completed installing a massive, state of the art powder coating system that went live a few weeks ago. With four current employees, the company plans to add 6-10 more in the next year, and 20-30 when they begin manufacturing products. The chamber will be hosting a Trunk or Treat on the Barreto site this year. 208 Designs has made a hand crafted wooden cut out of Idaho festooned with an American flag motif and a Horseshoe bend logo that will serve as the first prize award to the best decorated "trunk". Best youth costume will receive a hover board. There will be food available for purchase from Sonora restaurant and the haunted house at the American Legion Hall will be scaring those brave enough to enter.

American Reserve Munitions will be hosting a Turkey Shoot on the Saturday before Thanksgiving. More details will be available soon. New members, Overland Outreach, a non-profit that supports veterans by hosting over landing in trucks and camping outings for those that have served told the chamber they hope to give opportunities to veterans to be around others that have similar experiences. The chamber has plans to create a Veterans Memorial in the park by city hall to honor veterans from Horseshoe Bend. American Reserve Munitions will be the October Spotlight Member. 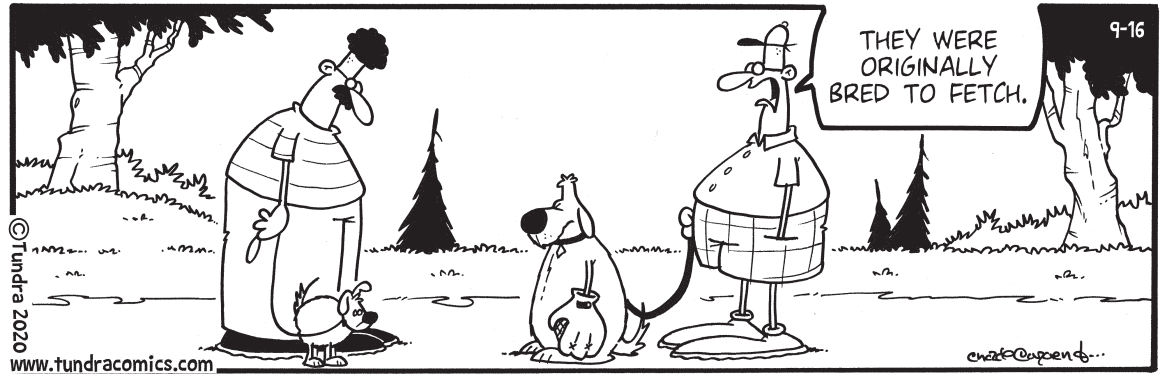

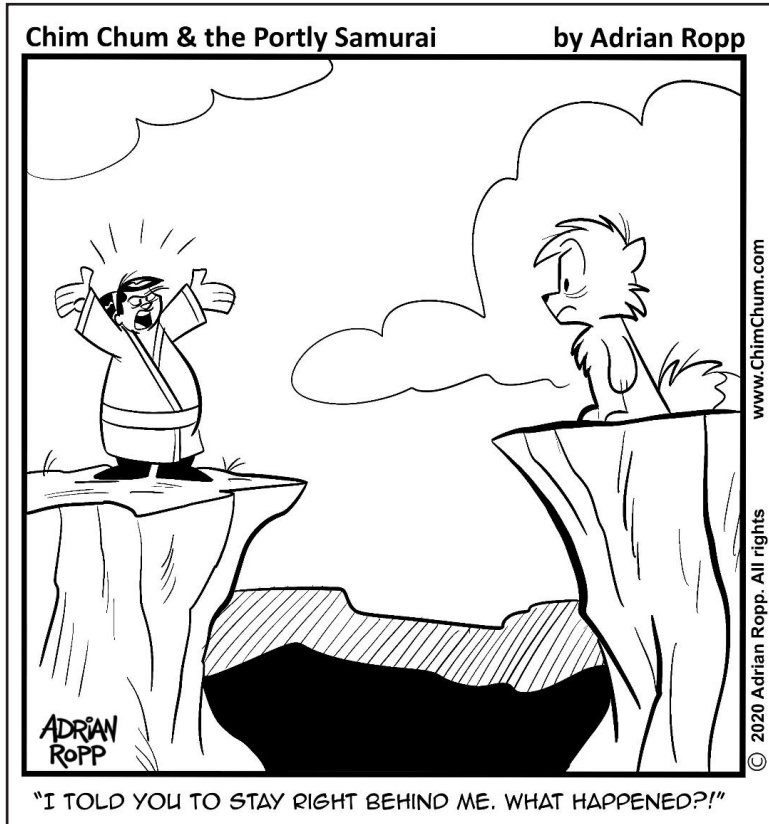
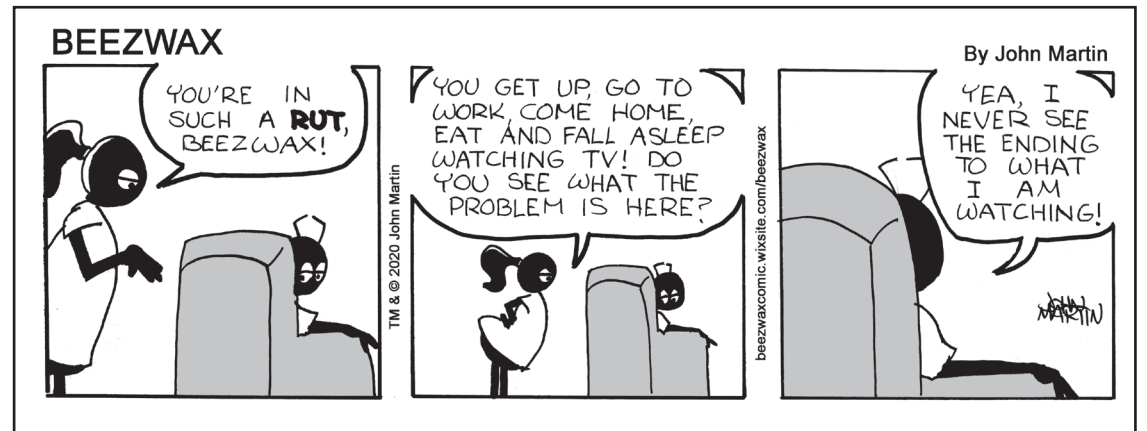

HORSESHOE BEND -- The Horseshoe Bend Varsity Volleyball team took down the Liberty Charter Patriots in Nampa on Thursday, September 10; 25-21, 25-14, 25-21. Standout players were freshman Annelie Wilson with 19 kills (an attack on the ball which is not returnable by the opposing team), 2 blocks (blocking the ball into the opponent's court leading to a point or side out), 6 aces (a serve which is unable to be played or returned by the opposing team), 12 digs (passing a spiked or hard hit ball), and 1 assist (pass, set or dig ball to another player who gets the kill). Senior Natalie Newell (librero) had 4 kills, 2 aces, and 8 digs and junior Kloe McReynolds had 4 aces, 6 digs, and 26 assists. The win gives the Lady Mustangs a 4/1 overall record for the season. Emergency Medical Responder Training Sign-Up Turns Citizens into Leaders

GARDEN VALLEY -- Emergencies happen when we least expect them. Wildfires and floods, rockslides and earthquakes are often big problems in Boise County. Some of the initial first responders make sure the community residents are aware of the next step to safety and critical help. A Lifestar Rural EMS Training Solutions program will be available in October in Garden Valley to turn regular citizens into a type of first responder at the most basic level. Training is designed for, but not limited to, Law Enforcement, athletic trainers, outdoor guides, and workplace or community disaster team members.

Sometimes a disaster will happen so quickly that the first people to "respond" are your neighbors. They will provide immediate information or calculate the needs to help people through a threatening situation. These will often will be the only people you see if EMS and fire resources are already stretched

thin. Citizens trained and prepared to be first responders will provide a service that prepares others for how to respond to their emergency or have an action plan to escape dangerous situations. When others "think" they know what they must do, the trained Emergency Medical Responders (EMR) can assist with details often overlooked.

The program will be offered as a 9-day class with the final day reserved for the exam. Classes are limited to 24 registered enrollees only. Included in the tuition is an EMR 11th Ed eManual and a combo Blood Pressure cuff/Stethoscope. Successful graduates will receive American Health and Safety Institute (ASHI) certification for two years. This will include CPR, advanced first aid, and other important medical diagnostics. This training will prepare enrollees to take care of non-medical emergencies in their community until the Emergency First responders arrive.

Course Cost is \$150.00.

Classes start October 1st at the Crouch Community Hall, 329 Village Circle, Garden Valley. Prepay with PayPal or Credit/Debit Card on the website for this class at www.lifestarruralems.org, or call 208-781-1862 for much more information. This opportunity will go

fast with limited enrollment. A typical EMR class enrollment cost is \$450-\$700. Not only is this considered a bargain, but the ability to bring help to lives within a rural community is priceless.

Dennis Allen Stewart, 59 years old, of Boise, Idaho.

On Friday, September 11th, 2020 Dennis Allen Stewart passed away suddenly at home. Dennis was born in Boise, Idaho in 1961, the son of Charles "Jack" Jackson Stewart and Wanda Lou Stewart. Growing up he spent a lot of time in logging camps cooking for his dad. He attended Meridian High School and was an accomplished 880-meter runner. He was Idaho State Champion in the 880M in 1979 (1.54:88). His running was described as gliding almost effortlessly around the track. Dennis participated in Timber sports with his dad. When in the mountains, he

always chose to go straight up the hill. He had a short college track career at Boise State. He married his high school sweetheart Chris Stewart and later they had a daughter, Angela.

He retired in March of this year from Yanke Machine Shop after 43 years of service. When he was 16 years old, he helped to build the Overland Sky Bridge, a bright yellow walking bridge in Boise, Idaho. Over the years he worked on mining equipment, built and repaired countless machinery. He was a very accomplished welder; he could fix anything broken; old equipment was his forte.

Dennis was a loving son, husband, dad, brother, uncle, grandpa and friend who will be missed by many people. He loved the mountains; camping, hiking, fishing, hunting, and gardening. He was a huge Boise State Football fan, he loved

sports and old western movies.

For the last 29 years, Dennis lived with his wife Chris on the land his great grandfather homesteaded around 1934. He loved that land, and he loved to tell the Stewart family story.

Dennis is survived by his wife of 41 years, Chris Stewart, Mother Wanda Stewart, Daughter Angela Stewart, Son-in-Law Torin Ford, Grandson Jackson Ford, Sister Chris Hanson, and numerous Uncles, Aunts, nieces, nephews, and cousins.

He is preceded in death by his father, Charles "Jack" Jackson Stewart, Uncle Joe, Uncle Johnny and his grandparents Charles & Evelyn Stewart.

Fire Started from Powerlines Near the Middlefork

GARDEN VALLEY -- Last week, a fire was reportedly started when a powerline brushed against a tree and was luckily spotted by neighbors returning from the Middlefork River. The emergency call to 911 was made by Isabela Elenes, a former Garden Valley resident, who was visiting her mom, Melanie Kellum.

"We were driving on the Middlefork Road," said Kellum, "when my daughter Isabela noticed an unusual light on a tree not far from the road."

"We were close to Bevan Road," said Elenes. "I saw an orange glow inside a tree and I said, 'Oh mom, look over at that tree! Isn't that a fire?'"

The mother and daughter waited for a few seconds, observing the fire before calling 911. Then, they warned nearby residents that there was a fire. They watched the fire jump from the tree to nearby brush, then to a pile of logs close by. Elenes said, "We called the fire department from very close to the fire, right at the intersection of Bruntsman and the Middlefork."

The Garden Valley Volunteer Fire Department was on the scene with stunning speed. They were assisted by civilians and a large water tanker. "The entire first pile of logs was lit by then," said Elenes. "We were so scared that it was going to hit the second pile, too." The quick action of the fire department and volunteers saved the second pile. They also prevented the growth of the fire from becoming a much larger wildfire, threatening fields and homes and people nearby. Due to the quick actions taken by the local volunteer fire department, fire was averted and contained on September 7th.

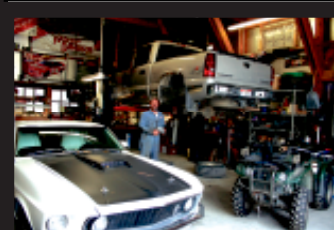
