HORSESHOE BEND -- The Horseshoe Bend Flight Park gave back to the community in a big way on Saturday, August 29th, when they played host to a fundraiser for the Horseshoe Bend Volunteer Fire Department. All of the day's proceeds will go towards purchasing swift water rescue gear for the department.

Several local vendors, Doji Pure, American Reserve Munitions, and Mass Mutual Idaho representative Malissa Meyer, were on hand to showcase their goods and services. The Horseshoe Bend Valley Chamber was set up to welcome businesses into their fold (*The*

Chamber meets next on Thursday, September 10 at the Longbranch at 6:00 p.m.)

The kids had plenty to do, with a dunk tank, face painting, snow cones, and cotton candy. There was a silent auction and raffle with chances to win VIP tickets to the Home Grown Country Music Fest, a Life Flight package, and a four-person whitewater raft trip from Idaho Whitewater Unlimited.

Horseshoe Bend Fire Department Chief Jason Gifford took a leap of faith with the Horseshoe Bend Flight Park owner Scott Edwards. They went for a tandem paragliding ride, Gifford's first flight. When asked

about his experience of soaring above Horseshoe Bend, Gifford said, "It was awesome!"

The Horseshoe Bend Flight Park is located at 235 Old Emmett Road. Anyone over the age of 14 can learn to paraglide, or go for a tandem flight with a trained professional.

The park will play host to the Home Grown Country Music Festival on Saturday, September 12 with headliners Parmalee. Tickets (*festival and camping*) are available through Eventbrite.com. 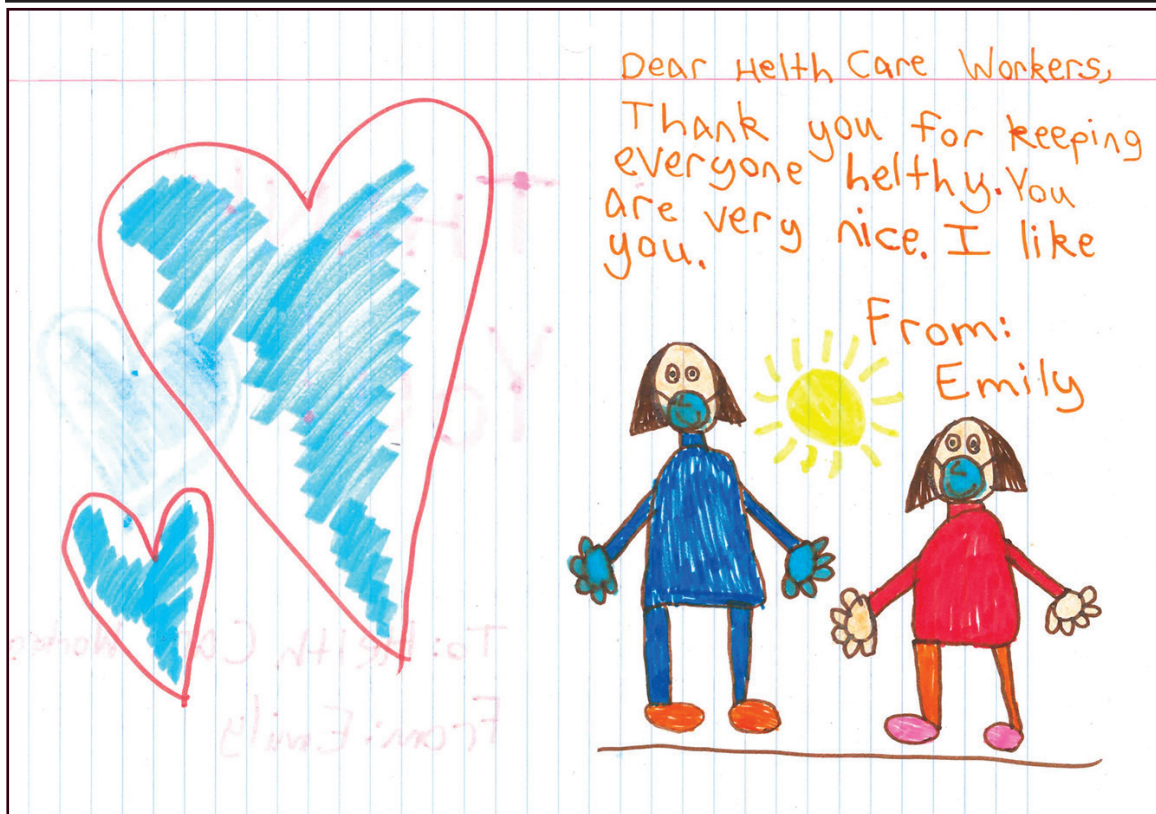

COVID-19 Case in GV School Community

Garden Valley School District Has its First Case of COVID-19 among the School Community

GARDEN VALLEY -- The Central Health District (CHD) of Idaho's Public Affairs Officer Christine Myron told the *World* that they are unable to share any additional information in regards to COVID-19 and any school system due to issues of legality. What we do know is that on August 27th CHD sent a letter to the Garden Valley School District confirming that a member of the school community had tested positive for the coronavirus, COVID-19.

A CHD guideline for schools clarifies that the school will 'disseminate a letter to the school community informing them of the situation.' The school nurse Kimberly Kahre, RN, along with Principal Jackie Johnson fulfilled this requirement through an electronic letter sent out on Thursday, August 28, to notify the school community. This letter stated: "The individual was not at the school at any time that students were in class." Ms. Kahre further explained that the school will be following protocol which includes notifying any individuals who may have been in contact with the infected individual and that those people will be under quarantine until it is evident if the virus was transmitted to them as well.

The CHD guidelines for schools begin with identifying anyone who may have been in close contact with a confirmed or suspected COVID-19 case. Close contact is less than 6 feet for more than 15 minutes. The CHD and the school will then, in collaboration, notify close

contacts and provide instructions for staying home and self-monitoring for symptoms. The school letter mentioned that all of the people that had been in close contact with the infected individual have already been notified. An attempt was made to contact Garden Valley School's Principal, Ms. Jackie Johnson, in regards to this, however we received no response.

Boise National Forest Road Closures



Forest road 384 "Edna Creek" will be temporarily closed Sept. 9-Oct.2

Idaho City, Idaho, August 27, 2020 – The Boise National Forest is temporarily closing National Forest Systems (NFS) Road 384, commonly referred to as the Edna Creek road, from Sept.9—Oct.2 to replace culverts and perform much-needed road maintenance. The Idaho City Ranger District was awarded a Federal highways administration grant to improve the road system and update infrastructure that has exceeded its life span.

"We have a real opportunity to update our most traveled road on the district, and create additional fish habitat for bull trout," said Brant Petersen, Idaho City District Ranger. "We want to give forest users early notice so they can plan for this temporary closure and access the forest by an alternate route."

A detour around the closure will be via NFS road 327 "Granite Creek" road to access the North Fork of the Boise River, and the town of Atlanta (see attached map). Several ki-

osks and signage will be placed out on the ground at major intersections to inform users of the temporary closure.

There will be a full road closure starting Wednesday September 9, 2020 at 7 a.m. until Friday October 2, 2020 at 5 p.m. During this time there will be no access to trails or campgrounds, however the Edna Creek Campground will remain open.

The Beaver/Edna sub-watershed is within a key bull trout recovery area. Habitat connectivity is a crucial factor in ensuring long-term sustainability of fish populations which are an essential aspect of an overall healthy forest ecosystem. Project efforts will improve drainage and reduce erosion and direct sediment delivery to bull trout habitats, while improving driving conditions for all forest users. This is the first phase of the infrastructure improvement project. "The Idaho City Ranger District was fortunate to be awarded this funding, the reconstruction work accomplished over the next two summer seasons will result in real improvement that travelers will appreciate for years to come," said Petersen.

There will be additional road construction and closures during the 2021 summer field season to allow for the road to be resurfaced. While having the

road closed for a period of time is an inconvenience, the project will lead to a better travel experience in the future and an improved fish habitat.

Road Closures: A temporary area closure is in place for fire-fighter and public safety during wildfire suppression activities through Oct. 1, unless rescinded earlier. With increased fire traffic, please avoid NFS roads 447, 414, 414A, 414A1, 414B, 414C, 448, 448C, 440, 440A, 451, 416W and NFS trails 089, 088, 075, 090, 081, 087, 097, and 297.

Winds over the weekend increased the fire activity. Cooler temperatures, some moisture and cloud cover have helped, but the fire presently has zero percent containment and is burning in dead timber, headed towards the Frank Church River of No Return Wilderness. Fire official are in discussions with the Salmon-Challis National Forest, coordinating with those from the Boise National Forest.

HORSESHOE BEND -- The Horseshoe Bend Varsity Volleyball team traveled north on Friday, August 28 to take part in a tri-match against the Salmon River Savages and the Castleford Wolves. Match number one had HSB defeating fellow Long Pin Division members Salmon River 27-25, 27-25.

Statistical standouts in the game were Senior Natalie Newell with 12 digs (passing a spiked or hard hit ball), 2 kills (an attack on the ball which is not returnable by the opposing team), and 1 assist (pass, set or dig ball to another player who gets the kill). Freshman Annelie Wilson making her debut as a varsity Mustang had 11 kills, 11 digs, and 2 aces (a serve which is unable to be played or returned by opposing team). Another freshman debutant, Abby Howerton, had 6 digs, 2 aces, 2 kills, and 1 assist. Junior Emily Shook was in for 4 digs, 2 aces, and 1 kill. Junior Lexi Roberts hustled up digs while junior classmates Kloe McReynolds had 3 kills and 2 digs, and Kenzie Renfro had 4 kills, 3 digs, and 1 ace. Another freshman standout

was Torey Tschida with 21 assists, 3 digs, 2 kills, and 1 ace. Match up number two against the Castleford Wolves put the Mustangs 1-1 for the day, losing 25-19, 25-23. Newell came out with 8 digs, 1 kill, and 1 assist. The freshman showed up with Wilson contributing 7 kills, 5 digs, and 2 aces, Howerton had 6 digs, 2 kills, and 1 assist, Tschida had 10 digs, 6 assists, and 2 kills, and Alaina Rane provided 1 dig. Shook had 1 kill, McReynolds put up 5 assists, 3 kills, and 1 ace, while Renfro was in with 3 digs and 1 kill.

The team plays at home on Tuesday, September 1st against Ambrose, they travel on Thursday, September 3 to Salmon River for a conference game with the Savages (6:00 p.m) and they're in Nampa at Liberty Charter on Thursday, September 10 (JV 6/Varsity 7:15)

Chainsaw Artist in Crouch

CROUCH -- Tom Wence, owner of "Tom's Tree Creations," started out twenty years ago as a helicopter logger. When logs are available to be cut, but the terrain prevents transporting them out by truck, helicopters can be used to harvest the timber. The helicopter drops a cable that is then connected to choker cables. Loggers on the ground, like Tom, hooked the trees to the helicopter. Through this work, he met the man who was to become his teacher and mentor, Blain Smart. What was once work evolved into his passion for woodwork.

Wence continued his education, studying Fish and Wildlife Management at Hocking College. Eventually, he qualified for a Public Works license and worked with the Idaho State agency, thinning trees in Pioneerville.

In his spare time, Wence honed his skills and techniques in woodworking, exploring the use of wood as a home builder and a carver. Through the learning process, cutting firewood for campers and homeowners, Tom Wence moved on to using his chainsaw as something of a sculptor's tool.

This creative artist has a business located in a perfect lit-

tle corner of Crouch. The man behind "Tom's Tree Creations" has become something of a local celebrity. As you drive through Crouch, you'll see his wood shop. A canopy covering provides a little shade and protection from the sun, and also defines a perfect outdoor studio where he creates. Nestled in the sawdust that covers the ground are his forest sculptures and the pieces he sells. You can watch as he seems to uncover characters from a bland piece of wood.

You can try to catch him early, if you want one of his iconic "heart bears." *They sell fast*, so keep your eyes open as

you drive by. Keep looking as you drive through the Garden Valley area, because there are entire heart-bear families and other pieces that have found joyful homes on porches and in yards.

Tom Wence says he enjoys living in Garden Valley, working with real wood, and doing real work. You won't find anything plastic for sale in his store or on his site. He trusts the integrity of the wood to reveal the character that hides inside. It's his job to bring it out. Once he sees it, he carves it out with a chainsaw. Along with his trees, he has carved

himself a life worth living. His two daughters, Katy, (16) and Madeline (3 1/2) are a big part of that life. He is grateful for the opportunity to be close to them.

Who: Youth from Elmore, Ada, Canyon, Owyhee, Gem, Boise, Payette, Adams, Valley, or Washington counties with previous riding experience.

What: A series of Sunday afternoon clinics providing hands-on experience handling, understanding, and roping cattle along with western horsemanship.

How: Youth new to the program must attend a mandatory orientation, pass a riding evaluation and enroll in 4-H to participate. Youth must attend Sept or Nov clinics to continue in Jan-May. All youth participants must wear an ASTM-SEI approved helmet when mounted. **All horses used in the project MUST have a negative Coggins test PRIOR to attending the mandatory orientation/riding evaluation.**

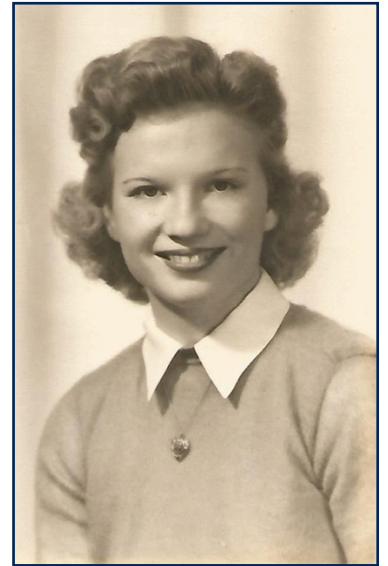
In retirement, Inie enjoyed traveling with Jack in their motorhome. She was a collector of things, including Liberty Bells, turtles, Native American art,

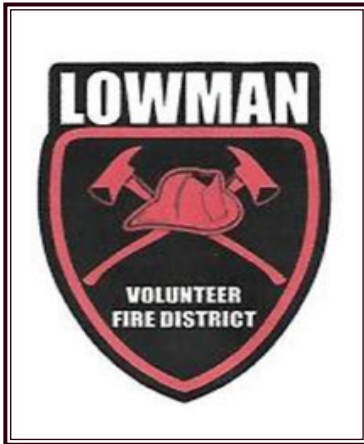

Idaho City Historical Foundation Makes the Best of the Pandemic Summer

IDAHO CITY -- The COVID-19 pandemic has had a dramatic impact on tourism throughout the world, and Idaho City is no exception. It caused the Idaho City Historical Foundation to cancel its summer fundraising festivities and to decrease the amount of days the Boise Basin Museum is open. Regardless of the financial impact, ICHF has a responsibility to maintain the preservation of more properties and historic structures than most other historical societies in Idaho.

"Our historic buildings, grounds, and parks must be protected and preserved, even during these troubling times," said ICHF Buildings and Grounds Committee Chair Barbara McClain.

Usually, the ICHF benefits from a spring crew of South Idaho Correctional Institution (SICI) inmates who come up every year to Idaho City for two weeks of labor to support preservation of the buildings. This year was an exception.

"Because of the pandemic, we did not receive our usual great crew of inmates to support our work," said ICHF President Beth Wilson. "We had to improvise with limited funds and rely more on the sup-

port of our local volunteers."

Thanks to a special grant from the Idaho Humanities Council and another from the Idaho Heritage Trust, the ICHF has applied wood preservative to all interpretive buildings and structures and more.

"We've been mowing, watering, weed-wacking, and caring for all of our properties as we normally would, despite the lack of usual revenue, including: the John Brogan Park, The Naylor-Little Park, Smoke Jumpers' Park, all the flower tubs, as well as the fire-wise Veterans Park and the historic portions of the Pioneer Cemetery," McClain said.

One of ICHF's most ambitious projects this summer involved installing a sprinkler system and pea gravel paths in the Smith Gardens, which are next to the historic Strauss House on Montgomery Street—the future home of the "Kenn Smith Wild-Fire Museum."

"It was an amazing effort," McClain said. "We accomplished it all in just a few weeks, thanks to Idaho City volunteers led by Dale Keleman with Chris Juszcak, John Roberts, Barbara McClain, Wayne Bushnell, Kurt Gindling, Linda Strohmeyer, Charlotte Watson, Lorie Keener and

Luke Longden. Many thanks with sprinkler system parts donated by HD Fowler and Tyson Stewart, and to The Springs for labor and materials."

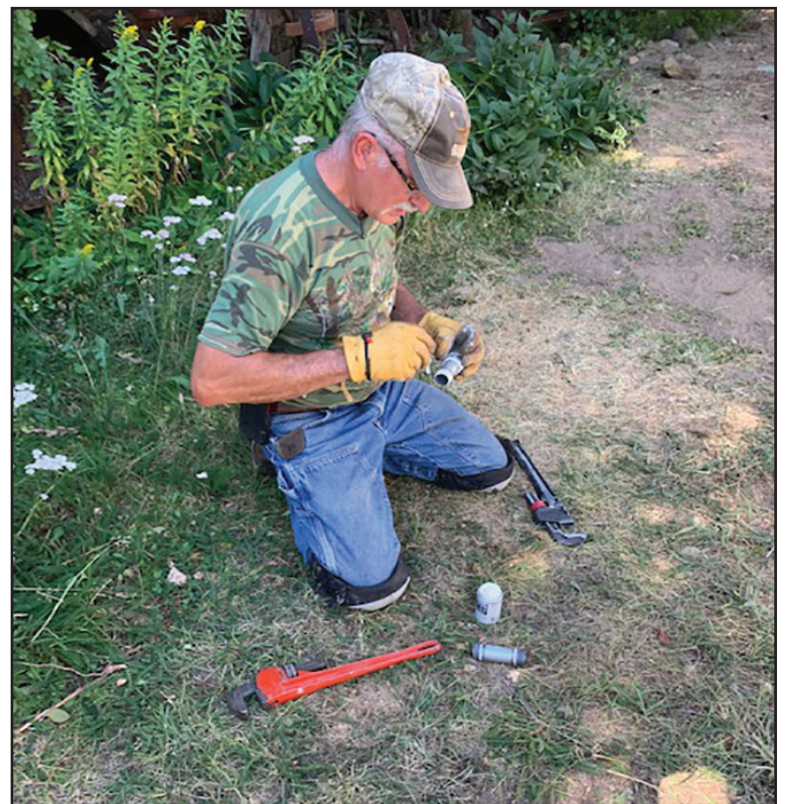
Thousands of tourists annually come to Idaho City to experience gold-rush history, and the Idaho City Historical Foundation does its part to tell that story, funded by ICHF memberships, donations, grants, museum admissions, and fundraising.

"The ICHF board can only accomplish so much on its own," said ICHF board member Linda Strohmeyer. McClain concurred.

"Because of the pandemic and the loss of the SICI crew we were behind the 'eight ball,' but the community and ICHF members stepped up and turned our challenges into a great season of completed projects," McClain said.

ICHF President Beth Wilson agreed.

"Earlier this year, who knew what we would be up against this summer," Wilson said. "We can't thank our membership, donors, the Idaho Humanities Council, the Idaho Heritage Trust, and the community enough for helping us meet the challenges of 2020."
