Lockdown Incident at Garden Valley School


BOISE COUNTY -- Tuesday October 6, 2020 at approximately 4:30 pm. a lockdown occurred at Garden Valley Schools. Boise County Sherriff Scott Turner stated that a man who was apparently suffering from psychosis parked his truck in the parking lot at the

Garden Valley School and began panicking, stating that his truck was 'going to blow.' The school was not in session at the time, though there were still several students and faculty on the premises. As a precautionary measure the school immediately initiated a lockdown. The School Resource Officer

(SRO) Deputy Josh Ward was on school premises and immediately notified dispatch to request back up. Deputy Josh Ward said that the man first spoke with a parent outside. That parent immediately informed school staff. The man was able to enter the school for a brief time. He then ran to

the nearby Chevron Station in Garden Valley. Boise County Sergeant Dave Anthony was able to apprehend the man at the Chevron approximately 15 minutes after the call for assistance went out. The man (who was not from Garden Valley) was extremely disorientated and confused. He was placed in an emergency hold for evaluation due to a mental illness crisis. His vehicle was searched and it was determined that no explosives existed. The vehicle was towed and the school resumed normal activities.

Sheriff Turner explained that all of the Boise County Schools have a lock down procedure in place in case of emergency. The school plans ahead and has practice drills with their School Resource Officer to ensure everything is done properly. A school lockdown is a procedure that is initiated when school officials believe that there may be a threat to student or staff safety. "The the SRO was a huge asset being at the school when the incident occurred," Sheriff Turner said. "If the SRO hadn't been at that school, response time could have been

delayed up to possibly 20 minutes depending on where the closest deputy was. The rolls SRO's play and the benefit to the schools and safety is huge."

Lockdowns can be used to protect students from any form of violence either at the school or nearby. Some schools also use the procedure if a national disaster has been declared.

Quick action by a parent, our Boise County Sheriffs, and Garden Valley School staff prevailed in this instance. The man received the assistance he needed and no one was injured.

earching for Bodies?

IDAHO CITY -- Federal officers, top Idaho State Police investigators, and local law enforcement were searching the land behind the former Idaho City resident, Michael Dauber. He was previously convicted in 2016 of killing two men and dismembering their bodies, sentencing him to life in prison. However, he would have the opportunity to come before the parole board in 2033.

According to a credible source, intel from Dauber, 52, indicated there was another body in the overgrown area behind the cabin. Officers, dressed in plain clothes, cleared the area of brush and smaller trees with a backhoe, used metal detectors, and placed a number of yellow flags in areas that pinged. However, nothing of significance was said to be found.

Mike's father, William "Billy" Dauber, had ties to the Chicago mob and was suspected to have been a notorious hitman. Billy

was gunned down while in his vehicle, after leaving the courthouse and testifying as an informant against colleagues in 1980.

regarding the security features surrounding an absentee ballot. In our current environment, there are many concerns about the security of our elections, especially regarding absentee voting. Our office takes the election process, for every election, very seriously. I hope to provide insight on the security features that exist with an absentee voter's ballot and ease the mind of the public. Here is the breakdown on what you will receive when you have re-

quested to vote absentee, and how we secure your privacy and your vote:

Absentee Ballot - each ballot contains security measures This week's information is to differentiate it from an "unofficial" ballot. Boise County is a paper ballot, hand count, county. Your ballot is assigned a unique number within the voter registration system. Finally, we do not identify your party affiliation on any of the absentee ballot components.

> **Secrecy Envelope** – this is the gold-colored envelope that is provided with your absentee ballot mailing. Your voted ballot is to be folded, placed in the gold secrecy envelope, and sealed. The purpose of this

envelope is to ensure that your voting choices remain unseen when your ballots are returned.

Ballot Return Envelope:

Your name is pre-printed on the return envelope.

Return postage has been included on the envelope.

A unique barcode is assigned to your voter record and is printed on the return envelope.

Your signature is required on the return envelope. Once received in our office, we validate your signature with the signature in your voter file. The signature in your voter file is from your voter registration document.

ELECTION REMINDERS Absentee Ballot Request - we must receive your absentee ballot request by 5:00 p.m. on Friday, October 23rd. A postmarked date of the 23rd will **not** be accepted.

Early Voting – in-person absentee voting will take place at the Boise County Clerk's Office, October 19th through October 30th, between the hours of 9 a.m. and 4 p.m., located at 420 Main Street, Idaho City.

In-Person Voting Novem-

ber 3rd - our polling locations will be open from 8:00 a.m. to 8:00 p.m. on election-day, November 3rd. You will need a valid photo identification card to vote on November 3rd. You may register to vote on election-day, November 3rd, by bringing your valid photo ID **AND** proof of residence. If you are unsure of your polling location, please contact the Boise County Clerk's Office.

Horseshoe Bend vs. Garden Valley

-- The Horseshoe Bend Varsity Lady Mustangs played host to 1A Long Pin Division II rivals, the Garden Valley Wolverines, losing the first game 22-25, the Mustangs rallied to win 25-11.

Contributing to the win was freshman Annelie Wilson with 22 kills (an attack on the ball which is not returnable by the opposing team), 1 ace (a serve which is unable to be played or returned by opposing team), 5 blocks (blocking the ball into the opponent's court leading to a point or side out), 18 digs (passing a spiked or hard hit ball), and 1 assist (pass, set or dig ball to another player who gets the kill). Junior Kloe McReynolds had 7 kills, 5 aces, and 6 digs. Junior Kenzie Renfro put up 6 kills, 5 aces, and 7 digs, while freshman Abby Howerton had 3 kills, 1 block, 13 digs, and 32 assists. Senior libero Natalie Newell had 1 kill, 31 digs, and 3 as-

sists, (The libero is a player 23-25, 14-25) on Thursday, specialized in defensive skills: the libero must wear a contrasting jersey color from their teammates and cannot block or attack the ball when it is enon Tuesday, October 6. After tirely above net height. When the ball is not in play, the libero can replace any back-row the next three 25-18, 25-21, player, without prior notice to the officials).

> At home again on Wednesday, October 7th, the Lady Mustangs took on the Nampa Christian Trojans in a nonconference game. Horseshoe Bend took the loss in a three game match, 21-25, 21-25, and 17-25. Stat leaders were Wilson with 14 kills, 1 block and 8 digs, Renfro with 5 kills, 1 ace, and 13 digs, Howerton had 2 kills, 1 ace, 10 digs, and 20 assists while freshman Torey Tschida came up with 1 ace, 13 digs, and 20 assists. The Lady Mustangs then traveled up north to Midvale on Friday, October 9 for a 1A Long Pin Division II conference game against the Tri-Valley Titans. After falling to the Titans at home (23-25, 25-14,

September 24 the Mustangs were looking to come back with the win but they fell short to Tri-Valley going a full set with the Titans, 25-20, 23-25, 25-21, 13-25, 12-15 and putting their conference record at 7-2 for the season. Statistical standouts in the match were Wilson with 30 kills, 2 aces, 1 block 32 digs, and 3 assists. Renfro had 13 kills, 4 aces, and 9 digs. Howerton came out with 2 kills, 14 digs, and 42 assists while Tschida had 39 digs and 5 assists. Libero Newell had 33 digs.

The team is 11-5 overall for the 2020 season. The Mustangs will make their last home appearance on Thursday, October 15 against fellow Long Pin Division team the Cascade Ramblers. The first game is at 7:15 p.m. The 1A Long Pin Division II District Tournament begins on Saturday, October 17 at Meadows Valley High School in New Meadows. Game times will be announced after regular season play is completed.

March for Peace Begins in Garden Valley

GARDEN VALLEY -- A group of Garden Valley residents are heeding Evangelist Frank Graham's call for peace by symbolically joining with him to show their support. In Washington, D.C., marchers paraded 1.8 miles from the Lincoln Memorial to the U.S. Capitol. Here in Garden Valley, an ecumenical group of Christians marched from the Church of Jesus Christ of Latter-Day Saints to Weilmunster Park. In this way, the Garden Valley group symbolically became part of the "Call for Peace" and helped to build bridges across the nation.

About twenty Garden Valley participants of all ages (one was only two years old) took part in the local march. Several participants carried signs calling for peace, or United States red, white, and blue flags. One marcher carried a sign reminding us of a favorite Biblical text, John 3:16, a reference to The Holy Bible, which reads: "For God so loved the world, that he gave his only begotten Son, that whosoever believeth on him should not perish, but have eternal life."

When the marchers gathered at the Church of Jesus Christ of Latter-Day Saints they were greeted with pouring rain that threatened to drench them before they even started. As they were gathered and were ready to begin, the rain suddenly stopped. The lull in the storm lasted all the way to the park, and the downpour resumed as soon as they were under cover at the park. The walk included periodic stops for prayer that focused attention to the issues that were especially meaningful to Garden Valley residents. Some of the topics included were the pandemic, continued religious freedom for all, racial understanding and acceptance, abortion, and support for our elected leaders.

The group plans to continue their support for this march by holding other marches at regular three-month intervals throughout the year.







Ann Finley 1931 - 2020

Patricia Ann Finley passed away peacefully at her Boise home surrounded by a small group of friends on August 18, 2020.

Ann was born June 27, 1931 in San Francisco, the only child of Robert and Sarah ("Sally" McNally) Finley. She attended schools in Piedmont and Oakland, California; Salt Lake City; and Boise; graduating from St. Teresa's Academy in 1949. In her late 50s and early 60s, she attended and graduated from Boise State University.

Ann was devoted to her parents, living with them most of her adult life except for a semester teaching English at the Holy Rosary Mission (now the Red Cloud School) on the Pine Ridge Reservation in South Dakota, and during Peace Corps training (plans to serve in Latin America fell through). She had fond memories of life on "the ranch" in Peaceful Cove (up Stewart Gulch in the Boise Foothills), where her family moved in '51 or '52.

She discovered her love of writing very early. By age 11, she'd already had a short story published in the Aunt Elsie

Magazine of the Oakland Tribune. In her later years, she described herself as a writer and independent journalist.

Ann also loved to sing, which was how she met her long-time friend and voice teacher Deanna Pond. Deanna and her husband Gilbert have always been there for Ann, especially during her final months.

Throughout her life, Ann was generous with her time and her talents, serving as a volunteer supporting wolf recovery, refugee resettlement, Idaho Mountain Search & Rescue, Doctors without Borders, and charities focused on repairing cleft lips and palates in children.

Ann was a remarkable gal, fiercely independent and with a lot of spunk. At 88 and no longer licensed to drive, she walked everywhere. She went to the Bistro for a meal and conversation almost every day. On Wednesdays, she met there with a group of like-minded folks to discuss current events.

Another long-time friend, Debra Riedel, sent Ann a note saying she'd like to see her. Two weeks later, Ann turned up at Deb's office, having walked downtown from her home in the Collister neighborhood. Ann refused the offer of an uber home, saying she'd rather walk.

After getting cash at the bank at 36th & State, Ann would often stop in to visit with Jackie and Jason at Aloha Auto Repair, who'd kept her Subaru running like a top and who always had a cold bottle of water handy for her. Ann had her own way of doing things, and in spite of repeated hints from Jason to stop riding the clutch, repairing the clutch had been an annual event.

Ann loved animals, especially German shepherds and horses (cats, not so much). One of her favorite pastimes was riding in the forests around her family's property near Pioneerville. That happy smile in the photo is because she was leading a horse, surrounded by pine trees, and there was undoubtedly a German shepherd just out of the frame.

Her dad died in 1983 at age 83. Ann cared for her mom until her death, aged 84, in 1992. She was also preceded in death by countless beloved German shepherds and horses.

She leaves behind her young black German shepherd mix Bravo, little black mare Velvet, and a number of supportive friends who are very grateful to Jazzmin, who made it possible for Ann to remain at home during her final months, to Michelle (Ann accepted new carers because we said they were your friends!), Ilena, Karrie, and Tiffany from Treasure Valley Hospice, and Pam, Christelle, Cora, and LaBrenda from Home Watch, who provided kind and gentle care during Ann's final days.

Although Ann had traveled the world, she wanted her ashes scattered in the Idaho backcountry. At her request, no services will be held.

[Ann was a good friend to Xinia Jones in Placerville. As young girls, during the summer months, the two would often go flower picking and then bring them back for Xinia's mother to arrange in vases.]

unteer based rural EMS agency which is part of a much larger Emergency Response System including local and regional Dispatch, Law Enforcement, multiple Fire Departments & County Emergency Management, along with other various Advance Life Support Agen-

Our agency provides Basic Life Support emergency transport services to several areas within Boise County. There are currently ambulances staged in Lowman, Idaho City, Placerville, and the Mores Creek

As Boise County continues to grow we have seen an increase in residents and visitors to our community, which as expected has resulted in an increase in call volume. Due to the recent pandemic, we have also seen a significant decrease in volunteer responders. In 2019 East Boise County Ambulance responded to 356 calls within its district. So far, 2020 has seen a 23% increase in call volume and due in part to the

current pandemic a 60% decrease in experienced EMT's while still providing 24 hour a day coverage.

As the community continues to grow, EMS services must grow as well to ensure the health and safety of those we serve. In the weeks to come, we will be advertising for a third paid EMT/Training Officer position. Utilizing this new position, our goal is to advance our training to be able to provide a higher level of care to our patients and to pursue a financial pathway for future growth to include grants, fundraisers, and other possible avenues for revenue with the goal of supporting further paid positions within the agency and increasing staff capabilities.



One amendment to the Idaho Constitution will appear on the November 8, 2016 General Election ballot. The amendment has been proposed to the people for ratification following action by the legislature. The proposed amendment, the Legislative Council's Statement of Meaning, Purpose and Result to be Accomplished, and the Statements For and the Statements Against are listed as follows:

HJR 5

Text of Proposed Amendment

IN THE HOUSE OF REPRESENTATIVES HOUSE JOINT **RESOLUTION NO. 5 BY STATE** AFFAIRS COMMITTEE

A JOINT RESOLUTION PROPOSING AN AMENDMENT TO ARTICLE III, OF THE CONSTITUTION OF THE STATE OF IDAHO, BY THE ADDITION OF A NEW SECTION 29, ARTICLE III, OF THE CONSTITUTION OF THE STATE OF IDAHO, RELATING TO THE LEGISLATIVE RESPONSE TO ADMINISTRATIVE RULES: STATING THE QUESTION TO BE SUBMITTED TO THE ELECTORATE: DIRECTING THE LEGISLATIVE COUNCIL TO PREPARE THE STATEMENTS REQUIRED BY LAW; AND DIRECTING THE SECRETARY OF STATE TO PUBLISH THE AMENDMENT AND ARGUMENTS AS REQUIRED BY

Be It Resolved by the Legislature of the State of Idaho:

SECTION 1. That Article III, of the Constitution of the State of Idaho, be, and the same is hereby amended by the addition thereto of a NEW SECTION. to be known and designated as Section 29 Article III of the Constitution of the State of Idaho and to read as follows: **LEGISLATIVF** 29.

SECTION RESPONSE TO ADMINISTRATIVE The legislature may review RULES. any administrative rule to ensure it is consistent with the legislative intent of the statute that the rule was written to interpret, prescribe, implement or enforce. After that review, the legislature may approve or reject, in whole or in part, any rule as provided by law. Legislative approval or rejection of a rule is not subject to gubernatorial veto under section 10, article IV, of the constitution of the state of Idaho.

Ballot Question

"Shall Article III, of the Constitution of the State of Idaho be amended by the addition of a new Section 29, to provide that the Legislature may review any administrative rule to ensure it is consistent with the legislative intent of the statute that the rule was written to interpret, prescribe, implement or enforce; to provide that, after review, the Legislature may approve or reject, in whole or in part, any rule as provided by law; and to provide that legislative approval or rejection of a rule is not subject to gubernatorial veto under Section 10, Article IV, of the Constitution of the State of Idaho?".

Legislative Council's Statement of Meaning, Purpose, and Result to be Accomplished HJR 5

The Legislature writes the laws of the state under which the state agencies adopt agency rules. By statute, 1. agencies make rules that only interpret and implement these laws, and the legislature reserves the authority to review and reject agency rules if a rule is contrary to the intent of the law.

The Legislature's ability to approve or reject agency rules is an important aspect of the separation of powers, because these rules have the force and effect of law. The Legislature currently oversees that rulemaking process by accepting or rejecting agency rules. The proposed amendment confirms and protects the Legislature's practice to authorize agency rulemaking, and to accept or reject agency rules.

Legislative Council's Statements FOR the Proposed Amendment

1. The proposed constitutional amendment safeguards the ability of the legislature - elected by the people - to review and reject agency rules created by unelected state officials if those rules conflict with legislative intent. This will protect Idahoans from unfair or over regulation.

The legislature's current ability to review agency rules is in the law. Idaho's Supreme Court previously held that statute valid, a future supreme

court could potentially declare it invalid, because Idaho's Constitution does not expressly recognize the ability of the legislature to review agency rules. The proposed constitutional amendment would protect the legislature's authority to ensure that agency rules conform with legislative intent.

3. If a future court determined the legislature did not have the right to review and reject agency rules. then Idahoans would have to hire lawyers and file lawsuits to challenge agencies' rules. That would be a much more expensive and time-consuming process than the current system which this amendment proposes to protect.

4. A Governor's veto is not required, because agency rules are proposed by the Governor's departments and

Statements AGAINST the Proposed Amendment

This constitutional amendment is unnecessary because the legislature already has legal authority to review agency rules. Even if the legislature did not have this authority, sufficient methods of challenging agency rules exist: the legislature can pass a law limiting an executive agency's rulemaking ability, or a rule can be challenged in court.

2. The legislature is overly involved with state agencies when it examines their rules to see whether they conform to legislative intent, and that practice should not be in Idaho's Constitution. Legislative review of agency rules is time-consuming and makes it more difficult for state agencies to conduct day-to-day business.

The legislature responds to agency rules in different ways. One way is to pass a bill, which it does every year to extend the agency rules from previous years. The proposed constitutional amendment would prohibit any veto of a rule approval or rejection and would infringe on the Governor's right to veto bills under the Idaho Constitution.



Emergency Manager's Corner By Bob Showalter

BOISE COUNTY -- First Responders are sometimes delayed in reaching patients because the residence they are responding to does not have visible and/or reflective house numbers. Some numbers are not reflective and cannot be seen easily at night. Other numbers are just plain worn out. Some "overmatch" grant money was allocated to the county from the Idaho Office of Emergency Management for last year, and would normally go into the county's "general" budget. However, with no strings attached for this money, the Boise County Emergency Manager asked the Boise County Commissioners (BOCC) if that \$7,400 dol-

lars could be used to purchase house numbers and the backing boards they attach to for residents in Boise County who would otherwise not have the financial means to obtain them. The BOCC agreed and the purchase was made for 4,000 numbers, 0 through 9. If you are in need of house numbers, you can go to the Planning and Zoning Department in Idaho City (413 Main St, Idaho City, ID 83631), the Horseshoe Bend City Hall (112 Ada St., Horseshoe Bend, ID 83629), or the Garden Valley Fire Department (373 Middlefork Rd, Garden Valley, ID 83622) located in Crouch. For accountability reasons, you will be required to fill out a form with your name, address, and signature. You may only obtain one set of numbers for each address. These num-



bers will only be given out for single family residences that are occupied. You cannot get numbers for camp trailers or other dwellings if they are not in an approved park or private property, with approved septic and electrical service. You also may not get numbers for a structure that was built without an approved building permit. These numbers are a one-time opportunity, so pick one up before they are all issued out.




