Trapped in a Vehicle in Grimes Creek

EAST BOISE COUNTY -- A call went out to the Clear Creek Volunteer Fire Department at 5:26 AM on Sunday morning, October 25th, reporting a one-vehicle rollover on the Grimes Creek Road. Firefighter Marvin Jennings was first on the scene. Seeing the lights from the vehicle down the embankment and across the creek, he began calling out to see if he could get a response, all the while racing to get across the water to the mangled truck on its top. When he reached the driver, he observed that the man was trying to keep his head out of the freezing cold water by lifting it as much as he could, his legs and feet submerged. Jennings helped prop the injured man's head on a rock, held the man's hand, and reassured him that help was on the way, letting him know that he could see flashlights up by the road.

Aaron Gross of Eagle was trapped and Wilderness Ranch Fire was dispatched to help with extrication. Due to the extent of the vehicle damage, the large tools could not be used, so hand tools were utilized to loosen the man from the wreckage of a red 2020 GMC Sierra truck. A non-motorized boat was affixed with ropes and a pulley system to bring medical personnel and extrication tools to the patient.

Emergency Manager Bob Showalter recounted the experience: "EBCAD Unit 15 with Pat and Cheryl Mento arrived on scene and they too crossed the creek,

getting completely wet from the waist down. Once by the patient, Cheryl did an assessment and provided care. Wilderness Ranch Fire arrived on scene and in complete darkness, with only headlamps, deployed a generator and extrication equipment. Volunteers forged the freezing water carrying the heavy extrication equipment to the truck on the other side of the creek to start cutting the vehicle open to rescue the driver. Many volunteers started showing up from both departments to assist. The driver was removed from the truck, secured to a backboard, and transported by small boat to the other side of the creek. Several volunteers helped lift up the patient up a steep embankment to the road where he was transported to the Air Saint Luke's helicopter."

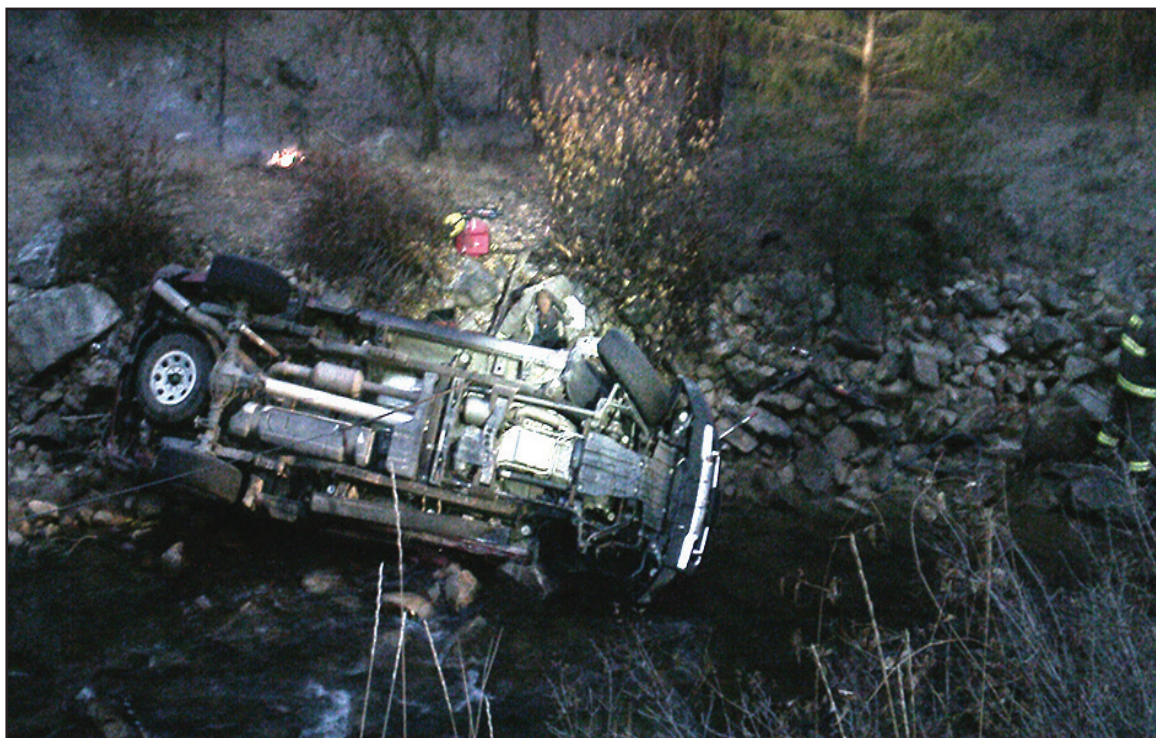

EAST BOISE COUNTY -- Early morning Saturday, a couple of hunters were headed northbound on Highway 21 in a pickup pulling a toy hauler camper when they noticed that the trailer had caught fire near Grimes Creek Road. A firetruck was located about a half mile away from the incident, so firefighters were able to respond quickly. However, it did not take long for the trailer to become fully engulfed in the center portion, The hunters were able to

save their ATVs and motorcycles from the rear of the trailer, as well as propane bottles from the front. The heat had reached the front of the trailer and they were unable to disconnect the pick-up from the trailer, but, with the fire truck, the Wilderness Ranch volunteer firefighters were able to saturate the flames so that the pickup could be safely disconnected. Although the trailer was a total loss, the owner was very appreciative, his toys and pickup were saved, and the trailer was insured.

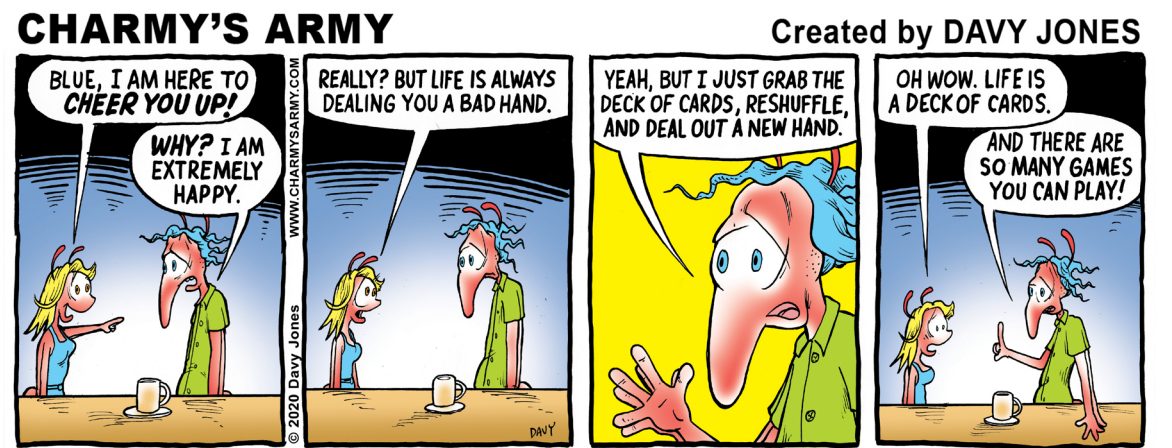
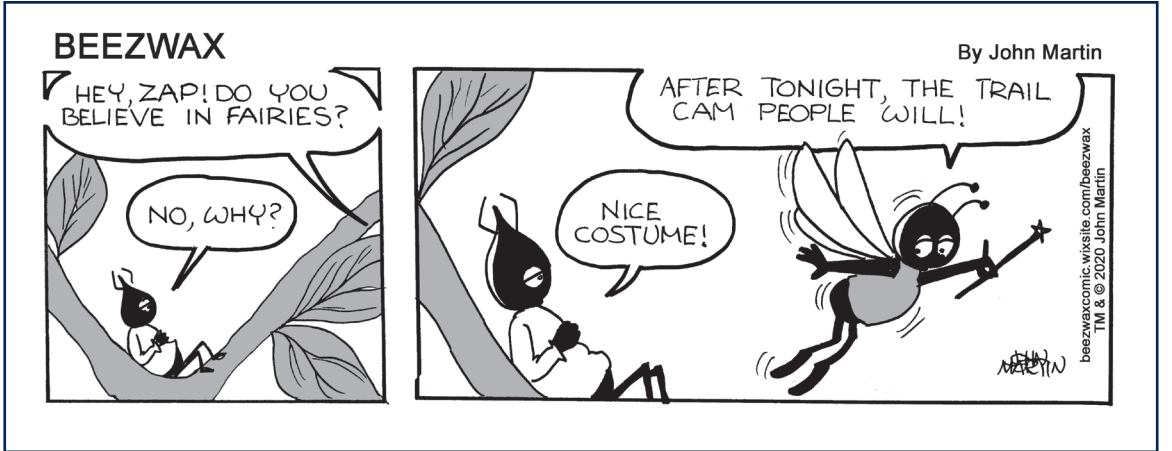
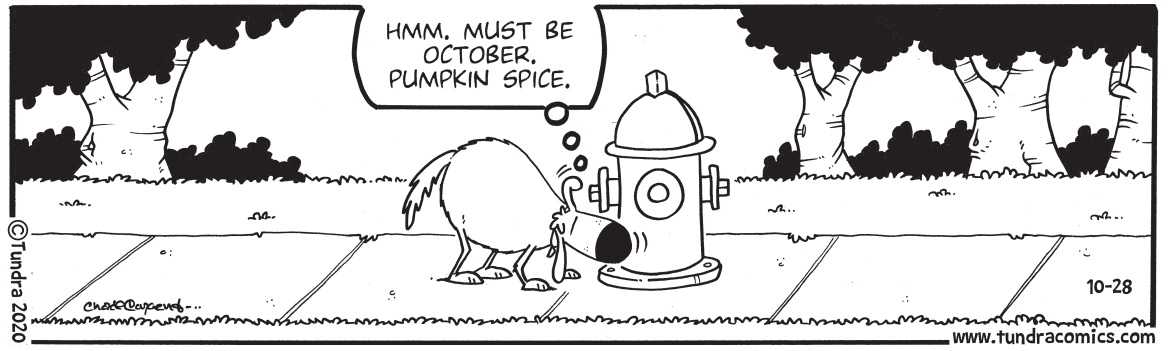

Outdoor Learning and Stolen Zipline

IDAHO CITY -- Basin Elementary was getting ready for their big outdoor learning day only to discover that their zipline had been stolen from the ICOE property. This activity was the highlight for Basin students. They were really disappointed when they heard that it was gone. If anyone has any information on the stolen zipline, please contact the district or law enforcement. The students would be extremely grateful to be able to zipline again.

As in true Basin fashion, students and teachers pushed on anyway, still having an awesome experience with their outdoor adventure. Grades kindergarten through sixth grade arrived at the ICOE property with their goals of academic engagement with nature, physical recreation, and service to the property on their minds. The most popular activity this time was focusing on force of motion by building catapults with the natural materials around them. Kindergarten, second, and third graders then launched anything from pinecones to rocks to apples into the sky. First grade spent their time talking about cardinal directions, what to do when you get lost in the forest, and the concept of animal camouflage. Students hid their camouflaged paper moths around the forest for others to locate them. Fourth grade looked at the structures of plants around the forest. Fifth graders were making observations on our watershed area and the health of it. Sixth graders became adventurous explorers when they charted out new territories by making maps and completed a scavenger hunt on animal tracks. Recreation ranged anywhere from building shelters, making nature bracelets, completing charcoal landscape sketches, competing in tug of war, to playing a predator/prey hide and seek game. Most of the students ended their day by helping out around the ICOE by picking up trash or clearing paths. Hopefully, the zipline issue can be resolved by the time spring rolls around so that they can once again enjoy flying through the trees. For now though, they are gearing up for some amazing winter outdoor activities!

LEGAL NOTICES

Amendment Number and Question HJR4

Shall Section 2, Article III, of the Constitution of the State of Idaho be amended to require that the Senate shall consist of thirty-five members; and shall Section 4, Article III, of the Constitution of the State of Idaho be amended to require that the Legislature shall be apportioned to thirty-five legislative districts?

Legislative Council's Statement of Meaning, Purpose, and Results to Be Accomplished

The purpose of the proposed amendment is to permanently set the number of senators in the Idaho Legislature, as well as the number of legislative districts in Idaho, at 35. (There are twice as many representatives as senators, which this amendment would not change.) Since 1992, there have been 35 districts and senators, but the Idaho Constitution permits as few as 30 and as many as 35 districts and senators, with the number determined during redistricting (the process of redrawing legislative district boundaries after a United States census). If this amendment is adopted, the number of districts and senators would be fixed at 35 and could not be changed during redistricting.

Statements FOR the Proposed Amendment

1. Setting the number of districts at 35 would prevent the number of districts from being reduced during redistricting in 2021. If the number of districts is reduced, Idaho would have fewer legislators, meaning that Idahoans would have less representation in the Legislature at a time when the state's population is growing and the Legislature is addressing complex issues related to population growth. With fewer legislators representing more constituents, Idahoans would have less access to their legislators, limiting their ability to discuss

issues of concern with the people elected to represent their interests. Additionally, with more constituents per legislator, legislators might not be able to provide as many individuals with constituent services.

2. Setting the number of districts at 35 and thus preventing any reduction in the number of districts would also keep urban and rural interests in balance. If the number of districts is reduced, rural residents could be added to mostly urban districts, and urban residents could be added to mostly rural districts. This could result in legislators being less responsive to some constituents' interests than others. Furthermore, reducing the number of districts might require districts of great geographical size, which could include many communities that have few interests in common. Large districts might also make travel difficult, and more remote areas of the district could be ignored by legislative candidates during campaigns and by elected legislators who focus on areas where more constituents live. By preserving 35 districts, this amendment makes it more likely that Idaho residents will have representation responsive to their local interests.

Statements AGAINST the Proposed Amendment

1. Redistricting is a complicated process, because redistricting plans must comply with several legal requirements that can be in conflict with each other. For example, districts must be roughly equal

in population, but must also avoid, to the extent possible, splitting up counties and communities - even though some counties and communities have significantly larger populations than others. Redistricting plans that fail to comply with all requirements can be challenged in court. By adding another fixed requirement, this amendment would make redistricting more difficult and might invite court challenges. The commission currently has the flexibility to determine the number of districts within a certain range because it is possible that a plan with 30 larger districts could better satisfy legal requirements than a plan with 35 smaller districts. The commission's flexibility should be preserved.

2. Changes to the redistricting process should be proposed well in advance of a redistricting year, with enough time to consider all possible consequences of the change. This amendment would cause a significant change to be made right before redistricting occurs in 2021 without sufficient time to consider the consequences.

3. Reducing the number of legislative districts would mean a corresponding reduction in the number of legislators. This would reduce the size of the government and could potentially save public funds spent on legislator salaries and benefits.

Horseshoe Bend City Council Meeting

HORSESHOE BEND --

Horseshoe Bend City Council meeting number 687 on October 21, 2020. Councilmember Martye White was not in attendance. After the call to order, Pledge of Allegiance, approval of the agenda, previous minutes, and the authorization to pay the city's bills (Mayor Pat Goff told the council that he had gone over the bills and that everything "looked fine"), Mayor Goff opened the dais for public comments. No one came forward. The council unanimously approved to continue a software agreement for another year with Computer Arts after city attorney Tony Pantera said that he had looked over the new contract and that he "didn't have any problem with it." Alex Lytle who was on the agenda to discuss the development of affordable housing was not in attendance.

Resident Vickie Andra came to the council to discuss a property line issue with a home she is renting in the city. Andra has a horse which is utilized as a service animal and wants allowances made in accordance with the ADA (Americans with Disabilities Act). The property she resides on is .423 acres and the city ordinance regarding horses being kept within the city requires at least .5 acres. Councilmember Curtis Corvinus clarified that it must be .5 acres of bare land, so land covered by a structure should not be included. Andra told the council that a simple fence

line alteration would alleviate the problem, but her neighbor Mrs. Hawkins did not want to change the current fence line thus giving Andra enough property to be in compliance with the city's ordinance. Andra told the city she would like them to grant her a prescriptive easement to Hawkins land. Pantera advised the council that there was a criminal action on the matter. Andra told the council that she sees chickens and goats on properties with less than .25 acres within the city. Andra also requested that the city look into getting its own police force because the "city is growing and the Sheriff's Department can't or won't handle things." She went on to add that she currently has a neighbor that is causing damage to her property and that "this is where people go berserk and do something they wouldn't normally do." Resident Jim Flannery spoke on Andra's behalf, telling the council that the "horse thing should be handled here in town not in Idaho City." Flannery also agreed with Andra's assessment regarding adding a police force to the city stating, "I don't know where we are financially but a lot of people ask me, 'Why don't we have a cop here.'" City grant writer/comprehensive plan reviser Cheryl Pleak advised the council that the city zoning plan says you can't have an animal within 100 yards of a house. Mayor Goff spoke regarding the creation of a city police

force by saying, "We've been looking into that. It would cost the town of Horseshoe Bend an immense amount of money," adding "We're growing but not that fast." Andra's husband Mike concluded by telling the council that people at Valley Christian Community Center come there just to see the horse and that the whole street has signed off on having the horse eat on their properties.

Councilmember Corvinus called for a vote on an amended Burn Ordinance. Pantera had drafted an ordinance that mirrors Boise County's but without the provision for a 5' chimney. Councilmember Ben Riley asked if a 55 gallon burn barrel would meet the NFPA (National Fire Protection Association) guidelines regarding a certified structure. Pantera said he would look into that. Corvinus said that the ordinance was to grant authority to cite people who were burning using "gross negligence." The ordinance

was approved unanimously.

Department updates. EMS spokesperson Michele Brothers said they had 12 runs in September and that 3 EMTs were back with the department. They are currently reviewing the personnel handbook and were moving the ambulance for the winter. Brothers also spoke on behalf of the Public Works Department and told the council that they had purchased an '06 GMC Sierra with 86k miles for Jake to use. The cost was \$14,500. DEQ inspected the sewer plant and she said, "We looked pretty good on that (report)." Water usage is down to the winter usage level rate of 70,000 gallons per day. The department is getting ready to shut down the park restrooms for the season. Pleak reported that the water source grant was fully executed and that fencing would be installed around the water facility in November. Another grant will be used to install comput-

ers and a touch screen system for training and/or meetings. 3 additional grants have been written but not executed. She stated that she had a discussion with ITD regarding new pedestrian crosswalks by the school as well as a rectangular flashing beacon. She indicated that she would be talking to school superintendent Dennis Chesnut regarding the matter. City Engineer Amy Woodruff said they were preparing a preliminary engineering report for the raw water pump station and that the department did an analysis for the former Tamarack Mill property. The sewer main has been installed on the bridge and the USDA wants the city to change their current interim loan to a permanent loan. The department is working with Barreto to get the infrastructure dedicated to the city. Pantera told the council that the Sheriff Department's contract was up next month. The city moved to executive session at 7:39 p.m.

Horseshoe Bend Secures Berth in State Championship Tournament

HORSESHOE BEND -- The Horseshoe Bend Varsity Mustang Football team is headed to the 1A Division II Idaho State Championship Football tournament after a pivotal 44-12 win on Friday, October 23 against the Council Lumberjacks finalized the Mustang's second seed placement.



The Mustangs finished their season 2-1 in conference play (4-3 overall) behind the Garden Valley Wolverines who were undefeated in the 1A Long Pin Division II conference. The win in Council sets Horseshoe Bend up to host the Castleford Wolves in the first round of the playoffs on Friday, October 30. The Wolves, part of the 1A Sawtooth Division II conference finished their regular season 2-1 in conference, 6-2 overall.

Friday night's game allowed Mustang quarterback, junior Colten Meyer, to rack up 255 passing yards and 54 rushing yards for 3 touchdowns. Senior Hunter Howerton was on the offense for 2 touchdowns, 104 rushing yards, and he contributed 10 tackles on defense. Junior Decker Larson had 2 touchdowns with a total of 111 receiving yards and a fumble recovery. Junior Keegan Smith kept up his tackle delivery with another 18 under his belt and he added a quarterback sack as did seniors John Gorbet and Ethan Meyer-who also had a fumble recovery.

Horseshoe Bend Upsets Tri-Valley For District Championship Title!

HORSESHOE BEND -- After their match win against the Salmon River Savages on Saturday, October 17, day one of the 1A Long Pin Division II District Championship Tournament, the Horseshoe Bend Lady Mustangs Volleyball team traveled back to McCall on Tuesday, October 20 for a chance at the championship title. The 8-2 Mustangs were scheduled to meet the 10-0 Tri-Valley Titans, who finished the regular season undefeated and were the only conference team that Horseshoe Bend didn't defeat.

The Mustangs came out strong winning the first 2 games of the match 25-23 & 25-21 before Tri-Valley came back in game number 3 and Horseshoe Bend went down 19-25. The Lady Mustangs rallied in game number 4 and the 25-23 win gave Horseshoe Bend the 1A Long Pin Division District II Championship and sent Tri-Valley to a play-in game at Timberline on 10/24 against Carey High School from the Sawtooth conference (Tri-Valley took the match win and will join the Mustangs at the state tournament).

Statistical standouts during the match were freshman Annelie Wilson with 26 kills (an attack on the ball which is not returnable by the opposing team), 1 ace (a serve which is unable to be played or returned by opposing team), 1 block (blocking the ball into the opponent's court leading to a point or side out), and 21 digs (passing a spiked or hard hit ball). Junior Kenzie Renfro with 10 kills, 1 block, 11 digs, and 2 assists (pass, set or dig ball to another player who gets the kill). The libero, senior Natalie Newell, had 3 kills and 30 digs. (The libero is a player specialized in defensive skills: the libero must wear a contrast-

ing jersey color from their teammates and cannot block or attack the ball when it is entirely above net height. When the ball is not in play, the libero can replace any back-row player, without prior notice to the officials). Junior Kloe McReynolds contributed 3 kills, 2 aces, 10 digs, and 2 assists. Freshman Olivia Bauer showed up to play with 3 kills, 2 block, 5 digs, and 1 assist. Freshman Torey Tschida had 2 kills, 36 digs, and 6 assists, freshman Abby Howerton had 1 kill, 19 digs, and 36 assists, and freshman Alaina Rane had 8 digs. Coach Sharsti Moore had the following to say about the team's upset win, "This match was one I will forever remember. We knew it was going to be a battle and the girls came to fight. These girls gave all they had and played with heart, passion, resilience, tenacity, and most importantly, they played AS A TEAM! So incredibly proud and can't wait to see what we will accomplish at the State Tournament!" The win sends the team to Burley High School on October 30-31 for a chance at the state title where they will play the Sun Valley Community High School Cutthroats. Despite having only played 4 regular season games, the Cutthroats advanced to the state tournament (their first time in 18 years) by winning 4 straight matches in their 1A Sawtooth District Conference Tournament and taking 2nd place after a loss to the Hansen High School Huskies in round 1. The match between the Mustangs and the Cutthroats has a start time of 1:00 p.m. Tickets are limited and can be purchased the day of the match via a link on the Idaho High School Activities Association-<https://idhsaa.org/volleyball>. Tickets will not be available at the door.
