Garden Valley: Together We Are Wolverine Strong

Garden Valley continues to grow and Garden Valley School District is growing with it. We are six weeks into the 2020-2021 school year and there is much to share with the community.

We would like to welcome our new staff members to the Garden Valley School District. We are feeling fortunate to have these new staff joining the Garden Valley School Team.

The new members are: Ashley Albright, School Counselor; Bailey Robert, MS Math and Science Teacher; Cara Larsen, Preschool Teacher; Christan Langsfeld, Paraprofessional; Cione Pinto, Paraprofessional; Earnest Updike, Maintenance/Janitorial; Emily Erickson, Paraprofessional; Guy Jenkins, Paraprofessional; Hannah Mitchell, 1st Grade Teacher; Kayden Tague, 2nd Grade Teacher; Kim Grigg, 5th Grade Teacher; Lynda Reese-Bradley, Food Services; Miranda Fellman, Paraprofessional; Nicole Goff, Paraprofessional; and Trevor Schiefelbein, MS Social Studies Teacher.

Our student enrollment and district totals have been a moving target over the past six months due to COVID-19, family choice, and community growth.

During the 2019-2020 school year our highest enrollment was 284, including Garden Valley, Lowman and Preschool.

At the end of the 19/20 school year the District enrollment totaled 245, including Garden Valley, Lowman, and the preschool.

We are now six weeks into the 2020-2021 school year with a district total of 316 students in Garden Valley, Lowman, and preschool.

Garden Valley School District has welcomed 87 new students this school year, exited 22 students, and started 15 new students in Preschool.

In terms of enrollment, this

is an increase of 80 students since May, over 39% of the entire student body. If we calculate an answer based on the highest enrollment in the 19/20 school year, there is a difference of 32 students, or 9% of the entire student body.

The influx in student enrollment has left the District falling short of materials, equipment, furniture, staff, and space. To provide the students and staff with what is needed, the District is also short of funds. For these reasons, the District has filed for an Emergency Levy. By filing for the Emergency Levy funding, the District will in turn lower the amount of tax funds needed for the bond and offset the increase for tax payers.

- Buses are filling to capacity
- Overcrowding
- •Not enough textbooks, workbooks, tech devices
- Additional staff needed to fill required accommodations
- Increase in Student Special Service needs
- The septic (SBR system) is at maximum capacity
- Additional staff hired for food services and janitorial to follow COVID-19 guidelines

The amount of dollars to be collected pursuant to this levy on a typical home of \$50,000 taxable value of last year is estimated to be \$20.69. The amount of dollars to be collected pursuant to this levy on a typical farm of \$100,000 taxable value of last year is estimated to be \$41.39. The amount of dollars to be collected pursuant to this levy on a typical business of \$200,000 taxable value of last year is estimated to be \$82.78. We are including a postage paid return envelope for our absentee voters and recommend that ballots be mailed back prior to October 27th. We recommend hand delivery to the Boise County

Garden Valley Youth Struck By Stray Bullet While in Bed

GARDEN VALLEY - On Friday night at around 11PM, after a young Garden Valley 8-year-old was tucked in bed by his father, Jason Petrick, there was a loud pop and his son screamed out. A bullet had gone through two walls, the boy's pillow, his hand, and into his face and neck. Mike Johnston, a family friend said, "LJ is one of the most amazing little lovable kids you will ever meet and is extremely lucky to be alive today, although he may never have the use of his hand again."

On Monday morning, September 5th, Jason Petrick came to the courthouse demanding to speak with Judge Roger Cockerille concerning the one misdemeanor charge issued to the neighbor who supposedly accidentally fired a gun and nearly killed his son. He claimed that if an individual were drunk while driving and killed someone, there would be harsher penalties. The father was asked to leave the courthouse, for the given reason that this was not how the judicial system worked and was

removed by officers.

Sheriff Scott Turner later said it was very frustrating and a bad situation because no criminal intent could be found, so was therefore not a felony. However, the sheriff's office is checking with other counties and with the Idaho State Police in this matter. This is still an ongoing investigation and pending

Mike Johnston stated that LJ is

going to require multiple surgeries to try and repair his hand, face, and neck, and this will be a heavy financial burden for the family. There has been a gofundme page set up for LJ under "Child Gunshot Victim" in Garden Valley. Johnston added, "He's such an amazing little man! He has the heart of a lion. His hand is pretty bad but with today's medical advances we're hopeful."







BEND MUSHANG VOLLE

HORSESHOE BEND -- The Horseshoe Bend Varsity Volleyball team hosted the Salmon River Savages on Friday, October 2 as part of Homecoming week. The Lady Mustangs won 3 out of 4 games in the 1A Long Pin conference match; 25-20, 26-24, 20-25, 25-6. Coach Sharsti Moore's statistical standouts were freshman Annelie Wilson with 29 kills (an attack on the ball which is not returnable by the opposing team), 2 blocks (blocking the ball into the opponent's court leading to a point or side out), 5 aces (a serve which is unable to be played or returned by opposing team), 20 digs (pass-

ing a spiked or hard hit ball), and 2 assists (pass, set or dig ball to another player who gets the kill). Senior Natalie Newell (team libero) had 2 kills, 37 digs, and 1 assist. The libero is easily identified as being the player with the different colored jersey. Since the position's creation in 1998, the libero has evolved into one of the most unique and important positions in the sport of volleyball, according to CoachesInsider.com. As the leader of the back row, the libero specializes in defense and as the service receiver. Freshmen standouts were Abby Howerton with 1 kill, 13 digs, and 44 assists, and Torey Tschida with 10 aces,

18 digs, and 3 assists.

The varsity team along with the junior varsity team were back at home the following day, Saturday, October 3 for another 1A Long Pin Division II conference match against the Council Lumberjacks. The junior varsity team defeated the JV Lumberjacks 26-24, 25-20. The Horseshoe Bend Varsity Mustangs took their win in three games; 25-13, 25-14, 25-18. Varsity stat leaders included Wilson with 22 kills, 3 aces, 15 digs, and 1 assist. Howerton had 3 kills, 11 digs, and 30 assists. Junior Kenzie Renfro contributed 5 kills, 5 aces, and 1 dig while libero Newell had 18 digs and 1 assist. The Varsity Mustangs are 6-1 in conference play with a 10-3 overall record for

the season to date.

Horseshoe Bend senior, Kylon Romrell, did double duty during the Mustangs Homecoming game against Salmon River, participating as color guard during the playing of the Nation Anthem and as commentator for the 1A Long Pin Division II game.

They start a two day home stand on Tuesday, October 6 against the Garden Valley Wolverines and on Wednesday, October 7th they host the Nampa Christian Trojans.

The teams are in Midvale on Friday, October 9 to face off against the Tri-Valley Titans and the JV team begins tournament play on Saturday, October 10.



Mining Critical Minerals

BOISE COUNTY -- On September 30th, President Donald Trump signed an executive order declaring a national emergency to expand the mining industry, to support mining jobs, and reduce the nation's dependence on China for critical minerals. Boise County is said to have the richest deposit of Molybdenum in the world, which has been explored by CuMo Mining Company. Midas Gold is also looking to mine the backcountry in Valley County, near McCall.

The CuMo Mining Project had done several core drillings, and the company purchased the surrounding land, but had been working on permitting through the U.S. Forest Service for over ten years.

Molybdenum is used in flat panel TVs, to remove sulfur from gas, in wind turbines, personal computers, rifle barrels, auto parts, hospital and laboratory equipment, and in strengthening steel.

President and CEO Shaun Dykes, or any of the Idaho CuMo Project employees, could not be reached for comment at this time.

Midas Gold is proposing to mine 4+ million pounds of gold, and 100 million pounds of antimony, in Stibnite, Idaho near Yellow Pine. Their objective is to clean up the Yellow Mine pit, restore natural resources in the area, and ensure that future mining will work at restoring nature and obtaining valuable minerals.

Their website further explains:
"The Stibnite Gold Project site is rich in a variety of minerals. In addition to gold, silver and tungsten, the area is also well known for its deposits of antimony, which is contained in a mineral called 'stibnite."

Midas Gold has two companies: one is Idaho-based with 35 people located in Idaho at McCall, Cascade and Boise, and the second is a parent Midas Gold corporation located in Vancouver, Canada.

As President of Operation Immunization for Idaho State University College of Pharmacy, she helped organize the drive-up flu clinic offered at the ISU Meridian campus in which approximately 650 individuals came to be vaccinated, while remaining seated in their vehicles. The Governor and First Lady did step out of their SUV for the press and to be vaccinated with this year's flu vaccine. Both wanted to set an example as to the importance of getting an annual flu shot, especially during this

pandemic.

Nursing students at ISU were also asked to join in the event, alongside the pharmacy students. Physician Assistants were charged with COVID-19 screenings, and after asking several health questions and taking everyone's temperature, they did opt to turn away four vehicles. The individuals within the vehicle were possibly not feeling well or had an elevated temperature. "We recommended that they receive their influenza vaccine at their pharmacy when they felt better," said Elise Capson.

Several medical students attended to each vehicle, to keep the line moving swiftly and effectively. The clinic had a steady stream of cars all day long, from 10am to 5pm. The vaccinations were a good way to get the whole family immunized at one time, free of charge.

The students were warned that an anti-vaccination group had made plans to campaign against the clinic, but no one came out in opposition. Meridian Police Officers, ISU Security, and the Governor's private detail were present for the event.

The College of Pharmacy and the ISU faculty worked alongside the Idaho Immunization Coalition to organize the event. Special thanks to Albertsons, Saint Al's, and St. Luke's who helped teach and oversee

the students. Idaho Health & Welfare input the names of all those vaccinated into the registry for Idaho's Immunization Reminder Information System (IRIS).

Capson thanked all involved in making this clinic a success: "I have had the wonderful opportunity to work with Karen Sharpnack (Idaho Immunization Executive Director), Dr. Kevin Cleveland (ISU Assistant Dean and Director for Experiential Education), various pharmacists from Albertsons and Saint Alphonsus, the Department of Health and Welfare, and the Nursing and PA programs at ISU! I also created

a fabulous committee of pharmacy students to help coordinate students (over 100 ISU students) and to plan this event. I have learned so many valuable skills by being a leader to my fellow students and also being an integral part of a team."

President of Operation Immunization for ISU College of Pharmacy, Elise Capson, added, "Receiving your flu shot is extra important this year during the COVID-19 pandemic. We want to recommend prevention strategies to reduce illness so that everyone's immune system will be in tiptop shape this year."
