# Ground Dedication for New Veteran's Memorial

## HORSESHOE BEND --

The City of Horseshoe Bend held a ground dedication for a plot of land in the city park on Veteran's Day, Wednesday, November 11, 2020. The ground dedication ceremony allocated a 20 x 20 area in the park for the proposed Horseshoe Bend Veteran's Memorial (the exact location has yet to be determined, but the city allocated the space during a special meeting held on Thursday, November 5). The city's contribution came about after the Horseshoe Bend Valley Chamber of Commerce approached the city regarding their desire to create a Veteran's Memorial within the city limits. While the final project is still in the design phase, local artisan Bo Fisher has been commissioned with creating the memorial. The final design will incorporate a giant horseshoe made of metal with a symbolic eternal flame at its center. The names of local veterans will be included. Park benches will border the memorial which will also showcase a continuously lit flagpole.

The chamber saw a need in the community for the memorial, as all ceremonies involving Horseshoe Bend fallen soldiers must currently be held out of town, due to the city's lack of a suitable memorial area.

Mayor Pat Goff told the ground dedication attendees that there would be a groundbreaking held in the spring. He thanked those in attendance for coming and said, "We want to honor those that have fallen, those that are fighting now, and those that will fight in the future." He added, "This day should be memorable for all of us regardless of your political party."

The family of fallen soldier Specialist Michael Osorio, who died while on active duty in the United States Army on April 23, 2019, attended the ceremony. They brought the Honor and Remember flag that

they were presented with at a ceremony held out of town.

David Osorio explained to the crowd what the flag symbolizes. The Red Field represents the blood spilled by brave men and women in America's military throughout our history, who willingly gave their lives so that we all would remain free. The Blue Star represents active service in military conflict. This symbol originated with World War I, but on this flag it signifies service through all generations from the American Revolution to present day. The White Border beneath and surrounding the gold star recognizes the purity of sacrifice. There is no greater price an American can pay than to give his or her life in service to our country. The Gold Star signifies the ultimate sacrifice of a warrior in active service who will not return home. Gold reflects the value of the life that was given. The Folded Flag signifies the final tribute to an individual life that a family sacrificed and gave to the nation. The Flame is an eternal reminder of the spirit that has departed this life, yet burns on in the memory of all who knew and loved the fallen hero.

According to honorandremember.org the flag was created because in the more than 200 years of our nation's history there has never been a specific public symbol that reminds us of the sacrifice made by members of our armed forces and sends a message of appreciation to the families they left behind. While 26 states have adopted the flag (Idaho is not one), there are currently two bills, one in the U.S. House and one in the U.S. Senate, that if passed would designate the Honor and Remember Flag as an official symbol to recognize and honor members of the Armed Forces who died in the line of duty.

## Proposed Mining Operation

*BLM seeks comments on proposed mining operation near Quartzburg*

**BOISE COUNTY** – The Bureau of Land Management (BLM) is seeking public comments on a proposed placer mine located near Quartzburg. The proponent, Mountain States Mining, LLC, has submitted a Plan of Operations to develop a 3-acre mining site after several years of exploratory work.

This scoping period for the environmental assessment allows the public, organizations and other interested parties to identify potential issues that the BLM may consider including in the environmental analysis. Comments are most helpful if they provide specific actions, resources or issues to be considered and analyzed. The BLM will accept comments throughout the scoping period: Nov. 13-27, 2020.

"The scoping process is a critical part of our planning process and ensures public involvement," said BLM Four Rivers Field Manager Brent

Ralston.

## Quartzburg History

**BOISE BASIN** -- Quartzburg, Idaho dates back to 1867 with the development of the Gold Hill mine. Following that, the Quartzburg post office operated between 1874 and 1940.

In the 1884 book, "History of Idaho Territory, Showing Its Resources and Advantages," Quartzburg is described as: "a little mining hamlet situated at the extreme northern portion of the Boise Basin. It is kept up mainly by the Gold Hill Mine and reduction works. The Gold Hill Mine is crushing away day and night, with twenty-five stamps, crushing fifty tons per diem. This is the finest mill in the territory."

A fire in 1931 burned down all the buildings in town except the post office and the school. Between the fire and the closure of the mine in 1938, Quartzburg was never again a boomtown.

The Gold Hill mine produced over 450,000 ounces of gold from 1863 to 1938.

My grandfather, David C. Heron worked the Quartzburg mine in 1910 and his son Corky Heron lived in Placerville until sometime in 2000.

## What Voting Machines Does Boise County Use?

**BOISE COUNTY** -- Boise County is required by the Federal government to provide equipment for voters with disabilities. Up until the end of 2018, the county used monstrous, heavy, machines called Auto-mark. These machines were often known to malfunction.

Mary Prisco, Boise County Clerk, explained, "We replaced the Auto-Mark with our Express Vote machines. Like the Auto-Mark, they are designed to accommodate the vision and hearing impaired voter. They are also light enough to allow curbside voting -- they have a battery which allows us to unplug without impairing function. Some of the great things about the Express Vote is that they are super user friendly, lightweight, meet the Federal requirements for voters falling under the Americans with Disabilities Act, and they use thermal paper for the ballot

print. The ballot information is provided by our vendor on a USB stick and customized for each polling location. Unless a thermal 'ballot' is stamped as an official ballot with the election date, we can use our inventory for future elections. Versus the traditional paper ballot that costs a lot (several dollars per ballot) and, once an election is done, becomes completely useless to us. The cost of an Express Vote machine is just under \$3,500 per machine and requires a maintenance agreement (reasonably priced) on top of the initial cost." She added, "It is critical to understand that the Express Vote machine is basically a glorified printer. It is not a computer and it has no access to the internet or other equipment. It is a method to print out a voter's ballot choices which are then included as part of our hand counting process."

"We have a State administered voter registration system

that was implemented (by all Idaho counties) in June of this year -- this software is called Tenex, or TED (Tenex Elections Desk). Though we had some system glitches leading up to the November General Election, TED is overall a significant improvement over the outdated previous voter registration system (also administered by the SOS Office)." Clerk Prisco is pleased with the new voter registration system and commented that it was more efficient than the previous system. Due to the 80% voter turnout, with over 6,000 registered voters, hand counting ballots has become very expensive and difficult to achieve within a reasonable time period. She will be working with the Secretary of State's Office in the coming week on a grant for acquiring more election technology for Boise County.

**HORSESHOE BEND** -- On November 13, Governor Little moved Idaho back to Stage 2 of the Idaho Rebounds Plan. One of the restrictions of Stage 2 involves indoor gatherings limiting to 10 people or less. The Idaho High School Activities Association has told Idaho schools that they expect school districts to abide by the governor's orders. The current orders will impact the number of spectators allowed into gyms to watch basketball games. Both the Long Pin Division and the Western Idaho conferences have decided to only allow home team fans into games and the total number of fans will be limited to 10. This rule will affect both high school and middle school basketball games. The Horseshoe Bend School District is telling parents and fans not to travel to away basketball games, as they will not be allowed in. The district plans to livestream all middle and high school home games via their Facebook page.

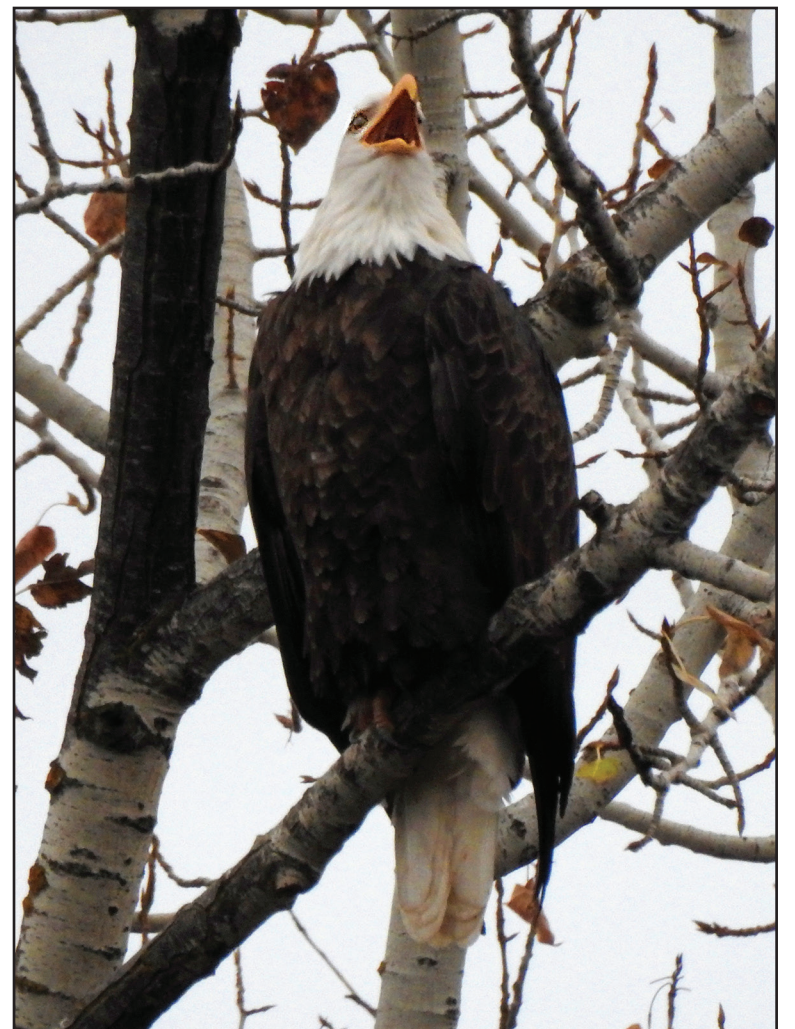

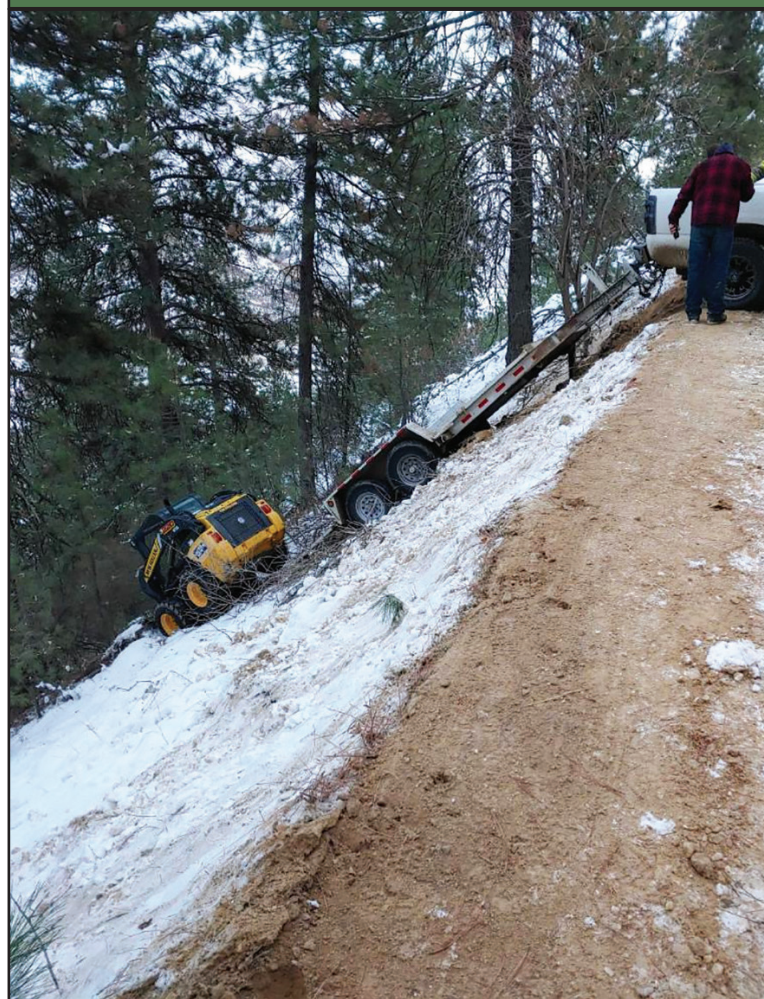
## JUST A LITTLE OVER THE EDGE

Karen Virginia Alley passed in her home in Garden Valley, Idaho on October 29, 2020. Karen was born to Sterling and Madelyn Fackrell Alley in Boise, Idaho on May 31, 1950. She was raised in Garden Valley in a time when the valley offered freedom to roam, wide open spaces, and a small, close-knit community.

Karen was an avid horse woman and spent most of her childhood up Gooseberry Creek behind the home place riding. In 1968, Karen ran for the Snake River Stampede rodeo queen, and while she didn't win, the memories of competing were very fond to her. Karen loved rodeo and began competing in high school. Af-

ter high school, she joined the women's professional rodeo circuit, competing in the northwest and in Canada.

In 1971 Karen married Richard Grosvenor, and together they had three children. This union lasted 20 years and produced a friendship that lasted their lifetime. In 1991, Karen was diagnosed with multiple sclerosis. Through the progression of the disease, Karen lost the ability to walk. Despite her condition, she never missed a junior rodeo, she was always there to support her grandkids and various family members.

Karen was well-loved by all that knew her, and she will be missed by all.

Karen is survived by her children, Tom Grosvenor (Linda Lee), Rusty (Amy) Grosvenor and Misty Grosvenor; her grandchildren, Perry Grosvenor, Wrenlie Grosvenor, Jevin Smart and Hayden Grosvenor; her two brothers Steve and Monte Alley; her three sisters, Jan Youren, Linda Miller and Melea Hileman along with numerous nieces, nephews, and cousins. 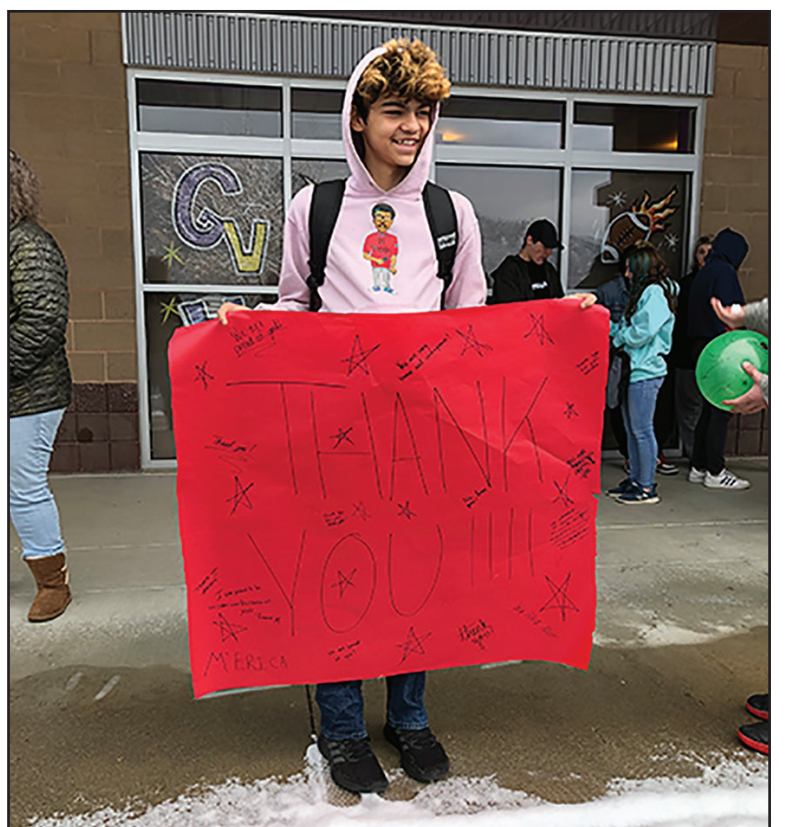
