# BOISE COUNTY BECOMES A 2ND AMENDMENT SANCTUARY COUNTY

BOISE COUNTY -- On February 9th, Boise County's Emergency Manager, Showalter stated during constituent input, "I believe this is an important topic for discussion. Democrats are already making a move to regulate and impose fees, and restrict some Americans who have not broken any laws." He added that should a 2nd Amendment Resolution be adopted, it would be a symbolic move and would send a message "that we support our Constitution and our right to bear arms. I'm glad to see that this topic is on the agenda today and I encourage you to support it."

Commissioner Steven Twilegar stated that he would lead this initiatitive. Showalter provided him with a possible resolution which the commissioner would review over the week and compare with his own drafted copy.

The discussion was tabled until the next Boise County Commmissioners' meeting on February 16th. A new resolution was adopted in support,

making Boise County a 2nd Amendment Sactuary County.

"I think most of us are gunfriendly in Idaho," Commissioner Twilegar started off by saying. "I'm a Constitutionalist, I don't think that's any secret to anybody here. Any statute, any law that goes against the Constitution is simply unconstitutional. Idaho has already said that we don't need a license to carry; we have a license, it's called the Second Amendment." He explained that enacting a resolution of this nature would be symbolic and would send a message to the governor and the United States government, "that counties, like Boise County, will not go against the Constitution on any level – the first amendment, second amendment – or any amendment."

Twilegar turned to Sheriff Scott Turner and said, "I'd love for you to sign, because you're really who's going to enforce those laws or not. *You are the law of the land.*" Sheriff Turner replied, "Absolutely, I support

it 100%."

Commissioner Holmes also agreed to being a Constitutionalist. "I believe, probably a little more, the fact that as long as an outsider or any other entity doesn't try to come in and disarm the citizens of this county, I'm okay if they were ever to do that, with the Sheriff on our side, we would stop that by any means necessary to keep that

from happening."

Commissioner Stirm also agreed 100% and supports the Constitution. He added, "I don't want to see anybody try to come in and try to impose another *will* on us. I'm in a 100% support of it." Chairman Stirm made a motion to adopt this new Boise County Resolution 2021-19 declaring the County of Boise County to be a

Second Amendment Sanctuary County. Commissioner Twilegar seconded the motion. Commissioner Holmes interjected, asking the audience if they had any input. Emergency Manager Bob Showalter agreed saying, "I think we're all like-minded." Commissioner Stirm asked if all were in favor, and the vote was unanimous and the motion carried.

# Horseshoe Bend's Monthly City Council Meeting

The following is a synopsis of the Horseshoe Bend City Council meeting on February 20, 2021. Mayor Pat Goff made the call to order at 7:00 p.m., led the Pledge of Allegiance, and after unanimous approval of the amended agenda, previous minutes, and the authorization to pay the city's bills, Goff opened the dais for public comments. Darrin Hendricks came forward to discuss the water study. Hendricks suggested that the city sell the parcel of land by the river that is currently slated to be a city park in order to build up the water reserve fund as the land was purchased with some of the money from the water fund. He also told the council that the proposed volume and capacity billing was inequitable and urged the council to bill customers strictly by volume only.

Next up in public comments was JD Dufresne who asked the council, "Is it possible to do a voter referendum or initiative for a municipality?" City attorney Tony Pantera questioned, "What do you mean?" Dufresne replied, "Is it legal for voters to change or initiate a law in the city?" Pantera said, "I don't think so." Dufresne then said, "Maybe you could find out and come back and tell us." Goff interjected, "We'll get back to you on that." Dufresne did not comment publicly on the water/sewer rate increase, however, he did send out comments via a city generated email that contained this month's agenda. Dufresne objected to the public comments section of the meeting being held before the council speaks on agenda items.

Resident Levi Burk came before the council with new business. Burk received a code infraction letter from the city regarding the amount of dogs he had on his property. Burk told the council they were hunting dogs that were used in his wife's taxidermy business and that the animals were members of their family. He stated that the dogs were kept kenneled and had been at the home since October. Councilmember Curtis Corvinus said that the dogs were the "best kept dogs I've ever seen." Burk indicated that the dogs don't bark and that they had "tens of thousands of dollars invested in them." He added, "The three dog thing, I can't do that." Burk said

that he wanted to work something out by getting a kennel license. Pantera said that the city does have a provision for a commercial kennel. Burk questioned the need for 100% agreement from surrounding neighbors in order for the code to be amended for a kennel as the norm in Boise County and the state of Idaho requires only 75%. Councilmember Stephen Chartier said, "Looks like we need some more investigation." The matter was tabled for further research and a possible amendment of the ordinance.

City grant writer Cheryl Pleak suggested that the council readopt the existing transportation plan since a new plan will not be completed until 2022. The council did not have a copy of the existing plan but when questioned, Pleak told them "it was excellent."

Ryan Stirm told the council that Dan Richter, the managing partner of the Avimor Community, donated much-needed equipment to get the city's second ambulance up and running, no strings attached. Councilmember Martye White questioned, "Why would someone in Ada County donate something to us with no strings attached?" Stirm replied, "They want us to be able to service the Avimor area if (ID) 55 is blocked." "Isn't that a string attached?" said White. Stirm told the council, "By Idaho law, we serve to the county line, regardless." Goff said, "It's kind of a win-win, since we've got to go to the county line anyway." White asked, "Where are we at legally on this?" to which Stirm replied, "Because we're an allvolunteer service, if we can't get a crew to go, we don't go. There's no contract in place." Stirm told the council that having two ambulances fully equipped was a benefit to the town.

Goff suggested tabling the water/sewer rate increase until next month. Chartier said he agreed after hearing what was said during the public com-

ments. White asked, "There's no rush for us to approve this?" "No," said Goff.

Lake Cascade Sport & Marina wants to operate on property next to the library. The owner of the property was in attendance and told the council he was unaware of the two conditions (install paved handicapped parking spots and to pave the entire lot within 5 years) that had not been met under the conditional use permit (CUP) that had been issued to the previous tenants. Panatera will supply the owner with a copy of the CUP and told them they had until November to comply with the paved lot but the handicap spots needed to be done now.

Report **EMS** (Michele

Brothers): 10 runs last month plus 1 standby. Everything is going well.

Public Works Report (Michele Brothers): City Hall sign is done, working on snow removal and the levy by the Riverside, which has been a "pretty big undertaking." Sewer and water plant is doing good.

Grant Writer Report (Pleak): Waiting until spring to apply for ADA ramp/sidewalk grants. Applying for grant to provide trees, grass, and fencing for new park property by river. Looking into grants to repair Boise Street Bridge. Will apply for EMS grant after finding out what the department needs.

Community Advisory Committee led by Pleak will resume meetings on March 1. It will involve planning community clean-up day and hopes to include painting 3-5 homes. Pleak asked if clean-up should "tackle" junk cars and large debris or if she should "let sleeping dogs lie." White replied, 'Let's hold off on that for a while. Give us a little more time to get law enforcement on board." Pleak said they would do the same thing as last year.

Civil Engineer Report (Amy Woodruff): "Mayor and Council, it was a slow month."

Report City Attorney (Pantera): Took care of some easements but "otherwise not much to report."

Goff adjourned the meeting at 7:54. The Horseshoe Bend City Council meets on the 3rd Wednesday of each month at 7:00 p.m. The next scheduled meeting is on March 17.





# COUNTY COMMIS

2/16/2021

**Present:** Commissioners Steve Twilegar, Ted Holmes

Via Phone: Commissioner Ryan Stirm [interference and feedback from the connection disrupted the audio recording]

Pledge of Allegiance

**EXECUTIVE SESSION:** Per personnel. [Closed session. Time 9:07 am to 9:19 am] No action required.

**EXECUTIVE SESSION:** Per hiring of an employee. [Closed session from 9:20 am to 9:36 am] No action required.

**CONSTITUENT INPUT:** None

MINUTES: The official meeting minutes from February 9<sup>th</sup> and 12<sup>th</sup> were approved.

TAX CANCELLATION: Assessor Chris Juszczak stated a gentleman that was in the Black Hawk helicopter crash also had a cabin in the county and requested that the taxes be cancelled in the amount of \$1,728. This was done by a motion.

**EMERGENCY MANAG-**ER: Bob Showalter spoke regarding funds for a grant and the Sheriff's Office covering the IT cost, and a quote. Clerk Prisco said there were other funds, in the general fund, which was an option. Commissioner Twilegar suggested a paper trail and said, "The issue is that we could have had the grant to pay for this." Commissioner Holmes said he didn't want to set precedence to do it, and suggested finding another way around it, "because I'm going to have to say, 'no.' That's the way I feel about it. I owe our constituents who put us in for a full transparency and

where the money's going."

**BUSINESS CARDS:** Clerk Mary Prisco will be ordering 500 business cards for each of the county commissioners.

**VEHICLES: COUNTY** There was concern and discussion that the county is paying insurance on vehicles that are no longer being driven, equipment that is unaccounted for,

**AGREEMENT: AUDIT** Clerk Prisco presented the audit agreement with Bailey and Co. for the county. They are scheduled to be done the second week of April. Chairman Stirm motioned to approve the annual audit from Bailey and Company in the amount of \$21,500. Commissioner Twilegar asked if this goes out to bid. Clerk Prisco responded that they have had this company for a number of years and her office is the most impacted, but could change auditors. The motion carried.

**SOFTWARE: LEGAL** Prosecutor Strong talked about how he negotiated to have the software cost cut in half. However, he will need more in his budget next year to cover the cost. It covers case law, statutes, and a lot of other tools. Commissioner Stirm made a







motion to accept the contract between the company and the Boise County Prosecutor's office in the amount of \$227 a month for 36 months.

2<sup>ND</sup> AMENDMENT SANC-TUARY COUNTY: [see front page]

**CONSERVATION** DE-**VELOPMENT COUNCIL:** Commissioner Stirm appointed himself as the primary contact and Commissioner Twilegar as an alternate contact with the Southwest of Idaho Resource Development Conservation Council.

**DEMAND WARRANTS:** Chairman Stirm made a motion to pay payee #1 [as part of the death penalty triall and payee #3 a total of \$7,450 for confidential legal services.

EBCAD: Bailey and Company audit agreement was discussed with the East Boise County Ambulance District Director Melissa Potts. A motion was made by Commissioner Stirm to approve the agreement between the two entities at a cost of \$7,000.

The EMT class is expected to start on February 27th. "We'll probably be sending out some invoices here at the end of the month to everyone that didn't follow through, that had contracted, and did not get their EMT license or have not been contributing." She said the bill would be \$600 a piece.

Commissioner Stirm asked if there was anything else, and Potts replied that it was a busy weekend. He said he'd heard about that. **OPEN MEETING LAW:** 

The Attorney General's Open Meeting Law manual and its content was discussed by Prosecutor Strong. Commissioner Holmes asked, "Is the only option we have, if something's wrong with another elected official, is the only option we have is notifying the Attorney General's Office to have an investigation?" Prosecutor Strong responded, "There is criminal conduct. If it is one of the county's elected officials, I have jurisdiction and so does the Attorney General. Almost all other violations of law would have to come through me and I can conflict it out if there's conflict... If there is an issue with a county elected official, and it has to be within the scope of their duties." Holmes said he'd been asked how commissioners were held accountable and also asked about employees of elected officials. Prosecutor Strong stated: "There could be an elected official that is doing really dumb things with their employee and it could cause a liability to the county, and you can talk to them. I can talk to

them, but in the end, they were elected by the taxpayers. And if taxpayers like someone that is going to cause them liability, they can do that... There's really not much anyone can do to stop that elected official, or force that elected official to take action against that employee. Like I said, they are duly elected and they get to choose their employees. And they get to make hiring and firing decisions, and hopefully they'll take council from commissioners and from me, if it's a legal issue, but they're not required to. They can make those decisions for themselves." However, he did agree with Commissioner Holmes, the commissioners do control the budget.





## **Second Amendment Sanctuary County**

## Boise County Resolution #2021-19

Resolution of Boise County Board of County Commissioners Declaring the County of Boise, Idaho, to be a Second Amendment Sanctuary County

Whereas, the Second Amendment of the United States Constitution reads: "A well-regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed"; and,

Whereas, the Boise County Board will oppose any infringement on the Second Amendment such as, but not limited to, long gun registration, magazine capacity limitations, ammunition possession and purchasing limits, mandatory physiological evaluation, gun purchasing application fees, requiring gun owners to purchase insurance before gun is legally owned, social media and search engine history background checks, and/or restrictions that otherwise impair the civil liberties of lawful gun owners; and,

Whereas, the Boise County

Board wishes to express opposition to any law that would unconstitutionally restrict the rights under the Second Amendment of the citizens of Boise County to keep and bear arms; and,

Whereas, the Boise County Board supports the requirement for any individual purchasing or possessing any type of firearm be able to prove without any reasonable doubt that they are an American citizen; and,

Whereas, the Boise County Board wishes to express its intent to stand as a Sanctuary County for Second Amendment rights and to oppose, within the limits of the Constitutions of the United States and the State of Idaho, any efforts to unconstitutionally restrict such right, and to use such legal means at its disposal to protect the right of the citizens to keep and bear arms, including through legal action, the power of appropriation of public funds, and the right to petition for redress of grievances.

Now, therefore, be it resolved by the Board of Commissioners of Boise County, Idaho: That the Board of County Commissioners hereby expresses its intent to

uphold the Second Amendment Rights of the citizens of Boise County and its intent that public funds of the County not be used to restrict Second Amendment rights or to aid in the unnecessary and unconstitutional restriction of the rights under the Second Amendment of the citizens of Boise County to keep and bear arms; and that the Board hereby declares its intent to oppose unconstitutional restrictions on the right to keep and bear arms through such legal means as may be expedient, including without limitation court

In witness whereof, the parties have adopted this agreement by its governing bodies and this resolution has been signed and attested by the authorized officials of each party.



# **COVID Vaccination in Boise County**

**BOISE COUNTY --** Adults 65 and older are now eligible to receive the COVID-19 vaccination in Idaho. Additionally, vaccinations are ongoing for medical personnel support staff, educational facilities, and first responders (a full list of eligible occupations is listed below). There are only two vaccine administration sites currently in Boise; the Garden Valley Family Medicine practice offers a clinic in Garden Valley and Horseshoe Bend. The World spoke with Betty from the Garden Valley Family Medicine. She said that vaccines are temporarily held up in Mississippi due to the weather right now, but she expects a new shipment any day. She is able to often set up same day appointments, with Saturdays being a big drive-through clinic in which she vaccinates 100 to 150 people in one day! There are also several vaccination administrations sites in Ada and Valley Counties as well. If you are in one of the eligible categories, you can obtain a vaccine in any county regardless of the county you reside in. The World spoke with several Boise County residents about their experiences with the vaccine.

Emil, Anke, and Bob, all of Lowman received their vaccination at Garden Family Medicine. Anke explained that Emil and Bob are in group 2 (Adults 65 and older). They at first tried to sign up for vaccination with St. Luke's in Boise through the hospital's website but it wasn't available until February 1st. So instead, Bob started making phone calls to clinics as far as McCall and was finally successful in getting an appointment with the Garden Valley Family Medicine clinic within days. Emil called the same day and got in too. On vaccination day, Anke (who is 60) was also able to get her first vaccine because the Garden Valley Family Medicine clinic had leftovers! Bob, Anke, and Emil all received the Moderna brand vaccine. Anke stated, "All three of us had a sore arm for about twelve hours." She added that, "Bob and Emil were also a little more tired than usual." Anke wished to include that, "the Garden Valley Family Medicine office did a great job in holding their vaccination clinic, very well organized, everything on time, waiting outside in your car until you were called in, face mask, social distancing, sanitizing inside and a

super friendly staff!"

I (Jennifer, group 1), was also able to get the vaccination. I was able to sign up through St. Luke's MyChart web service. The appointment was made two weeks in advance but it only took 15 minutes total from when I arrived for check in, to walking out after the vaccination. I received the Pfizer brand vaccine. The shot itself didn't hurt at all. I could barely feel the prick and did not feel the medicine being injected. Like Anke, Bob and Emil, I too had a sore arm for about twelve hours, similar to a good bruise, with no aftereffects other than that. The second vaccination is due for all of us in two weeks.

Regardless of where you go to receive the vaccine, it is free. Here are the facts:

### Who is currently eligible for the vaccine

- Adults 65 and older
- Adult and child protective
- Medical workers and staff personnel and home health and long-term care facility residents and staff
- Blood center workers
- Child welfare workers
- Clergy who enter healthcare facilities to provide religious support to patients

- Community food, housing, and relief services
- Coroners, medical examiners, mortuary and funeral services personnel
- Correctional and detention facility staff
- Emergency medical services and first responders.
- Idaho Fish and Game and USDA law enforcement officers
- Interpreters (ASL or other language) should be vaccinated with the sector and setting in which they work
- •Pharmacists, pharmacy technicians, and pharmacy aids
- Pre-K-12 school staff and teachers and childcare workers

IDAHOANS UP NEXT TO GET A VACCINATION (dates subject to change upon vaccine supply)

#### **EARLY APRIL**

- Food and agriculture workers (including food processing workers) and USDA plant inspectors
- Grocery, convenience store, and food pantry workers
- Idaho National Guard

- Manufacturing, public transit, and U.S. Postal Service workers
- Subset of essential gas, electric, water, and telecommunications utility workers, who work indoors
  - Homeless shelter residents

#### LATE APRIL.

- Other essential workers
- Individuals 16–64 years of age with high-risk medical conditions

#### MAY

• General public/individuals 16–64 years of age


