Protestors Burn Masks In Response to Mandate

IDAHO CITY -- The Gold Mine, supported by Steve Twilegar, sponsored a mask burning barrel on Saturday, March 6, 2021.

Idaho Representative Dorothy Moon of District 8B organized the mask burning events throughout the state. She gave a speech at the Capitol Building and stated that there were over 50 burn barrels located throughout the state and in her district, referencing burn barrels at Challis, Idaho City, Wilderness Ranch, and Horseshoe Bend. She stated that this was a way that the "Grass Roots" people could show the governor and the other legislatures how they feel. The "burn" is a symbolic event intended to send a message, "We've had enough! It's time to free Idaho!"

HORSESHOE BEND -- Idaho made the national news on Saturday, March 6 when a group of men, women, and children gathered at the state capital in Boise and encouraged others to join them in a mask burning event, to protest the wearing of masks. A similar protest was held in Horseshoe Bend, organized by local residents.

Health experts still encourage the use of masks and physical distancing in order to slow the spread of COVID-19, especially as variants of the deadly virus make their way to America.

During an interview on NBC's "Meet the Press," Michael Osterholm, who is an advisor to President Biden's coro-

navirus task force and director of the Center for Infectious Disease Research and Policy at the University of Minnesota told host Chuck Todd that the nation is currently "in the eye of the hurricane" with regards to the virus and the impending spring break season on its way. More than a half million Americans have died from COVID-19, or with COVID-like symptoms. It's been reported that more than 29 million have been infected.

According to the Center for Disease Control, as of March 8, 2021, more than 90 million doses of the coronavirus vaccine have been administered to 17.7% of the total US population. Just over 2.2 million shots are being given each day.

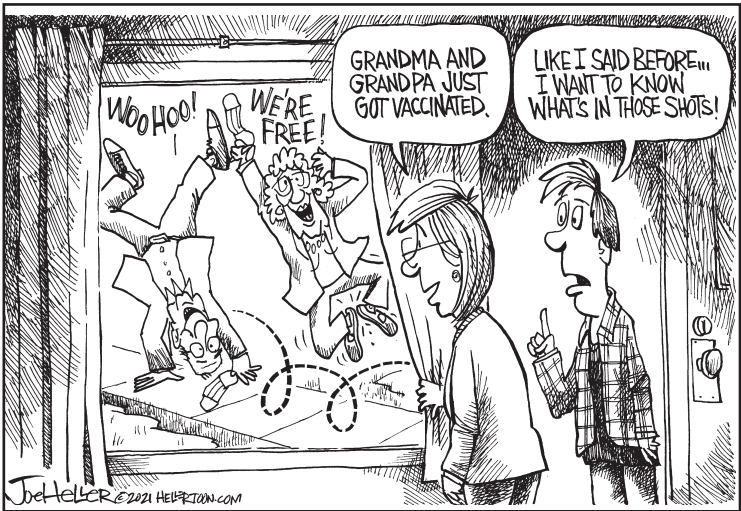
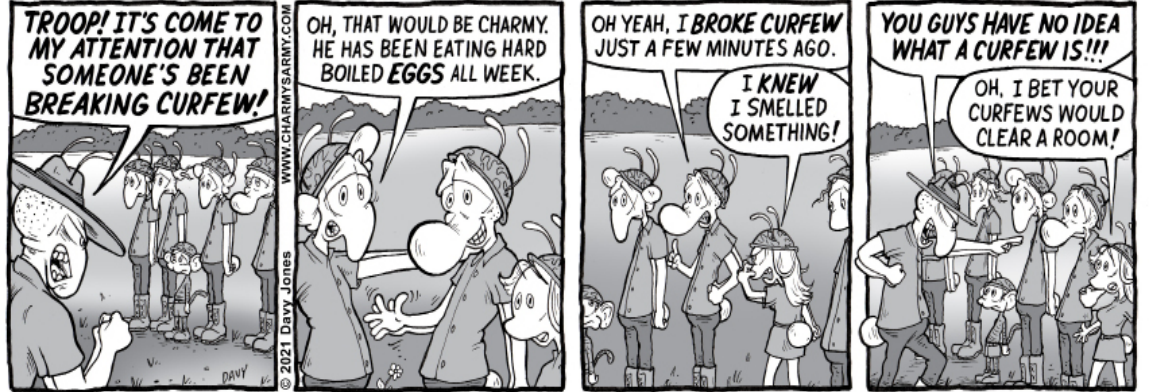

2/16/2021

Present: Commissioners Ryan Stirm, Steve Twilegar, and Ted Holmes

Pledge of Allegiance

EXECUTIVE SESSION: Closed session per Planning & Zoning administrator interview. [Time 9:32 – 10:20 am] No action required.

CONSTITUENT INPUT: None

MINUTES: The minutes from Feb. 23 were approved by a motion.

FORESTER: A radio installation quote was discussed, so she can get more coverage throughout the county. A motion was said to approve the quote for a two-way radio into the Forester's vehicle in the amount of \$936.

COVID-19 VACCINATIONS: Emergency Manager Bob Showalter stated: "I've been working with Central District Health to bring vaccinations into Boise County. We've had two clinics so far in Idaho City and one in Horseshoe Bend. These clinics have vaccinated more than 250 people." He continued, "I'm working with Central District Health to get clinics in the Garden Valley area, but I've run into some resistance from some folks over

there because there is a clinic that has been giving vaccinations. There's more demand than supply for the vaccine and the family clinic in Garden Valley is only allotted so many vaccinations. I am bringing in additional vaccines, above and beyond what is allotted to the clinic. I have been working with this pandemic since its onset and will continue as long as is needed." He said the next wave, group 2.3, will soon be opened. "That involves a lot more people. Then the demand is going to be far exceeding the vaccination supply. So, that's going to be more people in our county that are going to be eligible for the vaccine." He added that CDH has said they will continue to supply vaccines for rural clinics in Boise County, above what is supplied to the clinic.

Commissioner Ted Holmes interjected, "I want you to work with Dr. Koenig's office and to call the Garden Valley Board and work with them."

Showalter responded that CDH was setting up a conference call between himself and the Garden Valley Clinic. He went on to explain: "So, this is declared a disaster. This is what I do. This is my job. This

is bringing in additional vaccinations to the county... I'm here today asking the Board for support and approval for me to continue to work with Central District Health, bringing additional vaccines into Horseshoe Bend, Idaho City, and Garden Valley. My job is to get Boise County citizens vaccinated as soon as possible. Not supporting these efforts by anyone, is taking a position of neglecting the health and safety of our citizens."

Holmes noted: "That being said, I think you've done a good job, but there are some issues that have come out, and you and I've talked about it last week and I don't want to bring it up here right now. We'll probably go into executive session to do it." He continued, "CDH is outside of Boise County. There are people that do want, there are people that don't want vaccinations. Okay, do you understand that? And I understand that you're trying to get them to everybody, but right now you've kind of stepped on Dr. Koenig's toes and I've had to hear about it, and I told you last week about it. We've had this discussion."

Showalter asked again, "And that's why I'm here before the Board to get at least a two-thirds majority for me to continue to bring vaccinations in."

Commissioner Holmes firmly interjected again, "I want you to talk to Dr. Koenig's office and that board and then get back to us as Commissioners to make sure everything is ironed

out. I don't want any problems in our community with other entities. He is our county doctor, for the most part, and they do have a health board in Garden Valley. And I understand what you're trying to do, but, you know, you needed to inform the Board of County Commissioners, we make the decision, not you!" He added that there was a proper way to do it.

Emergency Manager Showalter asked point blank: "So, am I getting support from the Board today or do I need to shut down the clinics for this county?"

Commissioner Twilegar stated that as American citizens, people can make their own choice. "I'm not going to get the vaccine, but I'm not going to tell anybody they can't." He added that he had his support to do whatever the people wanted him to do.

Commissioner Holmes said he also had his support, after Showalter speaks with Dr. Koenig's office and says things have been smoothed out. "If they don't have insurance, they're not being charged. I went and found that out. They are professionals. They do give the vaccines. I want it straightened out for the community."

Clerk Mary Prisco reiterated, "This is above and beyond what Garden Valley Clinic can receive. So, it's actually additional resources."

Showalter asked why there was an argument and Commissioner Holmes responded,

"There is no argument. You ruffled some feathers and we didn't know about it. It caught the Board of County Commissioners off guard... and there could have been some legal issues that come up with it, which we discussed earlier."

Showalter asked Commissioner Stirm the role of CDH, [since he sits on the CDH board]. Chairman Stirm responded: "What we need to do is, the clinics outside of Garden Valley have been successful and I would say continue doing those. They have been extremely successful, there have been no issues, there have been no problems. Continue your phone call with Koenig's office, your conference call with Dr. Koenig's office and CDH. Do your best to hash something out with them in a peaceful manner." He asked that Showalter bring the result of that conversation back to the Board of County Commissioners. Commissioner Holmes added, "He needs to touch base and coordinate. They have a medical facility that could help and expedite this and I just think you bypassed them and it caused some problems that need to be corrected. That's the bottom line."

Commissioner Twilegar summed up, "I think the position of the Board, to answer the question, is that you need to coordinate and play nice with everybody and continue what you're doing." He added, "I don't think anybody up here is

going to say, 'Yes, stop the vaccine, because we don't want them.' Yeah, nobody's going to say that up here." Commission Holmes agreed, "That's not a part of the issue."

Showalter added, "I did not know that I was in conflict with the clinic by bringing in additional doses into the county."

Commissioner Stirm stated, "I think a big part too that will help out is having that conversation with Koenig and CDH, so that he understands that it's not taking away from the vaccinations that he's providing, it's adding to. Because there might be a misunderstanding on his end."

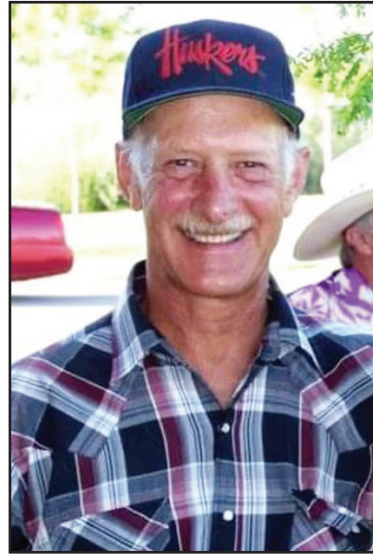
Showalter added before closing, "And I did ask Central District Health if these vaccinations coming into the county affected his allotment and they said no, it did not."

[The Idaho World reached out to Dr. Koenig's office, but they did not respond for comment.]

NO PARKING / TRESPASSING ORDINANCE: Prosecutor Adam Strong said they needed clearer indications where the problems were and noted that some of the roads were private. He said it was a "gray area" and that there were public easements. He referenced a map provided by the Assessor's office and said that one gentleman indicated the problem areas were any properties in Garden Valley that had access to the river. Chairman Stirm added, "Unfortunately, I can speak from experience. You could put three deputies on the Middlefork Road and they could pay their salaries in a week by just running traffic on that road, as it is now without the signs. So, I'm curious what's the reality of enforcement in the dead of summer when there's 90,000 people in Garden Valley and 10,000 of them are parked on the side of Middlefork Road? I don't agree with it. I don't like the fact that it's happening." He suggested

a trespassing issue would carry a larger weight than a parking violation. Sheriff Turner said the problem will be shifted to other areas to park and educate the landowners of what they can do on their private property. Prosecutor Strong suggested it might be beneficial to hear firsthand accounts of the issues from residents. Stirm suggested that the Sheriff's deputies note this summer where the largest congregations are along the river. Sheriff Turner stated, "There's a big misunderstanding of what we can and can't do, and what's required of the property owner, I think. So, I think if I have that plan in place and we address it as it comes, and then try to work with those property owners and help them out." The Board agreed and Stirm said, "It sounds like a great idea!"


