Chili Champions are Applauded in Idaho City

IDAHO CITY -- Everyone was a winner at this year's Annual Idaho City Chili Cook Off! There were more contestants than ever before, with a total of sixteen chili pots a-stirring. A number of commemorative chili bowls were sold quickly, with a few remaining for chili goers at the event. There were a total of 750 ceramic bowls, plus 250 disposable cups sold at a lesser price. Organizer Rhonda Jameson said that she was impressed that there were more contestants this year than any other year that she knew of and that almost as many cups sold as at last year's event held in February.

of *The Idaho World*, and Tyler of the *Go Agency!*

The event was held and organized by the Idaho City Chamber of Commerce. Although the date changed because of health restrictions, the new March date seemed to be more favorable with chili goers, and having the competitors spread out along Main Street and Montgomery helped the chili to last much longer than in past years. A new app was also introduced to help judge and rank favorite chilis for the People's Choice Award.

A huge thanks goes out to all the many volunteers that were so instrumental in pulling the event together in less than a month. Jameson said, "I'm thrilled that it was so successful, being one of the very first events allowed in almost a year."

Lee Daniel
1951 - 2021

Lehi "Lee" Albert Daniel blew into the world April 10, 1951. On this windy day in Elko, Nevada, he rolled in like a tumbleweed and took his place as the second eldest in a line of 8 children to parents Ernest and Gladys Daniel. He spent his childhood amongst the juniper and jackrabbits of Southwestern New Mexico. His youth was spent buckarooing in Nevada where he worked at various ranches. In the late '70s he headed north to work on the Alaskan pipeline

before making his home in Idaho where he became a father to two daughters and two sons.

His life was shaped by adventure and a kinship with the outdoors. After attending a log home building school in British Columbia, logging became his lifelong passion. He became a professional timber faller for the Escalunga Logging Company, and then joined Columbia Helicopter Logging where he passed down his knowledge to a younger generation.

In 1995, he created his own logging and milling business where he specialized in dangerous tree removal and thrived amongst the most challenging jobs. Having lived a life most folks only read about, Lee enjoyed sharing the stories of his life with those closest to him as well as those he met along the way. He spent his life working hard at doing what he loved, bringing home the warm smell of sawdust and sunshine more days than not. But when he kicked his boots

up, it was to barbeque on the river.

He was an inspiration to his children and a force of positivity and kindness to all that met him. He persevered when the chips were down, and never failed to fill a room with his big laugh, quick wit and wisdom. He was intellectual and generous, focused and ambitious, and one of the world's last real cowboys. He was an elder and a man who could remember the true freedom the west represents.

Lee Daniel joined his ancestors at 1:06 pm on January 17, 2021, surrounded by those that loved him.

He was preceded in death by his mother Gladys and brothers Mosiah and Nephi. He is survived by his four children; Preston Daniel, Danula Daniel and son-in-law Keith Bibbey, Alicia Daniel, and Ira Daniel, as well as five sisters and countless nieces, nephews, and extended family.

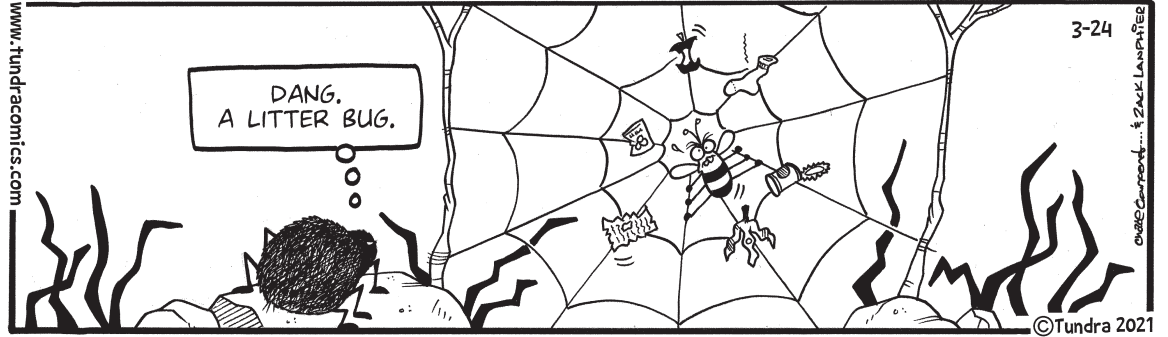

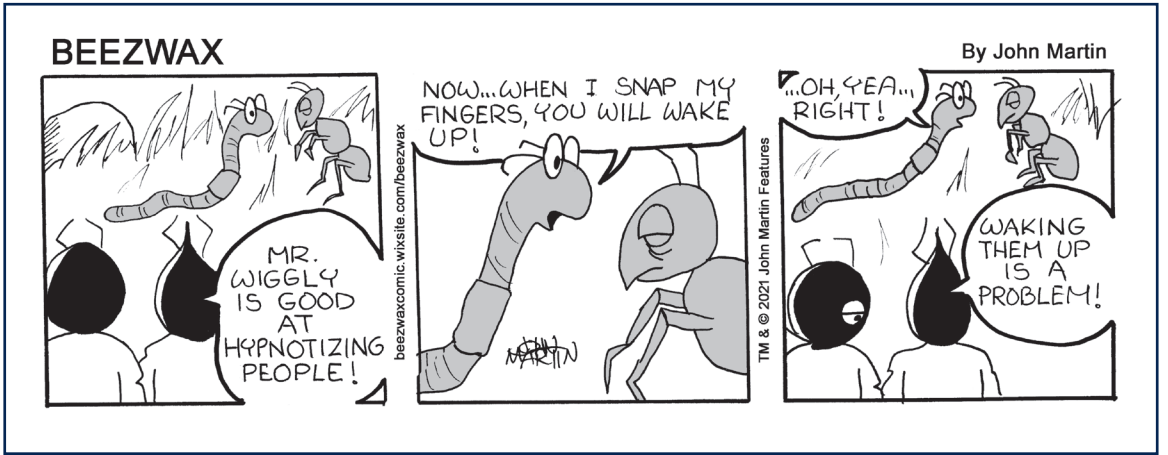
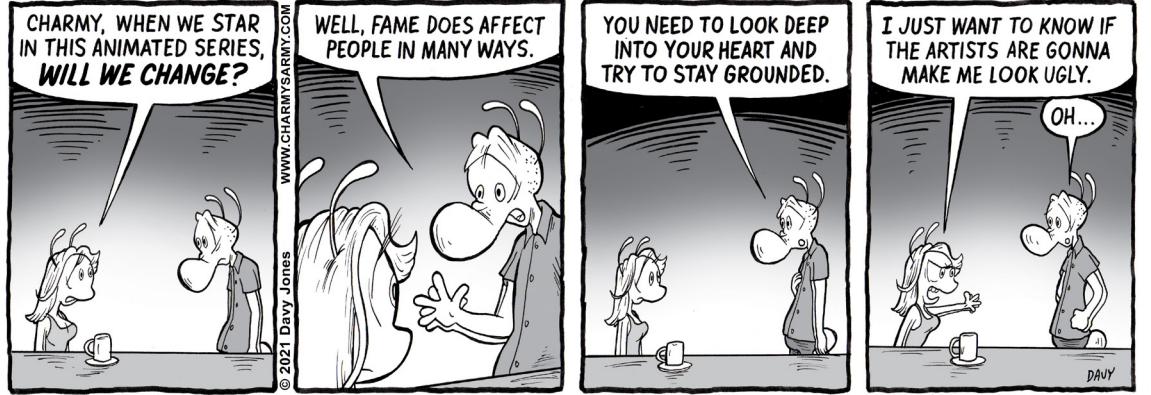

3/16/2021

Present: Commissioners Steve Twilegar and Ted Holmes
Absent: Commissioner Ryan Stirm

Pledge of Allegiance

EXECUTIVE SESSION:

Commissioner Twilegar made a motion to go into executive session per a request from Clerk Mary Prisco regarding a phone conversation and interview. [Closed session. Time 9:06 am to 9:18 am]

EXECUTIVE SESSION:

Per Idaho Code 74-206 b [consider the evaluation, dismissal or disciplining of, or to hear complaints or charges brought against, a public officer, employee, staff member or individual agent,] [Time 9:18 am to 9:48 am]

CONSTITUENT INPUT:

An individual living within the county spoke regarding censorship and big tech. He recommended other social media platforms might be used other than Facebook and Nextdoor for sending out emergency information. Chairman Twilegar said they had been discussing and developing policy for social media. He assured them that they would include this in the discussion. Emergency Manager Bob Showalter encouraged individuals to log onto the county website under the Sheriff's page to view information regarding the reverse 911 calling, AlertSense.

Commissioner Holmes asked, "Who is your point of contact or authorized to go and

use that?" Sheriff Scott Turner responded, "Myself, dispatch, Bob [Showalter], and there's a couple of deputies that have the ability to do that." Holmes said, "I think the Board of County Commissioners should be a part of that." Showalter stated that whenever he uses it, he first runs it through dispatch for approval. Holmes added, "I'm talking about county issues too, because, overall, we should have the responsibility to make new decisions over anything that's county or at the county level. And if we don't know and it comes from someone else, that's why I ask who's in charge of that." He asked if it was used strictly for the Sheriff's office. Sheriff Turner responded that it has been used for the road department, if there's a rockslide. It has also been used for missing children, fire evacuations, etc. Holmes said he received a text about "shots" and added, "we didn't know anything about it and that went out. I know you didn't authorize it. That came from our Emergency Manager. Some of those things are *not* considered emergency, shouldn't be put out." Turner said there is criteria against sending political messages with the reverse 911. Commissioner Twilegar said that the county was redoing their website, "which is a piece of junk."

MINUTES: Commissioner Twilegar motioned to accept the minutes from March 10, 2021.

EMERGENCY MANAGER:

Bob Showalter contacted the Idaho Emergency Management office to discuss the COVID-19 vaccine and said, "She agrees with my efforts in dealing with this COVID crisis as the Emergency Manager in the county. So, I need to know if I'm going to be given the authority by the Board to continue to work with Central District Health to bring vaccinations into this county, *in all of the county.*" Commissioner Twilegar responded, "As far as I'm concerned, absolutely, I think you continue what you're doing. Continue working with any doctors, or just like we have been." Showalter said that the pharmacy in Garden Valley is on a route rotation list with CDH. He encouraged the local towns to reach out to CDH to bring vaccination directly into their towns. He would like to assist, if he can. "By bringing in the Mayor of Crouch, and working with Central District Health, bringing in additional vaccines to be given at their community hall, because above and beyond what is being allocated to the medical clinic in Garden Valley and pharmacy, those do not affect the medical clinic in Garden Valley's allotment. It doesn't increase or decrease their allotments." Commissioner Holmes responded, "With that being said, did you make an attempt to work with Garden Valley Medical Clinic yet?" Showalter stated: "I think it's gotten to the point that, um,

that this letter that you gave me, which I think are 90% false accusations against me, which I... as far as I'm concerned, and you know, because you've been in the military, that this document is not worth the paper it's written on, because there is *no signature on it.* So, it can be denied as false accusations against me." Holmes stated, "We're not going to go there, Bob. We're setting up a meeting. We've already discussed it with Central District Health, that's going to be here, Garden Valley Medical... As long as you're *inclusive* on every entity within Garden Valley, or Idaho City, Horseshoe Bend. We're going to *fix that once and for all.*" Showalter assured, "I'm all about working with whoever I need to. If I have the Board's permission to communicate with Garden Valley, because there is some obvious static there. I'm more than willing to *drive over there and speak with them personally.*" Holmes said, "You can do that, if you smooth things out?" Showalter concluded, "Relationships like this going south in this emergency is *not* productive. I want to get everybody on board to get vaccinations to this county." He offered to go talk to the doctor today, if he's available. Commissioner Twilegar said, "That would be helpful if you want to fix it." Commissioner Holmes said, "If you want to do that and then report back, and let us know what's going on with

that... But that needs to be taken care of and we're still going to have a meeting though... Those that want to be vaccinated, *that's fine.* There's some of us, like us here that don't. So, just make sure you're getting those people that want to and don't try to impose or push people, because I don't want to get complaints back that our Emergency Manager is trying to force us to take a vaccine, *because then we'll be back in here with issues again.*" Showalter responded, "*That's ridiculous, I did not make any statements like that.*"

JUVENILE JUSTICE: A report for the Juvenile Justice was read in open session.

ELECTIONS: Clerk Prisco outlined the procedure for the election recently held in Horseshoe Bend in which the levy for the school was passed. Commissioner Twilegar motioned to approve the official abstract results of March 9, 2021, for the Horseshoe Bend School District.

DEPARTMENT HEADS: Commissioner Twilegar addressed the department heads, "We feel like we've been somewhat remiss in the fact that every department head reports to the Board. Well, that leaves us not being plugged in or involved. So, when something *happens*, we usually hear about it from constituents, or Dr. Koenig or *whoever.* That's partially on us too. So, the Board has made a decision to

become a liaison to each individual. So, each individual department head would have one point of contact on the Board, one of the three of us. That to me makes sense, because now it's going to force me to [meet] an individual and say, 'How are things going?' He added, 'Then I can share it with everybody. And then we don't get blindsided by stuff, not that it happens I think that often, but I think it's happening enough to where it's incumbent upon us to be more involved in it. Or maybe not so much more involved, or at least be more educated in what's happened.' He then made a motion saying that department heads would be assigned to a specific commissioner to be liaison. Showalter asked for a discussion and said that his position required him to go through the Chairman of the Board in an emergency situation. Prosecutor Adam Strong offered some legal advice. Twilegar said, 'I don't think that even touches on this, because that's not what we're talking about here. We're just talking about day-to-day operations, communications, stuff like that. *That wouldn't change.*' Holmes offered that because he had the most experience in emergency management that he would take that on for the first year, 'You'll be assigned to me for liaison, and

I'll keep the other two briefed on this. We haven't reassigned or assigned the other ones yet. We are in the process of doing that. Like I said, I have extensive knowledge in emergency management and all the courses and ICS. So, we will be working together. You'll basically come to me, if I'm not here, then you'll go to one of the others. But right now, that way there's no more confusion.' The motion passed.

EMERGENCY MANAGER: Showalter made the Board aware that he's involved with the Western Idaho Health Care Coalition and that he is a member. He asked if they wanted him to "back away from that" and made them aware that by state statute, someone needed to represent the county in that capacity. Holmes recommended Commissioner Stirm fill that because he also represents Boise County on the Board for CDH. He continued, "I have no problem with you being on these boards. The only thing I say be wary of, be cautious, is committing and making decisions that would override a decision that we *might make* that would be different." The topic will be tabled until the attorney can do some more research to advise the Board.

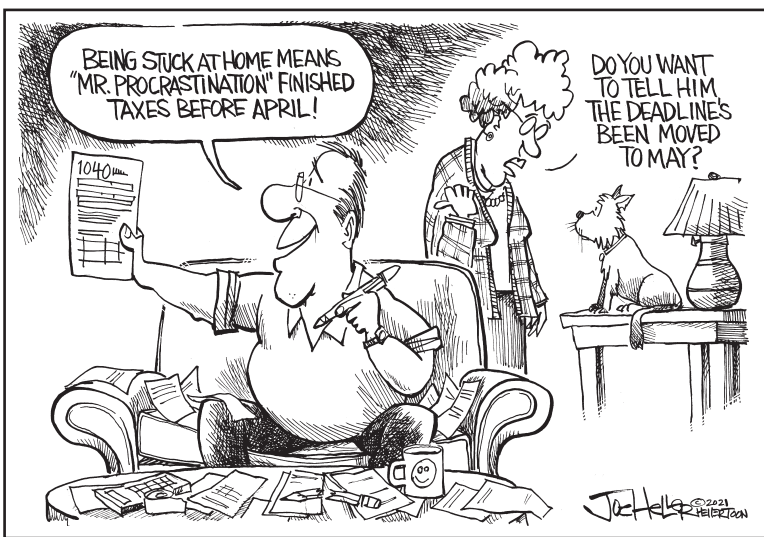

Horseshoe Bend's Structure Fire and Save

HORSESHOE BEND -- The Horseshoe Bend Fire Department was dispatched on Thursday, March 18th, at about 5 pm to a structure fire in progress along Highway 52. While en route, it was communicated that the structure was fully involved, prompting Fire Chief Jason Gifford to request mutual aid from neighboring stations, knowing there was going to be a water supply shortage. Horseshoe Bend Fire Dept. responded with eleven crew members, one QRU, two structure engines, one tender, and one wildland type six engine.

Mutual aid was also called in to assist and Gem County Stations 1 and 2, along with Garden Valley responded. Upon arrival, firefighters witnessed a detached carport, approximately 600 feet, that was fully engulfed. There was serious concern for several propane tanks in close proximity of the fire that were showing signs of purging. The fire was also beginning to creep up the hillside towards Hwy. 52, threatening

to become a small wildland fire.

Crews worked quickly and were able to extinguish the outer areas before the fire could grow out of control and burn the nearby home. Several motor vehicles, along with recreational vehicles, were a complete and total loss.

Hwy. 52 remained closed for approximately two hours while crews battled the fire. The fire remains under investigation by the State Fire Marshall.

The Horseshoe Bend Fire Dept would like to give thanks to: Gem County Stations 1 and 2, Garden Valley Fire Department, IDT, Boise County Sheriff's Office, and the Horseshoe Bend Ambulance for their assistance.

Horseshoe Bend Fire Chief Jason Gifford commented, "Sometimes it's difficult to bring together multiple agencies who have never trained together before; however, all crews did a great job with communications and we all worked well together."

The Old Garden Valley School

GARDEN VALLEY -- The Garden Valley area has a rich history of pioneers and settlers. People not only survived in the harsh climate but thrived. In 1924, parents that wanted their children to attend school past the 8th grade needed to send their children to board in Emmett, at incredible expense. As a result, a high school education was out of reach for many families. The residents recognized the need and importance of education and thus began a Garden Valley High School in 1925 in a rented building that was a former granary ('Tucker Granary' now located beside Crouch City Hall). But by 1926, the community built the first official high school building for Garden Valley students. The first principal was Maude Jennings of Boise, as principal and teacher of the freshman and sophomore class. However, in just four months, the building burnt down. The cause was unknown. The community and surrounding communities came to the student's aid and supplied them with books and other supplies while they continued their studies back at the old granary.

A new high school building was built in the fall of 1929. The original building had two large rooms, one for the middle school students and one for the high school students. The new school also had two smaller rooms that functioned as the principal's office and the typing room. The typing room was so small that the teacher had to stand outside in the hall while the students typed.

The first graduating class of 1930 consisted of a class of seven students.

The building later grew with two new additions, one for a science room and one for a library were built onto the existing school house, and the typing room was expanded.

The *World* spoke with Bruce Reay, class of 1957, about his family's purchase of the school house in 1964. He stated that in the fall of 1964, after construction of H.S. # 3 was completed, he attended a special school board meeting for his father, Davy Reay, who was unable to attend. The purpose of the meeting was to sell the, then unneeded, surplus H.S. building #2. Bruce added that "He did give me explicit instructions not to bid more than \$1,000, which I didn't. However, being a "neophyte" in the art of competitive bidding, my first bid was \$1,000! It so startled the other interested parties that they all withdrew and I won, never to know if I could have gotten the building for a cheaper price if I had did my bidding in smaller increments. My Dad, being forever an easy-going and forgiving man, never said a cross word about the incident. I'm sure he just considered it a good lesson for the both of us." In the summer of 1965, the Reay family with the assistance of Huckstep House Movers moved the old school building (which is about 40' x 70' in dimension), about 2 miles and placed it over a full basement. This is where the building has sat ever since.

Bruce Reay's sister, Kathy Kulm (Reay) of Garden Valley, class of 1962, and her husband Ron graciously gave the *World* a tour of the old building. Kathy was able to include personal stories of her time spent at the school, such as when

the boys pranked the girls by putting the typewriters in the attic. She explained that her parents were going to turn the old school building into a nice big home. Unfortunately, her father, Davy Reay was diagnosed with Parkinson's disease and her parents needed to alter their plans.

Kathy stated that the school building was in good condition when it was moved to the Reay property, but "vandals broke out most of the windows, causing birds and bats to get in to

make a mess of the inside." Weather and neglect have also taken their toll on the outside. She mentioned that "It's all fixable, but will take a lot of work and money to do so."

Kathy is passionate about the old school house and remarked that it is an historic building and that it "needs to be restored, but the Idaho Historical Society doesn't have enough money to help do that, and neither does the Reay family." She concluded, "The dream of turning it into a home is gone now,

but maybe someone will come along and rescue it from its unfortunate demise."
