**BOISE COUNTY** -- This week is national public safety telecommunications week. It is a week in which we at BCSO show our appreciation for the work of our dispatchers who support Boise County 24 hours a day for 365 days a year.

While we appreciate dispatchers all over the country, we are especially thankful for our BCSO dispatchers who help keep our deputies and our community safe. BCSO dispatchers are the lifeline of information and support in Boise County, where backup and cell service are both scarce. BCSO

dispatchers have the added challenge of often working solo without a second person to answer multiple calls that often ring into the office all at once.

What are we thankful for? Most people don't know that dispatchers do a lot more than just answer the phones and send an officer. Dispatchers are the first line of assistance when someone in need calls for help and often have to calm the caller before they can get the pertinent information. Dispatchers answer the call and then make split-second deci-

sions for how to best handle the call. Dispatchers then relay the information to any number of sources depending on who is suited to respond to the situation. Dispatchers are also paramount in coordinating multiple agencies to respond to events that require more than one type of responder.

# Local Residents Step Forward to Become EMTs

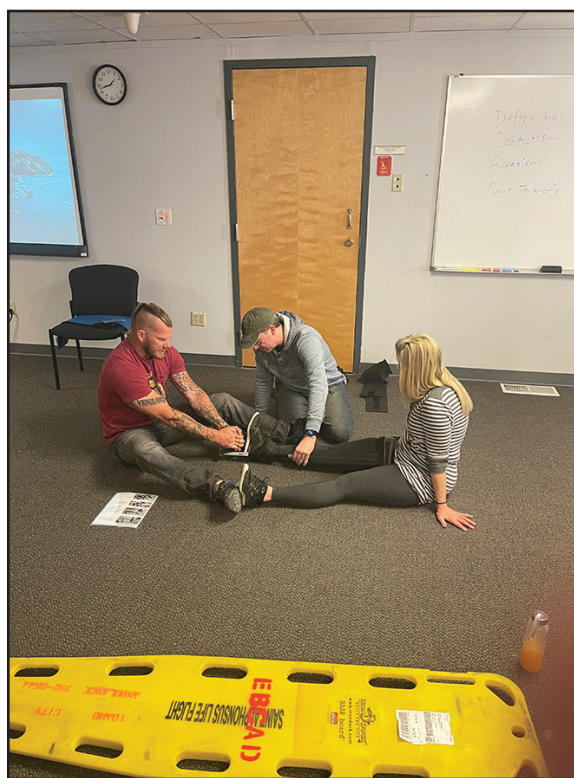


**BOISE COUNTY** -- East Boise County Ambulance District has initiated several courses for local citizens to take advantage of to become a certified EMT [emergency medical technician]. Dillon Brock has been the instructor for this course which has twelve new EMT candidates. Individuals are from Idaho City, Lowman, and other areas within Boise County. The new EMT students will complete the course, certify through the National Registry of Emergency Medical Technicians, and then volunteer in their communities with the ambulance district.

Since 2019, Brock and local teachers have instructed and certified 21 new EMTs from the area. The classes have incorporated those

serving as deputies for the Boise County Sheriff, Search and Rescue, and Idaho City Police officers. This allows the class members to crosstrain and bridge some of those gaps on the scene of an emergency. Even Idaho City's School Resource Officer has completed the EMT course and offers that additional level care to students.

East Boise County Ambulance District is a volunteer service and is operated by community members, providing care to their community. There are other opportunities in which to serve, such as becoming a driver. ## Horseshoe Bend Varsity Baseball

### HORSESHOE BEND --

The Horseshoe Bend Varsity Mustang Baseball team traveled to Glenns Ferry on Tuesday, April 8 for a 1A Western Conference game against the Pilots. The Mustangs came out with a 10-8 win with the help of the pitcher, senior Garden Valley co-op player Corban Fields, who was credited with the conference win.

On the offense, junior Decker Larson had 2 runs score, Fields had 2 runs, and junior Keegan Smith had 2 runs as well. Junior Bennett Thurman had 1 run score, and Garden Valley co-op player, junior Hudson Fields, had 1 run.

Horseshoe Bend was on their home field on Thursday, April 8th facing off against the Northstar Huskies (currently in 1st place in the 1A Western Conference) who traveled from Eagle to compete with the Mustangs for the second and final time in the regular season play. The Huskies, who do not have a home field, played as the home team. In the team's first match-up on March 16th,

the Huskies won 14-1 and likewise top in Thursday's re-match. The Mustangs couldn't pull off a win as the Huskies took the 4.5 inning 17-0 mercy victory.

Thurman started on the mound for the Mustangs and faced off against 29 batters, striking out 3, walking 4, and giving up 12 hits for 17 runs, 13 earned. Smith came in as the relief pitcher in the 4th inning, seeing 3 batters, then striking out the 1st before centerfield freshman Kaelun Jones caught a fly ball for the second out. Starting pitcher Thurman, now covering third base, went to first baseman for sophomore Gavin Kelly during the last out of the inning.

Offensively, Horseshoe Bend had difficulty connecting with the ball during the game as they ran through the entire line-up in 3 innings with everyone striking out with the exception of Kelly, who singled in the 3rd inning. Jones made contact for a single in the 4th inning, Thurman walked on a base on balls, and senior Jordan Bowles reached

first base on an error by the Huskies' third baseman.

In the 5th and final inning of the game, freshman Carson Drake had a single, Kelly got on by a fielder's choice, C. Fields got on after being hit by a pitch, and Jones was put on first by a base on balls. Drake was tagged out on Kelly's fielder's choice, Thurman struck out, and Bowles popped out to centerfield for the final out of the game.

Another tough day for the Mustangs, this time a double header, on Saturday, April 10 in Melba against the Junior Varsity Melba Mustangs. Melba came out on top 14-4 and 17-4.

The Mustangs hit the road to Bruneau on Monday, April 12 for a conference game against the Rimrock Raiders. This 6-7 loss for the Mustangs dropped them to 3rd place overall in the 1A Western Conference, 4-3 in district play and 4-4-1 overall for the season.

The team is at home on Friday, April 16 for a second game against the Glenns Ferry Pilots. First pitch is at noon.

# BOISE COUNTY COMMISSIONERS

Transcribed by Eileen Capson

**April 6, 2021**

**Present:** Commissioners Ryan Stirm, Steven Twilegar, and Robert "Ted" Holmes

Pledge of Allegiance

**EXECUTIVE SESSION:** Closed session per personnel. [Time 9:03 am – 9:17 am] No action was required.

**EXECUTIVE SESSION:** Closed session per risk management. [Time 9:17 am to 9:33 am] No action was required.

**CONSTITUENT INPUT:** None

**MINUTES:** Chairman Stirm motioned to approve the March 30, 2021, official meeting minutes.

**DEPARTMENTAL ISSUES:**

**FIELD TRIP:** Commissioner Stirm explained, "That is the day that we're going to take the Sheriff's van and drive around the county and look at everything that we want to look at." They decided on a May time-frame.

**PAYROLL ADDITION:** Stirm motioned to approve the payroll changes and addition for the Planning & Zoning Administrator and part-time clerk and trainer for Planning & Zoning.

Updated job descriptions for Solid Waste and Noxious

Weeds Assistant were approved.

**PLANNING AND ZONING COMMISSION:** Stirm stated: "Everybody, if you know of anyone who wants to be on the P&Z Board, we've got four open spots coming up in April." [This is a volunteer position.]

**SECOND AMENDMENT PRESERVATION ORDINANCE:** Commissioner Twilegar prepared an ordinance to present to the Board. Stirm clarified that a resolution would just be symbolic, but an ordinance would be enforceable by the Sheriff and Prosecutor, "It's a work in progress and will probably take a while. We want to do it right." Twilegar stated that declarations have "no teeth. If you want to make a declaration that it's 'Awesome People Day,' that's what a resolution is for. If you're talking about protecting Constitutional Rights, it needs to be in the law and an ordinance will fix that." He then asked the Sheriff how he felt about a posse, "I think Owyhee has the last one in the country." Sheriff Turner confirmed that Owyhee did have a posse and "we're kind of incorporating that concept in with our Search and Rescue." Commissioner Twilegar said

with humor, "Just primarily to me, it sounds cool. *Round up the posse.*"

Commissioner Holmes chimed in, "In the event of something serious happening in this county, you're not going to be able to do something with fifteen deputies. Are you willing and up to having people raise their right hand that can back you, former cops and military?" He said that something already existed, that he's a member of, in Garden Valley. There was discussion about keeping out convicted felons and, "pick and choose."

**SHERIFF:** An annual maintenance agreement was discussed for dispatch. Stirm motioned to approve the agreements in the amount of \$500, \$160, and \$1,115 for radio stations.

**EXECUTIVE SESSION:** Per exempt records. [Time 9:50 am to 9:58 am] No action required.

**EXECUTIVE SESSION:** Per personnel. [Time 9:58 am to 10:10 am] No action required.

Stirm motioned to approve three job descriptions for the Transfer Station Operator, Transfer Station Attend, and the Administrative Assistant for Solid Waste and Noxious Weeds Department.

**FUTURE AGENDA:** An individual asked for 15 minutes. The Avimor meeting will be moved to April 26<sup>th</sup>, Monday, after 6pm. The Commissioners' meeting will also be held on that day.

**VACCINATION CARD:** Chairman Stirm stated: "I kind of talked to Commissioner Twilegar about this a little bit. I've got to find out more details, but apparently, there's some states and some counties that the government offices and certain businesses are requiring a vaccination card in order for you to receive services. So, I want to make sure that, I don't know what we do again if it's an ordinance or what, *but to avoid that. To make sure that doesn't happen.* To make sure we don't have folks in the county doing that. Just to kind of put a lid on it, and say, 'Hey, *you can't do this.*' We're not going to allow this." Commissioner Holmes added, "We're not New York." Stirm continued, "So, it is happening in other more liberal states, but I want to kind of make sure that we're aware of it and that people know that we're not going to allow that." He added that they have no authority over private businesses, but government and county they do.

**FACEBOOK:** There was

a brief discussion with Prosecutor Strong regarding taking private money funneled for the Center for Elections Integrity, "Nineteen counties in Idaho" that took money. Twilegar stated firmly, "I don't think we should *ever take money.* I think we should maybe discuss that." This will be put on the agenda, or it was said to accept the money would be a decision made by the Board.

**BOISE COUNTY AUDIT:** Stirm said that the company called him and asked him some generic questions for the chairman. They will also reach out to Commissioner Twilegar regarding East Boise County Ambulance District.

**CENTRAL DISTRICT HEALTH:** Commissioner Stirm said they have a budget meeting coming up, and a representative from CDH will come up to one of the commissioners' meetings. Russ Duke will present the CDH budget in the first part of May and can ask him any questions.

**ROBIE CREEK ROAD:** A woman that had lived there for over 30 years asked if there was work planned for that road. Holmes said they've already had competitive bids to pave another mile of road, and planto work on it this summer. "I can assure you, next year you're not going to have the problems you've had this year." He added that there are other roads just as bad in the county and he's looking into grants.

**Adjourned at 10:32 am.**

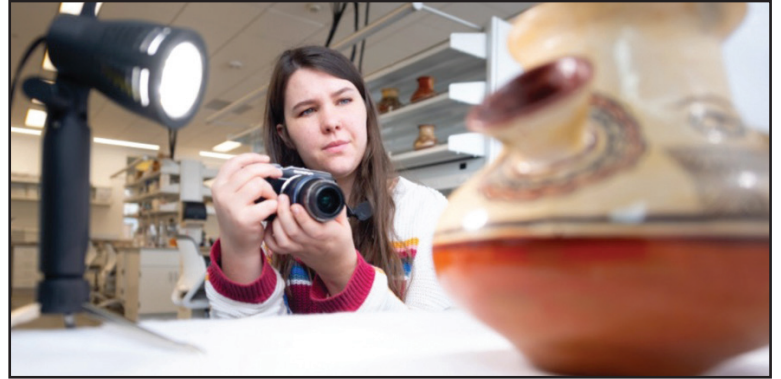
**IDAHO CITY** -- Stumbling onto historical remains of remote mining camps in the Boise Basin was part of University of Idaho senior Kristina Cockerille's outdoor experience as a teenager.

"We'd go for a hike and find mining camps, or old sheep herder cabins," the anthropology major from Idaho City said. "I was always around history."

On her first day as a freshman at U of I, Cockerille asked her archaeology professor for a research assignment. She found herself cataloguing century-old artifacts, coincidentally from mining camps in the Boise Basin where she grew up.

Her research has included

studying the remains of shoes found at Chinese mining camps in the basin. She has also investigated food remnants found under a former Chinese merchant shop in Idaho City and participated in bioarchaeology, the study of bones and material remains in order to learn about life in the past. Recent work included cataloguing a collection of pottery and artifacts from Ecuador that was donated to the university in 2019.

Kristina Cockerille was first introduced to historical remains while hiking through Boise County. She has now nearly obtained her degree in anthropology from the University of Idaho.

Cockerille photographed the collection of Sarayacu Quichua pottery, masks, and sculptures from central Ecuador, noting the recurring symbolism and themes among the pieces.

By providing a detailed survey of artifacts including a description, composition, function and what they may depict, cataloguing helps researchers understand patterns in human behavior and evolution.

"I love learning about people and cultures," she said. "Once I'm confident in one aspect, I

want to explore something else and learn more."
