Boise County Republican Women Host Guest Speakers

BOISE COUNTY -- The Boise County Republican Central Committee held their bi-monthly meeting on Thursday, April 15th, at the community hall in Crouch. Guest speaker Legislative District 8 Representative Dorothy Moon addressed the group of assembled republicans. She was later joined by Idaho Lieutenant Governor Janice McGeachin, who appeared virtually on a large television screen.

Representative Moon discussed the many ongoing actions within the Idaho State Legislature. There were several items of interest and discussion. Moon explained her priorities, which included limiting the governor's power to enforce emergency restrictions, such as restricting the number of people able to gather during an emergency event, like a pandemic. She also emphasized her desire to promote audits of paper ballots after elections. Representative Moon had deep concerns that critical race theory and a slant on social justice is being taught in public schools. Lt. Gov. McGeachin expressed a fear that children are, and have, the potential to be taught to hate America and each other in a school setting.

Later, Rep. Moon discussed

why she was in favor of the decision made by the House, House Bill 226, to not allow the State Board of Education to receive \$6 million in federal grants to support early childhood education across the state over the next three years. However, the State Board announced jointly with the Idaho Association for the Education of Young Children on Jan. 5 that Idaho had been awarded the grant. The State Board and Idaho AEYC leaders said the grant would support Gov. Brad Little's literary initiative by helping strengthen children's language and literacy skills from birth to age 5, before they start official schooling. Moon, along with other conservative republicans of the House, saw the partnership with Idaho AEYC and its national affiliate, the National Association for the Education of Young Children, as a threat to Idaho values and family dynamics. The conservative republicans suggested the national organization would use books and curriculum to indoctrinate children with a social justice agenda. Other republicans such as Rep. Paul Amador, who sponsored the bill, argued that the AEYC's national affiliate could not use the grant to push a social justice agenda. He stated, "This grant is 100 percent about local control."

Despite Idaho ranking last

in spending per student in the country, Moon stated, "We have plenty of money." She, as a former teacher, did not want education to be directed by the federal government. She felt that the consortium that would handle the money had no "transparency or accountability." Moon also brought up \$935,000 of funds either in federal COVID relief money or the grant that is to be directed to daycares. She stated, "This is a free market society; if you can't do that [the business you are in] then do something else." She further asked, "Why should they [daycares] receive money for the time they were closed?" She then asked, "Why didn't we do that for the restaurants? What elevates them [daycares] to super essential?"

The Idaho World asked Rep. Moon about the Lt. Governors' recent announcement that she planned on forming a taskforce to "uncover indoctrination in public education of critical race theory, socialism, communism and Marxism." She stated that the schools have already been identified. "The information has come to the legislators via parents and students." She stated that Boise State University, as a result of their president, has become "horrible." She said that students must go through a "walk of shame" where they are humiliated by others who yell "you are white"

while they are on the floor. She added that she knew of a young lady who had to "drop out in her junior year because she was white with curly red hair." To further support her description of BSU, she stated that they require three humanities classes. Moon, who attended Missouri State University, stated "When we went to college, we took only one humanities class, such as pencil drawing. BSU requires: "Three classes. That's nine credits we have to pay for, and they all include race." Humanities classes are intended to cover subjects such as history, art, philosophy, and religious studies.

Lieutenant Governor Janice McGeachin then spoke virtually to all in attendance. She highlighted the fact that she is happy that Idaho is beginning to get back to a normal life, but that it was frustrating to "be where we are at right now." She stated that meetings dealing with important issues were still being postponed, but there was a promise to us to restore the balance of power between the legislative and executive branches. She further explained that the governors' power needed to be limited and that an amendment to our Constitution needed to be made to allow the legislation to be called back into service under certain circumstances. Currently, only the governor has the authority to call a special session.

She also cited the Bundy and Schmidt case, who were to go on trial after being charged with trespassing in the Idaho Statehouse last year, but Bundy was arrested again after he refused to wear a mask in the courthouse for the trial. The courthouse has had a mask mandate in effect, which Bundy was protesting. McGeachin called it "ridiculous, that this is happening." That people are being restricted from a building and being arrested just because they refuse to wear a mask.

Lt. Governor McGeachin discussed her aggravation towards last year's order to self-isolate, and an individual's right and freedom to openly worship.

She indicated that the task force she intends on forming to investigate social justice in the public schools would be eye-opening to a lot of people, and additionally what is being taught to Kindergarten through 12th grade students. She stated, "We should not be teaching our children to hate America and hate each other."

The meeting ended with chairwoman Jean Mollenkopf Moore reading from a passage she wrote and submitted as a Letter to the Editor for publication in *The Idaho World*, which addresses the early education grant. She firmly added that, "We must protect Idaho's littlest people from early exposure to dangerous ideologies."

HORSESHOE BEND --

The Horseshoe Bend Mustang Varsity Baseball team hosted the Glens Ferry Pilots on Friday, April 12 in a 1A Western Conference showdown. Six days prior the Mustangs beat the Pilots 10-8 at Glens Ferry in their first match-up of the season.

Garden Valley co-op player, senior Corban Fields, started on the mound for Horseshoe Bend. Fields faced 23 batters in the first 5 innings, striking out 6 and giving up just two runs, 1 of them earned. Down 2-0 in the 5th inning, Mustang relief pitcher, junior Bennett Thurman, saw 7 batters, striking out 3 while giving up just one hit and no runs. In the sixth inning some of the Mustang's bats went to work starting with a double from junior Decker Larson, followed by a single from Thurman, and senior catcher Jordan Bowles got on after an error from the Pilots centerfielder. All scored runs and put the Mustangs ahead 3-2. In the top of the 7th Thurman struck out the first

and third batters and a fly out to centerfield was handled by freshman Kaelun Jones to end the game in a Mustang victory. Larson also had a double in the first inning and a single in the third. Thurman had an RBI and took the win as pitcher.

The team will be at home on Thursday, April 22 for a

Western 1A conference game against the Rimrock Raiders.

The Mustangs are looking to avenge their 6-7 loss to the Raiders on April 12. On Monday, April 26 Horseshoe Bend is at home again and faces the Wilder Wildcats for the first time this season. Both games start at 4:30.

HORSESHOE BEND --

The Horseshoe Bend Varsity Track team was in Payette on Tuesday, April 13 for the Payette Invitational Track Meet. Senior Ethan McDonald finished in 3rd place in the 100 meter dash with a time of 12.21 seconds. Senior Caedmon Graham placed 3rd in the triple jump with 36' 6" and 15th in the 200 meters with a time of 25.99 seconds. McDonald and Graham teamed up with senior Hunter Howerton and sophomore Jedi Graham for the 4 x 100 relay and came in 7th place with a time of 48.29 seconds. Howerton competed in the triple jump and placed 8th with 33' 10.5". J. Graham was 8th in the 400 meters with a finishing time of 58 seconds. Senior John Gorbet finished 24th in the discus throw with an ending measurement of 79' 5". Freshman Abby Howerton was the only girl to place and she did triple duty coming in 10th in the high jump (4'), 11th in the discus throw (72'9"), and 15th in the 400 meters (1 minute 18.26 seconds). The middle school track team had their first meet in Nampa on Friday, April 16. The team was at Columbia High School for the Western 1A Middle School Conference Meet. 8th grade student, Colby Swan, finished 1st in the discus throw (105' 11"), received 2nd place in the shot put event (32'3"), and placed 9th in the 100 meters with a time of 14.15

seconds. 8th grader Trey Bauer took 1st place in the 100 meters (13.04 seconds). The 8th grader also competed in the high jump finishing 2nd (14'11"), and 4th in the long jump (14'7"). Bauer was also part of the 4 x 100 relay team along with 7th grader Lukken March, and 6th graders Lakota Innes, and Taylon Osorio. The team took 4th place with a time of 58 seconds. March also competed in the high jump placing 4th (4'2"). Osorio ran the 100 meters in 16.14 seconds for a 20th place finish and placed 18th in the long jump (10'9"). Innes had a 9'1" at-

tempt in the long jump, good for 21st place. 8th grader Isaac Bowery placed 6th in the discus throw (60'5"). 8th grader Elliana Matter was 5th in the high jump (3' 8") and 12th in the 100 meter dash (16.37 seconds). 6th grader Addison Asher was 7th in the shot put competition (18') and 6th grader KayLee Bowery finished 15th (13' 7"). 6th grader Kimber Jones placed 8th in the 200 meters (34.76 seconds) and 11th in the 100 meter dash (16.10 seconds). 6th grader London Parker was 11th in the long jump (8' 5.25").







Present: Commissioners Ryan Stirm, Steven Twilegar, and Robert "Ted" Holmes

Pledge of Allegiance

EXECUTIVE SESSION: Closed session per personnel. [Time 9:03 am to 9:34 am]

SWEARING IN OF PLANNING AND ZONING COMMISSION MEMBER:

Commissioner Stirm swore in Philip McKay to support the Constitution of the United States and the State of Idaho. "And faithfully discharge the duties of Planning and Zoning Commissioner," according to the best of his abilities. Com-

missioner Stirm also added, "In case anybody wants to know, we do have, I believe, three more positions open for that same board, currently. So, if anybody knows anyone that wants to be on that board, there's plenty of space."

CONSTITUENT INPUT:

George Butters, Placerville Fire Chief, addressed the Board of County Commissioners with a concern regarding the new powerlines coming from Horseshoe Bend and over to Garden Valley. He said that the placement would essentially eliminate one of their helicopter landing areas. Com-

missioner Stirm thought the work was to be done on Alder Creek Road, because the road department helped clear some trees there. Chief Butters said the original plan was to come up Porter Creek, down to Mud Flatts, to the tee at Harris Creek Road, then cross Centerville Road at the tee, and go through Placerville and over Alder Creek Road. "There will be powerlines. We won't be able to put a helicopter down there *at all*."

Commissioner Holmes asked if Idaho Power had looked at it, and Butters said it was just brought to his attention on Friday. Holmes continued, "I'd like to look at it. I've been flying helicopters for 40 years and I could tell you if it's safe or not, based on looking at it, if it's going to effect it or not. I'll come out there and look at it. Because, if I won't land in it, then I'm sure they won't either. If it's unsafe, then we'll definitely talk to Idaho Power."

Chief Butters concluded with concern for the taxpayers, "We do need to figure something out, because we really can't afford to lose..." Holmes committed to checking out the site later that afternoon.

Bill Jones, Department Head for the Road Department, stated that the project had been ongoing for approximately the last four years. He recalled that they did present their project to the commissioners several years ago. Jones said the project has been stagnant because

the company has not been able to find anyone to clear the trees.

Commissioner Stirm said they should invite Idaho Power to come talk with the commissioners.

Richard Barber, of Placerville, was concerned about the representation of the Placerville City Council and feeling left out. "We weren't asked about the powerlines, and as he mentioned, that's one of

our major – that's the only helicopter landing zone we have year-round and we can count on. The rest of them, we can't count on." Barber stated that the ambulance out of Placerville has not been in operation for the past five years and it takes an ambulance between 45 minutes to an hour and a half to get to there. However, they're getting things moving in the right direction with the East Boise County Ambulance District.

MINUTES: The April 6, 2021, official meeting minutes were approved.

PLANNING & ZONING: Chairman Stirm made a motion to approve the payroll additions for Planning & Zoning, including the Inspector/Code Enforcer and Permit Technician.

JUVENILE JUSTICE: Department Head, Amanda Leader spoke about grounds maintenance for county office buildings and painting of the boardwalk. She also spoke about wasps nests and spray that is applied and budgeted for the Juvenile Justice building by Terminix several times a year because the maintenance person is allergic to bees. She said that the other buildings are responsible for their own maintenance, but she has seen nests forming and suggested the county may want to be proactive. Stirm suggested she get a quote from Terminix to do all the buildings, so they can discuss it as an annual maintenance. "If the building maintenance person is allergic, obviously we don't want her out there swinging at bees." Several others in the room admitted

to needing an epi pen should they be stung.

ROAD DEPARTMENT: Jones spoke about the engineering project on Robie Creek Road [to pave another mile of road] and he said they were pretty close to having it finished. Perhaps next week.

Bill Jones also handed out copies of his resignation letter. "I'm going to resign, after two weeks from today." Commissioner Holmes asked, "Who's your next senior guy in charge?" Jones listed two lead men. Holmes asked him to schedule a meeting at 12 noon the following Wednesday with all his people, and the prosecutor will be there.

CITY COUNCIL MEETING IN I.C.

IDAHO CITY -- At the Idaho City regular Council meeting held Wednesday April 14, 2021, there were two events approved. The first was the Idaho City Off Road Stampede, sponsored by The Go Agency. representative Page Wilson presented her requests for support from the Local Idaho City Police Department, in the Rodeo Park, and an alcohol variance for May 12, 2021. The Idaho City Council approved these to support this event.

The second event approved by the City Council was the Idaho City Historical Foundation – “Yard Sale of Historic Proportions.” This was presented by Beth Wilson and will be held in the park over Memorial Day weekend with an alcohol variance for the sale of beer, live music, and allowing other organizations to sell crafts and baked goods.

The Mayor Canody and the City Council members complimented the Historical Foundation for the good work that the inmates have done cleaning up the park, and other areas around Idaho City. Beth Wilson presented to the City Council

a land exchange proposal for Block B in the Idaho City Townsite. Part of the Idaho City land is under the historical building of the Penitentiary. This was discovered last June 2020, and Wilson presented the legal descriptions to show the exact land to be exchanged. After a lengthy discussion it was proposed that Attorney Linville prepare the deeds and Idaho City Council and Historical Foundation will sign the appropriate documents to do the land exchange.

The Lobby Coffee in the Idaho City Hotel requested a retail alcohol beverage license. The vote of the Council Members was 3/2 in favor of allowing alcohol to be served.

The Law enforcement department, Chief Mark Otter, requested an agreement with Watch Guard for “description services” in a Motorola body camera. This would enable police officers to have more communication with other precincts, 72-hour recording, and immediate information on scans such as drivers’ licenses and plates.

Central District Health



This week's Boise County updates:

- Boise County case counts increased, with 7 confirmed for the week of 4/11-4/17.
- Boise County schools moved into the yellow category (at a rate of 10.95/100k) as of Monday. (The CDC criteria lists Boise County in the orange or substantial risk category.)
- The Brazilian variant was detected in City of Boise wastewater – from a sample taken in late March. The variant has not been sequenced from any test samples in the CDH region yet.
- 7,020 doses of Pfizer vaccine, 5,500 doses of Moderna and 0 doses of Janssen* were received into the CDH region this week.
- Everyone ages 16+ in the US is eligible to receive their COVID vaccine as of Monday, April 19.
- As a reminder, Pfizer vaccine is the only vaccine approved for people 16+. (Moderna and Janssen are approved for 18+.)
- Janssen distribution and administration remains on pause while reviewers consider additional research on possible side effects. As a reminder, Janssen vaccines use a different delivery mechanism than Moderna or Pfizer, the side effect of concern is very rare (six instances out of 7 million doses administered), and the pause was done out of an abundance of caution.

• Vaccine uptake rates have slowed in Boise County. CDH and community providers will continue to support access to those who would like to receive a vaccine. We’ll continue to provide education and messaging to encourage uptake among those who have not decided to receive theirs yet. COVID-19 vaccines are the best tool that we have to get past this pandemic.

CDH Recommendations

We said it last week but we’ll say it again – if you are feeling any symptoms that might indicate a COVID infection, please seek out a test: <https://get-tested-covid19.org/>. Last week we heard about a stomach bug affecting groups of kiddos in Boise and Ada Counties. While germs and stomach bugs are not uncommon for our youngest age groups, it’s important to rule out COVID infection. Anyone waiting for COVID test results should quarantine until they receive those results.

As always, CDH would like to remind everyone to:

- Wear a face covering when out in public, especially when you are unable to maintain a physical distance of at least six feet. This includes at school and work.
- Maintain a physical distance of at least six feet from any non-household member
- Stay home if you are sick, even if symptoms are mild
- Limit your trips in public; limit unnecessary travel
- Wash your hands frequently and disinfect high-touch surfaces


- Create a plan for how to safely care for and isolate a household member if they become ill.
- Make arrangements to receive a COVID-19 vaccine as soon as possible.

Q&A

Question: Why are we hearing about more COVID cases in kids and teens?

Answer: “Doctors attributed the rise in hospital visits of teens and young adults, at least in part, to B.1.1.7, the coronavirus variant first identified in the U.K. that public health officials say is now the most common strain circulating in the U.S. The variant is highly contagious, thought to be about 60% more transmissible than the original strain of the virus.” Physicians, researchers, and public health officials expect the situation to improve as the U.S. vaccinates more people, regardless of age. As more people get vaccinated, it will become more difficult for the virus to spread from one person to another because more people will have antibodies. The less the virus is able to spread, the less chance there is for it to mutate into a new variant. IDAHO CITY -- If you go to the new Mayo Family Healthcare in Idaho City, you might meet "Harry" the cutest little pig ever, who roams happily throughout the hallways. Along with Harry there is also BillieSue Mayo, who operates the clinic. Mayo is a Nurse Practitioner along with Eva Bingham, who is a Dr. Practitioner, they trade days to keep the healthcare clinic open Monday, Wednesday and Friday from 9:00 AM to 5:00 PM. There is also a portal where patients can obtain help any day and on weekends if it's urgent.
