## Bolse County Interagency Emergency Exercise

**By Jennifer Haney BOISE COUNTY --** The

Garden Valley Protection District hosted this year's Boise County Interagency Exercise on Saturday, May 15, 2021. This annual exercise helps to bring emergency responders together, work more efficently as a team, and better gauge emergency responses. The exercise was staged at the Garden Valley School and involved many different agencies in the county.

The training was provided by simulating real-life emergencies. Participants gathered at the Garden Valley School and were divided into teams.

These participants were directed to respond to one of four different scenarios.

The scenarios included:

- 1. A victim had fallen from a cliffside to the river.
- 2. A victim was trapped inside a car that had live electrical wires laying on it.
- 3. A wildfire on a hillside threatened a structure with possible occupants.
- 4. A small HAZMAT spill.

In all four scenarios, responders needed to assess the situation, safely extract the victim and get them to the waiting ambulance. Additionally, responders also had to simulate traffic control and coordinate using radios from different agencies.

The exercise consisted of Garden Valley Fire, Centerville Fire, Horseshoe Bend Fire, Robie Creek Fire, Clear Creek Fire, Boise County Sheriff, Boise County Interagency and State Communication Dispatch, Boise County Fire Dispatch, Idaho Department of Lands, Atlanta Fire Department [Elmore County]. Wilderness Ranch, The U.S. Forest Service and Idaho Power.

The World spoke with Garden Valley Fire Chief Jon Delvalle. He recognized, "There are always hiccups, but ultimately the exercises went smoothly." He explained that this year, they did some different technical scenarios, instead of just fire. This added to the complexity and the opportunity to learn.





## ISE COUNTY COMMISS

May 11, 2021

**Present:** Commissioners Ted Holmes and Steve Twilegar

**Absent:** Commissioner Ryan Stirm

Pledge of Allegiance

**EXECUTIVE SESSION:** Closed session per personnel issues. [Time 9:02 am - 9:31 am] No action needed.

**CONSTITUENT INPUT:** None

ROBIE CREEK ROAD PAVING PROJECT: Commissioner Twilegar, acting Chairman, said they were going to open the four bids for the projects to review them and take action at a later date.

**MINUTES:** The minutes were approved for May 4th.

**ROAD DEPARTMENT:** A representative said they wanted to work with the grant writer to get more money for dust abatement, to help support the road and fix it. They are also looking to get more road mix on the roads, so they have more material to work with.

They are working to get their water rights permits.

Garden Valley's shop, their waste oil meter went out, so they will be seeking bids for that.

**EMERGENCY** MAN-

**AGER:** The Forest Protection Manager for the county will take on the job of Emergency Manager, for the time being, as per a motion by Chairman Twilegar.

**ROAD & BRIDGE JOB:** Twilegar made a motion to approve the job description for the Road and Bridge superin-

tendent, as revised. **ASSESSORS:** Chris Juszc-

zak spoke regarding the expenditure that is per statute, purchasing envelopes, etc.

TREASURER: Gina Turner said they would also have a large expenditure for mailing out tax bills.

SHERIFF: Scott Turner said its been very busy with crashes, fatalities, and suicides. Commissioner Twilegar agreed, "It's truly been a horrific year." Sheriff Turner said they are having June and July numbers in the month of April, "and this month is already shaping up to beat that already. It's going to be a long summer."

The Interagency Exercise would take place on Saturday.

**SUICIDE PREVENTION:** 

Ms. Leader from Juvenile Justice spoke to the Ada County Coroner about purchasing

rights for a suicide prevention campaign. They would like to get the word out. She said in Ada County, they have had 47 suicides this year, "and the primary demographic is adult white men, ages 40 to 60. So, that campaign is directed towards that demographic." Commissioner Twilegar stated: "We've had just an insane amount of suicides this month, or within the last six weeks." He said this campaign would be helpful.

GRANT WRITING: The grant writer discussed how she will approach grants and the process of notifying the commissioners of grants. A consulting agreement was approved through a motion with the grant writer, in the amount of \$1,500 and 10% of all grants awarded.

**BILLS:** Commissioner Twilegar motioned to pay the Claims Approval Report in the amount of \$136,070.52.

ITD RESPONSE LETTER:

Idaho Transportation Department sent a response regarding making Jake Brakes illegal within the city limits. Twilegar read, "The Idaho Transportation Department said, 'You can't do that,' any state highway or anything like that. You do not have jurisdiction over that, which is educating, but I guess there's not much we can do about that."

Sheriff Turner said he knew the city had the ability to change the speed limit on a federal highway. Twilegar will look into it, "I find it odd that they would even care about anything like that, because there are people that live all down that road."

**DEMAND WARRANTS**: For the capital crimes case there were several payees, [which the commissioners are not permitted to know their purpose or the particulars of the charges, but the state helps fund these death penalty cases] Commissioner Twilegar made a motion to pay for confidential legal service, payee #3 in the amount of \$8,068.25. He made another motion to pay payee #1

in the amount of \$5,962.50. EAST BOISE COUNTY AMBULANCE: The board spoke regarding an agreement to provide ambulance services to the Gold Dust Rodeo [June 25-26], Jack Pine Roundup, and the Idaho City 100 Enduro [June 5-6]. Motions were said for two of the events, but the Jack Pine Roundup was tabled until Commissioner Stirm could return, because Twilegar stated he is on their board.

**TWILEGAR:** Commissioner Twilegar said for the record, "My business partners have purchased a couple of businesses in town. I know that Boise County gets gasoline from the only gas station we have in town, and I want to go on record that I have zero

percent interest in that business and I have zero percent interest in the hotel."

**ROAD IMPROVE-**MENTS: There were representatives from ITD. Western Federal Highways Division, and Idaho Fish and Game to present. The Idaho Transportation Department representative stated there were six areas, including the Banks to Lowman intersection of Highway 55, "big picture improvements." There was also talk of the

Highway 21 Wildlife Overpass. Another overpass will be done a little further up the road at mile marker 19.3. The fence would be extended up to the private property. They are working on final designs, and it is scheduled to be complete by the end of this year. Construction is projected to be completed by the end of September 2022. There are about 8,000 deer and 1,500 elk that migrate through there twice a year.

## State Championship



The Horseshoe Bend Mustangs secured a third place berth in the Idaho 1A State Championship Tournament after a tough second round loss to the Glenns Ferry Pilots on Thursday, May 13 in Glenns Ferry. The Mustangs finished the season 13-4-1 overall and 10-2 in conference play earning them a second seed placement behind the Northstar Huskies. That second place finish gave them the home field advantage in game number one of the Western Idaho 1A District Tournament. Game number one was played on Wednesday, May 12 against the Greenleaf Friends Academy Greyhounds who joined up with the Gem State Adventist Academy to co-op a first year baseball program. The rookie team finished in last place with an 11-1 conference record. The game began with the Mustangs on defense and senior Jordan Bowles was on the mound for Horseshoe Bend. Bowles faced 18 batters in the 5 inning, 10-0 mercy win for the Mustangs. Bowles, the Mustang's starting

catcher, struck out 10, walked one, and gave up only one hit during the game.

In round two of the tournament, Horseshoe Bend faced off against the Glenns Ferry Pilots who hosted the remainder of the tournament. The Pilots ended their season in third place for the conference with a 7-5 Western Idaho 1A record. The loss put the Mustangs in the loser's bracket, setting them up for a win or go home game schedule.

On Saturday, they faced the Rimrock Raiders (6-7 conference record) and took the win 2-0 with Thurman and Fields scoring the only runs of the game. The win gave them the opportunity for a third place finish against the Wilder Wolverines who came into the tournament with a 6-7 conference record. Horseshoe Bend took the win 7-6 securing a spot in the State Tournament that takes place in Orofino on May 21-22. The Mustangs face the Kamiah Kubs at 11:30 a.m. on Friday, May 20.
