IDAHO POWER PLANS UPGRADES IN BOISE COUNTY

BOISE COUNTY -- The Idaho Power Company has been conducting line replacement and other types of repairs in the Garden Valley and Lowman areas. Often this work involves traffic lane restrictions and occasional power outages. However, Idaho Power assured that these nuisances are only temporary and the upgrades that are being completed will help ensure continuous power service to all in the

area.

Here is a rundown on projects that are ongoing or planned:

Lowman Area

• Idaho Power is replacing all the underground lines in the Lowman area. This work started in April and will continue until approximately August.

• They have also (last week) upgraded a pole and transformer on Archie Creek for a new customer.

Garden Valley Area

• Idaho Power is conducting routine maintenance, upgrades, and hardening the poles and lines to protect against fire.

• In June, line crews will start building a new distribution line between Horseshoe Bend and Garden Valley. They will begin in Horseshoe Bend and work their way to Placerville this year. Next year, work on the line from Placerville to Garden Valley is planned.

HSB Valley Chamber of Commerce

HORSESHOE BEND -- It was celebration time for the Horseshoe Bend Valley Chamber of Commerce as they surpassed the 100 members mark on Tuesday, May 18th. With 102 official members, the chamber is becoming a vital part of the Horseshoe Bend community. Chamber members, The Locking Horns Riverside Restaurant, opened up their facility for the celebratory event (The Riverside Restaurant is usually closed on Tuesdays) and served up a wide variety of pizzas for those in attendance. Chamber Co-lead Kimberly Welsh introduced executive team members and gave information regarding the upcoming "Connie Day" to help founding member and Chamber Community Coordinator Connie Petty pay for expenses related to a recent health scare. The citywide event takes place on Saturday, June 12 beginning

with breakfast at the Locking Horns Riverside where owners Cliff & Summer Ohler will be making a donation for every diner that says "Connie" when they order breakfast. Proceeds from a BBQ lunch in the park will go to Petty, as will monies earned from a silent auction at the city park during the BBQ from 12-2. Live music by Jesse Dayne & the Sagebrush Drifters will wrap things up at the Longbranch Saloon beginning at 8:30 p.m.

Auction items can be donated at local chamber establishments: The She Shoppe, The Parts Store, Ray's Corner Market, and The Corner Café.

The Ohlers were spotlighted during the meeting and spoke of their love for the community. They recently underwent a renovation of the restaurant, including expanding the back patio area which overlooks the scenic Payette River. They thanked Jay Roberts from

chamber member Backcountry Dirt Worx for his help with the transformation.

Another chamber member was spotlighted, Premier Aggregates, which operates in seven locations throughout the Treasure Valley, including Horseshoe Bend and Emmett. Spokesperson Lane Buchert spoke of the company wanting to become more involved with the community and helping younger individuals get into the workforce.

Welsh wrapped up the meeting with a rundown of events the chamber has planned in the upcoming months, including finalizing the Veteran's Memorial, which is set to go into the new city park that is being developed by the river, the new bridge, and the Casino Night being held on June 19 at the Riverside restaurant that will help fund the Memorial.

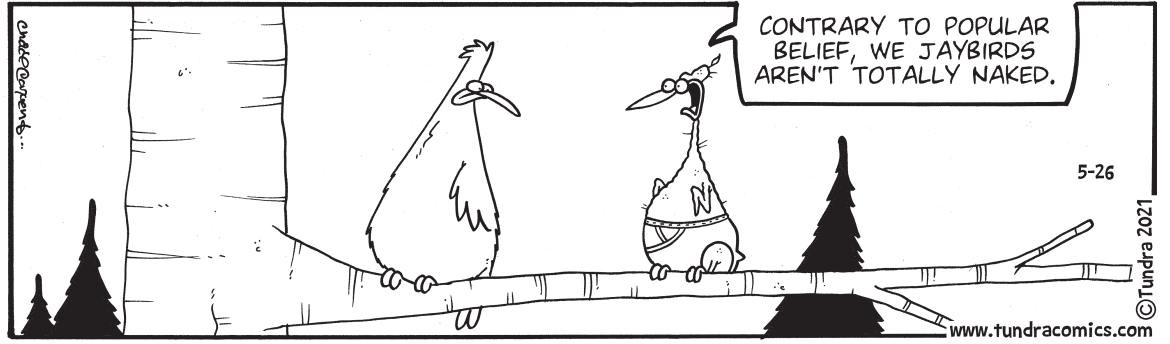
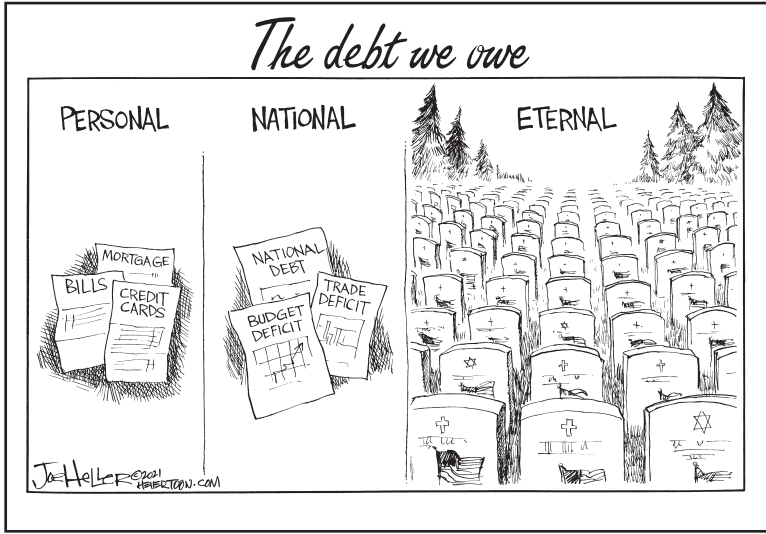

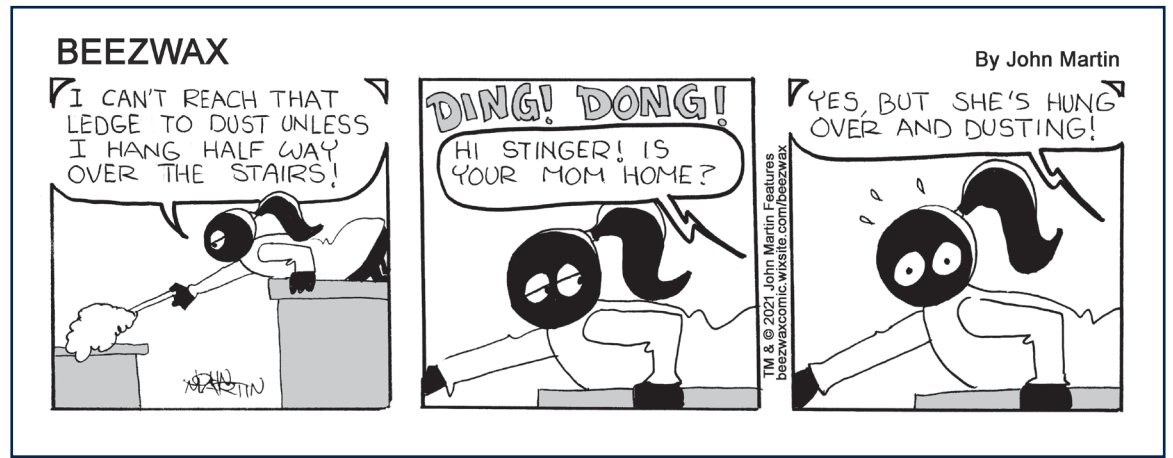

ROAD IMPROVEMENTS:

There were representatives from ITD, Western Federal Highways Division, and Idaho Fish and Game to present. *(Continued from last week)*

Mule Deer migration across Highway 21, supports one of the largest populations for game hunting. A new overpass was discussed, and more elk are expected to use this one. The fence is challenging construction, with the same design, just extended with "jump-outs." They will also position cameras to get pictures of animals using the overpass.

The next project they are focusing on is up Highway 21, at the entrance into Lowman, over the Payette River bridge – built in 1946. "It is at the end of its life," said a representative. It will be completely rebuilt in that location with enhanced safety features. The bridge will be wider to incorporate bikes and foot traffic, 6-foot-plus. He presented a drawing to the commissioners. Construction will begin in 2024.

Another bridge replacement project was discussed on Highway 55, at Fleming Creek, milepost 75. There's currently a culvert there now and there are issues with erosion. "When we replace it, we are able to maintain traffic in both directions, so we won't have to have a single lane restriction, which we will have to have for the Lowman bridge," said a representative. There may be some daytime flagging, Monday thru Thursday. The construction time is expected to be the summer of 2023, and take 4 to

6 months.

State Highway 55 and Banks "beach parking" was discussed. "There will actually be a tunnel that goes underneath the highway, to eliminate that pedestrian conflict," said another individual.

She then talked about the Banks Lowman intersection. The vehicles are coming westbound on Banks Lowman and they are having a hard time getting out. Flaggers have been there for high volume holiday weekends. "We're trying to figure out how to solve that problem... Overall, it's a safety issue." She recognized that there was a fatality a few years ago when someone was turning left there. They are gathering data, and in the planning stage. They will need more funding to proceed.

The first representative spoke again and said they were going to increase safety signage along the corridor leading up to the intersection. An advisory speed will be posted and lights will flash, to warn of congestion. They are going to double the amount of days that they are able to offer flaggers, from about 9am to 7pm. "It used to be three. We are going up to six... Every week in July, we've eliminated Memorial Day. We are going to be doing one on June 20th, because of an event happening in Garden Valley. We will be back for Labor Day as well," said the first representative. This schedule will depend on the weather. "We need to have out crews go out in pairs. There came a point in time, about a decade ago, when we were getting just constantly harassed when we were going out and flagging. And it's for their safety that we're going to have them out in pairs. Once someone with blue lights and a badge shows up, *it's crazy*, everyone's attitude becomes much

more cheery." They are looking to get a little more law enforcement support.

There was some talk regarding ITD's maintaining of Highway 21 over the last year. The first representative said their first priority is "freeze-ups on the interstate," although there was 6-inches of snow on Hwy. 21. They are also having issues with hiring and retention.

EXECUTIVE SESSION: Closed session per risk management, and it was mentioned by the Sheriff – for an accident. [Time 9:04 am to 9:33 am] Acting Chairman Twilegar said there was no action required.

CONSTITUENT INPUT: Bud Payne stated bluntly, "EBCAD [East Boise County Ambulance District] is not a broken system. It is a decimated system." He said that people that have two and three years of experience are not qualified to run the operation. "It needs to be run as a business, not a social club." He would like to present a plan to fix problems that cause delays with medical response. Commissioner Twilegar asked, "Do you think you could rally the sup-

port of people in this county to do it?" Payne answered, "Yes, *I do*." Twilegar replied, "*I don't*." Payne said that he has a plan for Lowman and says that politics are getting in the way. Twilegar replied, "I definitely care about people. Don't tell me I don't care about people. *You don't know me*. You think that because I don't respond to you, doesn't mean that I don't care about people? *Don't you come in here and tell me I don't care about people. It's inaccurate!*"

Payne says he has 45 years of experience and a progressive program he is putting together with paramedics.

Another constituent, Gary McLean from Wilderness Ranch subdivision spoke about EBCAD and proposals to fix response times in Lowman, Placerville, etc. "What is your plan to improve EBCAD member satisfaction and retention? To improve response and care in Lowman, Clear Creek, Placerville, and throughout east Boise County?" He also asked if there was a plan for public education. McLean said he had been in EMS since 1974 and spoke about running an operation as a Navy Seal. Commissioner Holmes stated he was concerned about leadership as a whole. Twilegar said, "It all sounds great! And people that come in here say they have all the right ideas, but nobody comes with an idea other than raising taxes, how to pay for it. Again, it's not a great service that we're providing, but it's the best we can do on the budget that we've got." This is a volunteer-based system. "This is not a small problem," said

Twilegar. "This is endemic of any small county, or poor county in Idaho... But, we are going to do some things. There will be things forthcoming."

Sam Bonovich, Fire Chief for Clear Creek, said, "In 15 years, you would think most people learn by mistakes, and you try to grow and do better. Where in medical, in 15 years, we've gotten worse." In working with state EMS, county fire departments, and the Sheriff, they produced a document. EBCAD elected not to add to the document. Commissioner Holmes stated, "We've got a problem, then... I believe in fixing things that are broken."

MINUTES: The minutes from May 11th were approved through a motion.

ROBIE CREEK PAVING BID: Commissioner Twilegar made a motion to award the bid subject to Knife River completing in range of contract to pave another mile of Robie Creek Road in the amount of \$172,000. The engineering firm had recommended Knife River.

SOLID WASTE: An employee resigned, so now there are two openings. They are parttime, \$12 hour, with benefits and medical. The department head would like to combine those two positions to offer a fulltime position.

COURT COSTS: Commissioner Twilegar motioned to approve the 2022 indigent defense financial assistant compliance proposal and application [to help with the added expense for a murder trial].

Adjourned at 11:37am.

Donald won first place in the 100 Meters.

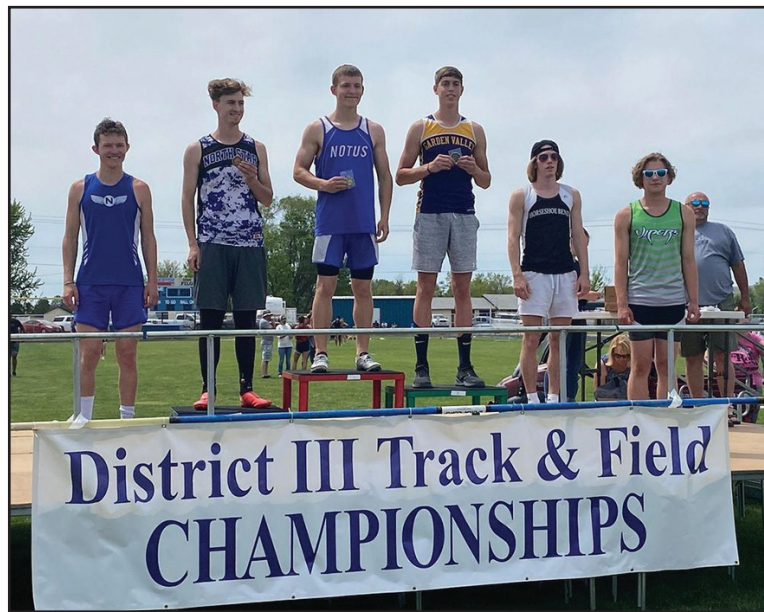

Idaho City's Trayton Nelson and Nathan Kindelberger won first and second in the 12lb Shot Put.

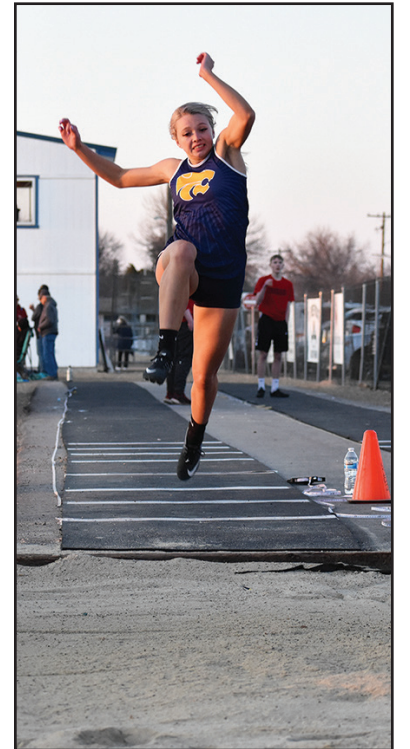
