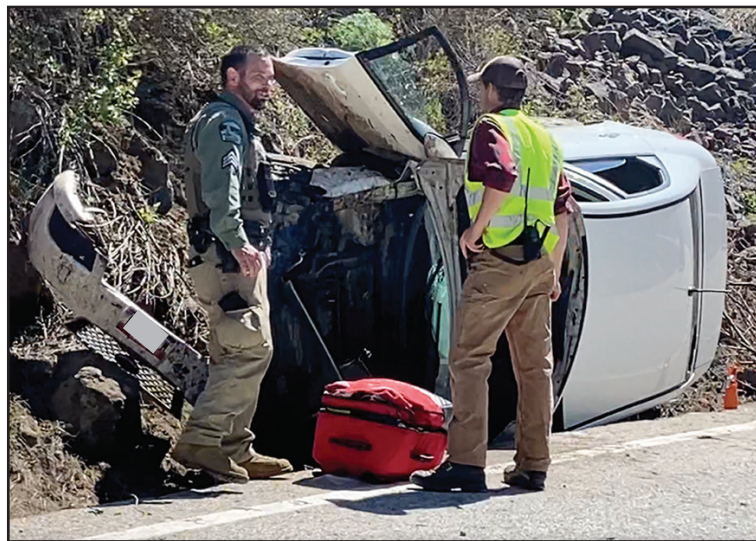

Auto Accidents and First Fatality in Boise County

BOISE COUNTY -- A single car accident occurred on Wednesday, April 28th, at 11:30 AM along Highway 21, located about 10 miles south of Idaho City. According to Boise County Deputies, the crash is still under investigation. Although speed may not have been a factor, an officer explained that a particular inhalant may have contributed to the crash into the rock embankment. There were two occupants and each were flown to St. Al's hospital by separate helicopters. The driver was wearing a seat-belt; however, the passenger was not.

Traffic was stopped on Wednesday, April 28th, for nearly two hours while emergency crews attended to a single vehicle crash along Highway 55, near milepost 73, south of Banks. Idaho State Police reported that Eva Kivett, 79, of Boise, was traveling southbound in a 1999 Toyota 4Runner when she drove off the roadway, overcorrected and lost control. "The vehicle overturned and traveled down a steep embankment where it came to rest partially in the south fork of the Payette River. Kivett was wearing her seat-belt." Although crews were able help in her rescue and had her transported by helicopter to St. Al's hospital in Boise, she later succumbed to her injuries.

GARDEN VALLEY -- Destinee Simpson, a 16-year-old student at Garden Valley School District lost her life as a result of a car accident on April 26, 2021 in Crouch. A 'Meal Train' has been organized for her family. This is an online method of providing meals for the family so they do not have to worry about preparing food. Instead, the community cares for them. The site allows participants to view dates, and allows an individual the opportunity to fill in their name and the dish they intend on bringing. Frozen meals that are easy to prepare are also acceptable.

There are three adults in the family. The site asks that participants "please do not disturb the family during this difficult

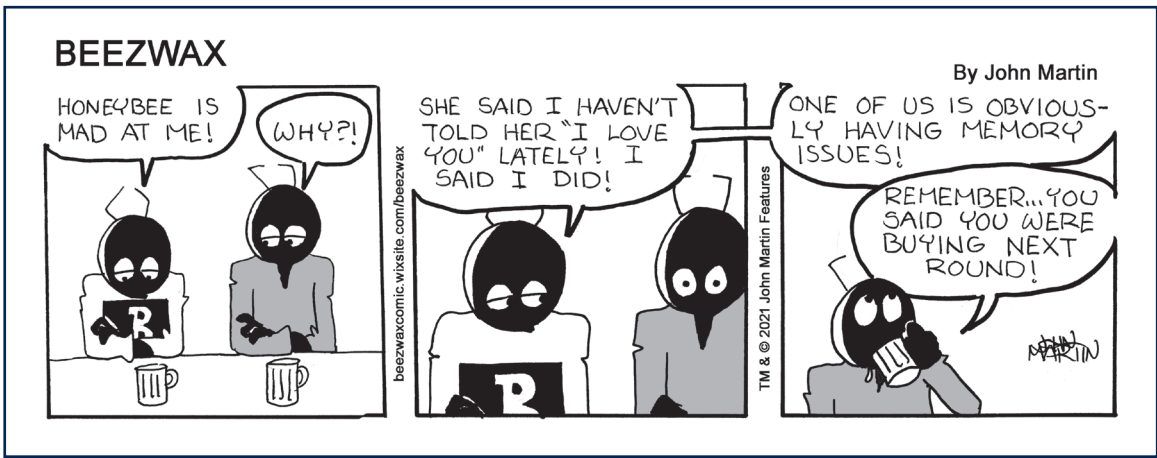
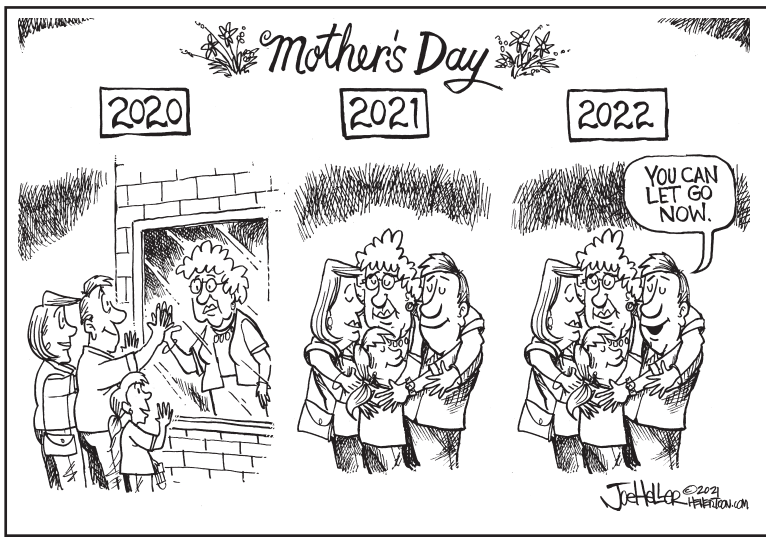
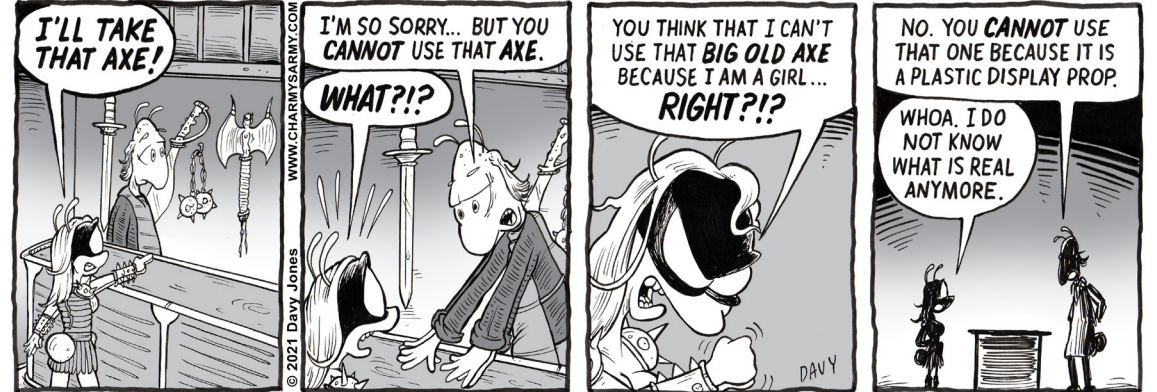

BOISE COUNTY COMMISSIONERS

April 26, 2021

Present: Commissioners Ryan Stirm, Steve Twilegar, and Ted Holmes

Pledge of Allegiance

EXECUTIVE SESSION: Closed session per personnel. [Time 9:05 am to 9:11 am] No action required.

EXECUTIVE SESSION: Closed session per risk management. [Time 9:11 am to 9:31 am] Commissioner Stirm said again, "No action required."

CONSTITUENT INPUT: A woman from Clear Creek spoke about the roads over the past 30 years that she's lived there. She said they had dust abatement before the Alamar lawsuit, and recognized that the cost of oil had gone up tremendously. "But we're here asking, as a community, to try to get some dust abatement, at least for the first mile of Clear Creek Road. It's horrible!" She said that in the morning with the commuters, you can't even see the sunrise and it looks like there is a fire. She had been reading in *The Idaho World* regarding the \$600,000 of dedicated funds for the road department. She asked that money be set aside for the dust abatement in Clear Creek and noted that she had paid for it last year. There are an estimated 800 people that live up Clear Creek Road and it's a prime selling location for land in Boise County.

Commissioner Holmes said he likes to be transparent and that Mr. Jones no longer works for the county. He had a two hour meeting with the road department and, "I have *one guy* out of sixteen that knows how to run a grader." He said over the past four years they've been

pushing the dirt off the roads, "That's why Crouch Road's so bad, that's why your road's so bad. That's not the way to do it. We're in the process of getting some of the guys trained in the department with the *one guy* that really knows how to run a grader... Proper procedure is to retrieve that material when they grade and they back lay it, put it back on the road, build a shoulder, run it out, wet it with a water truck and roll it." Holmes will be meeting with the three foremen all day on Thursday. "We're going to go out and prioritize roads. *Yours is one of them.* We are looking at that. I want to try to get roads like that because of our kids in school busses and health issues, *paved*, and most people agree with that. It's money and finding the grants to do it. The priorities are an issue based on traffic flow and also health issues."

Commissioner Twilegar stated that they are hearing concerns from the whole county about dust abatement. "It's just one of those things, it will be an ongoing thing, forever. *That's one of the reasons we live here. We like to be free, we like to do what we want with our land, we like to run our businesses some out of it. I hate raising taxes, fees and stuff like that. Personally, I don't mind dirt roads, but yeah, we could use some dust abatement. I know we used to do it all the time. That will be something we look at this summer, for sure.*"

Sheriff Scott Turner stated that there was a greater number people recreating in that area, in addition to the locals.

Commissioner Stirm noticed

on Harris Creek Road there were "donuts" spun on the gravel portion, "Just rutted up donuts all through the road. It's pretty much a countywide issue." He added, "It's going to be a process, but we're working on it."

MINUTES: A motion was said to approve the minutes from April 20 and April 22, 2021.

ROAD & BRIDGE JOB DISCRPTION: This was tabled to next week, but they would like to advertise the job.

A motion was said for a payroll change for the Road & Bridge lead man, to increase his wage.

PROSECUTOR: Adam Strong presented information regarding the need for a prosecutor in Idaho City and Horseshoe Bend.

NOXIOUS WEEDS: Commissioner Stirm made a motion to accept the agreement between the Boise County noxious weed department and the Idaho Transportation Department for weed control in the amount of \$5,100.

MASS GATHERING: Sheriff Turner spoke regarding the law enforcement agreement with the Idaho Road Rally for their annual mass gathering. The commissioners approved this agreement through a motion.

BILLS: Stirm motioned to approve the claims report in the amount of \$60,662.

LIQUOR LICENSE: Chairman Stirm motioned to

approve the liquor license for The Twisted Turkey, located on Highway 21 [previously Ellie's Store].

GRANT WRITER: An interview with a grant writer for the county. Chairman Stirm would like to know what kind of options they would have for grants as a county, and prioritize options.

IDAHO ASSOCIATION OF COUNTIES: A representative from the association gave a presentation and said there are many new commissioner board members, so he's been all over

the state. "Primarily, I'm here to talk about rules and responsibilities. Working as a team, because within the county, you all are an important team, *and the public is always watching.*"

Later on, he stated: "I suspect that within your personnel policy, that you have something on harassment in the workplace. If you don't, that needs to be in there, from a protection standpoint, for the county. Because, if you don't have that within your policy, you're opening yourself up to litigation."

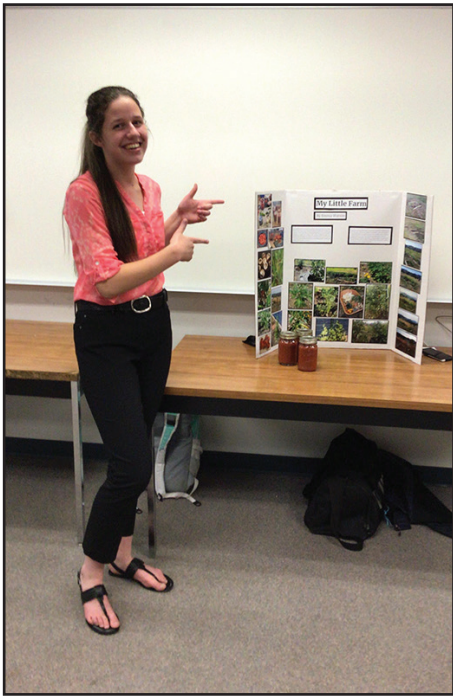

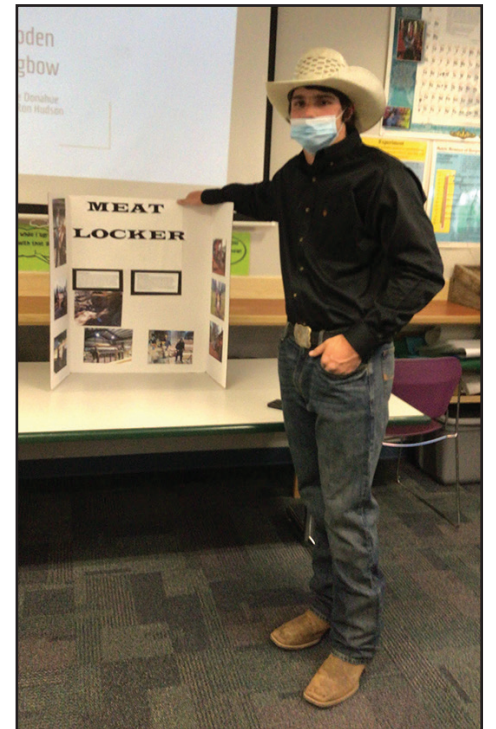

Well, let the fun begin!

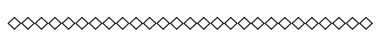

First I called the 'local' veterinary clinic but discovered the cost to spay her was very high. So I called the Humane Society, Veterinary Hospital of Idaho in Boise. We had such a positive experience that I wish to share our 'tail' with you. The nonprofit veterinary hospital is located within the animal shelter complex and provides a full range of services in addition to their primary mission of caring for the animals at the shelter, injured strays and occasionally even wildlife. The clinic performs about 10,000 spay and neuter surgeries each year! That is equivalent to about 27 pets a day! Compared to a regular veterinary office, the Humane Society Veterinary Clinic fees are much less, plus they also have a program for free or reduced cost spays / neuters for those who qualify. They even have a feral cat program. It costs only \$15 to spay or neuter these cats and they will even loan you a trap if needed. Besides preventing unwanted puppies or kittens, according to the ASPCA, spaying or neutering your pet can help them live longer, healthier lives. It can also help reduce or eliminate undesirable behaviors, such as leg-lifting and mounting, as well as decrease aggressive behaviors. Besides spay and neuters, the veterinary hospital also treats more than 20,000 animals each year for a variety of health issues. They have sliding scale fees for veterinary services based on the owner's

ability to pay. Our kitty, Fate, is now resting comfortably. Her surgery at the Humane Society went off without a hitch and it only cost us \$55. Now we too can rest in the quiet night of our household and the peace of mind that we will not need to be responsible for bringing a litter full of unwanted kittens into the world. 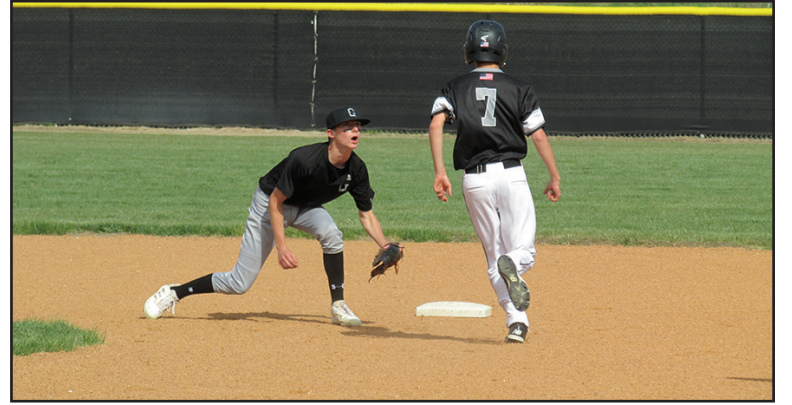

Found Guilty of Crimes Against Children

BOISE COUNTY -- Jeremy Hansford, 51, and Bessie Peterson, 43, were each found guilty last week of ten charges. After fleeing charges in Idaho City, they were apprehended in Los Vegas with passports in their possession. They appeared before Magistrate Judge Roger Cockerille in Boise County on July 8th, 2019 and were each given a bond of \$500,000 for their lewd and lascivious charges.

A search warrant was obtained for a residence where the couple had been staying for less than a year in Idaho City, on May 17th, 2019. During the investigation by the Boise County Sheriff's Office and Idaho City Police Department, meth and restricted fire arms were seized. There was also an extensive amount of child pornography images found at this location.

The case involved multiple agencies, working as a taskforce, to fight underaged sex crimes. Sentencing is expected to occur in nine weeks, pending the completion of the presentence investigation report.

The trial last week resulted in a guilty verdict of ten counts of Possession of Child Exploitative Material, child pornogra-

phy. Boise County Prosecutor Adam Strong stated, "I am grateful to the jury for carefully considering the evidence in these cases and rendering guilty verdicts. As the Boise County Prosecutor, crimes involving children are my top priority and I am glad I could help bring these two individuals to justice."
