Local Business Offers Incentive to Keep Kirkham Clean

LOWMAN -- Kevin and Darcy Courtney, owners of the Lowman Inn in Lowman are offering a free drink to anyone who picks up trash at Kirkham Hot Springs. Kirkham Hot Springs has come under national scrutiny lately after pictures, taken this past winter, of excessive trash in the pit toilet began circulating on social media. The Forest Service has limited services in the winter but the visitors kept pouring in and the trash kept building up.

The U.S. Forest Service is now operating with its summer staff and the hot springs has been cleaned up, but this is an ongoing battle. Many people in the Lowman community regularly go to Kirkham Hot Springs and clean up trash.

The *Idaho World* reported on the issue last year at the onset of the COVID-19 lockdown in March of 2020. Local community members penned a letter to the Forest Service expressing their frustrations and fears about the excess influx of visitors to the hot springs. Visitors were not only leaving trash but also neglecting to follow CDC recommendations.

Shortly afterwards, on March 26, Tawnya Brummett, Boise National Forest Supervisor, announced that all hot springs (including Kirkham), campgrounds, and other highly used areas where more people than the CDC recommends may gather would be closed until further notice. These restrictions have since been lifted and the trashing has continued.

To help alleviate the issue, the Lowman Inn wishes to incentivize people to keep Kirkham clean. The hot springs is vital to the community's businesses, bringing in thousands of people a year who need lodging, food, and drink. But at the same time, no one wants to see the hot springs destroyed with trash.

Both Darcy and Kevin stated that they want to help. It is their hope that maybe some people will assist with the community's "Keep Kirkham Clean" goal, and as a small reward, come to the Lowman Inn for a free drink of their choice. Just bring a picture or video of you picking up trash and you will receive not only a free drink but also a pat on the back and a sense of camaraderie.

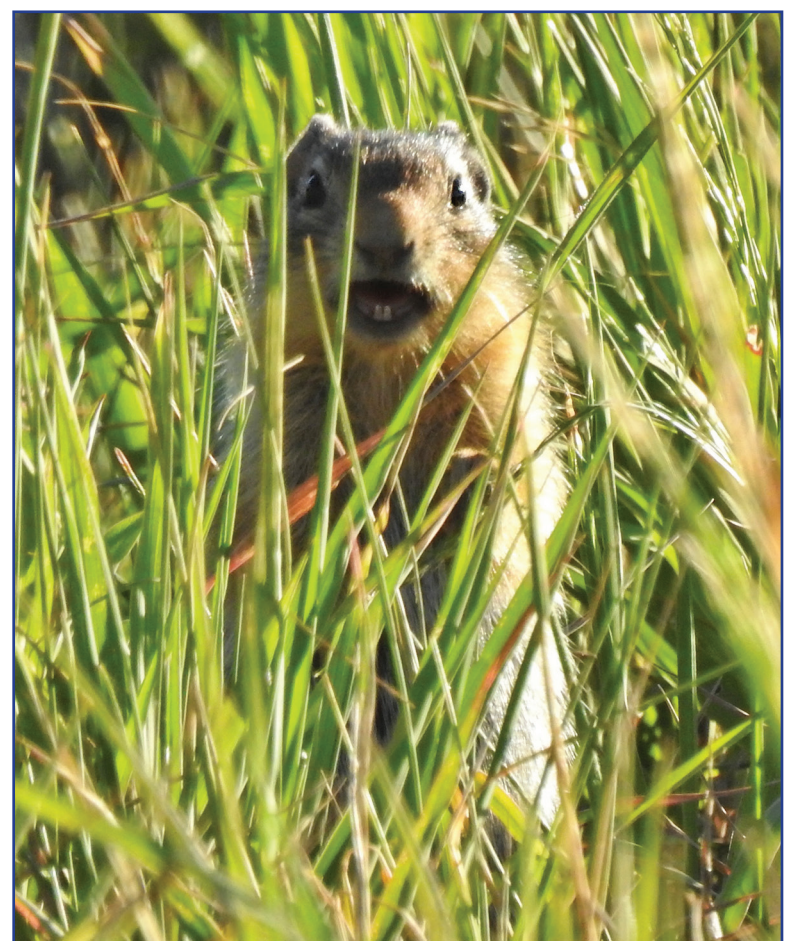

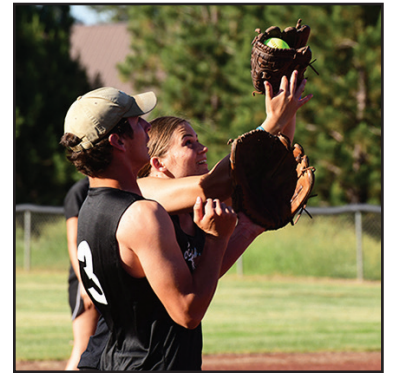

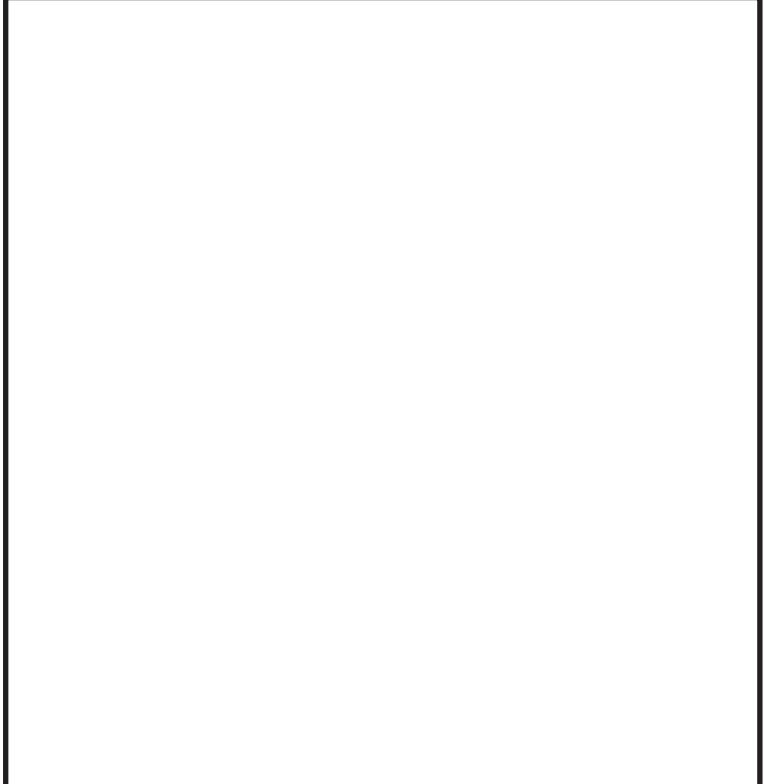

Strong Winds Hit Horseshoe Bend

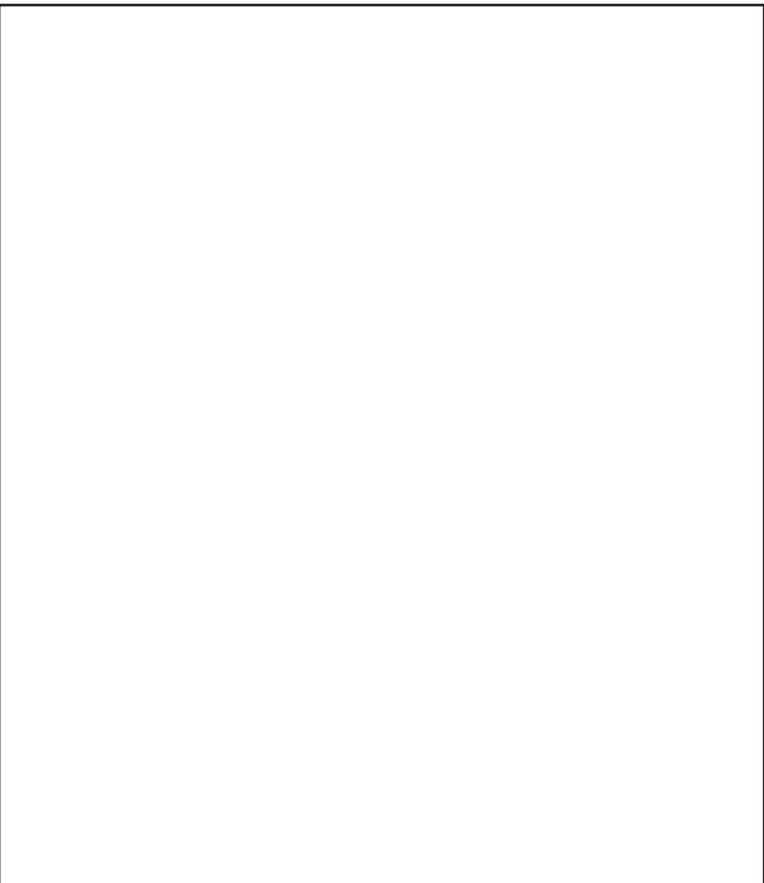

Gary Marvin McLean June 13, 1952 – June 14, 2021

Gary Marvin McLean was born June 13, 1952 and passed away unexpectedly on June 14, 2021, the day after celebrating his 69th birthday. He was in Portland visiting friends. Gary is survived by his wife, Kim Mellen-McLean, his sister Terry Martin, many McLean and Stafford family nieces, nephews and cousins, and friends across the world. He was a friend and mentor to so many.

Gary was born in Portland and grew up in Parkrose. He graduated from Parkrose High School in 1971 and joined the US Air Force. He served in Thailand, Michigan, and Wyoming. After leaving the Air Force in 1977, he decided to become a paramedic. He was one of the first paramedics in Oregon, graduating in the first paramedic class at OHSU. He worked for Buck Ambulance and AMR, including the Reach and Treat Team on Mt. Hood. He spent a year in Saudi Arabia as a paramedic and nearly 3 years as a remote site paramedic in Alaska.

Gary earned his AAS as an RN from Mt. Hood Community College in 1994 and then worked as an ER nurse while volunteering at Sandy Fire Department (SFD). He was hired by SFD as a firefighter/paramedic in 1998. He served as their EMS Training Officer and mentored many volunteers. In all, he served at SFD for 22 years before "retiring" in 2014.

Gary was a phenomenal paramedic and advocate for EMS. He was president of the Oregon EMS Association for 7 years,

served on the Board of Governors and the Membership Committee for the National Association of EMTs, and was an EMS Representative on the Epilepsy Foundation Professional Advisory Board.

Gary and his wife Kim moved to Wilderness Ranch, between Boise and Idaho City, in 2017. He began volunteering with the East Boise County Ambulance as a responder and as the Clinical Operations and Training Officer for Unit 15.

His passions for teaching EMS and travel took Gary all over the world. After he "retired," Gary taught EMS through Medical Teams International in Myanmar, Cambodia, and Nepal. He volunteered with HERO in Haiti providing EMS training and emergency response on an ambulance in Port au Prince. He was part of a team which developed protocols, a handbook, and provided training for Rural Medical Responders in Nepal. The program has been adopted by the Nepal Ministry of Health. Over 2000 Nepalese have been trained as rural and remote medical responders in remote medical care through this program.

Gary's work in Nepal resulted in a passion for both the country and people of Nepal. His students called him Gary Uncle. He made the trek to Everest Base Camp to see the medical facilities. His work in Nepal with Himalayan Medics Rescue Service, Nepal Medics, Himalayan Yokpu Foundation, and the Wongchhu Sherpa Me-

morial Hospital will always be remembered. Gary became active with Musa Masala and was going to be a major part of their nursing scholarship and educational programs.

Gary's interest in remote/wilderness medicine became his passion in the last few years. He became an instructor of Wilderness First Aid (WFA) through NOLS. He also joined the Wilderness Medical Society and earned his Fellow of the Academy of Wilderness Medicine (FAWM) in 2020. At the time of his death, he was working towards a Diploma in Mountain Medicine through WMS.

In addition to EMS travel, Gary loved a good road trip. A favorite destination was Tsylos, the McLean family's lodge in British Columbia, either with Kim or cousin Larry. Road trips were off the beaten path across western North America, from the Arctic Circle down to the southwest and Texas and from the Pacific Ocean to the Rocky Mountains. Often living in the small pop-up camper for weeks at a time. After Kim retired, more international trips were taken together, visiting 10 countries in 4 years. Many more trips were planned, but alas will not happen.

Gary loved animals, both family pets and wild animals. He loved watching the birds, elk, deer, and foxes around the Idaho home. One year he raised California quail from day-old chicks that were raised in the bath tub until they were big enough to go outside to the coop. He rescued frog eggs from the fish in the pond and raise the tadpoles in an aquarium on the kitchen counter. Quail in the tub, frogs on the counter. There was always a little boy that lived in Gary.

Gary never met a stranger. He was full of compassion and tried to make the world a better place act by act, patient by patient, deed by deed. He lived life to its fullest until his last day on earth. We lost him way too soon. Namaste Gary.

HORSESHOE BEND CITY COUNCIL

BOISE COUNTY -- The following is a synopsis of the Horseshoe Bend City Council meeting on June 23, 2021. Mayor Pat Goff made the call to order at 7:00 p.m., led the Pledge of Allegiance, and after unanimous approval of the agenda, previous minutes from May and special meeting in June, and the authorization to pay the city's bills, Goff opened the dais for public comments. No one came forward.

New Business: Gay McGee, events & Veteran's Memorial liaison for the Horseshoe Bend Valley Chamber of Commerce, told the council that after the Chamber's Casino Night on June 19th, the Veteran's Memorial project was fully funded. McGee asked the council when the park would be ready. Goff said that as soon as the ID-55 bridge construction crews were packed up and gone, work on the park could begin. McGee thanked the council for all of their support.

Water rate increase was deliberated and decided upon with the council opting unanimously for alternative #1, which increases the water rate by 3% each year for the next five years. New rates will go into effect on July 1, 2021.

The city council unanimously approved the auditing service contract (which was raised from \$6,100 to \$6,400) from Zwygart John & Associates for the upcoming fiscal year.

City Treasurer, Teri Nolan, presented the budget proposal to the council. They will need to provide a tentative approval for the July council meeting. The budget then goes to publication in August, before being voted on by the council. Council member Martye White asked Nolan, "Did you see anything that went up a whole lot?" Nolan replied, "As far as expenses, not really, no."

Public works employee, Jobie Catherman, told the council to expect an upcoming shortage of chlorine, but added that the city had 450 gallons on hand and should be able to make it through the year with-

out another load.

Gem County prosecutor, Eric Thomson, introduced himself to the council and gave the city his rate for assuming the role as the Horseshoe Bend City prosecutor (\$1,500 per month). Thomson explained that he is currently working with the city attorney, Tony Pantera, on revising the penalties associated with city ordinances. The proposed amendment would change penalties to a "3 strike" rule, which would mean that first and second offenses would be categorized as infractions payable by a fine and third offenses would be misdemeanors subject to incarceration. White asked, "When can we expect to have a final draft so we can start prosecuting some of our problem children?" Pantera said, "There are just a few tweaks left." White responded, "I'd like to see that just as soon as possible. We'll do anything to help you guys out. We've got some problems that have been out there a long time and we haven't done anything about it. If we approve this (amendment) can we start writing tickets tomorrow?" Pantera responded, "You can start writing tickets yesterday." White asked how many times someone could be cited for the same violation to which Thomson said "daily." The "3 strike" ordinance was approved unanimously (the three reading rule was voted on and waived, amendment was adopted by title only) by the council and carries a first time penalty of \$100, second offenses carry a \$300 fine, and 3rd strikes become misdemeanors punishable by jail time.

An amendment was made to existing city ordinance 1-4-1 regarding the number of exotic animals allowed on residential

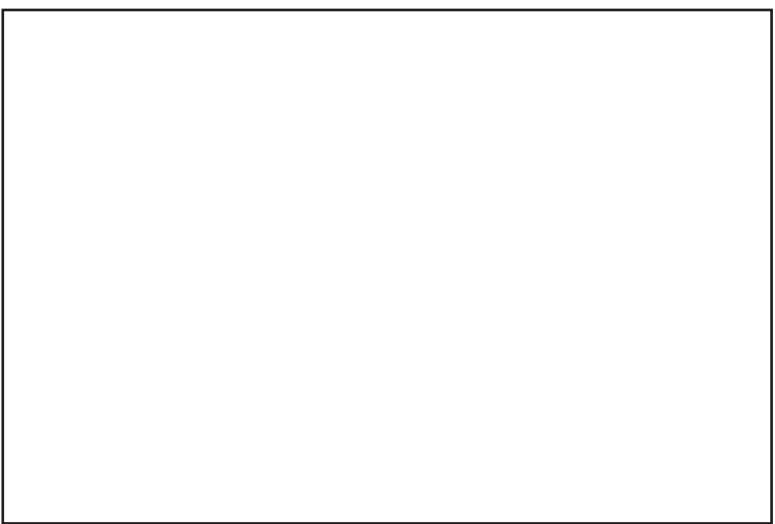
properties, changing it from a misdemeanor offense to an infraction.

EMS Report: Michele Brothers reported that the department had made 19 runs, 8 non-transports. White asked how they were doing on staffing and Brothers said, "A little bit thin." The gurney lift has been completely installed and is helping a lot.

Public Works Department: Water usage is running about 170,000 gallons per day with 3.4 million gallons so far this month. White asked what happens when the power goes out at the plants? Catherman said the sewer plant had generator back up, but there was no back up at the water plant and that they could continue to operate around 12 hours at typical usage, 1.5 days if conservation was in effect. Goff suggested that the city look into procuring a grant or purchasing generators for the water plant. He also brought up looking into replacing the redwood water tank that is in the north part of the city. Catherman agreed and said that the redwood material was not "ideal for this environment." He added that a steel welded tank would be nice as even the "liner in the redwood tank is not working right."

Goff told the council that he was meeting with Fatbeam, a fiber-based network provider, regarding meshing communication throughout the city.

Grant Writer: Cheryl Pleak reported that she submitted a grant benefiting the EMS Department for a Lucas (Lund University Cardiopulmonary Assist System) machine and a chair lift. Pleak stated that she had submitted reports for current grants and they were in 100% compliance. She is cur-

rently working on a DEQ water source grant and writing another grant for the Veteran's Memorial Park to provide for fencing, grass, trees, and plantings. Stack Rock Group Landscape Architects is providing a bid for the park. Pleak is gathering information for an Idaho Transportation Department (ITD) sidewalk grant but is having difficulty getting a bid for concrete. Goff posed that they may need to put off the project for two years, because there are issues getting building materials.

City Engineer: Setting up a water conservation ordinance in case of an emergency was discussed. Thomson found an existing ordinance regarding emergency water conservation.

There will be a technical re-

view of the proposed Deer Valley Plat beginning on July 29.

The Engineering Department is in the process of certifying the ITD bridge sewer project to ensure use of American-made products.

There was a brief discussion regarding lighting that the city must provide for the newly constructed ID-55 bridge. Goff asked Nolan to add \$120,000 to the proposed budget to pay for lighting.

City Attorney: "We covered most of my material"

Mayor's Report: "None for me."

The council went into executive session at the request of councilmember White at 7:58 p.m. The city council meets at 7:00 p.m. on the third Wednesday of each month at city hall.

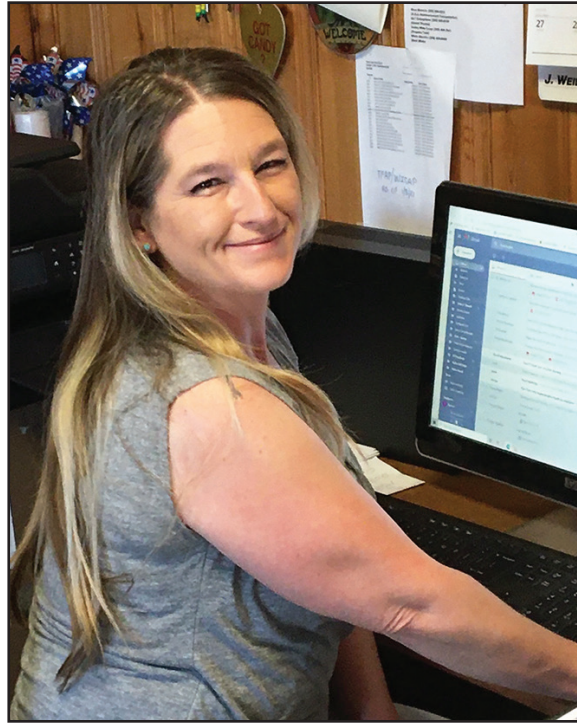

The Three Zone Wildfire Protection Plan

BOISE COUNTY -- The most recent drought monitor map, June 17, 2021, <https://droughtmonitor.unl.edu> has the southern portion of Boise County in "moderate" drought conditions, the northern portion in "severe" drought conditions, and the outlook is for the drought to persist in our area. So, what are "moderate and severe" conditions? Moderate drought is characterized by "some damage to crops, pastures; streams, reservoirs, or wells low, some water shortages developing or imminent; and voluntary water-use restrictions requested." Severe drought involves "crop or pasture losses likely, streams, reservoirs, or wells low, some water restrictions imposed" according to the National Weather Service's Drought Severity Classification.

The relationship between drought and fire is complex. Drought impacts the risk of wildland fire by in an **increased volume of live and dead fuels**, and increased evaporative demand, increasing the probability of large-scale wildfires. The timing, intensity, and frequency of drought events have divergent impacts on fuel flammability and fire behavior. A wet spring, like we just experienced, creates abundant fuels in forest and grasslands. Drought conditions can cause rapid drying of this fuel, which can feed larger fires. Source: <https://www.drought.gov> What all this means for us is the probability of an active wildfire season. The time to prepare is now!

"Research around home destruction vs. home survival in wildfires point to embers and small flames as the main way the majority of homes ignite in wildfires. Experiments, models, and post-fire studies have shown homes ignite due to the condition of the home and everything around it, up to 200' from the foundation." Source:

National Fire Protection Association

The "Home Ignition Zone" defense plan is a method for homeowners to prepare their homes to withstand ember attacks and minimize the likelihood of flames or surface fire touching the home or any attachments.

The Three Zone Plan to protect your home.

The immediate zone, 0 to 5 feet from your home:

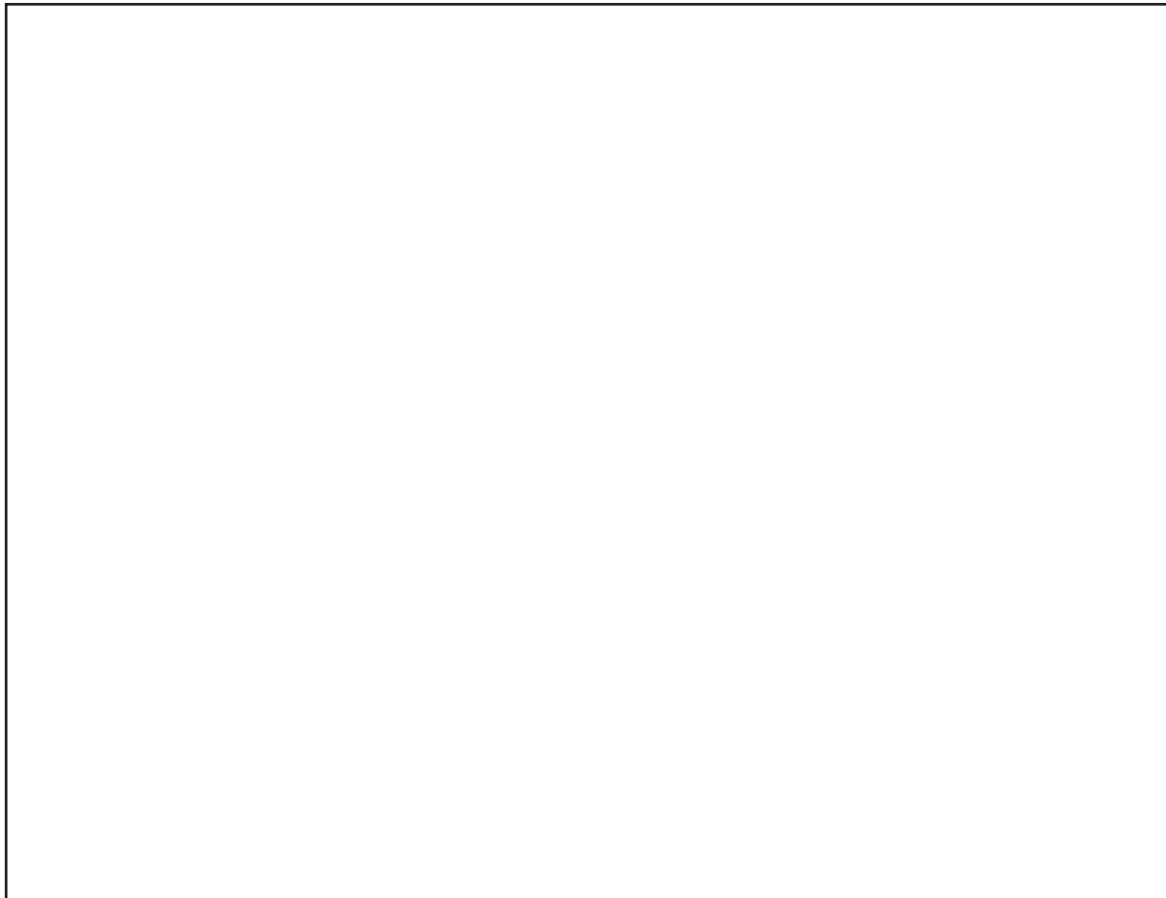
1. Is there dead vegetation, dried leaves, pine needles, and/or ground debris near your home?
2. Have you used hardscape around the perimeter of your home so you can keep the area immediately next to your home free of litter and debris?
3. Do you have wood mulch products near your home, or has it been replaced with non-combustible material like stone?

The intermediate zone, 5 to 30 feet from your home:

1. Are there fuel breaks such as driveways, walkways, and non-combustible patios between your home and grass or trees?
2. Are lawns, native grasses, trees, and shrubs maintained so they are moist and lawns at a height of 4 inches or less?
3. Are trees and shrubs in this area limited to small clusters with trees spaced at a minimum of 18 feet between crowns?
4. Have trees been pruned between 6 to 10 feet so ground fires cannot reach the branches and crowns?

The extended zone, 30 feet to a minimum of 100 feet or even better 200 feet:

1. Are there heavy accumula-

tions of ground litter, like old pine needles, that can smolder and allow a wildfire to spread underground or reach the root systems of trees and shrubs?

2. Are there dead plants and tree material that should be removed?
3. Are outbuildings in this zone maintained with their own zones of safety just like your home?
4. Have ladder fuels been removed, like mature trees having small conifers and brush growing between them?
5. Do trees 30 to 60 feet from the home have at least 12 feet between canopy tops? Is there at least 6 feet between canopy tops of trees located 60 to 100 feet from your home?

Many homes located in wildfire-prone areas have attached decks which can potentially spread fire to the house when the deck is ignited during a wildfire. A burning deck can ignite siding or break the glass in doors or windows, allowing fire to enter the house. Consequently, making decks less vulnerable to wildfire also makes your house less vulnerable. Reducing the deck's vulnerability requires an approach that focuses on the materials and design features used to build the deck and creating a noncombustible zone around and under the deck.

The first risk associated with decks is the collection of light fuel, i.e. pine needles, under the deck. The deck tends to allow accumulation and protects this fuel from getting very wet

from rain or snow. Light fuel ignites easily, and dry fuel ignites easier than wet fuel so light dry fuel is susceptible to ignition from traveling wildfire embers. Light dry fuel also tends to burn hotter than other fuels. The horizontal nature of decking is another risk. When you have pine needles burning under your deck, it does not take flame to ignite the deck, radiant heat from the fire under the deck can cause the decking material to exceed its ignition point and burst into flame.

Recent testing at the IBHS Research Center showed that embers lodge between deck board gaps and where deck boards rest on joists. Embers

can accumulate and potentially ignite decking and combustible joists. Embers can also fall through board gaps and land on materials stored beneath the deck. It is critical to remove all combustible materials from under the deck to minimize the opportunity for ignitions. IBHS tests also showed that even without vegetative debris in between deck gaps, medium density softwood decking products such as redwood or western red cedar are vulnerable to ember ignitions. Most wood-plastic composites, along with higher density tropical hardwood, and fire-retardant treated decking products are less vulnerable to embers.
