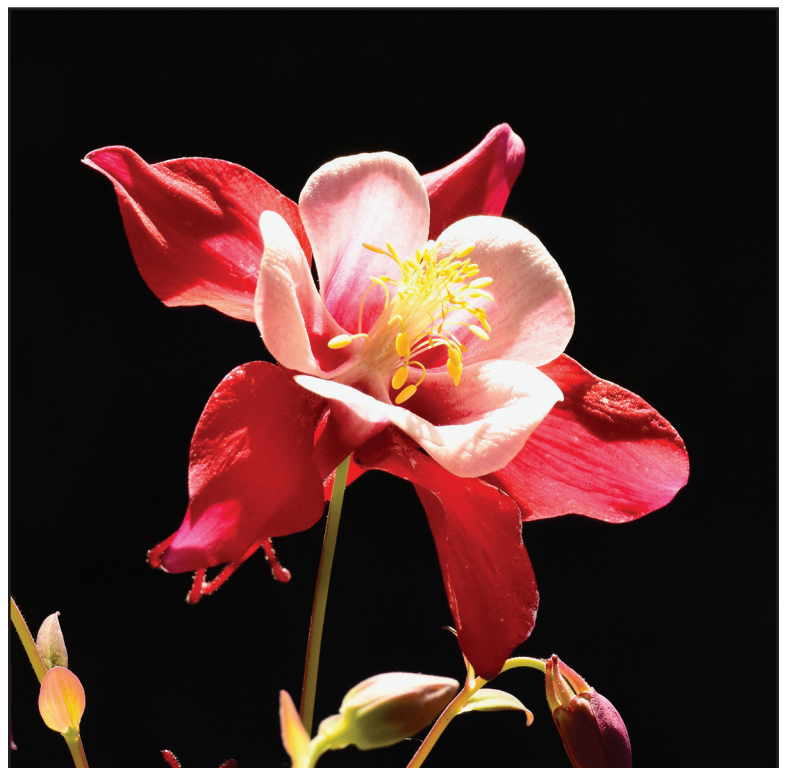

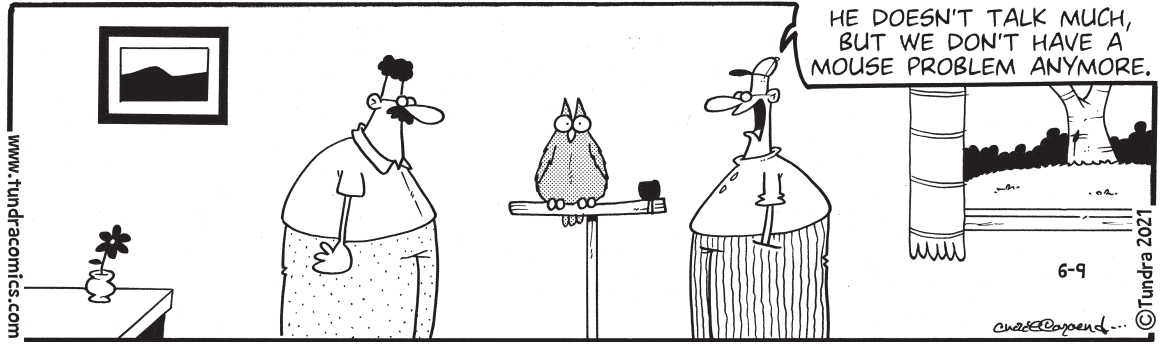
These are the most common violations we write to juveniles over the summer. Historically, it seems that juveniles with summer jobs get less citations than juveniles without jobs.

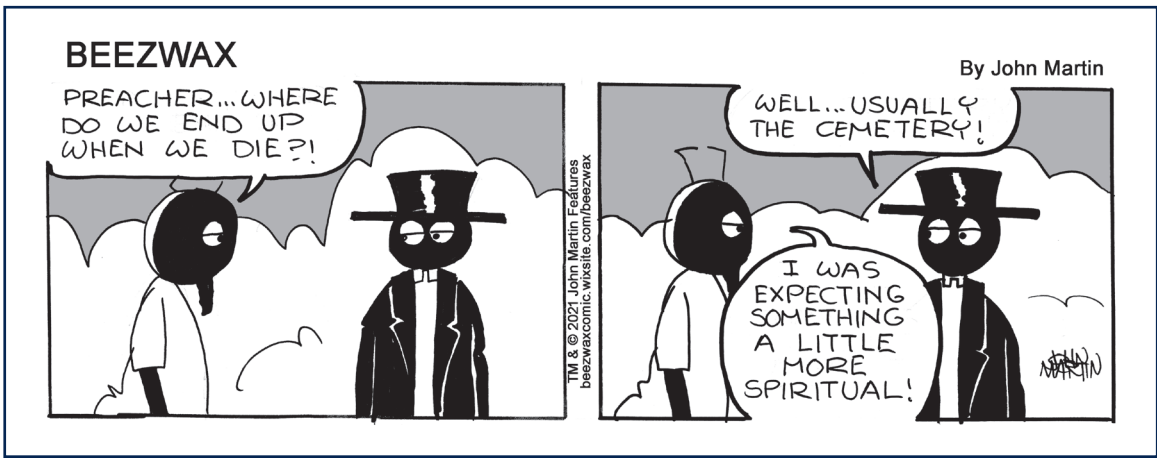
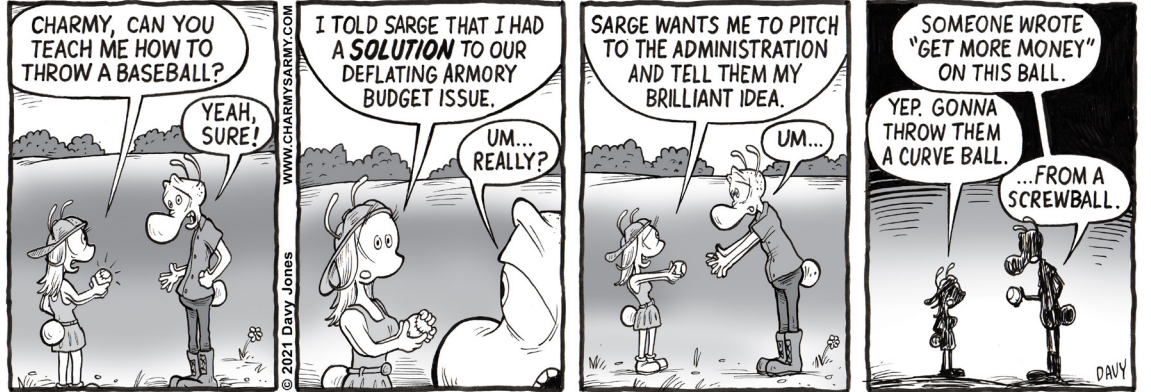

BOISE COUNTY COMMISSIONERS

6/1/2021

Present: Commissioners Ryan Stirm, Steven Twilegar, and Ted Holmes

Pledge of Allegiance

EXECUTIVE SESSION: Closed session per pending litigation and risk management. [Time 9:03 am to 9:43 am] No action was required.

CONSTITUENT INPUT: None

MINUTES: Commissioner Stirm motioned to approve the May 25th meeting minutes as written.

DEPARTMENTAL ISSUES:

COMMUNITY JUSTICE: Stains and sealers for the boardwalk were discussed for purchase. Clerk Mary Prisco said the funds would come out of capital projects to pay for it and Amanda Leader of Community Justice said the work would be done through community service. Chairman Stirm motioned to approve the purchase of stain/sealer not to exceed \$2,000.

Maintenance projects were tabled until next week.

EARTHQUAKE DAMAGE: The Public Safety building at the Sheriff's Office sustained foundation damage in March of 2020. Clerk Prisco said, amazingly, the 150-year old buildings, the courthouse, and Miners' Exchange building, were fine. However, the newer building, the public safety building did sustain damage. They have finally received an estimate for the damage, which comes to about \$18,000. This amount is below what the county's insurance will cover. She said, "We need to make the repairs. They're substantial enough that they need to happen." Chairman Stirm made a motion to accept the bid to repair the safety building in the amount of \$18,455.78, to make it waterproof again.

AGREEMENT: Cooperative Agreement for Univ. of Idaho Extension Office and the 4-H program with Gem County. A motion was said to approve the agreement in the amount of \$9,000. Clerk Prisco will reach out to Rebecca Mills regarding the program and to present to the new board of county commissioners.

COMMUNITY JUSTICE: Commissioner Stirm motioned to approve the AED defibrillator grant application for Community Justice.

LIQUOR PERMIT: A liquor permit was motioned and approved for Cowgirls of Kuna

for the Eagle Rodeo.

PUBLIC DEFENSE FUND: Clerk Prisco said that this was the second request for reimbursement from the Capital Crimes Defense Fund for the Capital Murder case. The amount of \$47,979.49 is what the county has paid out. The county is eligible for reimbursement under the capital defense fund. Chairman Stirm motioned to approve the letter for the Capital Crimes Defense reimbursement in the amount of \$47,979.49.

DEMAND WARRANTS: Chairman Stirm motioned to pay the Department of Transportation in the amount of \$55,000 for an agreement match for the Banks Lowman Road.

EBCAD: Commissioner Twilegar reached out to Melissa Potts, Director of East Boise County Ambulance in regards to where they started, where they're at now, and a separate report on what they want to do in the future. This will be a future agenda item.

COUNTY BUDGET: Clerk Prisco reviewed the progress on the budget. Commissioner Stirm stated, "I would like to look at what the financial responsibility would be to repair the Boise Street Bridge of Horseshoe Bend." His thought was to get it fixed and then give it to the city. It's about 10 feet out of the city limits. It has been closed for three years to everything except foot traffic and its closure adds another 5-minutes to response times for emergencies. Grant options will also be explored.

GRANTS - Possible grants were discussed with the grant writer, and a "wish list." Twilegar would like to include EBCAD in grant possibilities, but since they are their own taxing district, there are some administrative things that need to be figured out. She would like to know what grants they have applied for in the past and have received. [She also put in the application for the three defibrillators for Community Justice.]

GRANT SUPPORT LETTER: EBCAD is trying to get a new ambulance. One 2009 ambulance broke when it went on a call and had to be towed, another ambulance covered. Director Melissa Potts said, "The plan would be, not really to replace any of the ambulances, the plan would be to bring the oldest one over to Idaho City to have a spare backup ambu-

lance. In case there are multiple calls at one time. In case we have a disabled ambulance, we've got that backup right there." Commissioner Holmes asked where the ambulances were currently. Potts answered: Lowman, Mores Creek, Idaho City, and Placerville. They are all running, but aging. The grant is for \$140,000, so they will need to come up with \$50,000. Chairman Stirm mentioned that they might want to inquire about a grant to help with the \$50,000. Stirm made a motion to approve the East Boise County Ambulance FY2022 EMS grant letter of support.

Potts reported to Stirm that there were six new EMTs certified through their latest class, "six for six."

SHERIFF: Chairman Stirm asked if Sheriff Scott Turner had any problems with Kirkham Hot Springs over the Memorial Day weekend. Sheriff Turner replied, "We had an issue *everywhere*. My guys, they spent most of their time dealing with campers and campgrounds, and accidents." He added that they were back at multiple campsites, multiple times.

FUTURE AGENDA ITEM: Commissioner Twilegar would like to put on the agenda littering fines and parking fines. Clerk Prisco asked if it would be an ordinance, and was answered that it would. The sheriff was asked to be there for the discussion. The sheriff said there have been issues on the paved roads and nonroad ways.

PLANNING & ZONING

COMMISSION: Mr. Steve Moore was recognized as a new member of the P&Z Commission Board. He was sworn in by Commissioner Stirm, "to support the Constitution of the United States, and the Constitution of the State of Idaho," and to faithfully discharge the duties of the Planning and Zoning Commission according to the best of his abilities. Commissioner Stirm stated: "We still need more Planning and Zoning Commissioners, so if anybody wanted to volunteer, those jobs are open."

GRANT FOR VEHICLE: Mr. Bud Paine, per their request, asked to be put on the agenda in May, but he said it took too long and now the grant is due the following day. "That's kind of discouraging." Paine also said he put in a budget request for EBCAD, and that it is not stated on the county's website. He said he wants to bring in paramedics, "it would not cost the county or the taxpayers any more money than that's already in the existing budget." He asked to be put on the agenda for the following week to give a full presentation and line item budget for paramedics in Boise County.

Commissioner Twilegar said he would like to give Ms. Potts a chance to speak. Commissioner Stirm, an EMT with Horseshoe Bend Ambulance, asked regarding medical responses in the county and air meds. After much discussion, Stirm concluded, "We are working towards a higher level of care for patients. It is imperative to us that we have that..."

There's a reasonable number of people that are going to come through here and have an emergency, like the poor young lady that didn't wear a helmet and bounced her head off a rock this weekend. They're not going to survive a 45-minute ride; I don't care who have in the back of your ambulance. So, in that situation." Paine tried to interrupt, but was asked by Commissioner Twilegar to let Commissioner Stirm finish. Stirm continued, "So, that is going to influence our decision. Yes, pain management plays a role to some extent. At this point, I think the ambulance districts are doing their best to try and increase their levels of care. It's not been the medical director, it is simply the level of training that has been afforded them up to this point. They are working on that. Of course, Ms. Potts' been working on that, and Horseshoe Bend's been working on that, and Garden Valley's already there. They just need to get more people that are in that area. I, for one, *again personally*, would find it incredibly difficult to fund a full time paramedic-level ambulance with the current budget that Boise County has and I don't think that's possible." Paine insisted that it was possible. Chairman Stirm thanked him for his time and invited Paine to put in a public records request with the Clerk's office. Paine responded, "It's already solved. *Why should I?* You guys have fun!" Stirm thanked him again for coming in.

Adjourned at 12:16 pm.

Ione M. Messick, 86, of Crouch, Idaho, passed away at home on Wednesday, March 31, 2021 from natural causes. A remembrance celebration is being planned for 11:00 am, August 21, 2021, at the Crouch Community Church.

Ione was born on August 17, 1934, in the township of Deep Creek, North Dakota, to Warren B. Lowe and Francis M. Smith, who were living in Rhame, North Dakota. In June, 1935, Ione's parents moved the family to Nampa, Idaho, where her father worked many jobs. In 1941, the family moved to the Willamette Valley, Oregon, where there was steadier work. In 1945 they moved back to Nampa, then Ontario, Oregon, before finally settling down in Nyssa, Oregon.

Ione met her life long partner, Hal T. Messick, in Nyssa. They were married August 22, 1950, in Caldwell, ID, and then moved to Boise. Ione was a stay-at-home wife and mother until her two children were in

about the sixth grade. She then worked at a few different jobs. She was a school lunch cook, for a couple of years, at the Jr. High her daughter attended. And she was a sales clerk for a department store in downtown Boise. In 1976, Ione and Hal moved to Crouch, Idaho. They opened a repair shop and were agents for the Idaho Liquor Dispensary. They also sold hunting & fishing licenses and did vehicle registration and licensing. Ione ran the "store" and Hal was the mechanic. Ione enjoyed meeting and getting to know all of her customers and everyone in her new community.

Ione was an avid reader and was happy to find that Crouch had a small library sponsored by the local women's club, the Garden Valley Syringa Club. She became a member of the club and participated in their various community improvement projects. She enjoyed the many years she spent volunteering and fundraising to help the little library grow. In 1976, when the Club established a district for the library, she encouraged using a name for the library that would reflect the community that it would serve. Thus was born the Garden Valley Library District. In the late 1980's, Ione encouraged making the library district a taxing district. This allowed a reliable funding source for future growth. Ione continued her active involvement with the library into the late 1990's.

After Ione and Hal sold their business and retired in 2000, Ione started volunteering at

the Garden Valley Senior Center. She was an instructor for the Fit-n-fall proof exercise class for many years and she worked in "Granny's Closet" to help raise funds to support the center. She always enjoyed meeting people and helping the customers.

In the late 1980's, Ione was elected to the Crouch City Council and served for a couple of terms. Because the city population was so small, just about everybody had to take a turn. Hal had served several terms earlier in the 80's. Both Ione and Hal devoted many years giving back to the Garden Valley community.

In the 2000's Ione started going back to Church. She attended the Crouch Community Church regularly and found joy in her Church family. She always looked forward to all the hugs she would get on Sunday's, and was not happy when she couldn't attend.

Ione is greatly missed by her children, Diane and Richard Messick, both of Crouch; her brother-in-law and sister-in-law, John B. and Ernestine Messick, of Nyssa, OR; many nieces and nephews, of whom she professed to be their favorite aunt, scattered across the country; and her many friends made over her lifetime. She was preceded in death by her husband, Hal, both of her parents, and her brother and sisters.

Seeking Public Input on Skinny Dipper Hot Springs Closure Extension



BOISE COUNTY – The Bureau of Land Management announced today it is seeking public input on a proposal to extend an existing closure of the Skinny Dipper Hot Springs, located about 5 miles west of Garden Valley.

An April 2015 environmental analysis concluded that the unauthorized construction of pools and piping systems, and the use it generated, resulted in natural resource damage and a public health and safety hazard. In June 2016, the BLM issued a 5-year area closure and removed the unauthorized piping. Soon afterward, a natural rockslide filled the pools, making them largely unusable.

“Before the closure we received repeated complaints from local law enforcement, area landowners, and public health officials related to unsafe and illegal activity at the site,” said Brent Ralston, BLM Four Rivers Field Manager. “With

the potential for those same safety concerns to rise again, and with other authorized hot spring recreational opportunities in the area, we are reaching out to our partners and users while we consider extending the closure.”

The BIG Tree Is Gone, But Not Forgotten

EAST BOISE COUNTY -- The Big Tree is gone. To many it marked "almost home" when returning to Idaho City from the valley. Manetta Schrite and friends honored it with ribbons and bows. To visitors it was a wonder. Now there's an empty space near mile marker 33 on Highway 21. On May 4 and 5 the Ribbon Tree was removed.

It took a lot of people to remove and transport the giant tree. From the local Idaho Transportation Department District 3, Caleb Lakey made preparations while Jerry Richards and Elmer Nickerson pulled all the parts together. The Idaho City Road Crew directed traffic and took care of all the loose ends. Idaho Power's urban arborist Ron Mahler supervised the tree cutting crew. They managed to fall the tree right where they wanted it, missing other trees and power lines. That was only step one.

To move the tree from the site, local people with equipment and years of experience stepped in to volunteer. Todd Niehoff and Roger Jackson, using with some equipment from Neal Gardner, loaded the giant logs and transported them. Again Richards and Nickerson were there with their crew to make sure the logs were loaded and all the debris was cleared away. It couldn't have happened without you. Thanks also to all those who made phone calls and offered help. Truly a community that knows how to get things done.
